GENERAL:

Due to a miscommunication on race morning L Allpress was incorrectly declared for TENNESSEE ROSE.

RACE COMMENTS:

Race 1 DAVE HOSKIN CARRIERS MAIDEN 1200

MI CAROL (H Schofer) - Slow to begin

RAANI (T Taiaroa) - Slow to begin

RETZENA (S Macnab) - Made the bend near the 800 metres awkwardly and shifted out forcing **AMA LA VITA** wider.

AMA LA VITA (L Satherley) - Hampered passing the 800 metres.

HESACITIBOY (L Hemi) - Hampered and forced out near the 250 metres. After questioning riders it was established

that **CHIKIRA LASS** (K Asano) shifted out into clear running near the 250 metres when not the required distance clear of **LINCOLN HANOVER** (S O'Malley) which was dictated outwards into the line of **HESACITIBOY**. When assessing the interference, stewards took into account the tendency of **HESACITIBOY** to lay inwards across the heels of **LINCOLN HANOVER**. Nevertheless **K Asano** was issued with a warning under Rule 638 (1) (d) and advised to exercise greater care when shifting ground. **HESACITIBOY** continued to lay inwards for the remainder and had to be continuously straightened.

TUDOR QUEEN (S Collett) - When questioned regarding the performance S Collett advised that in her opinion the filly would improve with today's race.

Race 2 SOUND ELECTRICAL 1200

HORLISTIC (A Mudhoo) - Restrained from its wide barrier then was obliged to race wide without cover.

HYDROEXPRESS (M Hudson) - Held up until shifting out passing the 350 metres to improve

MAROTIRI BELLE (D Bradley) - Shifted out under pressure near the 150 metres and hampered **FIRST ROCK** for a short distance prior to being straightened.

DEDOJE (F Lazet) - Had to steady for some distance near the 600 metres when improving into restricted room between **SHADY GREY** and **SHE'S A LADY**. F Lazet was shown footage of her ride in the presence of the riding master.

Race 3 TCL COMMUNICATIONS 3YO 1200

NOD OF THE HEAD (L Hemi) - Began awkwardly then hampered shortly after losing ground.

ICONIC LASS (M Hudson) - Slow to begin

AMOSIA (K Asano) - Began awkwardly

Race 4 A+ PLUMBING 1340

MY FATHER'S GUN (R Bishop) - Slow to begin then crowded shortly after having to be steadied.

LADY LIRA (L Satherley) - Was inclined to lug inwards throughout the home straight and had to be continuously straightened.

IFNDOUBTGETOUT (F Lazet) – Had to shift out to obtain clear running passing the 150 metres.

Race 5 WANGANUI MOTORS AND THE DYKE FARM OPEN 1340

JUSTASKME (A Mudhoo) - Slow to begin

TAVIS COURT (L Allpress) - Raced keenly in the early and middle stages.

BRUNO MAGILE (C Johnson) - When questioned into the run of **BRUNO MAGILE** C Johnson had no excuse. R Lockett advised the gelding is now better suited to a longer distance.

Race 6 DUNSTAN FEEDS STAYERS CHAMPIONSHIP QUALIFIER 1600

CABOCHON (T Bau) – Slow to begin

GERDA (H Schofer) - Slow to begin

SPIDERMAN (T Taiaroa) – Slow to begin

CROSS ROADS (C Johnson) – Over-raced in the early and middle stages.

ANGARIA (L Satherley) — When questioned into the disappointing run of **ANGARIA** which finished well back, L Satherley was of the opinion something may be amiss with the gelding. A subsequent veterinary examination did not reveal any obvious abnormality.

SEAAPRINCE (L Allpress) – Finished well back. L Allpress had no excuse. A subsequent veterinary examination revealed a slow recovery rate.

Race 7 STEELFORM ROOFING GROUP WANGANUI CUP 2040

OBSESSIVE (L Allpress) – Slow to begin after being fractious in its barrier.

CHERRY LANE (T Taiaroa) - Slow to begin. Finished well back. T Taiaroa was of the opinion the mare was unable to overcome it's slow beginning and the fast pace in the early and middle stages. A subsequent veterinary examination did not reveal any obvious abnormality.

NYMPH MONTE (S Macnab) – Slow to begin

SIR NATE (K Asano) - Raced keenly in the early and middle stages. When questioned K Asano advised **SIR NATE** raced in a very fresh state and he was unable to settle the gelding until near the 1,000 metres.

Race 8 LOADERS WANGANUI 2040

DEUCE COUPE (S Collett) – Over-raced in the home straight on the first occasion.

BELLA NERO (M Hudson) – Raced three-wide throughout.

CARPE DIEM (A Mudhoo) - Was inclined to lay inwards near the 100 metres at the same time as **NO COMPROMISE** shifted ground outwards. **CARPE DIEM** continued to lay inwards and had to be steadied off the heels of **NO COMPROMISE** over the concluding stages. Connections of **CARPE DIEM** viewed video footage of the final stages but elected not to proceed with an objection against the winner.
