**OSAKA** (D Johnson) – Stable representative T Pollard advised Stewards, OSAKA was seen by the chiropractor on Saturday 28 November which revealed no abnormalities. T Pollard further advised it is the stables intention to continue on with the gelding's current preparation.

**RUN FOR COVER** (M Cameron) – Co-trainer P Gerard advised Stewards the stable was satisfied with the post-race condition of RUN FOR COVER and will continue on with the colt's current preparation.

**PRINCESS ANI** (J Riddell) – Trainer M Breslin reported to Stewards, that on return to the stable PRINCESS ANI underwent blood tests which revealed some abnormalities. M Breslin further advised PRINCESS ANI will be given a few days of rest and will then continue on with the mare's preparation.

# Race 4 DUNSTAN FEEDS STAYERS CHAMPIONSHIP QUALIFIER 2100

**GONE WEST** (C Grylls) – Co-trainer D Browne reported to Stewards, the stable was satisfied with the post-race condition of GONE WEST and it is their intention to continue on with the gelding's current preparation.

**AUGUST EDITION** (E McCall) – Trainer P Locked advised Stewards, after the completion of the mare's run at Ellerslie AUGUST EDITION underwent an Endoscopic Examination which revealed some abnormalities. P Lock further advised the mare will now have a few days of rest. A further follow up will be completed by Stewards on Monday 7 November.

**SHOWBEEL** (T Harris) – Co-trainer A Forsman advised Stewards, the stable was satisfied with the post-race condition of SHOWBEEL, however, has now been sent for a spell.

# Race 7 EAGLE TECHNOLOGY STAKES (1600m)

**TIPTRONIC** (D Johnson) – Co-trainer G Richardson advised the stable was satisfied with the post-race condition of TIPTRONIC and it is their intentions to continue on with the gelding's current preparation.

#### Race 8 STELLA ARTOIS 1500 CHAMPIONSHIP QUALIFIER 1400

**EVEN CHANCE** (V Colgan) – Co-trainer R Wellwood advised the stable was satisfied with the post-race condition of EVEN CHANCE and it is their intention to continue on with the gelding's current preparation.

KEKE STAR (D Johnson) – Trainer J Richards advised Stewards KEKE STAR has now been sent for a spell.

**HIGHLAND DANCER** (W Pinn) – Co-trainer G Cooksley reported to Stewards, the lameness to the left hind leg of HIGHLAND DANCER has now subsided, however, the gelding will be rested for the remainder of the week.

# **RACE COMMENTS:**

#### Race 1 WEST END BOWLING CLUB MDN 2000

BEAR GRYLS (S McKay) - Began awkwardly and settled back then raced wide without cover throughout.

**EXOTIC PEARL** (M Cameron) - Commenced to over race for a short distance near the 1800 metres.

**WICKED ROMANCE** (R Elliot) - Had to be steadied when placed in restricted room passing the 1800 metres.

**OUR MATRIARCH** (L Allpress) - Inconvenienced passing the 1800 metres. Underwent a post-race veterinary examination which did not reveal any abnormality.

**F Lazet** (VORALTO) - Issued with a warning for allowing her mount to shift in passing the 1800 metres crowding OUR MATRIARCH on to WICKED ROMANCE which had to be steadied when placed in restricted room.

**BOLD BETTE** (S Collett) - When questioned regarding performance the rider advised that the filly was unsuited by today's track conditions.

**H Schofer** (REDGUM) - Permission was granted for H Schofer to ride REDGUM 1kg over her riding weight due to there being no other suitable apprentice rider available.

#### Race 2 REVITAL FERTILISER MDN 3YO 1100

JINGLE JANGLE (J Fawcett) - Slow to begin.

LOIS LANE (S Macnab) - Slow to begin after being fractious in its barrier stall.

**PHELAN THE POWER** (C Grylls) - Raced three wide without cover throughout. Dictated wider passing the 200 metres by MADAME MOET which shifted out.

**GURTLYN** (A Mudhoo) - Inconvenienced after improving into a run between MADAME MOET which shifted in and WATTABREEZE which shifted out passing the 100 metres.

**J Kamaruddin** (MADAME MOET)- Issued with a warning for allowing his mount to shift out when not sufficiently clear of PHELAN THE POWER passing the 200 metres.

**UNDER HER SPELL** (D Johnson) - When questioned regarding the performance of the filly the rider could offer no excuse.

**T Thornton** (SONGSUNGBLU) - Was spoken to with regard to her whip use in consecutive strides prior to the 100 metres.

Connections of 5<sup>th</sup> place GURTLYN viewed video footage alleging interference from the 4<sup>th</sup> placed MADAME MOET before electing not to proceed with a protest.

#### Race 3 ARABAC MDN 1200

PARISIAN POPPY (F Lazet) - Jumped away awkwardly.

POKURU GRACE (S Macnab) - Tightened and got back at the start.

FOUR QUEENS (M McNab) - Hampered shortly after the start, losing ground.

**RECALCITRANT** (D Johnson) - Over raced in the early and middle stages.

**THE HOTTIE** (S Collett) - Steadied when placed in restricting room passing the 400 metres.

**DROP THE BEAT** (L Hemi) - Commenced to over race in the early stages with the saddle shifting forward passing the 950 metres placing the rider at a disadvantage for the remainder of the race.

**BLACKEYED BAZ** (H Schofer) - Had difficulty obtaining clear running early in the final straight.

**PURE INCANTO** (L Allpress) - When questioned regarding performance the rider advised that the mare had felt indifferent in its action. Underwent a post-race veterinary examination which did not reveal any abnormality.

# Race 4 NULOOK ALUMINIUM 1200

COOGA MOON (S McKay) - Began awkwardly and got back after bumping with VINO BELLA

**VINO BELLA** (J Kamaruddin) - Bumped at the start.

**BARNEY RUBBLE** (S Collett) - Slow to begin. When questioned regarding performance the rider advised that in her opinion the gelding would be better suited to improved track conditions and a step up in distance.

**CELTIC WONDER** (J Fawcett) - Slow to begin. Held up briefly shortly approaching the 200 metres.

**DESERT MAGIC** (F Lazet) - Raced keenly in the middle stages.

**L Allpress** (LIQUID INSPIRATION) - Was reminded of her obligations in that she must ride her mounts out fully to the end of the race when circumstances permit her to do so.

#### Race 5 THE DEVON HOTEL 1600

**CHEEKY BEE** (R Elliot) - Slow to begin. Lost its near front plate during the running. When questioned regarding performance the rider advised the gelding would benefit from improved track conditions.

**NOGOLF ETIKIT** (S Collett) - Began awkwardly then crowded shortly after losing ground.

**SKY HI RAHTWO** (F Lazet) - Slow to begin. Underwent a post-race veterinary examination which found the mare to have suffered a flexor tendon injury in the left foreleg. Connections were advised that a veterinary clearance would be required prior to racing next. Connections advised Stewards that they would be retiring the mare.

**TORQUE TIME** (H Schofer) - Raced keenly in the middle stages.

# Race 6 LANDMARK HOMES MDN 1600

**BELLES BIG BOY** (T Thornton) - Slow to begin. When questioned regarding performance the rider advised that the gelding had held its breath during the running and failed to run on when placed under pressure.

WICKLOW (H Schofer) - Slow to begin. Held up until shifting out passing the 250 metres to obtain clear running.

**MARTINA ROSE** (C Grylls) - Inconvenienced passing the 250 metres when WICKLOW (H Schofer) shifted out when not clear. H Schofer was advised to exercise care.

**FIVE SCHILLINGS** (D Johnson) - Returned to the enclosure with blood present in both nostrils. Underwent a post-race veterinary examination which confirmed the mare to have bled. Connections were advised FIVE SHILLINGS would now be subject to the mandatory two months stand down from training, 3 months stand down from racing with a veterinary clearance being required prior to racing or trialing next.

#### Race 7 NEW PLYMOUTH AUTO ELECTRICAL 1800

**REGAL ROCK** (S Collett) - Began awkwardly losing ground. When questioned regarding performance the rider advised that the mare had been unsuited by today's track conditions.

**ROC YA SOX** (D Johnson) - Tightened at the start and got back.

**SAIGON HOT NIGHT** (S Macnab) - Had to be steadled for some distance when improving on to the heels of CALPURNIA leaving the straight on the first occasion.

#### Race 8 STELLA ARTOIS MDN 1400

**LORD SPENCER** (S McKay) - Began awkwardly losing ground. Raced greenly when placed under pressure in the final straight.

**MONTY** (J Fawcett) - Hampered shortly after the start. Commenced to over race passing the 1200 metres then continued to do so through the middle stages. Shifted out abruptly despite the efforts of it's rider passing the 50 metres hampering BARRACUDA and IRISH HEART.

MIROCA HEIGHTS (A Mudhoo) - Crowded shortly after the start having to be steadied.

**IRISH HEART** (L Hemi) - Crowded shortly after the start having to be steadied. Hampered passing the 50 metres.

BARRACUDA (T Thornton) - Raced keenly in the middle stages. Hampered passing the 50 metres.

**NUN HISSING** (S Macnab) - Briefly held up entering the final straight.

# Race 9 MYERS FAMILY APPRECIATION MDN 1400

VINCENZO LORENZO (S McKay) - Slow to begin.

UMUTAHI LAD (S O'Malley) - Slow to begin.

**IRONIC** (M Cameron) - When questioned regarding performance the rider advised that the mare had raced greenly throughout. Underwent a post-race veterinary examination which did not reveal any abnormality.
