**AILEEN GRACE** - A post race endoscopy examination found the mare to have blood and mucus present in the trachea.

**COMBAT QUEEN** - Received veterinary treatment post race as the mare was suffering from post-race distress.

**S McKee** - Issued with a warning after presenting MAKE TIME with incorrect gear.

**LAVAGLO** (S McKay) - Jumped away very awkwardly shifting inwards abruptly crowding ROYAL PRINCE onto AMANO, with ROYAL PRINCE losing ground. Had to be steadied off heels going into the bend near the 850 metres and shifted outwards then racing three wide without cover.

**ROYAL PRINCE** (D Danis) - Hampered start losing ground. Shifted outwards across heels to obtain clear running near the 300 metres.

**AMANO** (M Hashizume) - Hampered start.

**TEARS OF JUPITER** (D Johnson) - Jumped away awkwardly hampering OHCEEDEE.

**ALL THE RAGE** (R Beemud) - Jumped away awkwardly.

**OHCEEDEE** (R Elliot) - Hampered start. When questioned regarding performance, rider advised that after being hampered at the start the gelding switched off feeling disinterested. A post race veterinary inspection including an endoscopic examination revealed OHCEEDEE to have bled with the mandatory stand down periods applicable.

**SCAGLIONI** (A Calder) - After coughing post race underwent an endoscopic examination which revealed a small amount of blood in the trachea.

**WOLFGANG** (S McKay) - Lay in under pressure in the straight having to be straightened by its rider on several occasions.

**FOXRAMBLA** (L Satherley) - Came under pressure near the 800 metres and failed to respond quickly becoming tailed off not being persevered with in the final straight. When questioned rider advised that the filly had felt indifferent in its action. A post race veterinary inspection revealed 1/5 fore limb lameness. Connections advised that the filly would now be spelled.

**KLAASEN** (S Collett) - Jumped away awkwardly shifting outwards hampering ILLUMINATION. Raced ungenerously in the early and middle stages then ran off rounding the bend near the 700 metres hampering SWEY MY WAY which was forced over considerable extra ground. KLAASEN continued to race very ungenerously running to the outside fence taking no further part in the race. Trainer R Patterson was advised that the gelding is now required to trial satisfactorily prior to racing again.

**ILLUMINATION** (D Johnson) - Hampered start. Raced ungenerously when being steadied approaching the bend near the 850 metres then making the turn awkwardly.

**CANTSAYTOOMUCH** (M Hashizume) - Ducked outwards near the 900 metres hampering PLAY THAT SONG. After being corrected CANTSAYTOOMUCH made contact with the running rail near the 850 metres.

**PLAY THAT SONG** (L Innes) - Hampered near the 900 metres. Rider reported that the filly had hung outwards throughout.

**SWEY MY WAY** (L Satherley) - Hampered rounding the bend near the 700 metres being forced over considerable extra ground.

**LILIKOI** (D Johnson) - Slow to begin.

**BURGUNDY ROSE** (J Kamaruddin) - Blundered on jumping.

**CASTANI** (M McNab) - Raced wide without cover throughout. Hampered near the 100 metres when CALL ME EVIE (J Fawcett) shifted outwards under pressure. J Fawcett was advised to exercise greater care.

**J Kamaruddin** - Spoken to regarding his whip use prior to the 100 metres.

**Race 5** | **J SWAP SPRINT (1400 metres)**

**P McKay** - Issued with a warning after presenting THE MITIGATOR with incorrect gear.

**MASCARPONE** (R Elliot) - Permission was granted for R Elliot to ride 1kg over. When questioned rider advised that he had ended up further forward than intended and was of the opinion that the gelding is better suited when ridden with cover.

**THE MITIGATOR** (S McKay) - Had to be steadied away from the heels of DAWN PATROL shortly after the start. When questioned regarding performance, rider advised that after being a little tardy out of the barriers the gelding had been unable to get to its normal position of leading, and had then raced a little dour. A post race veterinary examination did not reveal any abnormality.

**DAWN PATROL** (J Riddell) - Inclined to over race in the early to middle stages. When questioned regarding performance, rider was unable to offer any excuse but was of the opinion that the gelding may be feeling the effects of recent racing.

**VIGOR WINNER** (M Cameron) - Held up early in the final straight having to steady and shift ground to obtain clear running passing the 300 metres.

**JULIUS** (A Calder) - When questioned regarding performance, rider advised that the gelding had felt a little reluctant racing amongst horses, and in his opinion may be better suited racing in the open.

**Race 6** | **WENTWOOD GRANGE PREMIER (1400 metres)**

**CINZENTO** (M Hashizume) - Blundered leaving the barriers. Had to be restrained when over racing passing the 1200 metres with the saddle then shifting forward placing its rider in difficulty for the remainder of the race making contact with the running rail near the 900 metres when improving inside the heels of PARISIAN.

**MAI TAI** (O Bosson) - Jumped away awkwardly shifting inwards hampering KING FAROUK. Held up early in the straight before obtaining clear running near the 250 metres.

**KING FAROUK** (J Riddell) - Hampered start. Steadied when improving onto heels going into the bend near the 850 metres

**MEDALZA** (S Collett) - Raced three wide without cover.

**SON OF BIELSKI** (T Harris) - Held up entering the final straight having to shift outwards to obtain clear running.

**Race 7** | **SKYCITY HAMILTON WAIKATO CUP (2400 metres)**

**BLUE BREEZE** (C Dell) - Permission was granted for C Dell to ride 1kg over.

**SHERRIF** (L Innes) - Slow to begin. Made contact with SAVY YONG BLONK when attempting to shift outwards to avoid the heels of MASETTO near the 1200 metres then having to be steadied. Lay in early in the final straight coming together with MASETTO near the 350 metres.

**JUSTAMAIZ** (A Calder) - Slow away.

**REDCAYENNE** (J Kamaruddin) - Had to be firmly restrained when improving onto heels passing the 1200 metres.

**GRAND BOUQUET** (S McKay) - Jumped away awkwardly.

**OCEAN BILLY** (C Jones) - Raced wide without cover until the 1000 metres then improved forward to lead.

**VEE CECE** (L Satherley) - Steadied when placed in restricted room near the 400 metres.

**MASETTO** (V Colgan) - Made contact with SHERRIF near the 350 metres.

**YATIMA** (T Yanagida) - Had some difficulty obtaining clear running in the straight having to shift ground on a number of occasions.

**SINARAHMA** (O Bosson) - Slow to begin.

**LE CASTILE** (S Collett) - Raced wide without cover throughout.

**BAD 'N' BOUJ** (S McKay) - Raced three wide without cover. When weakening had to be steadied when becoming awkwardly placed near the heels of MOHAKA after being taken out by FISCAL FANTASY which when improving into a tight run was dictated outwards by LE CASTILE.

**FISCAL FANTASY** (L Innes) - Had difficulty obtaining clear running until passing the 150 metres.

**CRAFTY JESS** (M Cameron) - Held up in the straight until passing the 200 metres.

**SHOWOROSSES** (V Colgan) - Lay out under pressure over the final 200 metres.

**PINMEDOWN** (T Yanagida) -When questioned regarding performance, rider was unable to offer any excuse. A post race veterinary inspection found he mare to have suffered from cardiac arrhythmia with the appropriate veterinary clearance now required prior to racing again.

**ROYAL CHARM** (C Ormsby) - Jumped away awkwardly making contact with DEEP BEAUTY.

**DEEP BEAUTY** (V Colgan) - Contacted start.

**HOYT AXTON** (R Beemud) - When over racing near the 900 metres, had to steady off the heels of DEEP BEAUTY shifting outwards abruptly making the bend near the 800 metres awkwardly. Was eased down in the final straight when well beaten. After speaking with rider R Beemud, trainer P Coutts was advised that the gelding is now required to trial satisfactorily prior to racing again.

**RUSAVY** (M Hashizume) - Raced ungenerously for a distance when being steadied near the 900 metres.

**O'SUSANA** (L Innes) - Raced wide without cover.

**EVER SO CLEVER** (D Johnson) - Had difficulty obtaining clear running when racing in restricted room for the majority of the final straight, then further crowded when IFFIE SHOWS lay in approaching the 100 metres.

**ZENKURO** (R Elliot) - Disappointed for a run passing the 150 metres having to be steadied.

**IFFIE SHOWS** (O Bosson) - Lay in under pressure in the straight then being steadied by its rider over the concluding stages who advised that the gelding had gone off stride and felt indifferent in its action over the final stages but had then felt normal on pulling up. A post race veterinary inspection did not reveal any obvious abnormality.
