### GENERAL:

H Schofer was examined and cleared to ride by paramedics after standing down from her remaining engagements the previous day at Awapuni on 26.12.20.

## SUPPLEMENTARY:

#### Race 2 ASURE SADDLE & SULKY MOTOR LODGE MDN (1200 Metres)

**H Schofer** was unable to make the carded weight for DARCI LA BELLA being in excess of 1kg over. Connections opted to and were given permission to scratch the filly under Rule 534(2)(a). H Schofer was fined the sum of \$200 under the Minor Infringement Rule.

AUNTY CONDOR S Collett – Slow away.

**KEEN TO RUN** W Pinn – Shifted out at the start hampering OWEN MOORE.

**KOOL POWER** S McKay – Raced keenly in the early and middle stages and shifted out making the first bend forcing POROTENE CRUZA over extra ground.

**POROTENE CRUZA** S Macnab – Forced over extra ground at first bend. Hampered approaching home turn.

**SHAMPAGNE EXPRESS** C Grylls – Made the final corner awkwardly when hanging out and when being corrected shifted inwards across the heels of KEEN TO RUN and had to be steadied.

**WATTABREEZE** A Goindasamy – Raced in restricted room near the 150 metres; had to be steadied near the finish when a run narrowed between MELODY ROXX which shifted out simultaneously as KEEN TO RUN shifted in.

**HONEY HONEY** M McNab – Held up for a short distance approaching the home turn and when being angled out hampered POROTENE CRUZA. M McNab was advised to exercise greater care when shifting ground.

**W Pinn** – Dislodged from KEEN TO RUN on returning to the enclosure. Paramedics cleared W Pinn to fulfil his remaining engagements.

## Race 3 PETER SOLE TRANSPORT 1200 (1200 Metres)

**BEVAN STREET** M McNab – Slow to begin. Held up round the turn and early part of the home straight.

**GERDA** A Goindasamy – Slow to begin.

**CELTIC WONDER** B Ansell – Slow to begin. Raced three wide without cover from the 800 metres.

**GLITTERING ARMOUR** T Newman – Commenced to over race in the early and middle stages. Was held up passing the 200 metres and was momentarily hampered when PALM SPRINGS shifted out near the finish.

**PALM SPRINGS** C Grylls – Shifted out near the finish.

**EUKA LADY** L Allpress – Shifted out under pressure and bumped with MAISON ROXANNE near the 100 metres. L Allpress was shown footage of her ride and advised that she is expected to straighten her mount sooner than she did on this occasion.

#### Race 4 THE KIWI BUTCHER MDN (1400 Metres)

**BENTAYGA** – Galloped some distance in the preliminary prior to the rider being able to pull the gelding up. Bentayga underwent a veterinary examination and after consultation with rider M McNab was cleared to run.

**SKYROCA** L Hemi – Began awkwardly losing ground. Over raced when being steadied off heels passing the 1100 metres.

ALHAMBRA LAD H Schofer – Began awkwardly and was slow away.

**CAPITAL EXPENSE** W Pinn – Raced greenly at the junction and on to the course proper near the 1300 metres and shifted in abruptly checking TOBIAS which had to take evasive action. TOBIAS then commenced to over race. Had to be angled out near the 250 metres when held up behind BENTAYGA.

**TOBIAS** C Grylls – Checked near the 1300 metres and then over raced.

**SWEET TUI** S McKay – Commenced to over race in early stages when being restrained.

**POWER OF THE KITTY** L Allpress – Raced three wide without cover from the 800 metres. When questioned regarding performance rider advised that the filly had felt indifferent in its action. Underwent a post race veterinary examination which revealed lameness to the right foreleg. Connections were advised that a veterinary clearance will be required prior to trialing or racing next.

## Race 5 24/7 SECURITY SOLUTIONS LTD 1400 (1400 Metres)

**BANGLES** J Fawcett – Shifted in abruptly on jumping away tightening HOT SPRING PROJECT and SHE'S A RIPPER.

**HOT SPRING PROJECT** M McNab – Tightened at the start.

**SHE'S A RIPPER** B Ansell – Tightened at the start.

**COOGA MOON** H Schofer– Restrained and got back from its wide draw.

**PREAKNESS** A Goindasamy – Was inclined to race greenly and shifted out passing the 200 metres having to be straightened and shifted out again inside the final 100 metres prior to being straightened.

Race 6A+ DRIVEWAYS MDN 1600 (1600 Metres)VINCENZO LORENZO S McKay – Began awkwardly.

**TAKE A GAMBLE** R Elliot – Dictated wide entering the back straight when INDY FOX made the bend awkwardly. Checked home turn.

**SHOCKING BILL** S Collett – Raced wide without cover throughout.

**CISJURANE** B Ansell – Hung outwards rounding the home turn and near the 600 metres shifted into the line of INDY FOX which was forced outward and bumped with TAKE A GAMBLE.

CISJURANE continued to hang outwards for some distance and near the 300 metres hung outwards dictating CAPITAL GAINS out dictating INDY FOX into the line of TAKE A GAMBLE which was checked. After questioning riders the movement was considered beyond the control of apprentice B Ansell.

When questioned R Elliot advised that he thought there may be something amiss with TAKE A GAMBLE and did not persevere with the gelding. A subsequent veterinary inspection did not reveal abnormality.

**INDY FOX** H Schofer – Forced wide early part of the home straight and bumped TAKE A GAMBLE.

**CAPITAL GAINS** S Macnab – Dictated outwards on the home turn.

**PRINCE OF DOOM** – Held up in the early part of the home straight.

#### Race 7 STELLA ARTOIS 1800 (1800 Metres)

**ROYAL PATCH** W Pinn – Began awkwardly.

**BEAUDZ WELL** S Collett – Tightened at the start when ATA RANGI jumped inwards abruptly.

**OUR HAIL MARY** H Schofer – Shifted in going into the first bend tightening ATA RANGI inwards on to ROYAL PATCH. H Schofer was advised to exercise greater care. Three wide early so was taken forward to sit outside the leader entering the back straight.

ATA RANGI J Fawcett – Tightened first bend. J Fawcett was spoken to with regard her whip action

**NUDGE BAR** J Parkes – When questioned into the run rider J Parkes stated the gelding was obliged to improve wide rounding the home turn but did little in the home straight. J Parkes was of the opinion the gelding may be better suited to more rain affected going.

## Race 8 CHANCE TO WIN A FORD PUMA D 2000 (2000 Metres)

NOGOLF ETIKIT J Parkes – Began awkwardly and was slow away.

**WEE DRAM** J Fawcett – Was slow away. Shifted out on the home turn when not fully clear of UNACCEPTABLE which was hampered J Fawcett was shown footage of her ride and issued with a warning under Rule 638(1)(d).

**NOD** S Collett – Raced keenly in the early stages.

**TRUTH BEKNOWN** W Pinn – When questioned W Pinn reported that his mount was feeling the firm nature of the going and in his opinion is better suited to a more rain affected surface.
