RACE COMMENTS:

Race 1	PUKEMANU BAR & EATERY R65 1000 (1000 Metres)
This race was delayed approximately 35 seconds due to the late arrival of the ambulance to the start.	
MISS SWEET PEE (S Macnab) – Hung rounding the turn.	
RAINBOW DUNDEE (D Hirini) - Hung throughout placing the rider at a disadvantage and could not be ridden out fully in the home straight. Connections were advised a warning has been placed against the gelding's racing manners.	

Race 2	JACKSON ST BAR WYO MAIDEN 1000 (1000 Metres)
<p>TUI ROCKS (R Aukett) – Shifted out at the start hampering TITLED, which got back.</p> <p>TITLED (J Riddell) - Hampered start and lost ground. Steadied for a short distance when improving on to heels near the 400 metres and when being angled out, dictated MELANIA over extra ground. When questioned, J Riddell advised the opportunity for him to improve became available when MELANIA rolled out near the home turn and his mount, which was racing greenly, shifted out further than intended. Nevertheless, J Riddell was advised to exercise greater care when shifting ground.</p> <p>MELANIA (D Hirini) – Hung outwards approaching the home turn.</p> <p>Track upgraded to Good (3) following Race 2.</p>	
Race 3	COTTER & STEVENS MAIDEN 1000 (1000 Metres)
<p>MOHEGAN STAR (R Aukett) – Slow away.</p> <p>TUDOR QUEEN (F Lazet) - Steadied when improving on to the heels of GEE STRING near the 600 metre mark.</p> <p>UBER ROCA (J Parkes) – Finished well back. When questioned, J Parkes had no excuse.</p> <p>LADY WOBURN (L Allpress) – When questioned L Allpress advised the filly pulled up in a normal post-race condition and had no excuse.</p> <p>K Herccock (GEE STRING) – Admitted a breach of Rule 638(3)(b)(ii) and was fined the sum of \$350 in that she used her whip excessively prior to the 100 metres.</p>	
Race 4	KIRIPUNI ICE SUPPLIES MAIDEN 2050 (2050 Metres)
<p>LINCOLN LANE (J Riddell) – Got back from its wide draw.</p> <p>LINCOLN LANE (J Riddell) and WHITE SOX (D Bradley) - Bumped when both runners shifted ground simultaneously near the 100 metres.</p> <p>MAYONAKA (J Parkes) – When questioned into the run of MAYONAKA, J Parkes was of the opinion the gelding may be better suited to more rain affected going.</p>	
Race 5	ROSIES FURNITURE REMOVALS MAIDEN 1400 (1400 Metres)
<p>FAMILY TIME (D Bradley) – Stood in its gate and was slow away.</p> <p>GAELIC SPIRIT (L Hemi) - Made the first bend awkwardly.</p> <p>LOCARNO (L Allpress) – Finished well back. When questioned L Allpress was of the opinion the gelding may be better suited to more rain affected going. A post-race veterinary examination revealed the gelding to be 1/5 lame in the left hind leg. Connections were advised that LOCARNO requires a veterinary clearance prior to racing next.</p> <p>S O'Malley (RETZENA) - Reminded of his obligation to ride his mount out fully to the finish when circumstances permit.</p>	
Race 6	PIONEER FINANCE R65 1600 (1600 Metres)
<p>LINCOLN DREAMER – Late scratched at 11.32am on veterinary advice after suffering an injury en route to the course.</p> <p>POWER 'N' PASSION (D Bradley) – D Bradley was advised to exercise greater care after his mount jostled with</p>	

MASSIFF PRINCESS and BRUNO MAGILE near the 200 metres when attempting a narrow run. Stewards took into account outward movement from MASSIFF PRINCESS when assessing the interference.

S O'Malley (JACKAROO) – spoken to regarding the use of the whip prior to the 100 metres – above shoulder height.
