#### RACE COMMENTS:

## Race 1 MATAMATA FUNCTION CENTRE 2000

AMAZING MARIA (S Collett) - Crowded at the start, then blundered.

**BELLA NOCHE** (S Spratt) - Slow to begin losing ground.

SPIRIT OF GOLD (D Johnson) - Began awkwardly.

**HAIL DAMAGE** (T Yanagida) - Held up rounding the bend then had to be firmly restrained passing the 250 metres after improving onto heels.

WHANGA WONDER (S Weatherley) - Had difficulty obtaining clear running early in the final straight.

**CAMPING** (K Asano) - Steadied when placed in restricted room passing the 250 metres.

**VENI VICI** (W Pinn) - Travelled three wide without cover before improving forward to sit outside the leader near the 900 metres.

**MORNING STORM** (C Grylls) - Briefly steadied when placed in restricted room to the outside of WHANGA WONDER which shifted out to obtain clear running passing the 250 metres. S Weatherley was advised to exercise care.

**LOUIS LE GRAND** (L Satherley) - Rider reported that the gelding had felt indifferent in its action. Underwent a postrace veterinary examination which revealed the gelding to be lame in the right fore leg. Connections were advised that a veterinary clearance would be required prior to racing next.

# Race 2 GREGORY EQUINE 1200

**JAMIESONS TIPPLE** (C Grylls) - Became fractious in the barrier and underwent a pre-race veterinary inspection being late scratched. Rider C Grylls was examined by St John's Ambulance personnel and stood down from his rides for the remainder of the day. Connections were advised that the gelding would be required to barrier trial prior to racing next.

**SHE'S A MANEATER** (M McNab) - Crowded shortly after the start losing ground when runners to either side shifted ground.

**INTELLIGENT PATCH** (K Asano) - Commenced to over-race in the early to middle stages when being restrained.

**SILVERDALE CHIEF** (L Satherley) - Raced keenly in the early and middle stages.

**SNAKEYE** (C Dell) - Raced keenly in the early and middle stages.

**M McNab** (SHE'S A MANEATER) - Was reminded of his obligations in that he must ride his mounts out fully to the end of the race when circumstances permit him to do so.

#### Race 3 NZB INSURANCE PEARL SERIES RACE (1200 m)

TREE OF LIFE (M McNab) - Underwent a post-race veterinary examination which failed to reveal any abnormality.

**NOVERRE** (S Collett) - Began awkwardly.

**POLLY PLUM** (D Johnson) - Began awkwardly then crowded losing ground.

**AUBREE** (S Collett) - Crowded at the start losing ground.

**BONNY LASS** (L Satherley) - Began awkwardly.

**DRAGON BISCUIT** (T Yanagida) - Slow to begin. Raced wide without cover throughout.

PEARLS A SINGER (J Fillmore) - Over-raced in the middle stages having to shift out passing the 1000 metres.

## Race 4 THE BOLTHOLDER 1200

QIJI SWORDSMAN (S Collett) - Slow to begin losing ground.

**VALETTI** (S McKay) - Commenced to over-race in the early and middle stages when being restrained. When questioned regarding the performance Rider S McKay advised that after racing keenly in the early and middle stages the gelding had failed to finish the race off.

MANNIE'S POWER (M Hashizume) - Raced three wide without cover throughout.

**ERIDANI** (D Johnson) - Was unable to obtain clear running inside the final 100 metres. Underwent a post-race veterinary examination which failed to reveal any obvious abnormalities.

## Race 5 WAIKATO PRINTING COMPANY 1400

**AMERICO** (S McKay) - Pulled up shortly after jumping away. Was attended to immediately by the on course veterinarian and was found to have a compound fracture of the right hind tibia, and was subsequently euthanised.

**BAHIA EMERALD** (K Asano) - Crowded at the start losing ground.

**PLEASE TELL ROSIE** (J Fawcett) - Began awkwardly then hampered losing ground. Raced ungenerously through the early and middle stages.

**SLEEPYGIRL** (S Spratt) - Began awkwardly losing ground.

AZAFRAN (T Newman) - Blundered at the start.

LET'S DO THIS (T Thornton) - Raced three wide without cover throughout.

**FEELIN' FANCY** (D Johnson) - Held up entering the final straight having to shift inwards passing the 250 metres to obtain clear running.

**S Weatherley** (BEA A ROCA) - Issued with a warning for his whip use prior to the 100 metres.

# Race 6 THE MEAT CO, ROBOW'S, TWO TONES 1400

MISS ONAKI (M McNab) - Slow to begin.

**AMABO** (S McKay) - Began awkwardly losing ground. Briefly steadied passing the 250 metres when placed in restricted room.

NOTHINBRAXLYKAHART (R Beemud) - Began awkwardly losing ground.

## Race 7 J SWAP CONTRACTORS LTD 1600

The start of Race 7 was delayed due to DUNTAYAR requiring farrier attention.

**DUNTAYAR** (J Riddell) - Began awkwardly. Held up until passing the 200 metres.

**JUSTWONPRINCESS** (T Thornton) - Crowded shortly after the start losing ground. Crowded having to be steadied passing the 300 metres.

**DIAMOND DELIGHT** (S Collett) - Slow to begin losing ground. Held up entering the final straight.

LAUNCH PAD (S Weatherley) - Began awkwardly losing ground.

ALL NIGHT LONG (T Newman) - Hampered shortly after the start when DUNTAYAR shifted out.

SPEED OF LIGHT (D Johnson) - Began awkwardly losing ground.

AMA LA VITA (K Asano) - Had difficulty obtaining clear running early in the final straight.

WASP (E McCall) - Lost left front plate during the running.

L Satherley (ROCK MY HEART) - Was spoken to regarding her whip use prior to the 100 metres.

**S Spratt** (PEARL HART) - Issued with a warning for allowing her mount to shift out when not sufficiently clear of JUSTWONPRINCESS which was crowded and steadied passing the 300 metres.

# Race 8 NEW WORLD MATAMATA 1600

**LIGHT SHOW** (S McKay) - Dislodged rider on the way to the barriers. Underwent a pre-race veterinary examination and was subsequently late scratched.

**PANDEMIC** (T Harris) - Slow to begin losing ground. Held up entering the final straight. Shifted out passing the 300 metres making contact with AQUAOIR.

**INCY WINCY SPIDER** (T Yanagida) - Slow to begin. Had difficulty obtaining clear running for the majority of the final straight.

MILLIE GEORGIA (K Asano) - Began awkwardly. Raced three wide without cover throughout.

**AQUAOIR** (S Collett) - Slow to begin. Contacted passing the 300 metres.

**RUSALKA** (E McCall) - Over-raced in the early and middle stages when being restrained. Lay in when placed under pressure in the final straight.

**BUBALINA** (S Weatherley) - Held up until passing the 150 metres.

#### Race 9 PAPER PLUS MATAMATA 1600

ATA RANGI (J Riddell) - Began awkwardly. Did not obtain clear running throughout the final straight.

**ALEXANDRITE** (E McCall) - Crowded at the start losing ground. Did not obtain clear running throughout the final straight.

**QUALITY PREVAILS** (J Fawcett) - Began awkwardly.

**AVOCA WILLOW** (T Yanagida) - Slow to begin losing ground. Underwent a post-race veterinary examination including an endoscopic examination which revealed blood in the trachea.

ARLINGTON GOLD (M McNab) - Began awkwardly.

**VIRTUOSO LAD** (A Goindasamy) - Slow to begin losing ground. Raced keenly in the early and middle stages.

**SCOTTISH STAR** (S McKay) - Began awkwardly.

**LUCKY SHARK** (T Harris) - Commenced to over-race passing the 1000 metres having to shift out to avoid heels and was then obliged to race wide without cover for the remainder of the race.

**CASTLEPOINT** (W Pinn) - Underwent a post-race veterinary examination which revealed the gelding to be showing signs of heat stroke.

T Harris (LUCKY SHARK) - Was spoken to regarding his whip use prior to the 100 metres.

#### Race 10 FAIRVIEW MOTORS MATAMATA 2000

PATSYS LASS (S Spratt) - Slow to begin. Unable to obtain clear running over the final 200 metres.

**ZOULUMINOUS** (D Johnson) - Crowded shortly after the start when CALPURNIA shifted out. Improved onto the heels of DAWN JESSIE passing the 100 metres having to be steadied.

**OSAKA** (M McNab) - Crowded shortly after the start losing ground. Steadied when placed in restricted room near the 1700 metres.

**T Newman** (PEERLESS WARRIOR) - Issued with a warning for allowing her mount to shift in when not sufficiently clear of OSAKA which had to be steadied when placed in restricted room passing the 1700 metres.

**BRUEGEL** (M Hashizume) - Raced wide without cover throughout.

**SINGLE MOMENT** (L Satherley) - Underwent a post-race veterinary examination which revealed a wound to the left hind lateral cannon which required attention.

**EVER SO CLEVER** (A Goindasamy) - Held up for the majority of the final straight.

**NOWANAGEN** (R Elliot) - Had difficulty obtaining clear running until passing the 200 metres.

**CALPURNIA** (T Thornton) - Steadied when placed in restricted room over the concluding stages.

#### Race 11 MATAMATA BREEDERS' STAKES - 27 FEBRUARY (2000 m)

**JOJAKK** (M Hashizume) - Underwent a pre-race veterinary examination after becoming fractious in its barrier stall and was declared a late scratching. Connections were advised the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

**CASH ME OUSSIDE** (W Pinn) - Was removed from the barrier after being contacted by the fractious JOJAKK and underwent a pre-race veterinary examination being declared a late scratching.

PEECEE PUSSYCAT (M McNab) - Slow to begin.

**SAVEZAR** (R Elliot) - Slow to begin. Had to be steadied after improving into a marginal run to the outside of MAKTASTIC (S Spratt) which shifted out and away from ABSCONDED (K Asano) which had lay out under pressure approaching the 100 metres. Also contributing was slight inward movement from CERYS. Both S Spratt and K Asano were advised to exercise care in similar circumstances.

**CERYS** (T Yanagida) - Slow to begin. Had difficulty obtaining clear running until passing the 150 metres.

**MAKTASTIC** (S Spratt) - Placed in restricted room for a distance approaching the 100 metres then improved onto heels over the concluding stages having to be steadied.

**ABSCONDED** (K Asano) - Lay out when placed under pressure in the final straight.

**POLAR NIGHT** (S Collett) - Steadied when placed in restricted room over the concluding stages to the inside of BEAUTIFULNIGHTMARE which lay in, and ABSCONDED which lay out.

MISS FENDT (T Thornton) - Held up for a distance passing the 300 metres.
