#### **RACE COMMENTS:**

Race 1	HOBO'S 90 NOT OUT 1800M	
CAST IN BRONZE (A Goindasamy) – Crowded shortly after leaving the barrier and steadied.		
MY HUGO (S M	Nab) – Began awkwardly then steadied.	
<b>FREE SPIRIT</b> (I Allpress) – Raced wide without cover until near the 1000 metres when improving forward to lead		

**THOMAS AQUINA**S (S O'Malley) – Raced ungenerously passing the 1000 metres when the pace eased.

**COOGA MOON** (F Lazet) – Hampered passing the 600 metres when awkwardly placed near heels after being dictated outwards slightly by GERDA (H Schofer). Apprentice H Schofer was advised to exercise greater care when in similar circumstances.

**ZENKURO** (M McNab) – When questioned into the run M McNab advised he was held up for some distance passing the 600 metres but when in clear running ZENKURA failed to run on and was disappointing.

**SACRED COMMAND** (R Elliott) – When questioned regarding performance R Elliott advised that the gelding had hung throughout. A post race veterinary examination did not reveal any abnormality.

Race 2PUNTING COMP CLOSES 4PMBANGLES (T Thornton) – Slow to begin after being fractious in its barrier.

**CIVILISED** (T Yanagida) – Began awkwardly then crowded.

MONLULU (D Johnson) – Lay out across heels near the 1500 metres.

**ALHAMBRA LAD** (L Allpress) – Raced wide without cover for majority of the race. Underwent a post race veterinary examination which was clear.

**GALWAY BRO** (S O'Malley) – When questioned regarding performance S O'Malley advised that he considered something may have been amiss with the gelding. A post race veterinary examination did not reveal any abnormality.

Race 3 THRIFTY CAR RENTALS 1400M

**ARRAIGNMENT** (J Parkes) – Underwent a veterinary examination after becoming fractious in its barrier and was cleared fit to start.

**STREAK OF POWER** (L Allpress) – Began awkwardly and crowded then ridden urgently to recover.

**SCOTCH** (M McNab) – Began awkwardly then hampered and steadied. Held up for some distance from near the 500 metres and had to change ground outwards to improve near the 250 metres when denied a run to the inside of BRAAVOS.

**REGAL REWARD** (S McKay) – Raced wide without cover for the majority of the race.

**BRAAVOS** (H Schofer) – Had to be steadied for a short distance when improving into a marginal run to the inside of NUBIAN SMILE which lay in approaching the 200 metres. After questioning riders, D Johnson was issued with a warning under Rule 638(1)(d) and advised that she is expected to straighten her mount sooner than she did on this occasion. Stewards took into account the tendency of NUBIAN SMILE to lay inwards when assessing the interference.

NUBIAN SMILE (D Johnson) – Lay in approaching the 200 metres.

#### Race 4 ENERGY VETS TARANAKI 3YO 1300M

GURTLYN (T Taiaroa) – Underwent a veterinary examination in the tie-up stalls and was passed fit to race.

**TOBIAS** (J Parkes) – Slow to begin.

**WINKLE BAY** (S Collett) – Slow to begin. Was steadied for a distance passing the 700 metres when improving on to heels. Shifted in and away from TOBIAS and bumped with JUST BEN in the home straight.

**JUST BEN** (S McKay) – Began awkwardly shifting out, contacting with SACRED PALACE and when being corrected by its rider was steadied and lost ground.

GOLD EAGLE (L Satherley) – Raced keenly when leading.

**SACRED PALACE** (D Johnson) – When questioned into the disappointing run, D Johnson had no particular excuse but added the gelding lacked concentration and she was of the opinion may be suited to racing in blinkers.

Race 5WOBURN FARM 2YO CLASSICMADAM SASS (C Grylls) – Began awkwardly losing ground.

**JUST BOB** (J PARKES) – Slow to begin.

**MARTINA DIVA** (T Thornton) – Steadied when crowded 1100 metres by QUATTRO QUINTA which lay in and away from WOLFGANG. Contributing was outward movement from IMA ROCA BEE which commenced to lay out when being restrained. T Thornton dropped her whip near the 600 metres.

WOLFGANG (S McKay) – Raced wide without cover for the majority of the race. Dictated wide 300 metres.

**IMA ROCA BEE** (E McCall) – Commenced to hang out in the early stages when being restrained making the bend awkwardly near the 800 metres and then running wide entering the final straight, dictating QUATTRO QUINTA and WOLFGANG wider on the track near the 300 metres.

QUATTRO QUINTA (O Bosson) – Dictated wide 300 metres.

**O Bosson** (QUATTRO QUINTA) – Admitted a breach under Rule 648(5) in that he weighed in 0.8kgs heavier than when he weighed out. O Bosson was fined the sum of \$1000.

#### Race 6 PLATINUM HOMES SC MDN

**GINGER SNAPZ** (S McKay) – Began awkwardly and got back. Raced greenly and hung into and around the home turn losing considerable ground. Connections were advised a warning is placed against the filly.

**DARCI LA BELLA** (D Johnson) – Stood flat footed in its gate and lost ground prior to being ridden urgently forward to gain a trailing position.

**LILHOOVESGOTMOVES** (S Collett) – Got back from its wide draw.

KEEN TO RUN (M McNab) – Lay inwards near the 1000 metres hampering MAKADOON.

# Race 7 FASTTRACK INSURANCE OAKS PRELUDE 1800 M

The race was delayed 4 minutes when SONGSUNGBLU'S bridle needed to be reconfigured.

LOVETTORLEAVEIT (B May) – Crowded leaving the barriers. Held up for some distance near the 400 metres.

**CAROLINA REAPER** (S Collett) – Crowded leaving the barriers.

**SUMI** (D Johnson) – Crowded leaving the barriers, then raced ungenerously when being restrained to obtain cover near the 1600 metres, with SUMI continuing to race ungenerously before shifting outwards off heels and racing wide without cover for the remainder of the race. When questioned D Johnson advised the filly had little left at the finish after over racing in her first time in blinkers. Underwent a veterinary examination which did not reveal any obvious abnormality. Checked near the 250 metres.

**SONGSUNGBLU** (J Parkes) – Crowded leaving the barriers losing ground.

**LILLY'S LADY** (C Grylls) – Steadied from a wide barrier. Improved onto heels near the 1000 metres and when being restrained, went back on to SWING THE TIDE which was steadied. C Grylls reported that his mount had raced greenly throughout and was unsuited to the slow early pace.

YOLO (R Elliott) – Steadied from a wide barrier.

**SWING THE TIDE** (T Thornton) – Steadied from a wide barrier. Checked near the 700 metres when in restricted room between SIGNORA NERA and SONGSUNGBLU both of which shifted ground marginally. After questioning riders video footage proved inconclusive.

**SIGNORA NERA** (H Schofer) – Crowded onto LOVETTORLEAVEIT passing the 1600 metres by LILLY'S LADY (C Grylls) which had shifted in becoming awkwardly placed on the heels of SUMI. C Grylls was advised to exercise greater care in similar circumstances.

**LLANACORD** (L Hemi) – L Hemi admitted a charge of careless riding after angling her mount out near the 250 metres when not clear of SUMI which was checked which in turn bumped with LILLYS LADY. After submissions L Hemi had her license to ride in races suspended from the conclusion of racing on 12.2.21 up to the conclusion of racing on 21.2.21 (5 days).

### Race 8 POWERWORX TARANAKI CUP 1800 M

**CONCERT HALL** (D Johnson) – Dislodged rider D Johnson when being loaded away, backing out of the barrier abruptly with CONCERT HALL escaping the area and jumping the perimeter fence near the 2000 metre start landing awkwardly on its back. CONCERT HALL was declared a late scratching by the Stewards at 4.38 pm with all horses being removed from the barrier until CONCERT HALL was recaptured and returned to the stabling area. CONCERT HALL received veterinary treatment for skin abrasions and bruising. The race was delayed 9 minutes.

**GO NICHOLAS** (T Yanagida) – Steadied when improving into restricted room going in to the first bend. Lugged out over the final stages.

**CAMINO ROCOSO** (A Goindasamy) – A Goindasamy reported the saddle slipped in the home straight placing him at a disadvantage when the gelding was inclined to hang out under pressure.

# Race 9 THE DEVON HOTEL 1800M

MAUNA LOA (J Parkes) – Crowded leaving the barriers.

**REMARX** (S Collett) – Crowded leaving the barriers. When questioned into the performance rider S Collett could offer no excuse.

WICKLOW (T Yanagida) – Began awkwardly losing ground.

**REGAL ROCK** (M Hudson) - Began awkwardly losing ground.

GOBUYIT (S Macnab) - Crowded and restrained near the 1600 metres when in restricted room.

BEAVERTOWNBOY (M McNab) - Steadied near 1600 metres when in restricted room,.

**T Allan** (DETONATE) – Issued with a warning after permitting his mount to shift inwards near the 1600 metres when not sufficiently clear of GOBUYIT (S Macnab) and BEAVERTOWN BOY (M McNab) which were hampered.

**SHOCKING PENNY** (J Fawcett) – Raced ungenerously in the early stages.
