| <p>APERITIF (C Jones) - Began awkwardly losing ground. Raced wide without cover throughout.</p> <p>FEELIN' FANCY (D Johnson) - Began awkwardly. Shifted out to avoid heels passing the 1000 metres.</p> <p>SIDE EYE (D Danis) - Crowded and checked losing ground passing the 1350 metres. Had to be firmly restrained off heels approaching the 1000 metres dropping back onto FEELIN' FANCY which had to shift outwards to avoid heels.</p> <p>ROSEY POSEY (C Grylls) - Crowded and hampered 1350 metres.</p> <p>TAVIDORA (V Colgan) - Crowded passing the 1350 metres.</p> <p>DARCI'S QUEEN (R Elliot) - Began awkwardly shifting out making contact then restrained when in restricted room. Crowded 1350 metres and steadied.</p> <p>BENDERMERRY (S Collett) - Was unable to obtain clear running throughout the final straight.</p> <p>FAST WILLIE (T Yanagida) - Had difficulty obtaining clear running early in the final straight.</p> <p>S Spratt (CONFECTIONERY) - Issued with a warning after permitting her mount to shift in near the 1350 metres when insufficiently clear of SIDE EYE and ROSEY POSEY which were both crowded losing ground.</p> | |

| <p>BURCHA (B May) - Slow to begin.</p> <p>LOVE SHACK (L Satherley) - Hampered leaving the barrier when DOUBLE ACT shifted out abruptly.</p> <p>NOTHINSWEETABOUTME (D Danis) - Became unbalanced shortly after the start losing ground.</p> <p>DOUBLE ACT (T Thornton) - Began awkwardly and when being corrected by its rider, losing ground.</p> <p>CHARRED (S McKay) - Had to be steadied passing the 200 metres after attempting a marginal run to the inside of MIND YOU which shifted in and was then unable to obtain clear running for the remainder of the race.</p> <p>J Riddell (MIND YOU) - Issued with a warning for allowing his mount to shift in passing the 200 metres hampering CHARRED which had to be steadied.</p> | |

SUPER DALE (T Yanagida) - Slow to begin then crowded.

DUBAI LADY (S Collett) - Crowded and checked passing the 400 metres by O'JESSICA which shifted out. Contributing was slight inwards movement from HAPPY EGO. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

REMARKABLE RUTH (A Goindasamy) - Rider reported the mare had felt indifferent in its action rounding the final bend. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

A Calder (O'JESSICA) - Admitted a breach in that he permitted his mount to shift out near the 400 metres when insufficiently clear of DUBAI LADY which was checked. After hearing submissions, the Judicial Committee suspended A Calder's licence to ride in races from the conclusion of racing on Thursday 25 February 2021 until the conclusion of racing on Friday 5 March 2021, 4 national riding days and in addition imposed a fine of \$150.

AMORAMIO (E McCall) - Reared over in its barrier making contact with PEARLS A SINGER and PRIDE OF ASPEN which were both in adjacent barrier stalls with all three runners being declared late scratching's on veterinary advice. Trainer was advised that the gelding would have to barrier trial to the satisfaction of Stewards prior to racing next.

ATULLIBIGEAL (L Satherley) - Reared in its barrier becoming cast then late scratched on veterinary advice at 1.40 pm. Trainer was advised that the gelding would have to barrier trial to the satisfaction of Stewards prior to racing next.

LUCYBELLE (T Thornton) - Raced three wide without cover throughout.

LA DOLCE VITA (A Goindasamy) - Had some difficulty obtaining clear running for the majority of the final straight.

EZDARA (J Fawcett) - Commenced to hang out soon after leaving the barriers running wide passing the 1700 metres before being retired from the race near the 1400 metres. Trainer G Rogerson was advised that EZDARA would be required to barrier trial right-handed prior to racing right-handed again.

HAIL DAMAGE (D Johnson) - Began awkwardly. Raced keenly in the early stages.

DAWON (C Jones) - Began awkwardly.

OAK (T Harris) - Steadied from a wide barrier.

DIONYSUS (V Colgan) - Forced wide passing the 1700 metres by EZDARA.

SHERE KHAN (T Newman) - Hampered near the 1800 metres by EZDARA which shifted out. When questioned regarding the improved performance, connections advised that the gelding had benefitted from a freshen up and the addition of blinkers.

T Harris (OAK) - Was reminded of obligations in that he must ride his mounts out fully to the end of the race when circumstances permit him to do so.

LOT OF ZEES (J Fillmore) - Crowded at the start. Raced wide without cover for the majority of the race.

CERYs (T Yanagida) - Crowded shortly after the start and steadied.

DAQIANSWEET JUNIOR (S Collett) - Hampered passing the 1700 metres.

L Satherley (ABSCONDED) - Issued with a warning for her whip use prior to the 100 metres.

OUR WONDERLAND (C Jones) - Restrained 700 metres when awkwardly placed near heels. Held up early in the final straight before shifting in passing the 300 metres.

IT'S DOABLE (A Goindasamy) - Steadied passing the 300 metres when improving onto the heels of I'M CAPABLE which shifted out.

WASP (E McCall) - Began awkwardly losing ground after being restless in its barrier. When questioned regarding the performance rider advised that after being slow away the mare had settled further back than intended and had been unable to improve.

INSIDE STORY (R Elliot) - Raced wide without cover for a majority of the race.

ENDEAN LASS (A Calder) - Began awkwardly losing ground. Steadied after improving onto heels passing the 500 metres then had difficulty obtaining clear running until passing the 150 metres.

HAKUNA MATATA (S Spratt) - Slow to begin. Had to be steadied passing the 200 metres when denied clear running and was then unable to obtain clear running for the remainder of the race.

SEAJETZ (D Johnson) - Steadied from a wide barrier to obtain cover. Held up early in the final straight before shifting out passing the 300 metres crowding SCOTTISH STAR onto SEMPRINI with SEAJETZ then shifting out and away from MISTRESS MINX which was racing greenly, further inconveniencing SCOTTISH STAR and SEMPRINI. D Johnson was advised to exercise care.

SCOTTISH STAR (J Kamaruddin) - Held up entering the final straight then crowded passing the 300 metres before being further inconvenienced approaching the 200 metres.

SEMPRINI (D Danis) - Briefly crowded passing the 300 metres. Inconvenienced approaching the 200 metres.

WHANGA WONDER (A Calder) - Improved onto heels passing the 1400 metres having to be restrained. Held up until passing the 300 metres.

MILLIE GEORGIA (L Satherley) - Raced keenly in the early stages. Contacted and forced wider passing the 300 metres by HIBERNIA SEA which had shifted out to obtain clear running. T Newman was advised to exercise care.

QUELL (S Collett) - Raced wide without cover throughout.

HIBERNIA SEA (T Newman) - Raced in restricted room for a distance approaching the 400 metres. Then held up until passing the 300 metres.

SWANSEA BAY (J Fawcett) - Made the junction onto the course proper approaching the 1400 metres awkwardly and shifted out hampering ZAAXINA and LAGERFELD.

ZAAXINA (V Colgan) - Hampered approaching the 1400 metres.

LAGERFELD (M Falconer) - Hampered approaching the 1400 metres.

ANHEDONIA (J Fillmore) - Improved onto heels passing the 750 metres having to be firmly restrained.

TRA CEE ANN (C Grylls) - Raced in restricted room soon after leaving the barrier. Shifted out passing the 50 metres making slight contact with LIGHTNING FIELD.

LIGHTNING FIELD (O Bosson) - Contacted passing the 50 metres.

SWEY MY WAY (C Jones) - Began awkwardly then crowded.

ANNEXCEPTION (A Goindasamy) - Began awkwardly losing ground. Contacted and unbalanced passing the 150 metres.

RED STAR (B Rogerson) - Slow to begin.

LILY ALLEZ (R Elliot) - Raced greenly when placed under pressure in the final straight. Shifted out passing the 100 metres making contact with ANNEXCEPTION with both runners becoming unbalanced. When questioned regarding the performance the rider advised that the filly had been unsuited by the race track conditions and had raced greenly.

PARADING (D Johnson) - When questioned regarding the performance rider advised that the filly had been unsuited by today's track conditions.

FONTEYN (T Newman) - Shifted out abruptly passing the 50 metres having to be straightened by its rider.

Following the race, the connections of the 2nd placed horse **LIGHTNING FIELD** lodged a protest against the 1st placed horse **TRA CEE ANN** alleging interference in the final straight. After considering submissions the Judicial Committee dismissed the protest.
