**MOZZRELLA** (S Collett) – Co-trainer N Wigley advised Stewards, MOZZRELLA, pulled up shin sore in the near front leg, with the filly now being sent for a brief freshen up.

**LORD ARDMORE** (M McNab) – Trainer S McKee advised Stewards, he was satisfied with the post-race condition of the colt and it is his intention to continue on with LORD ARDMORE'S current preparation, where he will look to nominate the colt for the Manawatu Racing Club's meeting on Saturday 3 April.

**PERFECT SCENARIO** (O Bosson) – Trainer J Richards advised Stewards, he was satisfied with the post-race condition of PERFECT SCENARIO, however, has now been sent for a spell.

## RACE COMMENTS:

Race 1	MOUNT SHOP MAIDEN 2100
<p><b>GIULIANA'S JOY</b> (D Danis) – Began awkwardly. Had to be firmly restrained to avoid heels passing the 1800 metres.</p> <p><b>OCEANA LAD</b> (R Elliot) – Slow to begin then crowded shortly after, having to be steadied. Pulled up early in the final straight. Was immediately attended to by the on course veterinarian with the horse ambulance being deployed after OCEANA LAD suffered a significant near fore leg knee injury and after receiving sedation and treatment, OCEANA LAD was humanely euthanised.</p> <p><b>HEART OF A LION</b> (M McNab) – Began awkwardly then hampered shortly after.</p> <p><b>JOJAKK</b> (J Fawcett) – Began awkwardly. Raced wide without cover in the early stages.</p> <p><b>GRANADOS</b> (O Bosson) – Began awkwardly losing ground.</p> <p><b>PEARL HART</b> (A Goindasamy) – Raced in restricted room for a distance passing the 1800 metres. Made contact with LOVINGYOURWORK approaching the 400 metres.</p> <p><b>LOVINGYOURWORK</b> (D Johnson) – Raced wide in the early stages. Came together approaching the 400 metres with PEARL HART. Had difficulty obtaining clear running throughout the final straight.</p> <p><b>OH OUR WYATT</b> (T Thornton) – Steadied passing the 1800 metres when placed in restricted room dropping back onto GIULIANA'S JOY which had to be firmly restrained to avoid heels.</p> <p><b>J Fillmore</b> (LOTS OF ZEES) – Reminded of her obligation with regard to whip use prior to the 100 metres.</p> <p><b>PERFECT DIMENSION</b> (J Riddell) – Rider dismounted the gelding after pulling up as he was suffering from exhaustion with PERFECT DIMENSION then escaping and galloping a distance before being recaptured. PERFECT DIMENSION</p>	

received veterinary attention for superficial abrasion and cuts on both front limbs. J Riddell was exempted from weighing in, then attended to by the ambulance personnel and cleared fit to ride.	
<b>Race 2</b>	<b>PATUMAHOE PLUMBING MAIDEN 1200</b>
<p><b>BIFROST</b> (O Bosson) – Hung outwards throughout the race. Shifted out abruptly having to be steadied off heels near the 150 metres and could not be fully ridden out over the concluding stages.</p> <p><b>QUICKEN AWAY</b> (L Innes) – Had to be steadied when becoming awkwardly placed inside the heels of O’DUA which was laying in.</p> <p><b>COOL CHANGE</b> (A Calder) – Shifted out to obtain clear running passing the 200 metres making contact with CORISTA with that runner shifting out into the line of PRIDE OF ASPEN which had to be steadied when becoming awkwardly placed on heels.</p>	
<b>Race 3</b>	<b>NZB INSURANCE PEARL SERIES RACE MAIDEN (1200 m)</b>
<p><b>PICUAL</b> (S Collett) – Began awkwardly losing ground. Made the bend awkwardly when in restricted room near the 1000 metres shifting out hampering CUBIC MOON which had to be firmly restrained off heels.</p> <p><b>CUBIC MOON</b> (M McNab) – Began awkwardly after being restless in its barrier stall then hampered shortly after, losing ground. Hampered 1000 metres when awkwardly placed on heels and forced wider.</p> <p><b>LAMPUS</b> (D Johnson) – Began awkwardly losing ground.</p> <p><b>FONTEYN</b> (T Newman) – Held up for a distance passing the 300 metres having to shift out across heels to obtain clear running near the 200 metres.</p> <p><b>ARRIVO</b> (E McCall) – Made the bend awkwardly passing the 1000 metres. Raced ungenerously through the middle stages. Was held up passing the 350 metres until obtaining clear running passing the 200 metres. Returned to the enclosure with blood present in both nostrils. A subsequent veterinary examination confirmed the horse to have bled and is now subject to a 2 month stand down from training and a 3 month stand down from trialing or racing with a veterinary clearance also required before trialing or racing again.</p>	
<b>Race 4</b>	<b>DUNSTAN HORSEFEEDS MAIDEN 1200</b>
<p><b>TAUPO MISSY</b> (D Johnson) – Raced three wide without cover throughout.</p> <p><b>DEAR OH DEAR</b> (T Thornton) – Slow to begin.</p> <p><b>BANISH</b> (L Innes) – Slow to begin. Raced wide without cover for the majority of the race.</p> <p><b>CONTRIBUTE</b> (S McKay) – Began awkwardly losing ground.</p> <p><b>ENCANTADOR</b> (V Colgan) – Had to be restrained off heels on two occasions approaching the 400 metres.</p> <p><b>NOZI CYCLONE</b> – C Grylls replaced J Riddell at the request of co-trainer A Forsman as he was 0.5 kgs overweight.</p> <p><b>S Weatherley</b> (DEAR OH DEAR) – Was fined \$200 by the Judicial Committee after willfully breaking his riding engagement on DEAR OH DEAR.</p>	
<b>Race 5</b>	<b>HAUNUI FARM STALLIONS MAIDEN 1200</b>
<b>SCREEN BELLE</b> (S Wynne) – Began awkwardly then hampered shortly after having to steady. Hampered 650 metres.	

**DAADS EXPRESS** (M Hashizume) – Crowded shortly after the start. Steadied when in restricted room to the outside of IRISH MOONSHINE which made the bend awkwardly passing the 900 metres.

**JAMIESONS TIPPLE** (C Grylls) – Had to be firmly restrained off heels when the pace eased near the 650 metres dropping back onto DAADS EXPRESS which had to be firmly restrained off heels with the rider becoming unbalanced dropping back onto SCREEN BELLE which also had to be firmly restrained, shifting out abruptly.

**IRISH MOONSHINE** (T Yanagida) – Made the bend near the 900 metres awkwardly. Had to be firmly restrained off heels passing the 650 metres. Briefly held up entering the final straight.

**A Calder** (TEMPTING HEART) – Admitted a breach of careless riding in that he allowed TEMPTING HEART to shift in near the 950 metres when not fully clear of JAMIESON'S TIPPLE which was crowded and checked with A Calder's licence to ride in races being suspended from the conclusion of racing on Saturday 20 March up to and including racing on Friday 26 March, 4 national days and in addition imposed a fine of \$250.

**PRECISION SHOOTER** (D Johnson) – Slow to begin.

**CASTLE OF KINGS** (J Riddell) – Slow to begin.

**MALT TIME** (A Goindasamy) – Began awkwardly then crowded shortly after. Lay out when placed under pressure in the final straight.

**MARCHING ON TAVI** (S Wynne) – Crowded shortly after the start. Steadied when placed in restricted room passing the 950 metres.

**COPPER XPRESS** (E McCall) – Crowded and checked 950 metres. Rider dropped her whip passing the 200 metres.

**JUST KROOZIN** (C Grylls) – Crowded becoming unbalanced passing the 950 metres.

**A Goindasamy** (MALT TIME) – Issued with a warning for allowing his mount MALT TIME to shift in passing the 950 metres when not sufficiently clear of MARCHING ON TAVI which was forced inwards crowding JUST KROOZIN.

**C Jones** (SO CHARMING) – Admitted a breach of careless riding in that he allowed SO CHARMING to shift in near the 950 metres when not fully clear of COPPER XPRESS which was crowded and checked with C Jones' licence to ride in races being suspended from the conclusion of racing on Friday 12 March up to and including racing on Monday 22 March, 5 national days and in addition imposed a fine of \$250.

<b>Race 7</b>	<b>HAUNUI FARM 1400</b>

**QUEEN SUGAR** (W Pinn) – Slow to begin.

**CARLITO** (J Fawcett) – Over-raced for a distance when being restrained passing the 1000 metres.

**JIMMY FIVE** (S Wynne) – Made the bend awkwardly having to be firmly restrained off heels near the 850 metres.

**C Grylls** (FLORENTIA) – Issued with a warning in that he shifted out on FLORENTIA near the 250 metres when not fully clear of CARLITO which was laying in under pressure.

**L Satherley** (ANDUIN) – Was spoken to regarding her whip use prior to the 100 metres.

<b>Race 8</b>	<b>FIBER FRESH MAIDEN 1400</b>

**RED RUSHIN** (C Jones) – Slow to begin.

**GLEN FREY** (C Grylls) – Began awkwardly losing ground. Hampered 1200 metres.

**EARLE OF BUCKLAND** (S Collett) – Slow to begin.

**CASTLE BAY** (A Goindasamy) – Commenced to over-race near the 1200 metres and when being restrained to shift in and obtain cover, continued to race fiercely and clipped a heel of THE MIGHTY SPAR. Hampered as a result was GLEN FREY.

**MR FOX** (T Thornton) – Had difficulty obtaining clear running throughout the final straight.

**O Bosson** (THE MIGHTY SPAR) – Issued with a warning in that he directed MIGHTY SPAR out to obtain clear running approaching the 400 metres making contact with CASTLE BAY.

**FLAVIUS** (S Weatherley) – Had difficulty obtaining clear running until shifting out passing the 200 metres.

<b>Race 9</b>	<b>FRANKLIN AUCTIONS MAIDEN 1600</b>

**WITNESS** (A Goindasamy) – Slow to begin. Forced wider 250 metres.

**INDEEM** (O Bosson) – Slow to begin.

**SHE'S A MANEATER** (S Collett) – Crowded shortly after the start losing ground. Raced wide without cover.

**WINAFORTUNE** (W Pinn) – Raced keenly for a distance through the middle stages.

**ARABIA** (T Thornton) – Shifted out abruptly 250 metres.

**BRANCATELLI** (J Riddell) – Had to steady when awkwardly placed on the heels of WINAFORTUNE which shifted in under pressure passing the 200 metres.

**W Pinn** (WINAFORTUNE) – Issued with a warning in that he allowed his mount WINAFORTUNE to shift out near the 250 metres under pressure with ARABIA shifting away from that runner making contact with WITNESS forcing that runner wider on the track. Also inconvenienced was INDEEM.

<b>Race 10</b>	<b>RACING @ PUKEKOHE PARK 24 MARCH MAIDEN (1600 m)</b>

There was a 2 minute delay to the start of the race at the request of the TAB.

**DUNHILL** (J Riddell) – Restrained from its wide barrier.

**EL FIESTA GIRL** (S Weatherley) – Began awkwardly losing ground.

**SAILOR JERRY** (C Grylls) – Held up for clear running until passing the 250 metres.

**QUIET MICHAEL** (J Riddell) – Held up until passing the 100 metres then improved onto heels over the concluding stages having to be steadied.

**SPIRIT OF BAZ** (W Pinn) – When questioned regarding the improved performance co-trainer A Forsman advised that the filly had benefitted from the addition of blinkers.

**CHARRED** (S McKay) – Crowded 400 metres to the inside of CANADIAN MOUNTIE which lay in when placed under pressure in the final straight. Contributing was movement from VISTOCK which lay out when contacted. Riders L Innes and R Elliot were advised to exercise care in a similar circumstance.
