Race 5 JOHN BARY RACING 1200

BUCKY (S O'Malley) – Trainer Mr J Bary, advised Stewards, BUCKY underwent a veterinary examination on Monday 3 May, which included an endoscopic examination and blood tests, with all results showing no abnormalities. J Bary further advised the gelding had been rested for a few days, however, has now resumed with light track work.

RACE COMMENTS:

Race 1	PATRICIA SHANNON'S 60TH 1100 (1100 Metres)
<p>SANIBEL (K Hercock) - Underwent a veterinary examination prior to the start after being kicked and was passed fit to start. Hampered near the 800 metres. Wide throughout. Held up early in the home straight prior to being angled out passing the 300 metres to improve.</p> <p>THE DOUBLE UP (S Collett) - Began awkwardly losing ground.</p> <p>HE'S DONE A RUNNER (C Johnson) - Tightened near the 800 metres when LIGHT UP lay in and in doing so crowded GLITTERING ARMOUR and when being corrected shifted out hampering MISS FALVELON, which had to be steadied.</p> <p>POWER OF THE KITTY (D Montes de Oca) - Raced in restricted room for the majority of the home straight.</p>	
Race 2	MURRAY CONTRACTORS 1200 (1200 Metres)
<p>PURE INCANTO (H Schofer) – Late scratching at 11.01 am on veterinary advice after becoming fractious in the barriers losing the left hind plate. Veterinary examination revealed superficial injury to the left hind leg. Connections were advised that PURE INCANTO must trial to the satisfaction of Stewards prior to racing next. It was subsequently reported to the Stewards that PURE INCANTO was heavily in season.</p> <p>RED STAR (R Elliot) - Shifted out on jumping away crowding VESPASIA.</p> <p>VESPASIA (T Taiaroa) – Crowded start.</p> <p>COLOSTRUM (K Hercock) - Slow away.</p> <p>VENATO (C Johnson) – Slow away. Improved onto heels entering the final straight.</p> <p>SHEZ MALEFICENT (K Asano) – Inconvenienced near the 100 metres when EAGLE COUNTY was inclined to shift out under pressure.</p> <p>HILLCREST ROAD (J Riddell) – Wide without cover throughout.</p>	
Race 3	NETHERTON STATION FARM 1400 (1400 Metres)
<p>OCEAN CHIEF (J Fawcett) - Held up for some distance rounding the final turn and was then angled out near the 300 metres and in doing so was not clear SOPRANO SUPREME which was checked. Held up when improving onto heels of JANE O' over the final stages. J Fawcett admitted a subsequent breach of careless riding near the 300 metres and had her licence to ride in races suspended from the conclusion of racing Saturday, 15 May 2021 up to and including racing on Thursday, 27 May 2021 (7 national riding days) and in addition a fine of \$500 was imposed.</p> <p>SOPRANO SUPREME (S Collett) – Held up rounding the home turn. Checked early in the final straight.</p>	

LITTLE TEXAS SKY (F Lazet) – Held up from near the 250 metres prior to gaining clear running inside the final 100 metres.	
Race 4	MERRYLEES HOTEL 1400 (1400 Metres)
<p>FAR SITE (S Macnab) – Slow away.</p> <p>YOSSARIAN (W Pinn) – Raced wide without cover throughout.</p> <p>LINCOLN HILLS (J Riddell) - Disappointed. When questioned J Riddell was of the opinion that there may be something amiss with LINCOLN HILLS so did not ride the gelding out over the final stages. A subsequent veterinary inspection did not reveal any obvious abnormalities.</p> <p>ROC YA SOX (D Montes de Oca) – Raced disappointingly and was not persevered with from the 200 metres. When questioned D Montes de Oca was of the opinion that the gelding may have a respiratory issue. A subsequent veterinary examination revealed abnormal respiratory noises.</p>	
Race 5	MOTHERS' DAY 2021 1400 (1400 Metres)
<p>WOTARIPPER (J Riddell) – Slow to begin. Held up early in the final straight.</p> <p>DAWN COUNTY (S Macnab) – Began awkwardly.</p> <p>ELEGANT CHARM (C Dell) – Restrained from a wide draw. Held up for a short distance early in the final straight.</p> <p>SHOAL BAY (T Taiaroa) - Raced wide without cover throughout.</p>	
Race 6	DOUG LOCHEAD PAINTING 1400 (1400 Metres)
<p>CASTANI (L Allpress) – Late scratched at 1.10pm after becoming fractious in the barriers and dislodging the rider. L Allpress underwent an examination by paramedics and was stood down from her remaining riding engagements with a medical clearance required prior to riding next.</p> <p>PUKE PARK (W Pinn) - Shifted out abruptly on jumping away bumping with SIR BEETS.</p> <p>SIR BEETS (J Riddell) – Bumped start.</p> <p>KAHU ROCK (K Hercock) – Raced wide in the early stages.</p> <p>ST NANCY (S Macnab) – Lay in under pressure in the final straight.</p> <p>D Montes de Oca (BUBBLE GUM) – Dropped his whip near the 350 metres.</p>	
Race 7	THE PRESIDENT'S MILE (1600 Metres)
<p>PLATINUM BORDEAUX – D Bradley replaced L Allpress (injured).</p> <p>MARTINA MARIEA (B Rogerson) - Restrained at the start from its wide barrier.</p> <p>TIGERBEE (D Montes de Oca) – Charged the gates, gaining a marginal advantage. As the mare finished unplaced no further action was taken. The Starter undertook to check the gates prior to the next race.</p> <p>TE AWE AWE (S Collett) - Began awkwardly.</p>	

LILLY LAGUNA (W Pinn) –Pulled up shortly after the start. When questioned rider advised the filly had been buffeted on jumping away and stumbled and he was of the opinion there may be something amiss with the filly’s action and was pulled up. A post-race veterinary examination revealed 1/1 lameness with a veterinary clearance required prior to racing next.	
Race 8	HEWITT MOTORCYCLES 1600 (1600 Metres)
<p>MYSALLY – S Macnab replaced L Allpress.</p> <p>B Coxhead (SPACEK) – Issued with a warning under Rule 613(c) for presenting his runner with plating that was marginal.</p> <p>SO SUE ME (H Schofer) - Held up for the majority of the final straight and went to the line without being fully tested.</p> <p>NUN HISSING (S Collett) -Held up until the 150 metres and could not be fully ridden out for the remainder of the race.</p> <p>MASSO (A Mudhoo) – Lay in near the finish having to be steadied off the heels of IT’S NOT THAT EASY.</p>	
Race 9	WOODVILLE-PAHIATUA CUP (1600 Metres)
<p>NOT SANTA (W Pinn) – Began awkwardly then settled some distance behind the body of the field. An enquiry was opened into the ride of W Pinn. A post-race veterinary examination revealed no obvious abnormalities.</p> <p>VERY APPEALING (T Yanagida) – Slow to begin.</p> <p>PASSWORD (J Riddell) - Raced three wide without cover throughout.</p> <p>FEELIN’ FANCY (S Collett) - When questioned into performance rider advised the mare may prefer some more easing of the ground.</p>	
Race 10	JOHN & NATALIE MABEY 2000 (2000 Metres)
<p>GRAND PROSPECT – C Johnson replaced L Allpress. Contacted concluding stages.</p> <p>SWIFT (S Macnab) - Restrained at the start from its wide barrier draw.</p> <p>RAUCOUS (K Hercock) - Had to be steadied when becoming awkwardly placed on the heels of GINGER SNAPZ, which began to give ground, passing the 700 metres.</p> <p>IRISH FLARE (J Riddell) – Commenced to over-race and made the bend awkwardly passing the 1800 metres.</p> <p>TARTAN FIELD (R Elliot) - When questioned into the run of TARTAN FIELD, which commenced to give rounding the home turn and finished some distance last, R Elliot advised that he had no particular excuse other than the gelding may not be suited to the longer distance.</p> <p>PUTORINO (H Schofer) - Shifted out near the 250 metres bumping GRAND PROSPECT (C Johnson), which in turn shifted in abruptly and bumped PUTORINO. PUTORINO shifted out on two further occasions when struck with the whip making contact with GRAND PROSPECT near the finish. Following the race connections of the 2nd placed GRAND PROSPECT viewed footage of the home straight but elected not to proceed with an objection against the winner PUTORINO. H Schofer was shown footage of her ride in the presence of the riding master and advised she is expected to straighten her mount sooner than she did on this occasion.</p>	
Race 11	DANNEVIRKE SERVICES & CITIZENS’ CLUB 2200 (2200 Metres)
LA STRATA – T Yanagida replaced L Allpress.	

SASSENACH (C Johnson) – Restrained from its wide draw.

DALMATIA (J Riddell) – Raced wide for the majority of the race. When questioned into the performance, rider advised the gelding failed to handle the existing track conditions and the connections will consider spelling the gelding prior to racing again.

RED ‘N’ SURF (D Hirini) - Badly hampered by the fallen runner near the 200 metres.

JACKAROO (K Asano) – Clipped a heel of ROC LEGEND (M Singh) and fell near the 200 metres. An enquiry was opened into the fall of JACKAROO until the rider K Asano was available for questioning as he was transferred to hospital for further evaluation. JACKAROO was winded and took some minutes to recover. The horse ambulance was in attendance as soon as possible but was not required.
