RACE COMMENTS:

Race 1	NIGHT N DAY PARK MAIDEN 1200m
<p>SHEZA PRO (A Balloo) – Jumped away awkwardly getting its head up, made the bend near the 900 metres awkwardly.</p> <p>COFFERS (S Wynne) – Restrained to obtain cover in the early stages after jumping from a wide barrier, held up early in the straight having to shift ground near the 300 metres then again inside the final 200 metres to obtain clear running.</p> <p>HARLEEN QUINZEL (C Johnson) – Crowded when leaving the barriers, had difficulty obtaining clear running throughout the final straight and was inclined to lay in.</p> <p>DETTIFOSS (K Asano) – Crowded when leaving the barriers, steadied when placed in restricted room going into the bend near the 900 metres.</p> <p>ARE THERE (R Beeharry) – Placed in restricted room going into the bend near the 900 metres to the inside of FIRECRACKER which when over racing was inclined to shift away from KHITAN WARRIOR (J Lowry) to its outside. J Lowry was advised to exercise greater care. Held up early in the straight before obtaining clear running approaching the 200 metres. When questioned regarding the improved performance rider advised that the gelding had been better suited by today's improved track conditions.</p> <p>FIRECRACKER (T Moseley) – Over raced in the early to middle stages. When questioned regarding performance rider advised that after over racing early the gelding had been inclined to lay in once placed under pressure and would benefit from the experience of its race day debut. Required veterinary treatment post-race for a mild bout of colic.</p> <p>POSTCODE ENVY (K Chowdhoo) – Steadied to avoid the heels of FIRECRACKER passing the 900 metres and shifted outwards forcing LADY MODENA wider on the track, contacted near the 250 metres.</p> <p>LADY MODENA (R Mudhoo) – Raced wide without cover and further inconvenienced passing the 900 metres.</p> <p>MR HASS (J Laking) – Raced keenly in the middle stages, held up entering the final straight and when shifting outwards to obtain clear running made contact with POSTCODE ENVY near the 250 metres.</p> <p>KHITAN WARRIOR (J Lowry) – Lay out rounding the final turn.</p> <p>MR FOX (B Murray) – Held up entering the final straight continuing to have difficulty obtaining clear running until near the 100 metres.</p>	
Race 2	CATERING SOUTH CANTERBURY SPRINT MAIDEN 1200m
<p>Trainer P Corbett (MABILIS) - Issued with a warning for late declaration of rider.</p> <p>MAXIMUS PRIME (S Wynne) – Jumped away awkwardly, checked to avoid heels near the 1050 metres losing ground then over raced making the bend near the 900 metres awkwardly, held up rounding the turn from the 600 metres until shifting ground back to the inside and continued to have difficulty obtaining clear running having to shift ground in the straight until passing the 200 metres.</p> <p>WILLNOTQUIT (K Asano) – Restrained to obtain cover in the early stages after jumping from a wide barrier</p> <p>JUST A GIRL (K Mudhoo) – Restrained to obtain cover in the early stages after jumping from a wide barrier, had to be steadied and shift outwards to avoid the heels of GEE TEE GIRL near the 1050 metres hampering GALLERY GIRL.</p>	

C Barnes (RUSSIAN FABLE) - Admitted a charge of careless riding in that she permitted her mount to shift inwards when not sufficiently clear of GEE TEE GIRL which was forced inwards into the line of MAXIMUS PRIME which was checked near the 1050 metres. After viewing films and hearing evidence the Judicial Committee suspended C Barnes' licence to ride at race meetings for 4 national riding days effective from the conclusion of racing on Wednesday 12 May up to and including racing on Sunday 16 May and in addition imposed a fine of \$400.

GEE TEE GIRL (B Murray) – Hampered and forced inwards near the 1050 metres.

GALLERY GIRL (G Jogoo) – Hampered near the 1050 metres.

MISS HARLEY QUIN (T Moseley) – Held up passing the 600 metres having to be steadied off heels for a distance before obtaining clear running near the 300 metres.

TWIN SHOT (K Chowdhoo) – Inconvenienced near the 100 metres when FASTMOSA shifted outwards under pressure.

Race 3	NOEL WALKER AT LJ HOOKER GROUP DASH 1200m

TOO SAVVY (A Balloo) – Slow away, raced three wide without cover throughout. Rider was spoken to regarding his riding tactics as in the Stewards' view he had had the opportunity to obtain cover in the middle stages.

AUTHORITY (K Asano) – Raced wide without cover until passing the 800 metres.

GALILEO EXPRESS (C Johnson) – Raced keenly in the lead in the middle stages, lay out rounding the final turn and continued to lay out under pressure in the straight.

BARRY'S CHOICE (R Beeharry) – Hung outwards throughout then lay in under pressure becoming awkwardly placed near the heels of OHIO SHOWGIRL near the 250 metres.

FIONNUALA (K Kwo) – Slow away.

SORCERESS (J Lowry) – Jumped away awkwardly.

ARNAGE (T Moseley) – Commenced to race ungenerously when being restrained passing the 1000 metres getting its head up and over racing for some distance.

TOUCHABEEL (G Jogoo) – Steadied when placed in restricted room to the inside of ARNAGE which shifted inwards when racing very ungenerously and getting its head up near the 800 metres after becoming awkwardly placed near the heels of MISS SWEET PEE (S Wynne). S Wynne was advised to exercise care.

EXPRESSIVE (A Balloo) – Raced in restricted room near the 800 metres.

PLAY THE FIELD (R Beeharry) – Raced wide without cover. Rider dropped his whip inside the final 100 metres when well beaten.

MISS SWEET PEE (S Wynne) – Rider reported that the mare had raced in a flat state and was of the opinion that it had come to the end of its current campaign. S Wynne added it was her understanding consideration would now be given to sending MISS SWEET PEE for a spell.

POWNCE (R Mudhoo) – Over raced when being restrained in the early to middle stages.

THE GROWLER (K Williams) – Raced ungenerously when being restrained in the early stages on a slow tempo.

ORIGINAL GANGSTER (S Wynne) – Over raced in the early to middle stages on a slow tempo.

MANHATTAN FLAME (K Asano) – Rider dropped his whip passing the 150 metres.

Race 6 | **CHAMPIONS OF SEADOWN 1600m**

TAKEITLIKEAMAN (C Barnes) – Slow away.

MY SOVA (J Laking) – Slow away, had difficulty obtaining clear running in the straight.

HEAD OFFICE (K Chowdhury) – Restrained to obtain cover in the early stages after jumping from a wide barrier, steadied shortly after the start to avoid the heels of MY SOVA.

ZURAFAA (T Jonker) – Raced three wide without cover.

YEAH RIGHT (T Moseley) – Disappointed for a run early in the straight near the 300 metres.

THE GARRISON (K Asano) – When questioned regarding performance rider was unable to offer any excuse.

TAPPY'S ONE (C Johnson) – When questioned regarding the improved performance after failing at Wingatui mid-week, co-trainer K Taplin stated that the gelding had received a tough trip when three wide without cover throughout and had taken benefit from the race, along with the step up in distance today and a more economical trip the form turnaround was not unexpected.

Race 7 | **SILVER FERN FARMS MAIDEN 1600m**

KENKI (B Murray) – Crowded shortly after leaving the barriers having to be steadied losing ground, held up for a distance near the 300 metres before shifting outwards near the 250 metres then having to continue to shift outwards looking to obtain clear running before being steadied near the 100 metres when a marginal run between WAIHORA MIST (S Wynne) and IFFRAAJABLE (K Williams) appeared to be closing when both those runners shifted ground. S Wynne and K Williams were both advised to exercise greater care.

HOMBRE (C Johnson) – Over raced in the early to middle stages.

REPULSE (Z Bholah) – Raced three wide without cover.

B Murray (KENKI) - Issued with a warning after permitting his mount to shift outwards near the 250 metres hampering GROOVEYTOWN LAD.

GROOVEYTOWN LAD (C Barnes) – Hampered near the 250 metres.

CLUBCARD (K Chowdhury) – Steadied when placed in restricted room near the 150 metres.

K Williams (IFFRAAJABLE) - Issued with a warning after permitting her mount to shift inwards under pressure over the concluding stages.

WAIHORA MIST (S Wynne) – Steadied over the concluding stages when placed in restricted room to the inside of IFFRAAJABLE which shifted inwards under pressure.

Race 8 | **DOMINATOR DOORS 2200m**

BLACKJAKK (A Balloo) – Restrained to obtain cover in the early stages after jumping from a wide barrier, got its head up when making the bend awkwardly near the 1700 metres.

S Wynne (SEE WHATA PRINCESS) - Issued with a warning after permitting her mount to shift inwards near the 2000 metres crowding LANCASTER PARK which had to be steadied and shifted inwards hampering WENDY DARLING.

WENDY DARLING (T Jonker) – Hampered near the 2000 metres, clipped a heel of SEE WHATA PRINCESS and blundered near the 1700 metres, contacted near the 200 metres when SEE WHATA PRINCESS shifted outwards. Prior to the authorisation of dividends co-trainer P Robson viewed Stewards’ footage before electing not to proceed with a protest.

S Wynne (SEE WHATA PRINCESS) - Admitted a charge of careless riding in that she permitted her mount to shift inwards when not sufficiently clear of WENDY DARLING which clipped a heel and blundered near the 1700 metres, with DIAMOND RIVIERE also being hampered as a result. After viewing films and hearing evidence the Judicial Committee suspended S Wynne’s licence to ride at race meetings for 6 national riding days effective from the conclusion of racing on Wednesday 12 May up to and including racing on Thursday 20 May and in addition imposed a fine of \$400.

DIAMOND RIVIERE (R Beeharry) – Hampered near the 1700 metres, briefly steadied to avoid heels near the 400 metres.

LANCASTER PARK (J Laking) – Hampered when crowded near the 200 metres, lost its footing behind rounding the bend passing the 1700 metres with the rider advising that the gelding was negotiating the bend awkwardly and he did not see it as an issue with the track. No other rider reported experiencing any difficulty and after meeting with all riders engaged in the remaining race it was agreed to proceed with the meeting. Steadied when crowded near the 250 metres when DIAMOND RIVIERE (R Beeharry) shifted outwards, contributing was some inward movement from TAPPY’S LAD.

R Beeharry (DIAMOND RIVIERE) - Issued with a warning after permitting his mount to shift outwards near the 250 metres.

SEE WHATA PRINCESS (S Wynne) – Unbalanced when making contact with WENDY DARLING passing the 200 metres.

Race 9	EQUINE VETERINARY SERVICES STAYERS 2200m

L Prendergast (MISS TAVI) - Fined \$50 under the Minor Infringement Schedule after presenting the mare to race in blinkers which had not been notified.

KING OF THE DANCE (R Beeharry) – Jumped away awkwardly then further hampered when crowded losing ground.

SURE IS (C Johnson) – Over raced in the early to middle stages.

R Beeharry (KING OF THE DANCE) - Dropped his whip near the 250 metres.
