Race 1	TRAVELLERS REST TAVERN & RYDER ROOFING & HOWLEY JOINERY (2147m)
RUBY MARIE (D Frye) – Began awkwardly crowding outside runners. Over-raced in the early stages.	
TAPDOG (M Northcott) – Crowded on jumping.	
MIDNITE KAOS (B Kennedy) – Crowded on jumping.	
PABLEAU (Y Atchamah) – Crowded on jumping.	
YING RESOLUTE (K Shearing) – Ducked outwards away from the running rail near the 750 metres.	
Race 2	SAM BROWN CONCRETE CUTTING AND TODD & CO REALTY (1600m)

DUNHILL (R Mudhoo) – Slow to begin.

KENKI (B Murray) – Crowded shortly after the start losing ground.

DENALI (T Moseley) – Raced keenly on various occasions through the early and middle stages.

MISS CATHERINE (R Beeharry) – Under pressure and commenced to give ground from the 600 metres and was not persevered with in the final straight, being well beaten. Rider advised that the mare had felt indifferent in its action over the concluding stages. A post-race Veterinary examination did not reveal any obvious abnormalities.

Race 3 | **D T KING TRANSPORT (1600m)**

TRANSCENDENT (K Kwo) – Got back shortly after the start.

RITANI (C Johnson) – Over-raced when wide through the early stages then continued to race keenly through the middle stages.

WILD JACK (J Lowry) – Rider dropped his whip nearing the 200 metres.

PICTURE ME ROLLIN (K Chowdhoo) – Inclined to lay inwards throughout the run home having to be straightened on a number of occasions.

Race 4 | **TRENZ HOMES AND RIVERTON SUPERVALUE (1600m)**

RINGBOLT (R Beeharry) – Restrained shortly after the start after jumping from the outside barrier to shift to a position adjacent to the running rail.

FULL FURY (J Laking) – Briefly held up entering the home straight.

R Beeharry (RINGBOLT) was issued with a warning when using his whip on a runner out of contention.

Race 5 | **PHIL BEVIN SPRAYING & ICONIC BUILDER & VITAL SIGNS (1400m)**

FILL YA BOOTS (K Mudhoo) – Began awkwardly.

RINGADINGDING (M Gestain) – Began awkwardly.

KITTY POWER (T Moseley) – Crowded at the start when runners either side shifted ground. Raced three-wide without cover throughout. Rider reported that although the mare had been obliged to race three wide he was still slightly disappointed with the performance.

OUR SHAMAN (L Callaway) – Bumped and briefly unbalanced passing the 400 metres when KITTY POWER stepped in on the point of the turn.

K Kwo (JIM'S GIFT) was issued with a warning for his whip use prior to the 100 metres.

Race 6 | **BULLET COURIER AND TONY ROY BUILDING (1400m)**

COMMASSIE (K Mudhoo) – Slow to begin.

VENI VICI (B Murray) – Got back shortly after the start. Raced three-wide without cover through the middle stages.

EMILY ROSE (S Wynne) – Got back shortly after the start. Forced wider on the track passing the 700 metres.

WILD LIKE (M Gestain) – Got its head up when shying near the 1200 metres.

CAROLINE MARGARET (G Jogoo) – Gave ground from the 700 metres.

KING OF THE CASTLE (R Mudhoo) – Shifted ground outwards passing the 700 metres forcing EMILY ROSE wider on the track. R Mudhoo was advised to exercise care when shifting ground. Stewards took into consideration some movement from CLOWNIN AROUND which also shifted ground at this point to avoid the heels of the tiring CAROLINE MARGARET. R Beeharry was also advised to exercise care when shifting ground.

CLOWNIN AROUND (R Beeharry) – Shifted outwards to avoid the heels of a tiring runner near the 700 metres.

Race 7 | **THE RED DOOR & RIVERTON PLUMBING & WRENS INVERCARGILL (1200m)**

ROCKSHOW (C Johnson) – Underwent a pre-race veterinary examination after contacting the outside fence on the way to the barriers and was cleared to race.

ROSEY POSEY (G Jogoo) – Fractious in the barriers then began awkwardly losing ground.

EASY RIDER (K Chowdhoo) – Clipped a heel and blundered passing the 700 metres.

SLINKY LINKY (K Kwo) – Raced three-wide without cover in the early and middle stages.

MR FOX (B Murray) – Placed in restricted room, having to steady passing the 600 metres when EASYRIDER was taken inwards marginally by AGAINST ALL ODDS which was laying in at this point and becoming awkwardly placed inside the heels of THE LAST THYME. After viewing replays, which were inconclusive and interviewing the riders Stewards were satisfied no one rider was at fault with the matter taken no further.

FIERY RED (T Moseley) – Raced three-wide with cover throughout.

K Chowdhoo (EASYRIDER) admitted a breach of Rule 638(3)(b)(ii) in that he used his whip in an excessive manner prior to the 100 metres. After viewing replays and hearing submissions on penalty the Judicial Committee imposed a suspension of Mr Chowdhoo's licence to ride from the 13th May up to and including the 19th May. (5 days)

Race 8 | **FIRST NATIONAL REAL ESTATE RIVERTON & MCLEAY JEWELLERS & ENGRAVERS (1200m)**

SHAM ON TOAST (T Jonker) – Late scratching on Veterinary advice at 11.45am after being injured on the float ride to the course.

SO MUCH MOUR (R Mudhoo) – Trainers K & A Tyler were issued a Minor Infringement Notice and fined \$100 when presenting this gelding with Blinkers which were not notified.

SHOW PARK (T Moseley) – Slow to begin (5 lengths.) Connections were advised a warning was placed on the barrier manners of the mare.

I'M A TIGER (S Wynne) – Obligated to race three-wide without cover through the middle stages.
