GENERAL

Stewards were advised on Wednesday 28 July that Apprentice Rider **H Schofer** was unable to attend today's meeting due to being unwell. H Schofer is to provide a medical clearance prior to riding next.

SUPPLEMENTARY

Taranaki Racing Inc - 24 July 2021

Race 1 - 24/7 SECURITY 2 & 3YO MAIDEN (1200 metres)

SUNTRIBUTE (C Jones) – Crowded entering the 800 metre bend when becoming awkwardly placed inside the heels of IDLLYWILD (C Grylls) which had shifted in and away from PULL NO PUNCHES (L Allpress) which had shifted in slightly, with SUNTRIBUTE then being steadied and clipping the heels of IDLLYWILD blundering, dislodging C Jones who was uninjured. Footage of this incident was inconclusive with riders L Allpress and C Grylls being advised to exercise care in a similar circumstance.

Race 5 POWERWORX OPUNAKE CUP (1400 metres)

POP STAR PRINCESS (J Riddell) – Co-trainer Mr F Cornege advised Stewards, the stable was satisfied with the post-race condition of the mare.

BATTLE TIME (C Grylls) – Co-trainer Mrs M Carter advised Stewards, the stable was satisfied with the post-race condition of the gelding, however, puts the disappointing performance of BATTLE TIME down to the heavy track conditions. M Carter further advised it is the stables intention to continue with BATTLE TIME'S current preparation.

Race 8 COASTA AGRI/DE LAVAL (2000 metres)

QUEEN CONSTANTINE (C Grylls) – Co-trainer Mr K Shailer reported to Stewards, the stable was satisfied with the post-race condition of QUEEN CONSTANTINE, however, has now been retired from racing.

RACE COMMENTS

Race 1 | TOD SEEDS STEEPLECHASE (4200 Metres)

THE ROLLING STONE (D Parker) - Raced in restricted room shortly after leaving the barrier and was steadied. Shifted in after jumping the final fence contacting the hind quarters of COCONUT, which shifted out.

TITTLETATTLE (G Walsh) – Jumped indifferently in the early stages.

BLACK EYED SUE (L Douglas) – Jumped indifferently in the early stages.

MATOVANI (K Joyce) – Became tailed off prior to being retired from the race near the 1000 metres.

LA JUNGLES (T Moki) - Poor jump at the fence near the 900 metres.

ZEDACE (M Cropp) - Poor jump at the fence near the 900 metres then retired from the race near the 600 metres.

ITISWHATITIS (H McNeill) – Pulled up prior to jumping the final fence.

KIPKEINO (E Farr) - Poor jump at the eighth fence. Underwent a post-race veterinary examination with no obvious abnormality detected.

SUFFICE TO SAY (R Cole) – Poor jump final fence.

COCONUT (J Seivwright) – Had its hind quarters contacted after jumping the final fence when shifting out slightly, before being corrected by its rider.

Connections of the second placed **THE ROLLING STONE** (D Parker) viewed Stewards' footage of the final 150 metres electing not to proceed with a protest.

G Walsh (REMARX) - Issued with a warning after weighing in 0.6kg overweight.

Race 2 | **JAPAC HOMES HURDLES (2800 Metres)**

LIZZED (J Seivwright) – Crowded approaching the first fence losing momentum when crowded by MRS TWINKLETOES which was forced in by ELUSIVE ACE which ran the fence down.

MRS TWINKLETOES (E Farr) – Crowded approaching the first fence losing momentum.

MASTER FIN (T Moki) – Put in a poor jump at the second fence when crowded.

REMARX (G Walsh) – Steadied 850 metres on the first occasion when awkwardly placed near heels. Steadied near the 1800 metres when becoming awkwardly placed near the heels of SENASSY which had improved to inside of THE FOT after jumping the fourth fence. Raced in restricted room approaching the 800 metres and steadied when in restricted room to the inside of MRS TWINKLETOES which was crowded by CAPTAINS RUN who had improved to the inside of THE FOT which was being corrected after running the fence down near the 900 metres.

MIZZENA (S Fannin) - Raced ungenerously in the early to middle stages.

RITESAIDZED (H McNeill) – Hampered jumping the fence near the 900 metres losing ground.

THE FOT (L Douglas) – Underwent veterinary treatment following the race after suffering a tendon injury to the right foreleg. Connections were advised that a veterinary clearance is required prior to THE FOT racing next.

CAPTAINS RUN (M Cropp) – Following the race Stewards requested a ruling from the Adjudicative Committee after Jockey M Cropp weighed in 1.2kg underweight after the incorrect gear (lead bag and packing) were applied to the wrong horse. CAPTAINS RUN was disqualified.

ELUSIVE ACE (R Cole) - Rider weighed in 1.1kg overweight after the incorrect gear (lead bag and packing) were applied to the wrong horse.

D O'Leary (CAPTAINS RUN, ELUSIVE ACE) - Admitted a breach of Rule 625(1) in that he presented both CAPTAINS RUN and ELUSIVE ACE late in the birdcage and was fined \$100 by the Adjudicative Committee.

D O'Leary (CAPTAINS RUN, ELUSIVE ACE) - Admitted a breach in that he was neglectful in saddling CAPTAINS RUN and ELUSIVE ACE late after the incorrect gear (lead bag and packing) were applied to the wrong horses. After considering submissions the Adjudicative Committee imposed a fine of \$500.

Race 3 | **ABERDEEN ON BROADWAY 1100 (1100 Metres)**

TRUE BLESSING (B Rogerson) – Slow to begin. When questioned regarding performance, Apprentice Rider B Rogerson advised that the filly was not entirely comfortable in the existing track conditions and would derive improvement from the run. Lost the off-hind plate during the running.

BROTHER ONE (M Singh) – Began awkwardly losing ground. Underwent a post-race veterinary examination which could find no abnormality.

Race 4 | **WAKA PROPERTY, BUILDING & RENOVATIONS 1200 (1200 Metres)**

HUNTERVILLE HARRY (M Hudson) - Hampered leaving the barriers losing ground.

CHEQUER BOARD (C O'Beirne) – Shifted in abruptly leaving the barriers hampering HUNTERVILLE HARRY.

METEORA (M Singh) - Began awkwardly.

LANGLEY (D Hirini) – Slow to begin. Hung throughout.

Race 5 | **BIDFOOD 2200 (2200 Metres)**

FRIDAY (B Rogerson) - Began awkwardly losing ground.

REDGUM (L Allpress) – Crowded leaving the barriers losing ground.

WEST COAST (T Taiaroa) – Shifted out abruptly leaving the barriers crowding WAIAGARA on to FATHER DOM and REDGUM, which lost ground.

FATHER DOM (S Macnab) - Crowded leaving the barriers losing ground. Crowded and hampered 750 metres when in restricted room between COUNTRY BUMPKIN (J Mudhoo), which shifted in slightly, and WAIAGARA (L Hemi) which lay out when making the bend. Riders J Mudhoo and L Hemi were both advised to exercise care when in similar circumstances.

ESTABLISHMENT (M Hudson) - Began awkwardly losing ground. Raced ungenerously near the 1400 metres.

PRECIOUS NIAMH (M Singh) – Raced ungenerously when steadied to avoid heels near the 1800 metres.

COUNTRY BUMPKIN (J Mudhoo) – Commenced to give ground from near the 800 metres. Briefly hampered near the 600 metres. When questioned regarding performance, J Mudhoo advised that the gelding was not entirely comfortable in the existing track conditions.

NOESS (K Hercock) - Briefly steadied 300 metres to avoid the heels of WAIAGARA (L Hemi), which shifted out. L Hemi was advised to exercise care.

K Hercock (NOESS) - Issued with a warning after allowing her mount to shift in passing the 1800 metres when not clear of SUPER SPIRIT which was dictated in, crowding PRECIOUS NIAMH which had to be steadied.

Race 6 | **COURTESY FORD 3YO (1400 Metres)**

FLAMING TORCH (J Parkes) - Crowded and hampered soon after leaving the barriers. Raced in restricted room approaching the 800 metres and steadied.

MYSTERY BAR (A Mudhoo) - Crowded for a distance soon after leaving the barriers and steadied then raced keenly in the early to middle stages. Made the bend awkwardly shifting out abruptly near the 300 metres.

SWEET KARMA (D Montes de Oca) - Crowded soon after leaving the barriers.

D Montes de Oca (SWEET KARMA) – Admitted a breach in that he permitted a wrongful act with respect to weighing after attempting to weigh out without his irons and leathers. After considering submissions the Adjudicative Committee imposed a fine of \$450.

Race 7 | **CHRISSY BAMBRY RACING 1550 (1550 Metres)**

HARRY HARRISON (A Mudhoo) – Blundered leaving the barriers. When questioned regarding performance A Mudhoo advised the gelding was not comfortable in today's track conditions.

WONDERFUL BARBIE (L Kauri) – Began awkwardly losing ground.

DONARDO (J Mudhoo) - Began awkwardly losing ground.

JUGADOR (D Hirini) – Began awkwardly. Crowded near the 700 metres and steadied. When questioned regarding performance D Hirini advised the gelding was not comfortable in today's track conditions.

TIRO (T Taiaroa) – Crowded 700 metres and steadied.

L Kauri (WONDERFUL BARBIE) – Issued with a warning after allowing his mount to shift out near the 700 metres when insufficiently clear of TIRO and JUGADOR which were both crowded and hampered.
