Race 3 - Homestead Sportsbar Reuben Lewis Memorial (1400m)

EMPRESS QI (W Pinn) - Following an investigation, Apprentice rider W Pinn has been charged with a breach of Rule [636(1)(b)] in that he failed to show sufficient vigour when riding EMPRESS QI in the final 400 metres when it was reasonable and permissible to do so. It will be heard at a time and date to be set by the Judicial Control Authority.

RACE COMMENTS:

Race 1 PIKE RACING PUNTERS CHALLENGE OPENER (2800 metres)

MEANT TO BE (B Donoghue) - Slow to begin. Hit the fourth fence. Put in a poor jump at the third to last fence and blundered on landing.

PRIZED PINS (H McNeill) - Slow to begin. Over-raced on a slow pace in the early stages. Improved onto the heels of THE FOT which was being restrained passing the 2400 metres clipping a heel of that runner and blundering. Hampered after jumping the third fence. Misjudged the final fence.

SON OF ANNA KAY (D Parker) - Slow to begin.

BLIZZING AWAY (M Roustoby) - Made the first jump poorly. Hampered after jumping the third fence. Contacted and unbalanced after jumping the fifth fence. Pulled up prior to jumping the final three fences. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

THE FOT (L Douglas) - Made the first jump poorly when placed in restricted room.

OLLIE (E Farr) - Made the first jump poorly when placed in restricted room. Misjudged the second fence unbalancing its rider. Hampered after jumping the fifth fence.

BULLITT (R Cole) - Hampered passing the 2400 metres. Hampered after jumping the fifth fence.

CARNABY (J Seivwright) - Hampered passing the 2400 metres.

SOUTHERN COOL (M Cropp) - Over-raced when being restrained in the early stages. M Cropp was questioned regarding the tactics he adopted in the early stages when restraining his mount excessively. M Cropp advised that he had been instructed not to lead and it was his intention to obtain cover after jumping the first fence. He agreed with

Stewards that he could have maintained a position with cover closer to the lead than he did and that he had over restrained his mount on this occasion. The riding instructions were confirmed by Trainer N Quinn. M Cropp was advised that he would be expected to show better judgement in the future and he must not leave his rides open to query.

M Cropp (SOUTHERN COOL) - Admitted a breach in that he unreasonably slowed the pace on SOUTHERN COOL for a distance in the early stages causing interference to CARNABY and BULLITT. After viewing films the Judicial Committee suspended M Cropp's licence to ride in races from the conclusion of racing on Saturday 8 May up to and including racing on Friday 14 May, 2 national riding days.

L Douglas (THE FOT) - Admitted a breach in that he unreasonably slowed the pace in the early stages on THE FOT with PRIZED PINS, which was following, clipping a heel and blundering. After viewing films the Judicial Committee suspended L Douglas' licence to ride in races from the conclusion of racing on Saturday 8 May up to and including racing on Friday 14 May, 2 national riding days.

Race 2 FAIRVIEW MOTORS WAIKATO HURDLE PRELUDE (2800 metres)

BANKS ROAD (E Farr) - Crowded shortly after the start losing ground.

EACH WAY (D Parker) - Crowded shortly after the start losing ground. Rider dropped his whip after jumping the second to last fence.

NO CHANGE (L Douglas) - Hit the third to last fence and fell dislodging its rider. L Douglas was attended to by the oncourse Doctor and transferred to hospital for further assessment. Underwent a post-race veterinary examination which found no significant abnormality other than a small abrasion to the nostril.

MAGIC CANNON (M Cropp) - Pulled up prior to jumping the final three fences. Underwent a post-race veterinary examination which failed to reveal any abnormality.

BAK DA MASTER (M Roustoby) - Was inclined to run down his fences in the final straight.

EL LUCHADOR (B Donoghue) - Rider dropped his whip passing the 75 metres.

Race 3 SVS STARTING GATES 1200

ILLUMINATION (S Collett) - Knuckled shortly after the start. When questioned regarding performance rider advised that the filly would benefit from further easing of the track.

IGOTTADOITMYWAY (E McCall) - Hampered shortly after the start losing ground.

TANGODANZER (J Kamaruddin) - Slow to begin.

ISLA JAY (S Weatherley) - Raced three wide without cover throughout.

ZOULANDER (S Spratt) - Crowded over the concluding stages having to be steadied.

OUR FINE WINE (H Schofer) - Crowded over the concluding stages having to be steadied.

THE PANTHER (C Grylls) - Raced wide without cover throughout. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality. Connections advised the gelding would now be sent for a spell.

J Fawcett (TIME TO FLY) - Issued with a warning for permitting her mount to shift in when not sufficiently clear crowding OUR FINE WINE and ZOULANDER which both had to be steadied passing the 50 metres.

Race 4 KEN & ROGER BROWNE MEMORIAL STEEPLECHASE (3900 metres)

SHAMAL (B Lammas) - Put in a poor jump at the fence near the 700 metres.

EL DISPARO (B Donoghue) - Hampered after jumping the fence near the 700 metres.

COUNTRY BUMPKIN (J Seivwright) - Hit the fence passing the 600 metres landing awkwardly unbalancing its rider. Was pulled up prior to jumping the final fence. When questioned the rider advised that after the gelding had hit the fence near the 600 metres hard, COUNTRY BUMPKIN had felt indifferent in its action and this was the reason he had retired the gelding from the event. Underwent a post-race veterinary examination which revealed a small abrasion to the left knee.

Race 5 ROTARY BOOK FAIR 14-16/5 @ TE RAPA MILE

HUGH GLASS (H Schofer) - Began awkwardly.

ELLE D'BERRY (A Calder) - Began awkwardly.

LUDUS (D Johnson) - Slow to begin.

WILLY AWAY (T Yanagida) - Raced three wide without cover in the early stages.

SAVAPPIEL (S Spratt) - Raced wide without cover for the majority of the race.

ASPIRING (S Weatherley) - Held up for the majority of the final straight having to shift outwards passing the 150 metres to obtain clear running.

SHE SPEEDS (J Parkes) - Had some difficulty obtaining clear running early in the final straight.

Race 6 METROWASTE MILE (1600 metres)

CHA SIU BAO (S Weatherley) - Began awkwardly losing ground. Hampered by fallen runner passing the 350 metres.

STAND TALL (F Lazet) - Raced three wide without cover throughout.

MARRONI (M Hashizume) - Blundered and fell passing the 350 metres. An investigation was opened and adjourned into the reasons why the gelding fell passing the 350 metres. Underwent a post-race veterinary examination which revealed the gelding to have minor abrasions to the right foreleg and had lost the upper left lateral incisor. M Hashizume was attended to by the on-course ambulance personal and Club Doctor before being transferred to hospital for further assessment.

CUTTING UP ROUGH (J Parkes) - Unable to avoid fallen runner passing the 350 metres and was bought down. Was attended to by the oncourse veterinarian and the horse ambulance and was found to have fractured its left humerus, being humanely euthanised. J Parkes was attended to by the on-course and was stood down from his remaining rides.

GERMANICUS (D Johnson) - Contacted from behind by fallen runner passing the 350 metres becoming momentarily unbalanced.

Race 7 WAIKATO EQUINE VETERINARY CENTRE 2YO STAKES (1100 metres)

NOVERRE (A Calder) - Reared as the start was affected losing considerable ground. Connections were advised that the colt would be required to barrier trial to the satisfaction of Stewards prior to racing next.

RANGI TOA (S Collett) - Slow to begin then ridden urgently to recover.

DIVINE SAVA (S Spratt) - Raced keenly in the middle stages. Checked passing the 600 metres.

CHANCELLOR (T Yanagida) - Had to be steadied after improving onto heels passing the 100 metres.

S Spratt (DIVINE SAVA) - Issued with a warning for her whip use prior to the 100 metres.

T Yanagida (CHANCELLOR) - Defended a breach of careless riding in that he permitted his mount CHANCELLOR to shift out near the 600 metres when not sufficiently clear of DIVINE SAVA which was hampered, losing ground. After viewing films, the Judicial Committee found the charge proven and suspended T Yanagida's licence to ride in races from the conclusion of racing on Sunday 9 May up to and including racing on Saturday 15 May, 4 national riding days and in addition imposed a fine of \$250.

Race 8 DUNSTAN FEEDS 1200

RUN TO PERFECTION (D Johnson) - Slow to begin. Improved onto heels passing the 100 metres having to be steadied.

JE SUIS TIGER (J Fawcett) - Knuckled shortly after the start.

MR UNIVERSE (R Elliot) - Slow to begin.

MAKTOUM (S Spratt) - Began awkwardly losing ground.

ALIGNS WITH ME (A Calder) - Slow to begin.

LONDON EXPRESS (H Schofer) - Made the bend near the 800 metres awkwardly when racing keenly.

NEW YORK JAZZ (D Danis) - Steadied to avoid heels passing the 800 metres.

TOP BRASS (J Kamaruddin) - Held up until passing the 200 metres.

PIMMS 'N' PEARLS (L Satherley) - Underwent a post-race veterinary examination which found the mare to have a wound to the left hind hock and lameness to the left hind leg. Connections were advised that a veterinary clearance would be required prior to racing next.

Race 9 #COMPLETETHEFLEET - SUPPORT THE HORSE AMBULANCE TRUST MILE (1600 metres)

MALI STON (S Weatherley) - Became cast in its barrier before being removed and undergoing a pre-race veterinary examination with the gelding being late scratched at 3:50 pm.

WIND CHIMES (T Thornton) - Underwent a pre-race veterinary examination and was cleared fit to start.

SAVEZAR (D Danis) - Slow to begin. Had to steady after improving onto heels over the concluding stages.

ALWAYS MORE (J Kamaruddin) - Slow to begin. Raced in restricted room just prior to the winning post.

MALIK (S Collett) - Raced three wide without cover throughout.

EL NYMPH (T Newman) - Raced keenly in the early to middle stages. Had some difficulty obtaining clear running early in the final straight.

SHEZAWINKLE (S Spratt) - Improved onto heels passing the 400 metres having to be firmly restrained then was held up for a distance.

TEEN TITAN (E McCall) - Held up over the concluding stages.

LAVITA VISHVI (L Innes) - When questioned regarding performance rider could offer no tangible excuse. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

LUCKY SHARK (C Grylls) - When questioned regarding performance rider could offer no tangible excuse. Underwent a post-race veterinary examination including an endoscopic examination which did not reveal any abnormality.

Race 10 TE RAPA TAVERN 1400

OSAKA (L Innes) - Slow to begin. Lay in passing the 100 metres with THUNDER shifting in and away forcing ANGARIA inwards onto TIGHTLIGN which shifted in and away crowding LIMENTIS and BRAHMS SUNSET which were both steadied. L Innes was advised to exercise care.

YAMUNA (S Spratt) - Slow to begin.

THUNDER (E McCall) - Slow to begin.

BREEZON (T Newman) - Raced keenly in the early to middle stages. Raced three wide without cover throughout.

ALL PAID UP (H Schofer) - Raced wide without cover throughout.

ANGARIA (L Satherley) - Made the bend near the 800 metres awkwardly and shifted out making contact with QUEEN CONSTANTINE which was unbalanced.

QUEEN CONSTANTINE (C Grylls) - Contacted and unbalanced passing the 800 metres.

LIMENTIS (R Elliot) - Steadied when placed in restricted room passing the 100 metres.

FRANCESCA (S Weatherley) - Rider dropped his whip passing the 300 metres.

BRAHMA SUNSET (S Collett) - Steadied when placed in restricted room passing the 100 metres.
