## Race 2 FAIRVIEW MOTORS WAIKATO HURDLE PRELUDE (2800 metres)

**NO CHANGE** (L Douglas) – Co-trainer Mr P Nelson advised Stewards, the stable was satisfied with the post-race condition of NO CHANGE and it is their intention to continue on with the gelding's current preparation.

### Race 4 KEN & ROGER BROWNE MEMORIAL STEEPLECHASE (3900 metres)

**COUNTRY BUMPKIN** (J Seivwright) – Trainer Mr N Quinn reported to Stewards, COUNTRY BUMPKIN underwent a veterinary examination on Tuesday 11 May, which revealed bruising to the small abrasion which COUNTRY BUMPKIN received during the race, and slight swelling to both front knees. N Quinn further advised; COUNTRY BUMPKIN will not partake in track work until the swelling to the knees subsides.

## Race 6 METROWASTE MILE (1600 metres)

**MARRONI** (M Hashizume) – Co-trainer Mr A Forsman advised Stewards, the stable was satisfied with the post-race condition of MARRONI, however, has now been sent for a spell.

## Race 9 #COMPLETETHEFLEET - SUPPORT THE HORSE AMBULANCE TRUST MILE (1600 metres)

**LAVITA VISHVI** (L Innes) – Trainer Mr N Tiley reported, he was satisfied with the post-race condition of the filly and further advised that LAVITA VISHVI has now been sent for a spell.

**LUCKY SHARK** (C Grylls) – Trainer Mr J Richards informed Stewards; LUCKY SHARK, will now no longer be persevered with as a racing proposition at Te Akau Racing Stable.

### **RACE COMMENTS:**

## Race 1 MATAMATA FUNCTION CENTRE 2000

**CASHEL** (C Thornton) - Began awkwardly losing ground.

**NIZONA** (E Farr) - Improved into a marginal run to the inside of MOKELE MBEMBE (J Seivwright) which was shifting in with NIZONA being crowded and steadied passing the 1800 metres. J Seivwright was advised to exercise care.

**ROCCO** (R Cole) - Had to be steadied when placed in restricted room passing the 300 metres to the inside of CONTEMPLATION which lay in despite the efforts of its rider, also inconvenienced was PANGO.

**PANGO** (T Moki) - Contacted and unbalanced passing the 300 metres.

**CONTEMPLATION** (R Elliott) - When questioned regarding performance the rider could offer no excuse.

**CURRENTLY** (S Phelan) - When questioned regarding performance the rider could offer no excuse.

**H McNeill** (LOT OF ZEES) - Issued with a warning for his whip use prior to the 100 metres.

## Race 2 PEARSON 2000

RICHARD OF YORKE (M Roustoby) - Slow to begin.

**BARBARA** (D Parker) - Held up early in the final straight, having to shift inwards to obtain clear running passing the 300 metres.

**BOBBY DEE** (R Elliott) - When questioned regarding performance the rider advised that the gelding had been unsuited to today's track condition.

**C Thornton** (HAKUNA MATATA) - Admitted a charge in that he used his whip excessively prior to the 100 metres. After hearing submissions, the Judicial Committee imposed a fine of \$300.

## Race 3 CUNNINGHAM DECORATING SERVICES 1200

**SAFANIYA** (A Goindasamy) - Began awkwardly losing ground. Steadied when placed in restricted room to the inside of MUSTANG VALLEY (L Satherley) which shifted in passing the 1000 metres. Also contributing was slight outward movement from SOCIAL DISTANCE. L Satherley was advised to exercise care.

MUSTANG VALLEY (L Satherley) - Crowded shortly after jumping away losing ground.

SHOW ME CHAMPAGNE (S Weatherley) - Forced wider when jumping away losing ground.

**DUBAI DIVA** (D Johnson) - Steadied when awkwardly placed on the heels of LOLITA which shifted in when not fully clear passing the 1100 metres.

**T Newman** (LOLITA) - Issued with a warning for allowing her mount to shift in when not sufficiently clear of DUBAI DIVA which had to be steadied when awkwardly placed on heels passing the 1100 metres.

### Race 4 MATAMATA TRACTORS & MACHINERY 1200

**MOONLIGHT SHADOW** (M McNab) - Became fractious in the barriers and was removed to undergo a veterinary examination being declared a late scratching at 1:25pm.

**DIAMOND DELIGHT** (S Collett) - Slow to begin.

**POTENZA** (T Newman) - Raced keenly in the early to middle stages when being steadied. Inconvenienced after improving into a marginal run passing the 300 metres.

**HETTY** (A Goindasamy) - Raced ungenerously for a distance passing the 1000 metres.

# Race 5 PGG WRIGHTSON/FASTTRACK 5K BONUS 1400

SHE'S APPLES (S Weatherley) - Bumped and unbalanced at the start losing ground.

**LOVETTORLEAVEIT** (R Elliot) - Crowded and steadied at the start losing ground.

**SWEET MOLLY MALONE** (S Collett) - Raced wide without cover throughout.

**MANNIE'S POWER** (T Thornton) - Underwent a post-race veterinary examination which did not reveal any abnormality.

### Race 6 MATAMATA POST & RAILS 1200

**UNCLE OBED** (A Goindasamy) - Began awkwardly losing ground.

LORD WAIRERE (D Danis) - Slow to begin.

NOIFFSORBUTTS (S Collett) - Began awkwardly losing ground.

**HE'S THE MAN** (M McNab) - Had to be steadied when placed in restricted room to the inside of CHOPPER REED (S Spratt) which shifted in passing the 1000 metres, with HE'S THE MAN then laying in and away crowding FINAL EXPRESS and SIR ALLYKHAZANN for a distance. S Spratt was advised to exercise care.

**FINAL EXPRESS** (H Schofer) - Over raced in the early and middle stages. Placed in restricted room passing the 1000 metres.

**SIR ALLYKHAZANN** (L Satherley) - Placed in restricted room passing the 1000 metres.

**ROYAL KHAN** (E McCall) - Steadied when placed in restricted room to the inside of GOSPODIN which shifted in approaching the 1000 metres. J Riddell was advised to exercise care.

**PATCH PRINCE** (Y Kumagai) - When questioned regarding the improved performance trainer A Scott advised the gelding had benefited from the easing in the track conditions compared to its previous start.

**LEGIT** (C Grylls) - When questioned regarding today's performance rider advised that in his opinion the gelding would benefit from a step up in distance.

**LOCK UP** (D Johnson) - When questioned regarding today's performance rider advised the gelding had been unsuited in today's track conditions which she described as holding adding that in her opinion it would also benefit from a step up in distance.

### Race 7 SLATTERY CONTRACTING LTD 1200

WOODCOTE LASS (C Grylls) - Hampered when jumping away losing ground. Inconvenienced passing the 100 metres.

MAISON ROXANNE (H Schofer) - Began awkwardly.

**LALA LAND** (J Kamaruddin) - Stumbled shortly after jumping losing ground. Shifted out when placed under pressure passing the 100 metres inconveniencing WOODCOTE LASS. J Kamaruddin was advised to exercise care.

**DIVINE DIVE** (A Goindasamy) - Raced keenly in the early and middle stages.

**MAKZABEEL** (M McNab) - When questioned regarding the performance the rider advised that the gelding would derive benefit from today's race.

## Race 8 DON GRIFFITHS LTD 1600

YOU STAY CLASSY (A Calder) - Slow to begin.

RISING REWARD (M McNab) - Began awkwardly losing ground.

**TAKEITEASY** (D Danis) - Knuckled passing the 1500 metres.

**ZAC BLACK** (C Jones) - Raced keenly in the early and middle stages.

**COLIN OSCOPY** (A Goindasamy) - Rider dropped his right rein before being regathered passing the 200 metres.

**LEAVE IT TO ME** (S Collett) - When questioned regarding performance the rider advised that the gelding had been unsuited to today's track condition.

**SPIRIT OF KAHA** (C Grylls) - When questioned regarding performance the rider advised that the filly had been unsuited to today's track condition.

IMA WONDER (L Satherley) - Slow to begin.

BILLY BOLD (H Schofer) - Slow to begin.

WITNESS (S Spratt) - Raced keenly in the early and middle stages.
