RACE COMMENTS:

Race 1	NP AUTO ELECTRICAL DASH 1000M
The start of this race was delayed due to ROCKET SCIENCE being fractious in the barrier.	
ROCKET SCIENCE (J Fawcett) – Late scratched after being unruly in the barrier. ROCKET SCIENCE was removed and scratched on veterinary advice at 11.45 am. Trainer J Bliss was advised the gelding must trial to the satisfaction of stewards prior to its next start.	

BUTLER (J Karamuddin) – Began awkwardly and was slow away 5L. Had some difficulty obtaining clear running early in the final straight.

PHELAN THE POWER (S Spratt) – Made the first turn awkwardly near the 800 metres and skied its head for some distance.

GAME NIGHT (B May) – Had some difficulty obtaining clear running early in the final straight.

Race 2 | **DENIS WHEELER EARTHMOVING 2600 RTG 65**

CURIOUS GEORGE (J Kamaruddin) – Reared at the start and was slow away.

PIERIAN SPRING (B May) – Raced keenly in the middle stages.

BEAR GRYLS (A Mudhoo) – Wide without cover throughout.

HYPATIA (F Lazet) – Was shown footage of her ride in the presence of the riding Master after improving into a marginal run near the 800 metres when there was insufficient room to do so. HYPATIA clipped the heels of the rapidly tiring NOTABADROOSTER, blundered and lost several lengths.

PEECEE PUSSYCAT (S Spratt) – Lay inwards under pressure in the home straight contacting with CHARRED for some distance.

CHARRED (C Dell) – Made contact and bumped in the home straight.

BEAUDACEA (D Bradley) – Bumped near the 50 metres.

Race 3 | **WHITAKER CIVIL CONSTRUCTION MDN 1200M**

PRECISION SHOOTER (A Mudhoo) – Was slow to load, trainer D Walker was advised that a warning is placed against the gelding's barrier manners. D Walker advised PRECISION SHOOTER's future will be reassessed.

BLUE ARROW (S O'Malley) – Inclined to shift in near the finish and had to be straightened.

Race 4 | **SEATON PARK MAIDEN 1400M**

WINKLE BAY (J Kamaruddin) – Slow away.

TORRENT (A Mudhoo) – Slow to start and commenced to give ground. TORRENT underwent a post-race veterinary examination which did not reveal any obvious abnormality. A Mudhoo advised the mare was unsuited to the heavy 10 track.

THE BOUQUET SLAYER (S Spratt) – Raced three wide without cover throughout.

HAERE UP (C Jones) – Raced three wide without cover throughout. C Jones was shown footage of his ride in the presence of the riding Master and issued with a warning under Rule 638(1)(d) after allowing his mount to shift out some distance in the home straight inconvenienced BROTHER MAX near the finish.

BROTHER MAX (J Fawcett) – Inconvenienced just prior to the winning post.

Race 5 | **LANDMARK HOMES 1600M**

GOBUYIT (J Fawcett) – Tightened final stages when WAY ABOVE shifted out under pressure simultaneously as JUDY'S SONG shifted in under pressure.

WAY ABOVE (T Taiaroa) – Shown footage of her ride in the presence of the riding Master and advised that she is expected to straighten her mount sooner than she did on this occasion after allowing her mount to shift out over the final stages.

JUDY'S SONG (J Kamaruddin) – Shown footage of his ride in the presence of the riding Master and advised that he is

expected to straighten his mount sooner than he did on this occasion after allowing his mount to shift in over the final stages.

D Montes de Oca (BUBBLE GUM) – Issued with a warning under Rule 648(5) for weighing slightly in excess of the weight at which he weighed out.

Race 6 | **ANTON MORA & SON MDN 1600M**

CLEESE (S Spratt) – Shifted out on jumping away and tightened UPLAND COURT (M Hudson). Shifted out under pressure near the finish having to be straightened.

UPLAND COURT (M Hudson) – Tightened at start. Steadied when improving on to heels near the 200 metres.

ONE TO DIE FOR (T Taiaroa) – Momentarily hampered near the 200 metres when SIR CALEB shifted in.

When questioned into the run of ALL IN BLACKBERRY which finished some distance last D Bradley had no excuse.

Race 7 | **ENERGY CITY FORD 1800 OPN HCP**

D Montes de Oca (BEAUDZ WELL) – Was reminded of his obligations regarding his whip use.

Race 8 | **MORE FM 1400 OPN HCP**

ROSEWOOD (H Schofer) – Slow away.

BROTHER ONE (D Montes de Oca) – Finished some distance last. Trainer K Buttimore was advised that a warning will be placed on BROTHER ONE with regard to the gelding's competitiveness.

Race 9 | **POWERWORX OPUNAKE CUP SATURDAY JULY 24TH 1400M**

RHUZICK (C Jones) – Slow away.

COOGA MOON (F Lazet) – Over raced in the early stages and had to be steadied for some distance.

KOPUA (S O'Malley) – When questioned into the run of KOPUA rider S O'Malley advised the gelding was unsuited to the heavy track and would improve with the run.
