MEGALOMANIAC (K Williams) – Trainer Mr A Carston reported to Stewards, that upon return to the stable MEGALOMANIAC, underwent a veterinary examination which included blood tests with results showing a viral infection and the gelding now being placed on a course of antibiotics. A Carston further advised he will make a decision on MEGALOMANIAC'S current racing preparation in the coming days.

D Bothamley (MAXWELL) – Issued with a warning for his whip use prior to the 100 metres.

RACE COMMENTS

Race 1 MCKEOWEN GROUP LIMITED MAIDEN 1400M

Trainers **M and M Pitman** admitted a breach of rule 614(2) for presenting their two stable runners with incorrect numbers and saddles. After hearing from all parties, the Adjudicative committee imposed a fine of \$250.

ALL SHORE (C Johnson) – Jumped away awkwardly.

KOCHANSKI (A Comignaghi) – Raced wide without cover throughout.

HOUSE OF CARDS (B Murray) – Began awkwardly.

LA OPCION (R Mudhoo) – Began awkwardly shifting in contacting Bush Mills Billy.

WESTERN DREAM (S Khetoo) – When asked to comment on the performance of the favourite the rider reported the gelding was not entirely comfortable with today's track conditions.

Race 2 NEIL RIDLEY MEMORIAL 2YO 1200M

GO LOTTE (S Khetoo) – Slow away.

ELECTRIC LADY (L Allpress) – Began awkwardly.

BIRD OF PHIRE (K Kwo) – Made the bend awkwardly getting its head up. Steadied at 300 metres.

REENVEST (M Taylor) – Lay outwards rounding the final turn.

SHOW MY SAVVY (B Rogerson) – Dictated outwards passing the 300 metres.

M Taylor (Reenvest) was issued with a warning when allowing her mount to shift out passing the 300 metres dictating Show My Savvy outwards onto Bird Of Phire which had to be steadied. 638(1)(d)

Race 3 DARRYL SIGGLEKO HARCOURTS 1200M

MY SOVA – Declared a late scratching after refusing to enter the barriers. Trainer T Kennedy was advised the gelding would be required to barrier trial on a number of occasions until Stipendiary Stewards were satisfied that its barrier

manners had improved. Trainer T Kennedy advised Stewards the gelding would be retired from his stable as a racing proposition.

THE BUFFER (T Moseley) – Slow to begin.

VINO BELLA (R Cuneen) – Slow to begin. Lost a girth pad passing the 350 metres.

KAPALKA (T Comignaghi) – Dictated wider passing the 400 metres when King Of The Castle shifted out to find clear racing room.

Race 4 BAIN MCCALL MEMORIAL 1200M

Trainer J Dalton was issued with a warning under Rule 625(1) when presenting her runner late into the birdcage.

DREAM BRAVE (B Murray) – Slow away and tailed the field throughout.

KITTY POWER (K Williams) – Rider reported the mare had not been comfortable in today's track conditions.

Race 5 OPEN COUNTRY DIARY 1200M

GOODANYA (M Taylor) – Slow away.

IMBLAZE (A Comignaghi) – Briefly held up early in the run home when awkwardly placed on the heels of Our Girl Gilly.

EL BEE DARCI (R Mudhoo) – Rider was of the opinion the gelding was not comfortable in todays testing track conditions.

T Moseley (BENAUD) - Spoken to advisedly regarding his whip use above shoulder height.

Race 6 LIVAMOL 2200M

ZAMBEZI ZIPPER (L Allpress) – Slow away. Tailed the field for the remainder of the event. Rider reported the filly had failed to handle todays testing track conditions.

FIVE PRINCES (M Taylor) – Began awkwardly.

RUBY MARIE (C Campbell) – Raced keenly in the early stages before being allowed to stride forward to lead and continued to race keenly whilst leading through the middle stages.

C Campbell (Ruby Marie) – Was spoken to advisedly regarding his whip use prior to the 100 metres.

Race 7 GLENMOA FARM LTD WAITAKI 2200M

COUNTESS RUBY (L Allpress) - Crowded between runners leaving the barriers.

YOUVEBEENLITUP (K Asano) – Shifted inwards on jumping making contact with Countess Ruby then shifted outwards away from that runner making contact with Frances Drake which was checked losing ground. Raced three wide without cover for the majority of the event.

FRANCES DRAKE (C Campbell) – Checked when crowded shortly after the start.

MAGIC IVAN (T Moseley) - Slow to begin.

ORAKA PLAYBOY (K Kwo) – Rider reported the gelding was not comfortable in todays track conditions.

Race 8 DAVE ALLEN MEMORIAL 2200M

TRANSCENDENT (S Khetoo) – Slow away then raced ungenerously whilst being restrained in the early stages losing considerable ground. Rider S Khetoo in the presence of the riding mentor D Walsh was spoken to in regards to the way the mare was restrained shortly after the start. He advised he had been instructed to let the mare settle however the mare shifted out abruptly requiring him to straighten his mount. Stewards advised him he had erred on this occasion and should have let his mount have more rein to maintain contact with the body of the field through the early stages. The rider was of the opinion the mare was not comfortable in today's track conditions.

DIAMOND RIVIERE (A Comignaghi) – Gave ground from the 800 metres and was not persevered with. Rider reported the filly had not been comfortable at any stage in today's track conditions. A veterinary examination revealed no obvious abnormality.

SLAMMER (C Campbell) – Raced three wide without cover throughout.

MR FAHRENHEIT (J Lowry) – Rider reported the gelding had not handled todays track conditions.

YING RESOLUTE (G Jogoo) – Rider reported the gelding had not handled todays track conditions.

Race 9 CROMBIE AND PRICE LTD OAMARU CUP 1600M

PICTURE ME ROLLIN (A Comignaghi) – Slow to begin.

BLUEY'S CHANCE (T Jonker) – Jumped away awkwardly losing ground.

THE GROWLER (K Asano) – Crowded leaving the barriers losing ground.

RICKY BAKER (M Taylor) – Raced very wide throughout. Trainer J Blackadder confirmed that the instructions had been to race wide on the track for better ground due to the chopped up and testing track conditions close to the running rail.

MONZA CIRCUITO (J Lowry) – Began awkwardly.

FULL FURY (L Allpress) – Rider reported the gelding had not handled todays testing track conditions.

SO MUCH MOUR (L Callaway) – Rider reported the gelding had not handled todays testing track conditions.

R Mudhoo (TAKE THE DEEL) - Admitted a breach of rule 638(3)(b)(ii) in that he used his whip excessively prior to the 100 metres. The Adjudicative Committee imposed a fine of \$300.

Race 10 EASYMADE MARMALADE LTD 1400M

GERRY JOYCE (W Papier) – Crowded and got back shortly after the start and tailed the field throughout despite the efforts of the rider.

NESTA (L Callaway) - Made the bend awkwardly by the 900 getting its head up when being steadied.

ANJAMEME (K Asano) – Raced wide without cover throughout.

S Khetoo (PINHEAD) – An enquiry was opened and adjourned into the use of the whip prior to the 100 metres due to Mr Khetoo having left the course.

W Papier (GERRY JOYCE) – Assisted by M Pitman admitted a breach of rule 638(3)(b)(ii) in that he used his whip on his mount when out of contention. The Adjudicative Committee imposed a suspension of 2 weeks from the conclusion of racing today up to and including 7 August and also imposed a fine of \$350.
