RACE COMMENTS:

Race 1 THE SAIL SPRINT 1200m

PRINCESS NADIA (R Mudhoo) – Jumped away awkwardly hampering BARRY'S CHOICE, had to be checked to avoid heels passing the 1000 metres.

BARRY'S CHOICE (C Johnson) – Hampered at the start, hung throughout the running with the rider reporting that the gelding had proved a difficult ride throughout. A post-race veterinary inspection did not reveal any obvious abnormality. The connections were advised the gelding would be placed on a racing manners warning.

LACHIE'S MATE (K Kwo) - Slow away.

TRABRUK (J Laking) – Contacted leaving the barriers being forced across the heels of TWIN SHOT and having to steady losing ground.

K Chowdhoory (TWIN SHOT) admitted a charge of careless riding in that he permitted his mount to shift inwards when not sufficiently clear of PRINCESS NADIA which was checked passing the 1000 metres. After viewing films and hearing submissions the Judicial Committee suspended K Chowdhoory's licence to ride at race meetings for 6 national days effective from the conclusion of racing on 20 May up to and including 3 June plus imposing a fine of \$500.

TWIN SHOT (K Chowdhoory) – Lay out throughout the run home having to be straightened on a number of occasions.

GEE TEE GIRL (B Murray) – Held up for clear running for several strides passing the 200 metres.

KHITAN WARRIOR (J Lowry) – Inconvenienced passing the 100 metres when dictated wider by TWIN SHOT which was laying out.

Race 2 SHAWEIGH DASH 1200m

K James (BLUEGRASS DIXIE) was issued with a warning after presenting his runner in side winkers which had not been notified.

SHUTTHEFRONTDOOR (K Kwo) – Slow to begin.

GALLERY GIRL (K Mudhoo) – Slow to begin.

BLUEGRASS DIXIE (A Balloo) – Raced wide in the early stages.

IZZY HOUDINI (R Mudhoo) – Raced three wide without cover throughout.

VAN HALEN (R Beeharry) – Lay out rounding the final turn.

MISS HARLEY QUINN (C Campbell) – Held up early in the straight having to shift outwards across heels to obtain clear running near the 250 metres.

MIND YOU (C Johnson) – Rider reported in his opinion the gelding may have been feeling the firm nature of today's track.

JACK ATTACK (J Lowry) - Rider reported the gelding had held its breath during the running.

Race 3 CSI OWNERS & TRAINERS HANDICAP 1200m

RIVERFALLS (R Beeharry) – Underwent a pre-race veterinary inspection and was cleared to race after knocking itself in the float enroute to the track. The stable representative was issued with a warning for incorrect gear. Got its head up when being steadied shortly after the start and then made the bend awkwardly passing the 1000 metres. Awkwardly placed on heels again near the 700 metres having to shift ground outwards abruptly.

MANHATTAN FLAME (D Bothamley) – Crowded leaving the barriers and then steadied to shift to a position closer to the running rail.

I AM A ROCK (A Balloo) – Had to be steadied to avoid the heels of RIVERFALLS (R Beeharry) which shifted out abruptly when awkwardly placed near heels of CELINE passing the 700 metres. Rider R Beeharry was advised to exercise greater care when shifting ground. When asked to comment on the performance of this favoured runner the rider could offer no

tangible excuse.

TENNESSEE ROCK (K Williams) – Briefly placed in restricted room passing the 200 metres when runners either side shifted ground.

Race 4 MCINTOSH CATERING 1200m

AVAQUINELLA (K Chowdhoory) – Slow to begin, held up early in the run home having to shift ground outwards to find clear racing room passing the 300 metres.

TAP 'N' GO (L Callaway) – Contacted at the start.

AUTHENTIC CHARM (C Barnes) – Raced three wide without cover throughout, hampered when forced wide rounding the final turn.

THE GREEN GREMLIN (K Kwo) – Lay out rounding the final bend running wide hampering AUTHENTIC CHARM. Reported by its rider to have hung throughout.

Race 5 OMAHA LODGE 1600m

KENKI (C Barnes) – Slow to begin.

WAIHORA MIST (K Kwo) – Slow to begin, raced three wide without cover from the 1100 metres, lay in passing the 900 metres placing DROPS OF JUPITER in restricted room, lay in early in the run home having to be straightened by its rider and continued to lay in throughout the run home.

NAMIBIA MISS (K Williams) – Raced wide without cover through the early stages.

TANTALEE (R Mudhoo) – Raced in restricted room rounding the first bend, had to be steadied away from heels when making the bend awkwardly near the 900 metres.

MR TOOL (L Callaway) – Held up in the early to middle stages of the run home.

ALL LIT UP (J Laking) – Had trouble obtaining clear running for the majority of the run home having to be steadied and shifted outwards across heels passing the 125 metres.

DROPS OF JUPITER (D Bothamley) – Rider reported in his opinion the gelding had not handled the firm nature of today's track conditions.

Race 6 DOMINATOR DOORS MILE 1600m

REDFORD (R Beeharry) – Slow to begin, held up in the run home and had to shift ground outwards passing the 200 metres to find clear racing room.

SURE IS (C Campbell) – Restrained from a wide draw to take cover shortly after the start.

SHAZ THE BANK (M Gestain) – Raced three wide without cover in the early stages.

PEARL DAVONE (C Barnes) – Over raced for a distance through the back straight and was crowded and buffeted passing the 200 metres when runners to the inside shifted out.

SENOR MOSS (A Balloo) – Raced three wide without cover from the 1000 metres.

TAPPY'S ONE (C Johnson) – Held up in the middle of the run home and when attempting to take a run made contact with PANZER

C Johnson (TAPPY'S ONE) admitted a breach of careless riding in that he angled his mount outwards passing the 200 metres dictating PANZER and LLOVIZNA outwards onto PEARL DAVONE which was crowded, buffeted and checked. After viewing films and hearing submissions the Judicial Committee upheld the charge and suspended C Johnson's licence to ride at race meetings for 6 national days effective from the conclusion of racing on 29 May up to and including 7 June and fined \$500.

PANZER (K Chowdhoory) - Buffeted 200 metres.

LLOVIZNA (T Jonker) - Buffeted 200 metres.

CHARLIE BROWN (K Williams) – A post-race veterinary inspection revealed a slow recovery rate.

Race 7 NIGHT 'N DAY STAYERS 2200m

ROCCO (B Murray) – Slow to begin losing considerable ground and was not persevered with from the 600 metres dropping out to finish a distant last. Rider reported the gelding had not handled the firm nature of today's track. A post-race veterinary inspection did not reveal any obvious abnormality.

MR FAHRENHEIT (K Kwo) – Raced three wide without cover from the 900 metres.

MIDDLE ISLAND (K Chowdhoory) – Crowded and steadied passing the 500 metres.

C Campbell (NEVETS) was issued with a warning for allowing his mount to shift out passing the 500 metres crowding MIDDLE ISLAND which had to be restrained.

Race 8 EQUINE VETERINARY SERVICES 2200m

VERMONT (A Balloo) – Blundered leaving the barriers.

ANTHINGCOULDHAPPN (K Chowdhoory) – Began awkwardly and was crowded and checked near the 2000 metres when taken in onto WANNABE 'N' PARIS, over raced through the early to middle stages.

WANNABE 'N' PARIS (C Barnes) - Hampered 2000 metres.

A Balloo (VERMONT) defended a charge of careless riding in that he permitted his mount to shift inwards near the 2000 metres when not sufficiently clear of ANYTHINGCOULDHAPPN which was checked and forced inwards hampering WANNABE 'N' PARIS. After viewing films and hearing submissions A Balloo changed his plea to admit the charge, with the Judicial Committee suspending his licence to ride at race meetings for 5 national days effective from the conclusion of racing on 28 May up to and including 5 June.

HOT TAP (C Johnson) – Held up rounding the final turn before obtaining clear running early in the final straight.

MANHATTEN AFFAIR (R Mudhoo) – Inconvenienced over the concluding stages when VERMONT (A Balloo) shifted in under pressure. A Balloo was advised to exercise greater care.

Rider K Williams was excused from weighing in after being kicked in the birdcage and requiring attention from St John Paramedics. K Williams was advised that a medical clearance is required prior to racing next.
