RACE COMMENTS	
Race 1	24/7 SECURITY 2 & 3YO MAIDEN (1200 metres)
<p>LOOX LIKE A PRO (C Dell) - Began awkwardly losing ground.</p> <p>SUNTRIBUTE (C Jones) – Crowded passing the 800 metres clipping heels and blundering, dislodging Rider Apprentice C Jones who was attended to by paramedics and cleared to fill his remaining engagements. An enquiry into the incident was adjourned.</p> <p>CALL ME LOLLY (J Mudhoo) - Crowded near the 500 metres and hampered losing ground when racing in restricted room to the inside of IDYLLWILD which was dictated in by PULL NO PUNCHES.</p> <p>KEANTOKISS (T Thornton) – Hampered 800 metres and forced wide by the riderless horse. Then hung out making the final bend awkwardly.</p> <p>L Allpress (PULL NO PUNCHES) – Issued with a warning after permitting PULL NO PUNCHES to shift in passing the 500 metres crowding IDYLLWILD on to CALL ME LOLLY which was hampered losing ground. Video footage of the incident proved inconclusive.</p>	
Race 2	SANDFORDS RURAL CARRIERS DC 100 MAIDEN (1800 metres)
<p>ROCKTILYOU DROP (E Nicholas) – Dislodged rider E Nicholas during the preliminary and galloped a short distance. Was then cleared fit to race after undergoing a subsequent veterinary examination.</p> <p>MRS BIG (C Dell) – Slow away.</p> <p>HARDTIMES (C O’Beirne) – Over raced in the early and middle stages. Over raced in the back straight.</p> <p>WHISKEY TANGO (K Hercock) - Hampered leaving the barrier.</p> <p>SACRED LADY (D Hirini) – Raced keenly in the early stages.</p> <p>OUR FAIR TRADE (J Parkes) - Hung in when placed under pressure from near the 400 metres.</p> <p>BARRACUDA (T Thornton) - Lay in under pressure in the final 100 metres contacting COLIN OSCOPY near the finish.</p> <p>COLIN OSCOPY (A Goindasamy) – Lay in when placed under pressure becoming awkwardly placed near heels passing the 250 metres. Raced in restricted room inside the final 100 metres to the inside of BARRACUDA which had to lay in and further crowded by KING KHAN which shifted out approaching the winning post.</p>	
Race 3	UBP LTD (1800 metres)
<p>CURIOUS GEORGE (C Grylls) - Began awkwardly.</p> <p>SUPER FLASH (J Parkes) - Knuckled leaving the barrier.</p> <p>SPLODGE (J Riddell) - Restrained soon after leaving the barrier.</p> <p>ZEEFA ZED (L Allpress) - Raced in restricted room passing the 1600 metres to the inside of LE GRAZIE which was dictated in marginally by LUCKY PARK (H Schofer). H Schofer was advised to exercise care in similar circumstances.</p> <p>DELUXE EDITION (T Tairaoa) – Raced in restricted room passing the 1600 metres.</p>	

D Hirini (SMOOTH COGNAC) – Issued with a warning for using her whip excessively prior to the 100 metres.

Race 4 SEATON PARK (1600 metres)

RAZORS EDGE (D Bradley) - Dislodged its rider during the preliminary. Rider D Bradley was declared fit by the paramedics with RAZORS EDGE also being passed fit to race by the veterinarian.

FAR SITE (L Allpress) – Hampered leaving the barrier.

PLATINUM STAR (A Mudhoo) - Inconvenienced 600 metres when improving on to the heels of the weakening GOODNIGHT IRENE.

ARICINA (H Schofer) - Steadied approaching the 400 metres when improving near the weakening GOODNIGHT IRENE.

RUN LIKE BOO (J Mudhoo) – When questioned into the improved performance Trainer T Bliss advised that the addition of blinkers and being able to lead today had contributed further advising that RUN LIKE BOO had also been schooling.

Race 5 POWERWORX OPUNAKE CUP (1400 metres)

MONT VENTOUX (C Dell) - Blundered leaving the barrier and dislodged Rider C Dell who was examined by the paramedic and cleared to fulfil his remaining engagements. MONT VENTOUX also underwent a veterinary examination with no obvious abnormalities being found.

ROSEWOOD (C Jones) - Slow away.

MAJOR TOM (K Hercock) – Raced keenly in the early stages and dipped approaching the 1200 metres.

BATTLE TIME (C Grylls) – Raced in restricted room for a distance passing the 1100 metres when awkwardly placed near the heels of SWEET CLEMENTINE (T Thornton) which shifted in slightly when steadying. When questioned regarding the performance Rider C Grylls advised the gelding had failed to handle the existing track conditions.

POP STAR PRINCESS (J Riddell) - Following the race POP STAR PRINCESS received veterinary attention for a superficial laceration to the left hind hock.

Race 6 REVITAL FERTILISERS (1400 metres)

BAE CORP (J Mudhoo) - Began awkwardly losing ground.

TIN SOLDIER (K Hercock) - Began awkwardly losing ground.

COOGA MOON (M Singh) – Began awkwardly losing ground.

DUBAI'S MOKO (C Dell) - Crowded approaching the 800 metres and hampered losing ground.

DAME VERA (J Parkes) – Contacted approaching the 800 metres becoming unbalanced.

C O'Beirne (CHEEKY AZZ) - Admitted a charge of careless riding in that she permitted CHEEKY AZZ to shift in near the 800 metres when insufficiently clear of DUBAI'S MOKO which was hampered. After considering submissions the Adjudicative Committee suspended her licence to ride in races from the conclusion of racing on Saturday 31 July up to and including racing on Wednesday 4 August, 2 national riding days.

Race 7	SINCLAIR ELECTRICAL & REFRIGERATION SC MAIDEN (1400 metres)
<p>ODE TO JOY (D Bradley) – Rider D Bradley was struck in the face soon after mounting ODE TO JOY suffering a facial injury and was stood down. ODE TO JOY was then declared a late scratching at 3.20pm.</p> <p>ORLA (C O’Beirne) – Proved difficult to load. Connections were advised that a warning will be placed on the mare’s barrier manners. Slow to begin then becoming detached from the body of the field. Apprentice Rider C O’Beirne reported the mare had failed to hit out at any stage of the race. A post-race veterinary examination revealed the mare to be lame in the left hind leg. Connections were advised that a veterinary clearance is required before the next start.</p> <p>TENNESSEE ROSE (M Singh) - Began awkwardly losing ground.</p> <p>RETURNTOSEDA (E Nicholas) – Began awkwardly losing ground.</p> <p>TED LASSO (J Riddell) – Lay out in the early to middle stages.</p> <p>TUMBRIL (L Hemi) – Shifted out to avoid heels 900 metres when racing keenly.</p> <p>LADIES MAN (H Schofer) – Held up until shifting out approaching the 200 metres to obtain clear running.</p>	
Race 8	COASTA AGRI/DE LAVAL (2000 metres)
<p>OBRIGADO (F Lazet) – Slow away. Hampered 350 metres.</p> <p>CARPE DIEM (T Taiaroa) - Shifted out passing the 250 metres to obtain clear running.</p> <p>QUEEN CONSTANTINE (C Grylls) – Commenced to give ground rapidly rounding the home turn. Briefly steadied when awkwardly placed near the 300 metres. When questioned regarding the performance Rider C Grylls advised the mare was unsuited to the track which he described as holding.</p> <p>PENELOPE CRUISE (L Allpress) - Hampered passing the 350 metres when improving into restricted to the outside of QUEEN CONSTANTINE which was weakening. OBRIGADO was also hampered as a result.</p> <p>J Riddell (ENGLISH GAMBLER) - Issued with a warning for using his whip excessively prior to the 100 metres.</p>
