Race 3 HOMESTEAD SPORTSBAR REUBEN LEWIS MEMORIAL 1400

W Pinn admitted a breach within the meaning of Rule 636(1)(b) in that being the holder of a Class B Jockey's licence he failed to take all reasonable and permissible measures throughout the race to give EMPRESS QI full opportunity to obtain the best possible finishing placing in that he failed to show sufficient vigour in the final straight when it was both reasonable and permissible to do so. After considering submissions the Judicial Committee suspended W Pinn's licence to ride in races from the conclusion of racing on Saturday 29 May up to and including racing on Saturday 10 July 2021, 6 weeks.

Woodville-Pahiatua Racing Club - Sunday 09 May 2021

Race 9 WOODVILLE-PAHIATUA CUP 1600 metres

W Pinn admitted a breach within the meaning of Rule 636(1)(b) in that being the holder of a Class B Jockey's licence he failed to take all reasonable and permissible measures throughout the race to give NOT SANTA full opportunity to obtain the best possible finishing placing in that he failed to maintain contact with the body of the field allowing NOT SANTA to drift approximately 10 lengths behind the last horse in the race when there was the opportunity to maintain contact with the body of the field. After considering submissions the Judicial Committee suspended W Pinn's licence to ride in races from the conclusion of racing on Saturday 10 July up to and including racing on Saturday 31 July 2021, 3 weeks.

RACE COMMENTS:

Race 1 SVS STARTING GATES HURDLE (2800 metres)

PRIZED PINS (H McNeill) - Slow to begin. Put in a poor jump at the second to last and final fence.

CHIEF SEQUOYAH (E Farr) - Knuckled when jumping away. Misjudged the final fence landing awkwardly.

RAUCOUS (A Kuru) - Misjudged the second fence.

ULUAKI (B Donoghue) - Pulled up prior to jumping the final two fences.

NOTABADROOSTER (R Cole) - Crowded having to be steadied passing the 2550 metres. Raced ungenerously in the early to middle stages. Commenced to give ground passing the 800 metres and was pulled up by its rider prior to jumping the final three fences. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

H McNeill (PRIZED PINS) - Reminded of his obligations in that he must retire his mounts from the race when they have become tailed off.

T Moki (JAKKI SPARROW) - Issued with a warning for permitting her mount to shift in near the 2550 metres when not sufficiently clear of ULUAKI which was forced in with NOTABADROOSTER having to be steadied to avoid heels.

Race 2 FAIRVIEW MOTORS WAIKATO HURDLE (3200 metres)

DELEGATE (H McNeill) - Crowded shortly after the start.

TOMMYRA (R Cole) - Crowded shortly after the start.

BAK DA MASTER (M Roustoby) - Shifted in prior to jumping the third to last fence hampering ALI BABA. Hit the final fence losing momentum with the rider becoming momentarily unbalanced.

ALI BABA (J Seivwright) - Hampered when jumping the third to last fence.

THE COSSACK (A Kuru) - Hit the final fence.

B Donoghue (EL LUCHADOR) - Issued with a warning for leaving the jockeys area without permission prior to the running of race three.

Race 3 TE AKAU RACING 1200

GOODO JO (J Fillmore) - Underwent a veterinary examination after being late to arrive on course. GOODO JO was again subject to a veterinary examination upon arrival at the barrier and was declared fit to race. Began awkwardly then crowded. Hampered having to be steadied passing the 450 metres.

MISCONDUCT (E Leighton) - Began awkwardly losing ground.

ROW OF EIGHTS (L Satherley) - Raced in restricted room soon after leaving the barrier. Had some difficulty obtaining clear running passing the 400 metres.

NORTH OF HAVANA (C Jones) - Steadied from a wide barrier. Lay in and away from ROW OF EIGHTS passing the 450 metres hampering GOODO JO which had to be firmly restrained. C Jones was advised to exercise care in a similar circumstance.

MACH SCHNELL (M Hashizume) - Raced wide without cover.

PAPENHUYZEN (T Newman) - When questioned regarding the performance rider advised that the gelding had been unsuited by today's track conditions.

Race 4 TE RAPA FUNCTION CENTRE STEEPLECHASE (3900 metres)

NO CHANGE (A Kuru) - Began awkwardly making firm contact with YARDARM with the rider becoming briefly unbalanced.

GRANDISCOCCYMELUMS (H McNeill) - Landed awkwardly after jumping the fifth fence. Hampered after jumping the sixth fence.

THE ROLLING STONE (D Parker) - Jumped indifferently throughout. Pulled up prior to jumping the final fence. When questioned the rider advised that the gelding would benefit from some easing in the ground. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

LOCALLY SAUCED (R Cole) - Knuckled after jumping the sixth fence dislodging its rider hampering GRANDISCOCCYMELUMS and PIERIAN SPRING. Rider R Cole was uninjured. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

ZINZAN (B Donoghue) - Knuckled on landing after jumping the final fence.

PIERIAN SPRING (E Farr) - Hampered after jumping the sixth fence.

TITTLETATTLE (T Moki) - Pulled up prior to jumping the final fence.

THE FOT (N Downs) - Pulled up prior to jumping the final fence.

D Parker (THE ROLLING STONE) - Reminded of his obligations in that he must retire his mounts from the race when they have become tailed off.

T Moki (TITTLETATTLE) - Was questioned as to the reasons why she had not made a greater attempt to maintain contact with the body of the field in the early and middle stages. T Moki advised that the mare had been outpaced and, in her opinion, would benefit from some easing of the ground adding that when she did urge TITTLETATTLE the mare had not responded. T Moki's explanation was noted however she was advised that she would be expected to make a greater attempt than she did on this occasion.

T Moki (TITTLETATTLE) - Reminded of her obligations in that she must retire her mounts from the race when they have become tailed off.

E Farr (PIERIAN SPRING) - Admitted a charge in that she used her whip excessively over the concluding stages when using her whip in consecutive strides. After hearing submissions, the Judicial Committee imposed a fine of \$300.

Race 5 SIGNATURE HOMES WAIKATO STEEPLECHASE (3900 metres)

K Duncan (SHAMAL) - Issued with a warning for presenting SHAMAL to race without the notified tongue tie.

SHAMAL (B Lammas) - Put in a poor jump at the second to last fence making heavy contact.

MAX (J Seivwright) - Shied at displaced boards when jumping the second to last fence.

Race 6 BCD GROUP 2100

TWIN SPINNER (T Thornton) - Crowded soon after leaving the barrier.

STARRYBEEL (A Goindasamy) - Began awkwardly.

UAREASTAR (M McNab) - Restrained to avoid the heels of JUNIOR (E Leighton) which shifted in when not fully clear passing the 1850 metres. E Leighton was advised to exercise care in a similar circumstance.

PURSUED (D Danis) - Raced ungenerously when being restrained approaching the 1400 metres when the pace steadied. L Satherley was reminded of her obligations in that she must not steady the pace to a degree that places riders behind her in difficulty.

RANGER (L Satherley) - Raced ungenerously when being restrained in the early stages.

SONOFABUTCHER (E McCall) - Had some difficulty obtaining clear running early in the final straight.

EVEN CHANCE (A Calder) - Held up for a distance passing the 400 metres.

JAMES BARRIE (S Weatherley) - When questioned regarding the performance rider advised that the gelding had failed to handle the existing track conditions.

Race 7 SKYCITY HAMILTON MILE (1600 metres)

GERI (C Jones) - Knuckled soon after leaving the barriers crowding HIBERNIA SEA onto LET'Z AV BUBBLES which had begun awkwardly.

LETZ'AV BUBBLES (S Spratt) - Began awkwardly. When questioned regarding performance rider advised that the mare may have been unsuited by today's track conditions. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

SHEZDELICIOUS (M Hashizume) - Slow to begin. Had to be steadied when improving into restricted room just prior to the winning post.

DEVOTED (J Kamaruddin) - Steadied to avoid the heels of SPEED OF LIGHT which shifted in when not fully clear passing the 1400 metres. D Danis was advised to exercise care in a similar circumstance.

PLAYSAMEANPINBALL (S Weatherley) - When questioned regarding performance rider advised that the gelding had failed to handle today's track conditions.

Race 8 DUNSTAN FEEDS 1400

STEVEN JAMES (L Satherley) - Began awkwardly losing ground.

RUN TO PERFECTION (M McNab) - Slow to begin.

CRAFTY JESS (T Newman) - Raced in restricted room for a distance rounding the final bend. When questioned regarding performance the rider could not offer any excuse.

BREEZON (S Spratt) - Steadied when placed in restricted room approaching the 350 metres to the inside of SUMMER MONSOON which shifted in slightly and outside of RUN TO PERFECTION which improved into a marginal run outside of MASETTO which then shifted out slightly.

E Leighton (BATTLE TIME) - Issued with a warning for her whip use prior to the 100 metres.

Race 9 VALACHI DOWNS FOXBRIDGE PLATE DAY 28/8 (1400 metres)

LONDON BOUND (M McNab) - Slow to begin. Raced keenly for a distance passing the 1200 metres.

OUR BEESKEES (J Kamaruddin) - Hampered soon after leaving the barrier.

MY WORLD (C Jones) - Crowded soon after leaving the barrier.

KYA KHOOB LAGTI HO (M Hashizume) - Began awkwardly then restrained.

RIVER RUN (A Goindasamy) - Began awkwardly then restrained.

MAKE TIME (S Spratt) - Raced ungenerously in the early to middle stages.

LILY D'OR (E McCall) - Lost the right front plate during the running. Had to be steadied after becoming awkwardly placed on the heels of LONDON BOUND which shifted out passing the 600 metres. Also inconvenienced as a result was LAVAGLO.

LAVAGLO (T Thornton) - Inconvenienced passing the 600 metres.

M McNab (LONDON BOUND) - Issued with a warning for allowing his mount to shift out when not fully clear of LILY D'OR which had to be steadied to avoid heels passing the 600 metres.
