## RACE COMMENTS:

<b>Race 1</b>	<b>WANGANUI TARANAKI OWNERS ASSN "PAKARAKA STAR" MDN (2000 Metres)</b>
<b>BALLINA</b> (T Taiaroa) – Began awkwardly. Had to steady near the 1400 metres.	

**BIG HEMA** (M Hudson) – Slow to then tailed the field throughout. Connections were advised that a warning would be placed against the mare for its non-competitiveness. Trainer P Pascoe indicated that BIG HEMA was now likely to be retired as a racing proposition.

**FORT WILLIAM** (R Elliot) – Began awkwardly.

**NYMENCHE** (S Weatherley) – Began awkwardly

**LAVA ROCK** (C Dell) – Steadied and placed in restricted room going into the first turn near the 1700 metres when racing to the inside of NOTHINGSWEETABOUTME (E Leighton), which shifted inwards when awkwardly placed near the heels of DAYLIGHT (S MacNab). Raced ungenerously getting its head up for a distance rounding the bend passing the 1500 metres.

**NOTHINGSWEETABOUTME** (E Leighton) – Steadied when awkwardly placed near the heels of DAYLIGHT near the 1700 metres.

**S MacNab** (DAYLIGHT) – Issued with a warning after permitting her mount to shift inwards near the 1700 metres when not fully clear of NOTHINGSWEETABOUTME.

**NUN HISSING** (S Collett) – Got its head up and raced ungenerously when being steadied near the 1700 metres and had to ease again near the 1400 metres when in restricted room.

**SIR CALEB** (J Riddell) – Got its head up and raced ungenerously for a distance near the 1400 metres.

**CAPTION** (D Hirini) – Was held up and unable to improve for some distance in the home straight and went to the line without being fully tested.

**R Elliot** (FOR WILLIAM) – Issued with a warning for his whip use with his arm raised above shoulder height.

**ROULADE** (H Schofer) – Began awkwardly.

**DREAM MACHINE** (A Mudhoo) – Began awkwardly, steadied passing the 800 metres when improving on to heels and was in restricted room from the 600 metres until near the 400 metres.

**MI DREAM** (F Lazet) – Raced three wide without cover throughout.

**DAME VERA** (S Collett) – Inconvenienced near the 1000 metres when TICKLE ME ALMO (T Yanagida) shifted outwards when not fully clear. T Yanagida was advised to exercise greater care when shifting ground.

**FIGHTING FIRE** (B Rogerson) – Slow to begin. Hampered near the finish.

**PLUTON** (B Rogerson) – Began awkwardly.

**MISS RICKY BOBBY** (L Allpress) – Shifted out abruptly when shying at the winning post and in doing so hampered FIGHTING FIRE.

<b>Race 4</b>	<b>HARD TIMES SYND "BATTLE DRESS" MAIDEN (1200 Metres)</b>

**PASHAMALA** (T Yanagida) – Commenced to buck for a short distance after the start. Trainer C Dravitzki was advised the filly is required to trial satisfactorily prior to racing again.

**LEON ROUGE** (K Hercock) – Over raced in the early and middle stages.

**MISS DIXIE** (L Allpress) – Lay out under pressure in the home straight.

**Race 5** | **TRANSAG “ÖUR PADDY BOY” MAIDEN (1400 Metres)**

**DARLINGTON COUNTY** (S Macnab)– Slow to begin. Lay out under pressure in the home straight.

**GO MICKEY** (T Yanagida) – Hampered at the start by REDGUM which began awkwardly.

**PARDON** (H Schofer) – Crowded losing ground shortly after the start. Steadied off heels near the 900 metres.

**THE BOUNDER** (L Hemi) – Over raced in the early stages. Raced three wide without cover throughout.

**OUR FAIR TRADE** (S Collett) – Held up for clear running early in the home straight.

**BLUE ARROW** (S O’Malley) - Held up for clear running early in the home straight.

**ELEGANT CHARM** (C Dell) – Held up for clear running in the early part of the home straight.

**Race 6** | **UHLENBERG HAULAGE “THE FILBERT” (1100 Metres) RATING 65**

**IRISH ODDS** (H Schofer) – Slow to begin.

**TRIFOLIUM** (A Mudhoo) – Steadied away from heels shortly after the start. Held up passing the 400 metres prior to being angled wide in order to improve.

**EL NOIR** (M McNab) – Raced wide without cover throughout.

**MAGNESS** (C O’Beirne – Hung outwards throughout.

**Race 7** | **HOLDEM CONTRACTING “EVEN TERMS” MAIDEN 3YO (1600 Metres)**

**WIND IN MY WINGS** (K Hercock) – Dislodged rider K Hercock behind the barrier and after being recaptured was examined by the Veterinary Surgeon and was cleared to race. K Hercock was unhurt.

**WALK THE WALK** (A Goindasamy) – Slow to begin. Checked near the 700 metres when attempting a run to the outside of WINKLE BAY which did not eventuate. A Goindasamy was shown footage of his ride in the present of the Riding Master and advised to exercise greater care.

**SKYROCA** (S Macnab) – Slow to begin.

**WINKLE BAY** (S Collett) – Slow to begin. Disappointed. S Collett was of the opinion the filly did not travel well with the removal of blinkers and in her opinion may be feeling the effects of recent racing. A subsequent veterinary examination failed to reveal any abnormality.

**BARACUDA** (H Schofer) – Was inclined to shift out under pressure in the home straight.

**CASTLE ON THE HILL** (D Montes de Oca) – Was shown footage of his ride in the presence of the Riding Master and issued with a warning after allowing his mount to shift outwards in the home straight and bumping WHETU near the finish.

**RONIN POROTENE** (F Lazet) – Briefly inconvenienced near the 150 metres when CASTLE ON THE HILL shifted inwards.

**WHETU** (S Weatherley) – Bumped near the finish.

**Race 8** | **NZB INSURANCE PEARL SERIES RACE “MY BINNIE”MAIDEN (1600 Metres)**

**PINSK** (D Montes de Oca) – Began awkwardly.

**TRUEFALLS** (S Collett) – Began awkwardly.

**ALEGRE** (S Macnab) – Steadied when awkwardly placed near heels passing the 1400 metres.

**SPANISH ANGEL** – (M Hudson) – Badly unbalanced when contacted rounding the bend near the 1250 metres by **PARTY BELT** which in turn had been bumped outwards by **HALF OF NOTHING**, after that runner was contacted by **LA RAPIDE** (S Weatherley) which had been racing tight to its inside and in turn had been contacted by **MISS INTERPRET** which lay out on the point of the corner, after racing in restricted room. Raced wide without cover throughout.

**MISS INTERPRET** (A Goindasamy) – Lay out making the bend near the 1250 metres after racing in restricted room.

**LA RAPIDE** (S Weatherley) – Contacted when racing in restricted room near the 1250 metres.

**HALF OF NOTHING** (E Leighton) – Steadied to avoid the heels of **SMOOTH COGNAC** passing the 1400 metres then commencing to over race getting its head up and shifted outwards making contact near the 1250 metres.

**PARTY BELT** (T Taiaroa) – Contacted near the 1250 metres.

**SPACEK** (M McNab) – Held up rounding the final turn and in the straight being unable to obtain clear running until approaching 50 metres.

**PLATINUM BOARDEAUX** (J Riddell)– Had to be steadied when placed in restricted room near the 250 metres.

**D Montes de Oca** (PINSK) – Admitted a charge in that he used his whip excessively prior to the 100 metres being eight strikes including five strikes in consecutive strides. After hearing submissions the Judicial Committee imposed a fine of \$500.

**Race 9** | **ELTHAM VET SERVICES “COPPER BELT”1600 (1600 Metres) RATING 65**

**METRO WINNER** (L Hemi) – Became fractious after entering the barriers and was removed being declared a late scratching at 4.25 pm acting upon Veterinary advice. Trainer P Lock was advised that **METRO WINNER** must barrier trial to the satisfaction of the Stipendiary Stewards prior to racing next.

**POWER ‘N’PASSION** (S Collett) – Slow to begin. Crowded near the 1000 metres.

**BRINGITONPET** (S Macnab) – Crowded at the start losing ground.

**SHEZABELTA** (C Dell) – Became awkwardly placed on heels near the 1000 metres and shifted inwards crowding **POWER N’ PASSION**.

**MAUNA LOA** (K Hercock) – Over raced near the 1000 metres when the pace eased. Held up rounding the final turn and did not obtain clear running until near the 200 metres.

**I AM A CRAFTSMAN** (L Allpress) – Over raced near the 1000 metres when the pace eased.

**CARPE DIEM** (D Bradley) – Had to be steadied when improving on to heels near the 1000 metres.

**TOUCH THE CLOUDS** (A Goindasamy) – Steadied for some distance in the back straight when on the heels of MISTEREX.

**GAMEOUT** (S Weatherley) – Shifted ground inwards over the final stages.

**LUCKY PARK** (T Yanagida) – Shifted ground inwards final stages.
