RACE COMMENTS:

Race 1	NUFARM HURDLE 2500
<p>MY TOMMY (M Gibbs-Manssen) - Crowded shortly after the start. Hit the fence near the 600 metres. M Gibbs-Manssen was questioned regarding the perceived lack of vigour shown between the 500 metres and the 400 metres. M Gibbs-Manssen explained that after jumping the fence near the 600 metres awkwardly the gelding had felt indifferent in its action for several strides. Further adding he had considered retiring MY TOMMY from the race before the gelding responded and its action improved shortly after. MY TOMMY then finished the race off fairly. A post-race veterinary examination did not reveal any abnormality.</p> <p>MR FLYNN (E Farr) - Raced keenly early so was taken forward. Put in a poor jump at the final fence.</p> <p>BAKELA (S Fannin) - Raced in restricted room to the inside of PHELAN FOXY (B Donoghue), which was forced inwards by SHACKLETON'S EDGE (M Roustoby) passing the winning post on the first occasion. M Roustoby was advised to exercise care. Raced in restricted room just prior to the winning post to the inside of CARNABY (J Seivwright), which shifted in. J Seivwright was advised to exercise care.</p> <p>CARNABY (J Seivwright) - Hit the fourth fence. Made contact with the final fence.</p> <p>CLASS ABOVE (D Parker) - Put in a poor jump at the fence near the 600 metres losing ground.</p>	
Race 2	AGRITRADE VALAGRO HIGHWEIGHT 2500
<p>SHADOW KING (S O'Malley) - Slow to begin.</p> <p>LA JUNGLES (M Gibbs-Manssen) - Slow to begin. The saddle shifted forward going into the back straight placing the rider at a disadvantage for the remainder.</p> <p>K Macnab (FANTASY FLIGHT) - Admitted a breach of Rule 638(3)(b)(ii) in that she used her whip excessively prior to the 100 metres. After hearing submissions, the Judicial Committee imposed a fine of \$300.</p> <p>M Cropp (NEDWIN) - Admitted a breach of Rule 638(3)(b)(ii) in that he used his whip excessively prior to the 100 metres. After hearing submissions, the Judicial Committee imposed a fine of \$300.</p> <p>S Fannin (TALLYHO TWINKLETOE) - Was spoken to regarding his whip use prior to the 100 metres.</p>	
Race 3	CORTEVA AGRISCIENCE 2100
<p>FIRE DANCER (J McIlroy) - Slow away and settled back.</p> <p>DRAGON REALM (N Smith) - Slow away.</p> <p>OUR CUZZIE (S Malki) - Raced wide without cover throughout. Went amiss entering the home straight and was pulled up. Was immediately attended to by the on-course veterinarian and the horse ambulance. OUR CUZZIE was found to have fractured the right hind fetlock being humanely euthanized.</p>	
Race 4	YARA FERTILISER 1100
<p>CANCHERO (J Riddell) - Underwent a pre-race veterinary examination and was cleared to start after breaking through its barrier stall. Steadied when placed in restricted room to the inside of VIN ROUGE (A Mudhoo) which shifted in passing the 750 metres. Checked passing the 300 metres.</p> <p>DENY (L Hemi) - Shifted out abruptly at the start dictating DARCI'S FLIGHT outwards on to OLD TOWN ROAD, which in turn shifted into the line of AND WE DANCED, which got back. Hampered having to be steadied passing the 300 metres.</p>	

EUPOLIA (S Collett) - Began awkwardly and was slow away. Held up early in the final straight then improved into restricted room between EXPRESS DESIRE and EAGLE COUNTY, having to be steadied passing the 100 metres.

PINK CHAMPAGNE (K HercocK) - Slow to begin.

AURORA STAR (T Yanagida) - Had to be steadied to avoid the heels of EAGLE COUNTY which shifted in approaching the 800 metres. D Bradley was advised to exercise care. Hampered having to be steadied passing the 300 metres.

EAGLE COUNTY (D Bradley) - Raced wide without cover.

EXPRESS DESIRE (T Newman) - Held up early in the final straight.

AND WE DANCED (S Macnab) - Hampered at the start losing ground. Held up early in the final straight.

OLD TOWN ROAD (R Aukett) - Had to shift out passing the 300 metres to obtain clear running.

R Aukett (OLD TOWN ROAD) - Admitted a breach of careless riding in that he allowed his mount to shift out near the 300 metres when not clear of DENY (L Hemi), AURORA STAR (T Yanagida) and CANCHERO (J Riddell), which were all hampered. After hearing submissions, the Judicial Committee suspended R Aukett's licence to ride in races from the conclusion of racing on Saturday, 29th May up to and including racing on Sunday, 6th June (5 national riding days) and in addition imposed a fine of \$300.

V Wilson (SPYDAPUS)- Was issued with a warning for presenting SPYDAPUS to race without the notified ear covers.

LILLY LAGUNA (L Hemi) - Raced three wide without cover throughout.

RIPEMGINI (K HercocK) - Had difficulty obtaining clear running until passing the 200 metres.

LUDUS (C Grylls) - Tightened at the start when SAVEZAR shifted in.

SAVEZAR (D Dannis) - Lay inwards and away from SAVASTEP near the 1800 metres having to be steadied and went back on to PLATINUM PETALS.

PLATINUM PETALS (K HercocK) - Steadied when placed in restricted room passing the 1800 metres.

RED RUFUS (A Goindasamy) - Shifted out passing the 300 metres making contact with SAVASTEP when improving into a tight run then lay out and away from EL NYMPH, which shifted out slightly. Shifted outwards having to be straightened by its rider passing the 150 metres.

SAVASTEP (S Collett) - Contacted and forced wider passing the 300 metres.

R James & R Wellwood (SAVEZAR) - Issued with a warning for presenting their runner without the notified tongue tie.

Following the race connections of the 3rd placed **RED RUFUS** lodged a protest against the 1st placed **EL NYMPH** alleging interference in the final straight. After hearing submissions, the Judicial Committee dismissed the protest.

Following the race D Danis advised Stewards that he was unwell and was subsequently stood down for his remaining rides.

<p>TAIKA (L Hemi) - Slow to begin.</p> <p>WITSABOUTHIM (M McNab) - Began awkwardly. Held up until approaching the 100 metres.</p> <p>LORD WAIRERE (K Hercock) - Raced keenly in the early and middle stages.</p> <p>HEARTSTOPPER (L Allpress) - Raced wide without cover until near the 800 metres.</p>	
Race 8	BALANCE AGRI-NUTRIENTS 3YO 1400
<p>LIGHTNING MISS (A Mudhoo) - Stewards permitted A Mudhoo to replace D Danis as there was no other suitable senior rider available. Slow to begin.</p> <p>BE SOMEBODY (T Newman) - Shifted in at the start bumping PALATINATE.</p> <p>PALATINATE (A Goindasamy) - Bumped shortly after the start.</p> <p>ZA CEIBAS (J Riddell) - Slow away.</p> <p>SHE'S SO RELIABLE (L Hemi) - Inconvenienced passing the 350 metres by LA BELLARINA, which shifted out slightly.</p> <p>VELOCE SORELLA (D Hirini) - Lay out rounding the final bend.</p> <p>K Hercock (SERENGETI) - Issued with a warning for her whip use prior to the 100 metres.</p> <p>ZA CEIBAS (J Riddell) - Spoken to regarding his whip use prior to the 100 metres.</p>

<p>LINCOLN DREAMER (T Taiaroa) - Began awkwardly losing ground.</p> <p>LORNA DOON (L Hemi) - Raced ungenerously in the early and middle stages.</p> <p>ESTEFANIA (D Hirini) - Raced in restricted room passing the 1200 metres to the inside of EXCITONIC which became awkwardly placed on the heels of RABADA (C Grylls), which shifted in when not fully clear. C Grylls was advised to exercise care.</p> <p>LANDRY (J Riddell) - Shifted out passing the 300 metres making contact with the hind quarters of EXCITONIC, which then lay in for a distance, having to be corrected by its rider. J Riddell was advised to exercise care.</p> <p>EXCITONIC (J Kamaruddin) - Had its hind quarters contacted passing the 300 metres, becoming unbalanced for a distance.</p>
