Race 7 SKYCITY HAMILTON MILE (1600 metres)

LETZ'AV BUBBLES (S Spratt) – Stable representative Mr R Mildon advised Stewards, that on Monday 24 May, LETZ'AV BUBBLES underwent blood tests which revealed no abnormalities. R Mildon further advised it is the stables intention to continue on with the mare's current preparation.

RACE COMMENTS:**Race 1** | **CHOOKY'S AUTO 2200**

RICHARD OF YORKE (M Roustoby) – Began awkwardly losing ground.

LOVETTORLEAVEIT (C Chipperfield) – Crowded 2100 metres and steadied when awkwardly placed inside the heels of MAGIC CANNON which shifted in when not sufficiently clear.

CALL ME BOB (D Parker) – Raced in restricted room near the 1800 metres. Steadied when awkwardly placed on the heels of ARITE GURU which shifted in when not fully clear. When questioned regarding performance rider D Parker advised that he was briefly held up early in the final straight with the gelding finishing the race off disappointingly and was unable to offer any other reason.

RENEGADE FIGHTER (M Gibbs-Manssen) – Shifted out approaching the 1000 metres making contact with PATSYS LAD which became briefly unbalanced.

RISING RANSOM (E Farr) – Lay out near the 400 metres when weakening, crowding ARITE GURU onto the hindquarters of PATSYS LAD which became unbalanced.

PATSYS LAD (R Cole) – Crowded 400 metres becoming unbalanced. Crowded and checked 300 metres.

S Phelan (MAGIC CANNON) – Issued with a warning after permitting MAGIC CANNON to shift in when not sufficiently clear of LOVETTORLEAVEIT near the 2100 metres.

E Farr (RISING RANSOM) – Issued with a warning after allowing RISING RANSOM to shift out passing the 400 metres when insufficiently clear of ARITE GURU who shifted out making contact with the hindquarters with PATSYS LAD which became unbalanced.

M Gibbs-Manssen (RENEGADE FIGHTER) – Admitted a breach of careless riding in that he permitted RENEGADE FIGHTER to shift in near the 300 metres when not sufficiently clear of PATSYS LAD which was crowded and checked. After considering submissions the Judicial Committee suspended M Gibbs-Manssen’s licence to ride in races from the conclusion of racing on Friday 04 June up to and including racing on Thursday 10 June, 2 national riding days and in addition imposed a fine of \$250.

IMA WONDER (H Schofer) – Began awkwardly losing ground.

MOKELE MBEMBE (S Weatherley) – Began awkwardly.

ZION HILL (L Satherley) – Slow to begin. Inconvenienced 450 metres by TAKEITEASY which shifted out slightly, and again at the 250 metres. E Leighton was advised to exercise care.

RISING REWARD (M McNab) – Raced keenly in the early stages

BULLISH (T Yanagida) – Raced ungenerously when being steadied in the early to middle stages.

FLICK ON (T Newman) – Made the first bend awkwardly when racing keenly, running wide.

DUSKY EYES (A Calder) – Lost the left front plate during the running.

L Satherley (ZION HILL) – Admitted a breach in that she used her whip excessively prior to the 100 metres and was fined the sum of \$300 by the Judicial Committee.

E Leighton (TAKEITEASY) – Issued with a warning for excessive use of the whip prior to the 100 metres.

ROCTHEPARTY (M Roustoby) – Steadied from a wide barrier.

BEAU ARCHERS ROSE (N Downs) – Began awkwardly.

MR GHIBSON (R Cole) – Raced keenly when being restrained in the early stages.

MALARKEY (C Thornton) – Commenced to over-race when being steadied near the 1400 metres for a distance. Made the bend awkwardly passing the 1000 metres having to be steadied.

S Phelan (JUDAH) – Admitted a breach in that he used his whip excessively prior to the 100 metres and was fined the sum of \$300 by the Judicial Committee.

H McNeill (TAUMALOLO) – Admitted a breach in that he used his whip excessively prior to the 100 metres and was fined the sum of \$300 by the Judicial Committee.

LINEN AND LACE (M Hashizume) – Began awkwardly losing ground.

FARRENC (T Yanagida) – Began awkwardly losing ground. Raced wide without cover throughout.

COPY THAT (S Collett) – Steadied when becoming awkwardly placed on the heels of EL VENCEDOR which shifted in when not fully clear passing the 1100 metres. V Colgan was advised to exercise care in a similar circumstance.

EL VENCEDOR (V Colgan) – Rider dropped his whip near the 250 metres.

Race 5

HAUNUI FARM 1200

IGOTTADOITMYWAY (E McCall) – Hampered when crowded soon after leaving the barrier.

THISTLE DO (T Yanagida) – Crowded soon after leaving the barrier. Steadied when placed in restricted room to the inside of JUSTASTATE which improved to the inside of STYLISH SUGGESTION when not fully clear passing the 900 metres.

JUSTASTATE (L Satherley) – Began awkwardly losing ground.

PACIFIC MASTER (J Kamaruddin) – Raced in restricted room approaching the 900 metres to the inside of BRING IT ON (S Spratt) then made the bend awkwardly shifting out across heels, losing ground. S Spratt was reprimanded and advised to exercise care in a similar circumstance.

TIMBERLAKE (A Goindasamy) – Improved onto heels and held up for a distance from near the 200 metres.

CALLIOPE (C Grylls) – When questioned regarding performance rider advised that the filly had become unsettled at the start which may have affected its chances and was unable to offer any other reason for the performance. Improved into restricted room 300 metres.

L Satherley (JUSTASTATE) – Issued with a warning for shifting ground 900 metres.

Race 6

NZB INSURANCE PEARL SERIES RACE 1200

HETTY (T Yanagida) – Slow to begin.

PAYON TIME (T Newman) – Began awkwardly then ridden urgently to recover and commenced to over-race becoming awkwardly placed near heels being further restrained approaching the 850 metres.

MAENAD (L Satherley) – Lost its off-front plate during the running.

RICH GIRL (C Grylls) – Inconvenienced when forced wide 900 metres then commenced to hang out for the remainder of the race. When questioned regarding performance rider advised that after being forced wider the filly raced disappointingly for the remainder of the race. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

S & E Clotworthy (THE BIZZNESS) – Issued with a warning for presenting a runner without notified gear.

Race 7

DUNSTAN HORSEFEEDS 1400

PLATFORM (S Weatherley) – The start was delayed due to PLATFORM becoming cast when getting its head in the adjacent barrier stall with CHEVRON who was in that stall becoming fractious and cast. Connections were advised that a warning would be placed against the gelding. Made contact on at least two occasions when attempting a marginal run near the 400 metres.

CHEVRON (C Jones) – Was a late scratching at 2.26 pm after becoming briefly cast in the barrier.

MRS BIG (C Dell) – Slow to begin.

STRAIGHTSHOOTERDEB (S Collett) – Held up passing the 300 metres having to shift out to obtain clear running.

C'EST UNE STAR (C Grylls) – Made contact on at least two occasions when attempting a marginal run near the 400 metres.

Following the race connections of MAX THE BRAVE viewed Stewards footage of the final straight before electing not to proceed with a protest.

Race 8 | **FRANKLIN AUCTIONS 1400**

UNCLE OBED (C Grylls) – Slow to begin.

SHIRAZELLE (S Collett) – Began awkwardly then crowded.

DE CHAMBEAU (L Satherley) – Slow to begin.

LAGERFELD (H Schofer) – Began awkwardly then steadied. Raced keenly in the early to middle stages making the bend awkwardly near the 900 metres contacting NACENE which became unbalanced.

NACENE (T Thornton) – Contacted 900 metres and unbalanced.

CANNSEA CLEARLY (J Kamaruddin) – Restrained to obtain cover in the early stages.

MASTER CHATTER BOX (M McNab) – Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

C Jones (IRISH BOY) – Admitted a breach in that he used his whip excessively prior to the 100 metres. After considering submissions the Judicial Committee suspended C Jones' licence to ride in races from the conclusion of racing on Saturday 29 May up to and including racing on Friday 04 June, 3 national riding days and in addition imposed a fine of \$2000.

Race 9 | **KARAKA VETERINARY SERVICES LTD 1600**

CHAKANA (M McNab) – Crowded at the start.

OCEANTOOCEAN (V Colgan) – Began awkwardly.

CURRENT SURGE (T Yanagida) – Crowded shortly after the start.

HARD DONE (J Kamaruddin) – Began awkwardly.

LOGAN'S LOGIC (T Thornton) – Raced wide without cover throughout.

KING KHAN (S Spratt) – Shifted in abruptly when struck with the whip passing the 250 metres and when being corrected, shifted out inconveniencing HARD DONE.

LEAVE IT TO ME (S Collett) – Held up briefly early in the final straight. When questioned regarding the performance rider advised that the gelding had got a little further back than intended but ran on fairly but was unable to offer any other excuse for the performance.

T Newman (CORRINE) – Issued with a warning for her whip use prior to the 100 metres.

J Riddell (LOGAN'S LOGIC) – Fined \$200 under the minor infringement schedule after failing to make the contracted weight.

Race 10

LINDAUER LADIES DAY 23RD JUNE 1600

ASPIRING (S Weatherley) – Began awkwardly. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

OUR CRAFTSMAN (J Riddell) – Slow to begin.

MR BAZAMOUR (S Collett) – Slow to begin.

MAH GIRL (V Colgan) – Raced three wide without cover throughout.

TURRET (J Kamaruddin) – Had difficulty obtaining clear running in the final straight until passing the 100 metres.

GRACIANO (T Yanagida) – Had difficulty obtaining clear running early in the final straight.

T Yanagida (GRACIANO) - Admitted a breach of careless riding in that he allowed his mount GRACIANO to shift out near the 50 metres when not sufficiently clear of SAVAPPIEL which was checked. After considering submissions the Judicial Committee suspended T Yanagida's licence to ride in races from the conclusion of racing on Saturday 05 June up to and including racing on Thursday 10 June, 4 national riding days and in addition imposed a fine of \$500.
