### RACE COMMENTS:

Race 1 DADS PIES 1500

QUALITY PREVAILS (J Fawcett) - Slow to begin.

**VOLITIVO** (T Thornton) – Raced wide without cover throughout. When questioned regarding performance rider T Thornton explained that being caught wide without cover had been detrimental to the mare's chances after she had been asked to ride the horse forward and may now be better suited to racing over more ground.

**TIME TO CELEBRATE** (M McNab) – Restrained after improving onto heels near the 900 metres.

**HEZTHEWONFORUS** (M Hashizume) – Had difficulty obtaining clear running early in the final straight, then attempted to improve into a marginal run passing the 150 metres to the inside of MAKTOUM which shifted in with HEZTHEWONFORUS then being held up for the remainder of the race.

MAKTOUM (S Spratt) – When questioned regarding performance rider S Spratt could offer no tangible excuse.

# Race 2 SCOPE PAINTING 1300

ALWAYS ON TIME (J Riddell) – Crowded at the start losing ground.

MARLEY (T Newman) – Began awkwardly losing ground.

**MODESTY** (S Weatherley) – Began awkwardly then steadied when in restricted room. Crowded 100 metres and steadied losing ground.

FLAVIUS (J Fawcett) – Raced wide without cover for the majority of the race.

**THE BOUQUET SLAYER** (S Collett) – Attempted to improve to the outside of MS CANDEE LANE approaching the 100 metres and was then crowded when that runner shifted out. Contributing was inward movement from MODESTY which was taken in slightly by STORMY'S SECRET.

**PAPENHUYZEN** (M McNab) – Made the final bend awkwardly when hanging out. When questioned regarding performance rider M McNab advised the gelding may be feeling the effects of recent racing. Underwent a post-race veterinary examination which revealed the gelding to have a slow recovery rate.

LIGHTNING FIELD (J Kamaruddin) – Briefly held up near the 350 metres.

**D** Danis (STORMY'S SECRET) – Issued with a warning after permitting STORMY'S SECRET to shift in near the 100 metres crowding MODESTY which was hampered. Contributing was outward movement from THE BOUQUET SLAYER which had been dictated outwards by MS CANDEE LANE.

**S Spratt** (MS CANDEE LANE) – Issued with a warning after permitting MS CANDEE LANE to shift out near the 100 metres crowding THE BOUQUET SLAYER which was hampered and steadied. Contributing was inward movement from MODESTY which was taken in by STORMY'S SECRET.

Race 3 CELEBRATING SAVY YONG BLONK 1400

**SWEET HUNTER** (S Weatherley) – Began awkwardly losing ground.

**CAPALDI** (T Thornton) – Began awkwardly losing ground.

**EL TIRADOR** (S Collett) – Raced wide without cover throughout.

STRINGLINE (V Colgan) – Steadied away from heels near the 500 metres.

**ILLUMINATION** (C Grylls) – Hung out when making the final bend.

**S Weatherley** (SWEET HUNTER) – Issued with a warning for his whip use prior to the 100 metres.

### Race 4 HYGIENE SYSTEMS 2100

**INDEEM** (M McNab) – Crowded and steadied at the start losing ground. Steadied approaching the 2000 metres when awkwardly placed near the heels of TUNZAGUTZ which shifted in abruptly. T Newman was reprimanded and advised that she must exercise greater care in a similar circumstance. Inconvenienced 200 metres.

**HAIL DAMAGE** (T Yanagida) – Steadied 1800 metres then commenced to race ungenerously when in restricted room to the inside of ATA RANGI. Hampered when forced wide 1500 metres.

**ATA RANGI** (J Riddell) – Raced ungenerously passing the 1500 metres when awkwardly placed near the heels of CATE BLANCO which steadied abruptly with ATA RANGI then shifting out to avoid that runner's heels forcing HAIL DAMAGE wide on the track. When questioned regarding performance rider J Riddell could offer no tangible excuse. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

**RISING RENOWN** (E Leighton) – Held up early in the final straight before shifting in approaching the 300 metres to obtain clear running. Shifted out slightly approaching the 200 metres inconveniencing INDEEM.

**LOT OF ZEES** (J Fillmore) – Shifted out under pressure over the concluding stages, briefly crowding INDEEM when improving to the outside of CASSIO which shifted out.

**MALIK** (S Collett) – Underwent a post-race veterinary examination which revealed the gelding to be suffering from a mild respiratory infection.

**J Riddell** (ATA RANGI) – Issued with a warning after permitting ATA RANGI to shift in near the 1800 when insufficiently clear of HAIL DAMAGE which was steadied. Contributing was slight outward movement from WIND CHIMES.

V Colgan (CATE BLANCO) – Issued with a warning for steadying the pace near the 1500 metres hampering ATA RANGI and HAIL DAMAGE.

J Fillmore (LOT OF ZEES) – Issued with a warning for using her whip above shoulder height.

# Race 5 MAINLAND AUCKLAND FUTURITY STAKES 1400

**TE POROPITI** (S Collett) – Slow to begin.

KING MONDO (S Weatherley) – Began awkwardly losing ground. Restrained 1000 metres when the pace eased.

LADY MAROAL (M McNab) – Hampered when forced wider 1000 metres.

**ME LIBEREZ** (M Hashizume) – Steadied when awkwardly placed near the heels of SAMARKAND which shifted in and steadied approaching the 1000 metres with ME LIBEREZ then shifting out to avoid the heels of SAMARKAND hampering LADY MAROAL which was forced wider on the track. Then raced wide without cover for the remainder of the race.

**THERE YOU GO** (T Yanagida) – Had some difficulty obtaining clear running early in the final straight.

**ATULLIBIGEAL** (A Calder) – Restrained 1000 metres when the pace eased. Raced greenly when placed under pressure in the final straight, shifting in passing the 300 metres.

**S Weatherley** (KING MONDO) – Reminded of his obligation regarding whip use on a runner that is out of contention.

**C Grylls** (SAMARKAND) – Issued with a warning after permitting SAMARKAND to shift in near the 1000 metres when not sufficiently clear of ME LIBEREZ which had to steady and shift out to avoid heels.

# Race 6 CELEBRATING TE AKAU'S BLACK TYPE WINNERS AT ELLERSLIE 1100

**BURGUNDY ROSE** (N Parmar) – Slow to begin then improved quickly before racing keenly in the early to middle stages when improving forward. Apprentice N Parmar was advised that he would be expected to exercise better judgement in future. Apprentice N Parmar was reminded of his obligations in that he must ride his mounts out to the end of the race when circumstances permit him to do so.

LOVE SQUIRRELS (C Grylls) – Began awkwardly then crowded.

**CYBER ATTACK** (M McNab) – Began awkwardly.

**MONACO** (M Hashizume) – Began awkwardly and shifted out then when being corrected by its rider, lost ground.

**IHU** (Y Kumagai) – Raced very wide when disputing the pace. Apprentice rider Y Kumagai was advised that he would be expected to exercise better judgement in future and is to undergo supervision by riding master N Harris.

**PRINCESS RIHANNA** (T Yanagida) – Steadied 300 metres when crowded by SPEEDY MEADY which lay out when placed under pressure. E McCall was reprimanded and advised to exercise greater care in a similar circumstance. PRINCESS RIHANNA was then held up for a distance before shifting out approaching the 200 metres to obtain clear running.

**POP STAR PRINCESS** (J Riddell) – Crowded and checked 100 metres losing ground. When questioned regarding performance rider J Riddell advised that the mare had been run off her feet today after coming back from 1400 metres on an improved track, together with the impost of 62 kilograms.

**SHOSHONE** (S Collett) – When questioned regarding performance rider S Collett advised that the mare may appreciate some easing of the ground.

**M Gaskell** (IHU) – Issued with a warning for presenting a runner with gear that was not notified.

**E McCall** (SPEEDY MEADY) – Admitted a breach of careless riding in that she permitted her mount SPEEDY MEADY to shift out passing the 100 metres when not sufficiently clear of POP STAR PRINCESS which was checked losing ground. After hearing submissions, the Judicial Committee suspended E McCall's licence to ride in races from the conclusion of racing on Monday 7 June up to and including racing on Sunday 13 June, 4 national riding days and in addition imposed a fine of \$250.

Race 7 NETWORK VISUALS 1200

LONDON BOUND (M McNab) – Began awkwardly.

**APPELLANT** (T Yanagida) – Began awkwardly losing ground then raced ungenerously when getting its head up.

THUNDER (E McCall) – Steadied from a wide barrier.

**INCA WARRIOR** (J Riddell) – Steadied from a wide barrier.

**MEGEVE** (A Goindasamy) – Crowded and checked 1100 metres. Held up early in the final straight. Briefly crowded 200 metres.

ALICE TINKER (D Danis) – Crowded 1100 metres.

GORGEOUS GEISHA (A Calder) – Hampered 1100 metres and steadied.

**LE SABLIER** (E Leighton) – Held up from near the 300 metres until shifting out to obtain clear running over the final 50 metres.

**AERO DE PARIS** (C Grylls) – Raced greenly in the final straight briefly crowding THE DOM onto MEGEVE passing the 200 metres.

**MEKELLE** (S Weatherley) – Made contact becoming briefly unbalanced near the 200 metres.

V Colgan (PACKING NOBLESSE) – Admitted a breach of careless riding in that he allowed PACKING NOBLESSE to shift in approaching the 1100 metres when insufficiently clear of MEGEVE which was crowded and checked. After hearing submissions, the Judicial Committee suspended V Colgan's licence to ride in races from the conclusion of racing on Saturday 05 June up to and including racing on Thursday 10 June, 4 national riding days and in addition imposed a fine of \$350.

#### Race 8 JON SNOW AT CLEARVIEW PARK 1600

**FINAL SUGGESTION** (Y Kumagai) – Was cleared fit to race by the club veterinarian after being kicked at the barrier. FINAL SUGGESTION also underwent a post-race veterinary examination which could find no significant abnormality other than a minor laceration to the left hind leg as a result of the kick.

**DIVINE DUKE** (T Yanagida) – Crowded and steadied at the start, losing ground.

BABY FACE (M McNab) – Began awkwardly.

AMAZING AZ (S Collett) – Began awkwardly.

ALL THE RAGE (R Elliot) – Hampered 1500 metres when in restricted room.

**NO LOITERING** (E Leighton) – Crowded and hampered 1500 metres.

**QUEEN CONSTANTINE** (C Grylls) – Crowded and checked 1500 metres losing ground to the outside of CHERRY LANE which shifted out and away from CALL ME EVIE which shifted out when linking onto the course proper, despite the efforts of its rider. Contributing was inward movement from NO LOITERING which was crowded by WORDSWORTH who had shifted in and away from CALPURNIA which shifted in slightly before being corrected by its rider. L Satherley was advised to exercise care in a similar circumstance.

**WORDSWORTH** (S Spratt) – Raced keenly in the early stages then further steadied when awkwardly placed near the heels of ANGARIA which shifted in when steadying near the 1200 metres. V Colgan was reprimanded and advised to exercise greater care in a similar circumstance. WORDSWORTH then continued to race keenly through the middle stages forcing FINAL SUGGESTION wider on the track near the 1000 metres. Knuckled near the 900 metres when racing keenly.

**ISOLA SACRA** (A Goindasamy) – Began awkwardly then bumped becoming briefly unbalanced. Improved onto heels 250 metres and again improved onto heels passing the 100 metres and was steadied for the remainder of the race.

# Race 9 AUCKLAND CO-OP TAXIS 1400

**TAHUROA HEIGHT** (M Hashizume) – Was declared a late scratching at 4.18 pm after arriving at the barrier when apprentice rider M Hashizume alerted Stewards that a towel had been omitted from his gear which he had weighed out with.

**HEART OF THE OCEAN** (S Weatherley) – Refused to leave the barrier stall taking no part in the race. Connections were advised that the mare would be required to barrier trial to the satisfaction of Stewards prior to racing next.

BENTAYGA (M McNab) – Began awkwardly losing ground.

**GINGER TOO** (A Calder) – Slow to begin. Crowded approaching the 200 metres between OUR FINE WINE which shifted in when struck with the whip which was immediately corrected by its rider, and JUTANUGARN which shifted out slightly under pressure. Apprentice rider A Goindasamy was advised to exercise care in a similar circumstance.

**GLITTERING ARMOUR** (T Thornton) – Commenced to over-race when being steadied near the 1100 metres. Steadied approaching the 300 metres when shifting in briefly making contact with BENTAYGA which was shifting out with GLITTERING ARMOUR then becoming awkwardly placed near the heels of JUTANUGARN which shifted in slightly with GLITTERING ARMOUR being further steadied for a distance.

**DIAMOND GIRL** (S Collett) – Held up for clear running near the 300 metres and was again unable to obtain clear running until inside the final 100 metres.

VIBRATO (S Spratt) – Awkwardly placed near heels and steadied approaching the 200 metres.

**S Ralph** (TAHUROA HEIGHT) – Admitted a breach in that he was neglectful in saddling TAHUROA HEIGHT after omitting a piece of the jockey's gear (towel) which the rider had weighed out with. After hearing submissions, the Judicial Committee imposed a fine of \$700.
