RACE COMMENTS

Race 1 AVONDALE SUNDAY MARKETS 2100

TUNZAGUTZ (T Newman) – Slow away.

TIMBERLAKE (A Goindasamy) – Improved into a marginal run passing the 300 metres crowding O'SUSANA which was hampered losing ground.

O'SUSANA (S Spratt) – Crowded and hampered 300 metres losing ground.

LA CASA (K Asano) – Underwent a post-race veterinary examination which failed to reveal any abnormality.

A Goindasamy (TIMBERLAKE) – Admitted a charge of careless riding in that he permitted TIMBERLAKE to shift out near the 300 metres when not sufficiently clear of O'SUSANA which was hampered losing ground. After hearing submissions, the Adjudicative Committee suspended A Goindasamy's licence to ride in races from the conclusion of racing on Saturday 24 July up to and including racing on Sunday 01 August, 4 national riding days and in addition imposed a fine of \$300.

Race 2 WESTBROOK CELLAR DOOR 1600

POACHER (T Abel) – Jumped away awkwardly losing ground. Held up entering the final straight.

MAITLAND (K Asano) - Slow away.

GLAD ALL OVER (E McCall) – Jumped away awkwardly.

THE TWINKLING (S Spratt) – Lay in over the concluding stages. Rider S Spratt advised that the mare had not been entirely comfortable in today's track conditions.

YOUKNOWWHATIMEAN (T Thornton) – When questioned regarding performance rider T Thornton advised that the gelding had become disinterested in the very testing track conditions.

Race 3 AJC TRIALS 9 SEPTEMBER 1400

APATCHEE POWER (E Nicholas) - Slow away.

MAKE A MOVE (M Hashizume) – Jumped away awkwardly contacting SHOCKOVA.

SHOCKOVA (T Yanagida) – Contacted start.

SPICEY LAD (E McCall) – Jumped away awkwardly then clipped a heel of CINNAMON STAR shortly after the start and blundered.

CAPTAIN OUMUAMUA (K Asano) – Had to steady off the heels of APATCHEE POWER and change ground passing the 150 metres.

BEAUTY FOR ASHES (A Goindasamy) – When questioned regarding performance rider A Goindasamy advised that the filly had not been suited by today's track conditions which he described as holding.

LOFTY (T Newman) – Raced in restricted room passing the 150 metres before shifting out to obtain clear running.

J Fawcett (TRUE NORTH) – Spoken to with regards to her whip use prior to the 100 metres.

A Goindasamy (BEAUTY FOR ASHES) – Spoken to with regards to his whip use prior to the 100 metres.

Race 4 NZB INSURANCE PEARL SERIES RACE (1200 metres)

KEEN AS (D Danis) – Jumped away awkwardly losing ground.

HALF OF NOTHING (E Leighton) – Hampered leaving the barriers when contacted by JAQUOLEE.

JAQUOLEE (T Newman) – Jumped away awkwardly making contact with HALF OF NOTHING. Commenced to over-race when being restrained passing the 1000 metres. Hampered when forced wider near the 800 metres.

MUSE (E Nicholas) – Steadied off the heels of SHE'S DASHING which shifted inwards when being steadied after being forced wider by JAQUOLEE which had been taken out by PERFECTIONIST which shifted out to avoid the heels of BENDERMERRY near the 800 metres.

SHE'S DASHING (M McNab) – Hampered when forced wider near the 800 metres.

PERFECTIONIST (Y Kumagai) – Commenced to over-race after being crossed by BENDERMERRY, shifting outwards to avoid that runners heels, then continued to over-race. Apprentice Y Kumagai was shown footage of the race in the presence of the riding mentor.

Race 5 TULLOCH CAFÉ 1200

BERGAMO FOX (E Nicholas) – Jumped away awkwardly.

KELLY KEEPER (T Newman) – Jumped away awkwardly.

PEARL BODINE (S Collett) – Steadied to avoid the heels of PRINCE CHARMING which shifted inwards passing the 1000 metres. PEARL BODINE had left the course before a veterinary examination could take place with Trainer P Coutts advising the mare was showing signs of lameness and may not be persevered with as a racing proposition. A veterinary certificate of fitness is required for PEARL BODINE prior to the mare racing again.

A Goindasamy (PRINCE CHARMING) – Issued with a warning after permitting his mount PRINCE CHARMING to shift inwards passing the 1000 metres when not fully clear of PEARL BODINE.

S Spratt (ERNIE'S TAKEN) – Issued with a warning for her whip use prior to the 100 metres.

Race 6 WESTBROOK VINE & WINE CLUB MAIDEN 2100

SON OF SASANOF (T Abel) – Slow away after being fractious in its barrier. Tailed the field in the early to middle stages despite the efforts of its rider. Contacted near the 50 metres.

ZION HILL (E Nicholas) – Slow away.

KHANGO (T Thornton) – Lay out under pressure making contact with SON OF SASANOF near the 50 metres.

TAVI WITH ME (M Hashizume) – When questioned regarding performance rider M Hashizume advised that the filly had resented the kick back in the very testing track conditions.

BURCHA (B Rogerson) – When questioned regarding performance rider B Rogerson advised that the gelding had failed to handle today's track conditions.

NONAAME (E Leighton) – When questioned regarding performance rider E Leighton advised that the filly had failed to handle today's track conditions.

Race 7 AJC CONFERENCE CENTRE 1600

QUALITY PREVAILS (J Fawcett) – Slow away.

ALASKAN GOLD (T Thornton) – Jumped away awkwardly. Unbalanced when making contact with GOODNIGHT IRENE approaching the 1400 metres.

PUSHKA (E McCall) – Inclined to lay out under pressure in the final straight.

T Thornton (ALASKAN GOLD) – Admitted a breach in that she used her whip excessively prior to the 100 metres. After hearing submissions the Adjudicative Committee suspended T Thornton's licence to ride in races from the conclusion of racing on Saturday 24 July up to and including racing on Saturday 07 August, 6 national riding days.
