### Race 2 SCOPE PAINTING 1300

**PAPENHUYZEN** (M McNab) – Trainer Mr G Harvey advised Stewards, he was satisfied with the post-race condition of PAPENHUYZEN, however, has now been sent for a spell.

#### Race 4 HYGIENE SYSTEMS 2100

**MALIK** (S Collett) – Trainer Mr N Tiley reported to Stewards, MALIK, underwent an endoscopic examination following the race, which revealed a mild respiratory infection in the trachea. N Tiley further advised MALIK has now been sent for a freshen up.

#### RACE COMMENTS:

Race 1 SISTEMA 1600

**ILLUMINATION** (M McNab) – Slow to begin. Commenced to race ungenerously when being steadied and was then crowded near the 1350 metres and hampered having to shift out to avoid the heels forcing KING KHAN and SIDE EYE wider on the track. Then continued to race keenly for a distance.

**DAADS EXPRESS** (E McCall) – Slow to begin.

**HOT PINX** (C Grylls) – Steadied off heels shortly after the start when crowded between SPIRIT OF BAZ which lay in and away from CLEESE and SIDE EYE which was crowded by KING KHAN which lay out. Had difficulty obtaining clear running early in the final straight then lay out under pressure over the final 100 metres.

**LAPEL** (B Rogerson) – Became awkwardly placed near heels and restrained passing the 700 metres. Hampered 30 metres.

**SIDE EYE** (D Danis) – Forced wide 1350 metres.

**KING KHAN** (T Yanagida) – Crowded and steadied passing the 1100 metres when awkwardly placed inside the heels of SIDE EYE which lay in. Forced wide 1350 metres.

**S Weatherley** (QUEEN OF SOUL) – Defended a charge of careless riding after allowing his mount to shift in when not sufficiently clear of ILLUMINATION which was checked having to shift out to avoid heels forcing KING KHAN and SIDE EYE wider near the 1350 metres. After hearing submissions, the Judicial Committee found the charge proven and suspended S Weatherley's licence to ride in races from the conclusion of racing on Saturday 12 June up to and including racing on Friday 18 June, 4 national riding days.

**D** Danis (SIDE EYE) – Issued with a warning after permitting SIDE EYE to shift in passing the 1100 metres when insufficiently clear of KING KHAN which was hampered and steadied.

**C Grylls** (HOT PINX) – Issued with a warning after permitting HOT PINX to shift out near the 30 metres into the line of LAPEL which was hampered.

Race 2	THOMSONS FOOD SERVICE CORNWALL HANDICAP (2200 metres)			
MONT VENTOUX	(A Calder) – Crowded and steadied losing ground. Raced keenly in the early to middle stages.			

**RENEGADE FIGHTER** (E McCall) – Began awkwardly losing ground then steadied shortly after when becoming awkwardly placed on the heels of KAHARAU.

**VOLER POUR MOI** (J Kamaruddin) – Had some difficulty obtaining clear running in the final straight until near the 200 metres.

## Race 3 BARFOOT & THOMPSON 1200

**PADDY WAGON** (T Abel) – Began awkwardly then restrained becoming tailed off in the early stages. Improved into restricted room approaching the 100 metres and was briefly steadied.

**TO BE FAIR** (J Kamaruddin) – Crowded soon after leaving the barrier.

**SEVEN PAIRS** (S Spratt) – Crowded soon after leaving the barrier.

**ROCHMIE RAY** (V Colgan) – Commenced to over-race passing the 900 metres when in restricted room to the inside of MASTER KHAN. Footage of this incident proved inconclusive with J Riddell advised to exercise greater care in a similar circumstance. Hampered when crowded approaching the 600 metres to the outside of LADY DE WINTER which shifted out. Had difficulty obtaining clear running until near the 250 metres.

**LADY DE WINTER** (T Thornton) – Held up early in the final straight.

**TUMBRIL** (T Yanagida) – Commenced to over-race near the 800 metres becoming awkwardly placed outside heels of DEVOTIONINMOTION which was forced out slightly by HIT THE SWITCH which shifted out when racing keenly with TUMBRIL then clipping a heel and blundering.

**SAVONOSKI** (C Grylls) – Returned to the enclosure with blood present in both nostrils and after undergoing a veterinary examination was deemed to have bled. SAVONOSKI is now subject to a 2 month stand down from training and a 3 month stand down from racing or trialling with a veterinary certificate of fitness being required before racing or trialling again.

**T Thornton** (LADY DE WINTER) – Issued with a warning after permitting LADY DE WINTER to shift out approaching the 600 metres crowding ROCHMIE RAY.

### Race 4 SKYCITY 1200

FUNTONIC (T Yanagida) – Slow to begin. Forced wider 900 metres then restrained to obtain cover.

BUTLER (M Hashizume) – Slow to begin. Shifted out passing the 900 metres forcing FUNTONIC to race wide.

**OSELETA** (M McNab) – Restrained from its wide barrier.

**SACRED OPTION** (A Goindasamy) – Over-raced through the middle stages. Raced keenly for a distance passing the 900 metres. Briefly steadied 200 metres when improving into a diminishing run.

**ESCUDO** (C Grylls) – Lay out rounding the final bend forcing BUTLER wider. Briefly crowded when weakening 250 metres.

**ANDUIN** (J Kamaruddin) – Forced wider when contacted passing the 250 metres and again passing the 200 metres by EVA JAMES which shifted out under pressure.

**E McCall** (EVA JAMES) – Issued with a warning after permitting EVA JAMES to shift out under pressure near the 200 metres when not sufficiently clear of ANDUIN which was crowded onto SACRED OPTION which was improving into a diminishing run.

Race 5 VODAFONE 2200

**ZEDCREST** (A Goindasamy) – Began awkwardly losing round.

OSTASIO (S Weatherley) - Slow to begin.

AONGATETE EXPRESS (C Grylls) – Slow to begin.

**CURIOUS GEORGE** (J Kamaruddin) – Began awkwardly.

**CHARMINGAFFAIR** (T Thornton) – Began awkwardly losing ground. When questioned regarding performance rider T Thornton advised that the mare had not been entirely comfortable in today's track conditions.

**HAKUNA MATATA** (D Danis) – Raced in restricted room passing the 300 metres between CHARMINGAFFAIR which lay out when struck with the whip, and O'SUSANA which shifted in slightly.

JUDY'S SONG (J Fawcett) – Held up when improving onto heels passing the 300 metres.

**RISING REWARD** (M McNab) - When questioned regarding performance rider M McNab advised that he had not anticipated leading but had been left in front after there was no early pace in the race, further advising that the filly had then not responded when placed under pressure in the final straight.

Race 6 STELLA ARTOIS CHAIRMAN'S TROPHY (1400 metres)

**RUN TO PERFECTION** (M McNab) – Slow to begin. Rider M McNab advised that the gelding had never been entirely happy in today's track conditions.

**SWEET CLEMENTINE** (A Calder) – Made brief contact with JE SUIS TIGER when looking to obtain clear running near the 350 metres.

Race 7 CELEBRATING SHOWOROSES 1400

**COUTURIERE** (A Goindasamy) – Began awkwardly. Raced keenly in the early to middle stages.

GALLARDO (M McNab) – Began awkwardly.

BELT ROAD (A Calder) – Began awkwardly.

**PACKING JOY** (V Colgan) – Restrained soon after leaving the barrier.

**HEZTHEWONFORUS** (J Riddell) – Held up early in the final straight then improved into a marginal run passing the 300 metres making brief contact with AIR CENTRE. Lay out over the concluding stages under pressure making brief contact with MEKELLE which then lay in.

**MEKELLE** (S Weatherley) – Briefly contacted over the concluding stages, then lay in.

### Race 8 BARFOOT & THOMPSON 1600

**ZENNTARI** (M Hashizume) – Began awkwardly then steadied off heels losing ground. Had difficulty obtaining clear running until shifting out passing the 175 metres making contact with TARIQ.

**TARIQ** (M McNab) – Began awkwardly shifting out making contact with GRACIANO which became briefly unbalanced.

**GRACIANO** (T Yanagida) – Contacted at the start becoming briefly unbalanced. Made the final bend awkwardly making contact with the hindquarters of WORDSWORTH. When questioned regarding performance rider advised the mare had failed to handle todays track conditions.

**LETZ'AV BUBBLES** (C Grylls) – Raced ungenerously in the early to middle stages. Had difficulty obtaining clear running early in the final straight then briefly crowded passing the 300 metres. When questioned regarding performance rider C Grylls could offer no excuse. Underwent a post-race veterinary examination which failed to reveal any abnormality.

ALASKAN GOLD (T Abel) – Held up 350 metres when improving into a diminishing run to the inside of GREEN BRAVO which shifted in.

**INTO THE DEEP** (A Goindasamy) – Briefly hampered when forced wider 800 metres by CERYS which was dictated out slightly by LETZ'AV BUBBLES. A Calder was advised to exercise care in a similar circumstance.

**M** Hashizume (ZENNTARI) – Issued with a warning after directing his mount out near the 175 metres making contact with TARIQ which was briefly hampered.
