## RACE COMMENTS:

Race 1	BARFOOT & THOMPSON HURDLE (2760 metres)
<p><b>IZYMYDAAD</b> (H McNeill) – Slow to begin. Jumped indifferently throughout. Put in a poor jump at the second to last fence.</p> <p><b>RAUCOUS</b> (S Phelan) – Improved onto heels when jumping the fence near the 2250 metres. Misjudged the third fence landing awkwardly. Misjudged the final fence, landing awkwardly.</p> <p><b>JAKKI SPARROW</b> (T Moki) – Rider became unbalanced on jumping the first fence. Commenced to give ground near the 1000 metres and was pulled up prior to jumping the final two fences. Rider T Moki was reminded of her obligations in that she should have pulled the mare out of the race earlier after becoming well tailed off.</p> <p><b>CALL ME BOB</b> (D Parker) – Jumped indifferently throughout. Commenced to give ground near the 600 metres and was pulled up prior to jumping the final two fences.</p>	

<p><b>WINDY HEIGHT</b> (G Walsh) – Put in a poor jump at the fence near the 1100 metres. Misjudged the fence near the 700 metres landing awkwardly.</p> <p><b>WICKLOW</b> (E Farr) – Landed awkwardly after jumping the fence near the 700 metres.</p> <p><b>KANGAROO</b> (R Cole) – Commenced to give ground near the 600 metres and was pulled up prior to jumping the final two fences.</p>	
<b>Race 2</b>	<b>NZB INSURANCE PEARL SERIES RACE (1200 metres)</b>
<p><b>GAME NIGHT</b> (B Rogerson) – Hung out when making the final bend then ducked out passing the 300 metres shifting into the line of FLASH MARY which had to steady.</p> <p><b>FLASH MARY</b> (L Satherley) – Hampered 300 metres by GAME NIGHT which shifted out and continued to hang out for the remainder of the straight.</p> <p><b>INVIALO</b> (J Kamaruddin) – Became awkwardly placed on the heels of MR RAFIKI which lay out under pressure then was unable to obtain clear running for the remainder of the race.</p>	
<b>Race 3</b>	<b>SCOTT ELECTRICAL STEEPLECHASE (4150 metres)</b>
<p><b>TITTLETATTLE</b> (G Walsh) – Slow to begin. Put in a poor jump at the second fence on the hill on the first occasion, landing awkwardly with the rider momentarily losing the use of his stirrup iron.</p> <p><b>ZINZAN</b> (B Donoghue) – Hampered when jumping the first fence. Put in a poor jump landing awkwardly at the first fence on top of the hill on the second occasion.</p> <p><b>LEICA WARRIOR</b> (T Moki) – Landed awkwardly after jumping the second fence with the rider becoming unbalanced. Hit the third to last fence dislodging rider T Moki who was uninjured, hampering MRS TWINKLETOES.</p> <p><b>RAAJ</b> (J Seivwright) – Put in a poor jump at the second fence of the stand double, landing awkwardly.</p> <p><b>MRS TWINKLETOES</b> (D Parker) – Pulled up prior to jumping the final fence.</p>	
<b>Race 4</b>	<b>KS BROWNE HURDLE (3350 metres)</b>
<p><b>EL DISPARO</b> (J Seivwright) – Slow to begin. Commenced to give ground passing the 600 metres and was pulled up prior to jumping the final two fences.</p> <p><b>CLASS ABOVE</b> (D Parker) – Over-raced in the early to middle stages. Put in a poor jump at the fence near the 1200 metres on the second occasion. Put in a poor jump at the fence near the 800 metres and commenced to give ground. Pulled up prior to jumping the last two fences.</p> <p><b>ARITE GURU</b> (H McNeill) – Put in a poor jump at the fence near the 700 metres on the first occasion.</p> <p><b>EL LUCHADOR</b> (B Donoghue) – Hit the second to last fence, landing awkwardly.</p> <p><b>TOMMYRA</b> (R Cole) – Landed awkwardly after jumping the second to last fence.</p> <p><b>LOCHARBURN</b> (S Fannin) – When questioned into the performance rider S Fannin advised that the gelding failed to handle today's track conditions.</p>	
<b>Race 5</b>	<b>VODAFONE 2200</b>
<p><b>DRAGON REALM</b> (N Smith) – Began awkwardly losing ground.</p>	

**HAPPY CHAPPY** (L Kennedy) – Began awkwardly then crowded losing ground. Raced ungenerously when being restrained in the early stages, getting its head up. Commenced to give ground passing the 600 metres and was not persevered with. When questioned rider was unable to offer any reason for the gelding's performance.

**BRUCIE** (S Malki) – Began awkwardly then crowded, losing ground.

**MOKELE MBEMBE** (P Matthews) – Shifted out leaving the barriers crowding HAPPY CHAPPY and BRUCIE which lost ground.

**SHOCKING BILL** (R Shinde) – Raced in restricted room for a distance passing the 1300 metres when awkwardly placed near heels.

**PANGO** (J McIlroy) – Had to be restrained when becoming awkwardly placed on the heels of the weakening HAPPY CHAPPY passing the 600 metres.

<b>Race 6</b>	<b>MCGREGOR GRANT STEEPLECHASE (4150 metres)</b>

**MR ENTHUSIASTIC** (E Farr) – Required a gear adjustment prior to the start with the race being delayed as a result. Began awkwardly. Stumbled at the fence near the 1600 metres.

**H McNeill** (EION) – Admitted a breach in that he made a celebratory gesture prior to the winning post with the Judicial Committee fining H McNeill the sum of \$200.

**MAGDALA** (A Calder) – Crowded soon after leaving the barrier, losing ground.

**ROLL THE GOLD** (E Leighton) – Began awkwardly but quickly recovered, then raced keenly through the early to middle stages.

**TRIGON LAD** (T Thornton) – When questioned regarding performance rider T Thornton advised that the gelding had struggled in the existing track conditions.

**DIVINE DUKE** (J Kamaruddin) – Slow to begin.

**BARBARA** (S Spratt) – Raced in restricted room for a distance passing the 400 metres and was further crowded near the 350 metres by TWIN SPINNER which was briefly crowded by LEITRIM LAD.

**LEITRIM LAD** (T Thornton) – Inconvenienced near the 250 metres by DIVINE DUKE which shifted out under pressure. J Kamaruddin was advised to exercise care in a similar circumstance.

**ISOLA SACRA** (C Grylls) – When questioned regarding performance rider C Grylls advised that the mare had failed to handle today's track conditions.

**BABY FACE** (M McNab) – When questioned regarding performance rider M McNab advised that the mare had failed to handle today's track conditions.

**DELUXE EDITION** (E Leighton) – Began awkwardly.

**ANGELICA** (J Kamaruddin) – Crowded soon after leaving the barrier. Made contact with HEZA LOOKER passing the 100 metres.

**ELLE MAKFI** (H Schofer) – Crowded soon after leaving the barrier.

**TIME TO FLY** (J Fawcett) – J Fawcett was advised to exercise care in that she allowed TIME TO FLY to shift out when not fully clear of HEZA LOOKER near the 400 metres.

**HEZA LOOKER** (A Goindasamy) – Made contact with ANGELICA passing the 100 metres.

**IMAREADY** (C Grylls) – Had to steady when becoming awkwardly placed on the heels of ANGELICA which shifted out. Contributing was inward movement from HEZA LOOKER.
