RACE COMMENTS:

Race 1 | **TAINUI PRESS DESIGN & PRINT 1600**

CURRENT SURGE (C Grylls) - Contacted on jumping away, losing ground.

UNCLE OBED (A Goindasamy) - Began awkwardly.

ENRIGHT (T Thornton) - Slow to begin. Over-raced in the early and middle stages. Had to be restrained when placed in restricted room to the inside of **HARD DONE** which was forced inwards by **BURCHA** which shifted in approaching the 800 metres. J Kamaruddin and B Rogerson were advised to exercise care in similar circumstances.

HARD DONE (J Kamaruddin) - Slow to begin, then over-raced in the early to middle stages.

BLACK CHEETAH (J Fawcett) - Knuckled shortly after the start. Contacted passing the 50 metres.

GOLDEN EAGLE (L Satherley) - Over-raced in the early to middle stages.

BURCHA (B Rogerson) - Over-raced in the early stages.

PLATFORM (S Weatherley) - Shifted out passing the 50 metres making slight contact with **BLACK CHEETAH**.

DAADS EXPRESS (C Dell) - Improved into restricted room when crossing onto the course proper having to be firmly restrained passing the 1200 metres.

LAGERFELD (S Spratt) - Had to be firmly restrained off heels when the pace steadied passing the 1100 metres.

S Weatherley (**PLATFORM**) - Reminded of his obligations for the manner in which he eased the pace passing the 1100 metres causing **LAGERFELD** to be steadied to avoid heels.

J Fawcett (**BLACK CHEETAH**) - Issued with a warning for her whip use above shoulder height.

| <p>BONO (L Satherley) - Hampered leaving the barriers, losing ground.</p> <p>KAIMAI QUEEN (S Weatherley) - Hampered leaving the barriers, losing ground.</p> <p>ANNEXCEPTION (A Goindasamy) - Began awkwardly. Came together with PRAETORIAN passing the 150 metres when both runners shifted ground.</p> <p>PEARL BODINE (M Hashizume) - Had to be steadied when placed in restricted room passing the 100 metres.</p> <p>PARADING (M McNab) - Improved into a marginal run outside of SHOCKOVA approaching the 100 metres with SHOCKOVA then shifted out slightly crowding PARADING outward onto PEARL BODINE which had to be steadied when placed in restricted room. E Leighton was advised to exercise care in a similar circumstance. When questioned regarding the performance the rider advised that in his opinion the filly would derive benefit from today's race.</p> <p>PRAETORIAN (C Barnes) - Came together with ANNEXCEPTION passing the 150 metres when both runners shifted ground.</p> <p>REMARKABLE RUTH (C Grylls) - Raced in restricted room for a distance passing the 300 metres.</p> | |

J Kamaruddin (SPEED OF LIGHT) - Issued with a warning for failing to ride his mount out fully to the finish when circumstances permitted him to do so.

S Rees (MAESTRO BLU) - Issued with a warning for presenting MAESTRO BLU to race without the notified pre-race ear covers.
