## RACE COMMENTS:

<b>Race 1</b>	<b>RETURN 2 EARTH SUPPORTING LIFE EDUCATION TRUST MDN HWT</b>
Track conditions were downgraded to Heavy 10 retrospective to race 1.	
<b>SOIREE</b> (N Downs) – Began awkwardly losing ground. Raced keenly in the early and middle stages.	
<b>NADEEMS DREAM</b> (C Chipperfield) – Had to be firmly restrained when improving onto the heels of <b>ROCK HARD REX</b> near the 1700 metres.	
<b>HOLD MY BEER</b> (B Lammas) – Travelled three wide without cover throughout. Rider reported that after struggling in the going he opted to shift wider on the track looking for better footing, with the gelding running on strongly over the concluding stages.	
<b>JUDAH</b> (S Phelan) – Briefly inconvenienced passing the 1000 metres.	

**C Chipperfield** (NADEEMS DREAM) – Spoken to in regard to his whip use prior to the 100 metres.

**E Farr** (BLACK EYED SUE) – Warned under Rule 638(3)(b)(ii) for her whip use prior to the 100 metres.

**Race 2** | **MONSTAVISION SUPPORTING LIFE EDUCATION TRUST HWT**

**B Lammas** – Was permitted to ride GOBUYIT 1kg over weight due to some confusion as to his recorded weight when initially weighing out.

**MANDALAY** (S O’Malley) – Slow to begin.

**ROC YA SOX** (B Donoghue) – Slow to begin.

**MASTER PATRICK** (S Fannin) – Raced wide throughout.

**C Chipperfield** (I AM A CRAFTSMAN) – Charged with using his whip excessively prior to 100 metres. As C Chipperfield had left the course the matter was adjourned until a date to be set.

**N Downs** (BLANCO BAY) – Charged with using his whip excessively prior to 100 metres. As N Downs had left the course the matter was adjourned until a date to be set.

**B Donoghue** (ROC YA SOX) – Spoken to and reminded of his obligations with regard to his whip use prior to the 100 metres.

**E Farr** (CAPELLANI) – Admitted a charge under Rule 638(3)(b)(ii) in that she used her whip excessively prior to the 100 metres with the Judicial Committee imposing a fine of \$450.

**Race 3** | **DAVE BROPHY MEMORIAL MDN**

**JANE O’** (J Mudhoo) – Began very awkwardly losing ground with Apprentice J Mudhoo being shown footage in the presence of the Riding Mentor.

**IT’S A BOY** (C O’Beirne)– Slow to begin.

**GO MICKEY** (C Jones) – Hampered shortly after the start losing ground. Had to be steadied off heels on entering the back straight. Bumped near the 800 metres. Dictated outwards in the home straight.

**MR GHIBSON** (T Newman) – Raced keenly in the early and middle stages.

**OUR FAIR TRADE** (J Kamaruddin) – Was restrained to obtain cover near the 1100 metres.

**SPACEK** (A Goindasamy) – Hampered shortly after the start losing ground. Over raced for some distance in the back straight, having to be continually steadied off heels near the 800 metres and in doing so shifted in and bumped GO MICKEY (C Jones). Shifted in abruptly on entering the home straight and bumped with PARDON (T Taiaroa).

**WELL I NEVER** (K Chowdhoo) – Held up in the home straight prior to being angled out to improve near the 200 metres and in doing so dictated GO MICKEY outwards.

**Race 4** | **OCEAN EMPEROR @ WEONWA PARK SUPPORTING LIFE EDUCATION TRUST MDN**

**LOIS LANE** (H Schofer) – Slow to begin. Shifted out across heels passing the 300 metres. When questioned regarding performance rider could offer no excuse. Underwent a post-race veterinary examination which revealed a poor rate of recovery with Trainer S Rainford indicating the filly was now likely to be spelled.

**GIRLBOSS** (E Leighton) – Raced keenly in the early and middle stages.

**ACQUITTAL** (B Rogerson) – Raced keenly in the early and middle stages.

**MISCHIEVIOUS THING** (M Mudhoo) – A post-race veterinary examination did not reveal any obvious abnormality, but it was recommended to Trainer K Rohloff to have further tests conducted on return to his stable.

**Race 5** | **COMCAT SUPPORTING LIFE EDUCATION TRUST MDN**

**GOOG 'N' ROY** (J Kamaruddin) – Crowded shortly after the start losing ground.

**ICONIC LASS** (C O'Beirne) – Buffeted shortly after the start. Was shown footage of her ride over the final stages in the presence of the riding Mentor and reminded of her obligation to ride her mounts out fully to the finish.

**SWEET KARMA** (T Taiaroa) – Hampered shortly after the start losing ground.

**ALBERT O'CEIRIN** (S O'Malley) – Slow to begin.

**WINSTON** (H Schofer) – Raced keenly in the early and middle stages when being restrained.

**LINDA LOLA** (F Lazzet) – Inconvenienced approaching the 100 metres when MORE PZAZZ lay in under pressure.

**Race 6** | **NZB INSURANCE PEARL SERIES RACE**

**CARAMELLA** (A Goindasamy) – Began awkwardly. Rider reported the filly had not felt comfortable in today's holding track conditions.

**HALF OF NOTHING** (E Leighton) – Hampered shortly after the start losing ground. Rider advised that the filly had failed to handle today's holding track conditions.

**MYSALLY** (J Mudhoo) – Slow to begin.

**HOT SHOCKOLATE** (H Schofer) – Ducked in abruptly at the junction entering the course proper approaching the 1200 metres, briefly unbalancing its rider. Commenced to over race in the early and middle stages.

**DAME VERA** (J Kamaruddin) – Raced keenly in the early stages. Shifted out under pressure over the concluding stages. J Kamaruddin was shown footage of his ride in the presence of the Riding Mentor and advised to straighten his mount in similar circumstances.

**CASTLE ON THE HILL** (D Montes de Oca) – Rider dropped his right rein near the 200 metres having to regather.

**D Montes de Oca** (CASTLE ON THE HILL) – Issued with a warning for his whip use in consecutive strides prior to the 100 metres.

**Race 7** | **JOHN WHITE BLOODSTOCK SUPPORTING LIFE EDUCATION TRUST 3YO MDN**

**ROSIELICIOUS** (J Mudhoo) – Slow away losing several lengths after being fractious in the barriers. Trainer I Kelly was advised that a barrier warning would be placed against the filly.

**TSUMAMI** (D Montes De Oca) – Began awkwardly losing ground.

**LOOX LIKE A PRO** (C Jones) – Slow to begin.

**LADIES MAN** (H Schofer) – Over raced in the early and middle stages.

**CONNEMARA** (T Taiaroa) – Went off stride when racing greenly near the 250 metres. The rider reported the filly failed to handle today's track conditions.

**DERRYN @ GRANGEWILLIAM STUD SUPPORTING LIFE EDUCATION TRUST 1400**

**SEMPRINI** (E Leighton) – Began awkwardly.

**RHUZICK** (M Hashizume) – Slow begin.

**BAE CORP** (J Mudhoo) – Slow to begin.

**ZEEFA ZED** (D Montes de Oca) – Slow to begin.

**SHE'S APPLES** (K Chowdhoo) – Began awkwardly losing ground.

**TRIFOLIUM** (C Jones) – Raced keenly in early and middle stages. When questioned regarding performance rider had no excuse. Underwent a post-race veterinary examination which revealed no abnormalities.

**D Montes de Oca** (ZEEFA ZED) – Spoken to in regards to his whip use in consecutive strides.
