## RACE COMMENTS:

<b>Race 1</b>	<b>SVS STARTING GATES 1100</b>
<b>AMASTAR</b> (C Barnes) - Slow away.	

**FIGHTING FIRE** (M McNab) - Slow away. Had to be steadied when placed in restricted room passing the 1000 metres to the inside of AMASTAR (C Barnes) which shifted in. C Barnes was advised to exercise care when in similar circumstances. Raced keenly in the early stages.

**OTTAVIO** (B Rogerson) - Shifted out approaching the 400 metres to obtain clear running making contact with LITTLE BELLE which was forced wider.

**LITTLE BELLE** (A Calder) - Contacted and forced wider approaching the 400 metres.

**Race 2** | **SKYCITY HAMILTON 1200**

**RIVERPLATE** (A Goindasamy) - Began awkwardly.

**MOLINARA** (J Kamaruddin) - Began awkwardly with the rider losing the use of his right iron losing significant ground.

**POTOSI** (S Weatherley) - Began awkwardly.

**SAFANIYA** (M Hashizume) - Had difficulty obtaining clear running early in the final straight.

**R Elliot** (LOLITA) - Issued with a warning for his whip use prior to the 100 metres.

**Race 3** | **TE AKAU RACING 3YO (1400 metres)**

**SEMPER FI** (H Schofer) - Began awkwardly losing ground.

**DIAMOND DELIGHT** (R Elliot) - Slow to begin then hampered losing ground.

**SPRING SUCCESS** (T Yanagida) - Restrained behind runners shortly after the start.

**FONTEYN** (A Goindasamy) - Steadied off heels shortly after the start. Raced keenly for a distance when being restrained in the early stages.

**TEVERE** (M McNab) - When questioned regarding the performance the rider could offer no excuse.

**Race 4** | **FAIRVIEW MOTORS MILE (1600 metres)**

**LOCK UP** (V Colgan) - Began awkwardly. Over raced in the early stages then had to be restrained when awkwardly placed on heels passing the 1100 metres.

**ELEGANT CHARM** (C Dell) - Restrained behind runners shortly after the start.

**SON OF SASANOF** (T Abel) - Began awkwardly losing ground. Had to be steadied when placed in restricted room passing the 200 metres to the inside of FAYE'S WARRIOR which lay in before being corrected by its rider.

**PROPHETIC** (R Elliot) - Began awkwardly.

**FLAVIUS** (J Fawcett) - Began awkwardly then restrained from its wide barrier.

**CHOPPER REED** (S Spratt) - Raced ungenerously for a distance passing the 1400 metres.

**CHAKANA** (M McNab) - Underwent a post-race veterinary examination which did not reveal any abnormality.

**C'EST UNE STAR** (C Grylls) - Raced three wide without cover throughout.

**THE BOUNDER** (E Leighton) - Had to be steadied to avoid heels passing the 1200 metres.

**S Weatherley** (THE TWINKLING) - Issued with a warning for permitting his mount to shift in when not sufficiently clear of THE BOUNDER which had to be steadied to avoid heels passing the 1200 metres.

**Race 5** | **GREEN RACING MILE (1600 metres)**

**STEVEN JAMES** (C Grylls) - Began awkwardly losing ground.

**BIG MIKE** (E Nicholas) - Began awkwardly.

**YAMUNA** (M McNab) - Slow to begin. When questioned regarding the performance the rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.

**CRAFTY JESS** (T Newman) - When questioned regarding the performance the rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.

**MASETTO** (T Thornton) - Raced three wide without cover throughout.

**Race 6** | **NZB READY TO RUN SALE 17-18 NOV 1400**

**LADY RUDOLPH** (H Schofer) - Slow to begin.

**APPELLANT** (C Grylls) - Began awkwardly. Raced ungenerously in the early to middle stages.

**BABICHE** (A Calder) - Hampered shortly after the start.

**TAMMIE WYNETTE** (T Newman) - Raced three wide without cover throughout.

**EQUINOX** (J Kamaruddin) - Raced keenly for a distance approaching the 1000 metres when being restrained.

**GINGER TOO** (L Satherley) - Shifted outwards approaching the 300 metres making contact with PABLO ESK (M McNab), simultaneously as PABLO ESK has shifted in to improve into a marginal run with PABLO ESK then laying in and away from VIBRATO which was forced inwards by COVENANT which was dictated inwards by TAMMIE WYNETTE (T Newman) which shifted in slightly resulted in GINGER TOO being forced inwards onto heels having to be steadied. T Newman and M McNab were both advised to exercise care.

**VIBRATO** (S Spratt) - Steadied when placed in restricted room passing the 300 metres.

**COVENANT** (V Colgan) - Held up for a distance passing the 400 metres.

**PABLO ESK** (M McNab) - Held up early in the final straight before improving into a marginal run passing the 300 metres.

**D Wiles** - Admitted a charge in that he resented VIBRATO and GINGER TOO with incorrect saddle cloth numbers. The Judicial Committee imposed a fine of \$50.

**Race 7** | **DUNSTAN FEEDS 1400**

**METRO WINNER** (J Kamaruddin) - Slow to begin.

**GLITTERING ARMOUR** (S Spratt) - Crowded shortly after the start losing ground.

**THE REAL TEST** (V Colgan) - Hampered shortly after the start. Raced three wide without cover throughout.

**GERDA** (H Schofer) - Slow away.

**KIRRA LAD** (S Weatherley) - Slow to begin. Had difficulty obtaining clear running until passing the 150 metres.

**IRISH BOY** (T Newman) - Raced wide without cover throughout. Contacted passing the 200 metres when THE REAL TEST shifted out when being corrected by its rider.

**LANDRY** (C Grylls) - Held up early in the final straight then improved into a marginal run between THE REAL TEST (V Colgan) and OUR FINE WINE (L Satherley) before having to be steadied when runners either side shifted ground passing the 200 metres. Had to be steadied again passing the 150 metres again, when runners either side shifted ground. L Satherley and V Colgan were both advised to exercise care.

**SECRET SQUIRREL** (J Riddell) - When questioned regarding performance the rider advised that in his opinion the gelding would prefer some easing of the ground.

**MEDALZA** (T Yanagida) - Held up early in the final straight.

**WHOSHE'S GIRL** (M Hashizume) - Held up early in the final straight.

**HE'S THE MAN** (M McNab) - Had difficulty obtaining clear running early in the final straight.

**A Calder** (LILLY D'OR) - Was spoken to regarding his whip use prior to the 100 metres.

**ASPIRING** (T Yanagida) - Slow to begin.

**LADY GWENDOLYN** (L Satherley) - Began awkwardly.

**ELLE D'BERRY** (A Calder) - Began awkwardly.

**ZENNTARI** (H Schofer) - Began awkwardly.

**LUDUS** (A Goindasamy) - Raced in restricted room for a distance passing the 1800 metres.

**TRUTH BEKNOWN** (S Weatherley) - Hampered having to be steadied passing the 250 metres.

**HENRY HUDSON** (R Elliot) - When questioned regarding performance the rider advised that the race had not been run to suit and the gelding had lacked pace when the field sprinted entering the final straight.

**JUDY'S SONG** (M McNab) - Held up early in the straight before improving into a marginal run passing the 250 metres making contact with TRUTH BEKNOWN.

**H Schofer** (ZENNTARI) - Issued with a warning for permitting her mount to shift in when not sufficiently clear of JUDY'S SONG which was forced inwards hampering TRUTH BEKNOWN.

**C Dell** (SHEZABELTER) - Spoken to regarding his whip use prior to the 100 metres.

**S Spratt** (PEECEEE PUSSYCAT) - Spoken to regarding her whip use prior to the 100 metres.

**T Thornton** (LOVEITORLEAVEIT) - Issued with warning for her whip use prior to the 100 metres.
