## GENERAL

Rider **T Moki** advised she was unable to attend the meeting today due to illness which necessitated the scratching of SOUNDS PROMISING in Race 1 due to no other rider being available. T Moki was advised she must provide a medical certificate prior to riding next.

## SUPPLEMENTARY

**Ashburton Racing Club - Thursday, 8 July 2021**

**Race 8 - SIMS BAKERY 1600m**

**HILLERSDEN (C Jones)** – Trainer Mr D Crozier advised Stewards that on Friday 9 July HILLERSDEN underwent a veterinary examination which included endoscopic examination and blood tests, with results showing the gelding's heart rate to be back to normal and results of the blood tests showing signs of HILLERSDEN tying up. D Crozier further advised it is his intention to continue with the gelding's current preparation.

**Race 9 TREMBATH PLUMBING 1600m**

**ATHENE** (L Allpress) – Trainer Ms T Rae reported to Stewards that ATHENE was examined by the veterinarian upon return to the stable, with the mare requiring stitches to the right hind leg. T Rae further advised that ATHENE has been placed on antibiotics and will not participate in any form of exercise over the next three to four weeks.

**RACE COMMENTS**

**Race 1 HAROLD PATEMAN HURDLES 3000m**

**JACKFROST** (C Campbell) – Jumped indifferently in the early stages. Put in a poor leap at the last fence. When spoken to, the rider advised he had not been disappointed with the gelding's effort in its first up jumping race for two year and believed it would derive natural benefit from today's race.

**HEAD OFFICE** (R Cuneen) – Over raced when being restrained in the lead on a slow tempo in the early to middle stages. Further restrained near the winning post on the first occasion to take the trail. Put in a poor leap at the second to last fence unbalancing the rider.

**Race 2 TIMARU TOWN & COUNTRY CLUB MAIDEN 1200m**

**ONCEACONNER** (K Kwo) – Slow away.

**DIORADELLE** (C Campbell) – Restrained to obtain cover in the early stages after jumping from the outside barrier.

**DOUBLE PROSPERITY** (B Murray) – Raced three wide without cover throughout.

**GOOSE BAY** (T Moseley) – Over raced when being restrained going into the bend near the 900 metres and shifted inwards crowding SUPER ABBA which was also over racing having to be restrained at this point. Continued to over race for a distance.

**SUPER ABBA** (S Toolooa) – Steadied when crowded and over racing near the 900 metres. Had to be further restrained when improving onto the heels of GOOSE BAY near the 800 metres.

**NATURE BELLE** (L Callaway) – Briefly steadied when placed in restricted room passing the 900 metres. Raced greenly rounding by the 800 metres making the bend awkwardly.

**BABY CHEESES** (R Muhoo) – Lay inwards early in the run home with the rider swapping the whip to the left hand. Continued to lay in throughout the home straight.

**Race 3 POWER FARMING TIMARU LTD MAIDEN 1200m**

**CAPTAIN** (T Moseley) – Slow away after being fractious in the barriers. Lay in throughout the run home.

**RYLEE MAY** (L Callaway) – Slow away. Raced wide without cover for the majority of the race.

**AREYOUOKAY** (B Murray) – Steadied off heels near the 800 metres.

**PEMBROKE** (C Campbell) – Steadied when improving onto the heels of JUST A GIRL near the 400 metres.

**JAMIESON'S TIPPLE** (C Johnson) – Lay out under pressure in the straight.

**KHITAN WARRIOR** (S Toolooa) – Rider reported that the gelding had not been comfortable in today’s testing track conditions.

**MR HASS** (J Laking) – Rider reported that the gelding had not been comfortable in today’s testing track conditions.

**Race 4** | **SOUTH CANTERBURY SADDLERY DASH 1200m**

**ARNAGE** (R Mudhoo) – Slow to begin.

**DRAKE BAY** (M Taylor) – Restrained to obtain cover shortly after the start.

**STRAIGHT SETS** (K Asano) – Clipped a heel and blundered passing the 700 metres dislodging rider K Asano. Neither horse nor rider were injured in this incident.

**M Taylor** (DRAKE BAY) admitted a breach of the careless riding rule in that she directed her mount outwards passing the 700 metres forcing STRAIGHT SETS onto the heels of HOLY LOCH, eventually clipping a heel and blundering with K Asano being dislodged. After hearing submissions, the Adjudicative Committee suspended M Taylor’s licence to ride in races from the conclusion of racing on Sunday 25 July until the conclusion of racing on Saturday 22 August, 4 national riding weeks.

**T Moseley** (THE BUFFER) admitted a breach of the excessive whip use rule prior to the 100 metres when using his whip above shoulder height, with the Adjudicative Committee imposing a fine of \$300.

**B Murray** (I’M A TIGER) was issued with a warning for his whip use prior to the 100 metres.

**Race 5** | **JON SNOW @ CLEARVIEW PARK SPRINT 1200m**

**PLAY THE FIELD** (K Asano) – Slow away. Raced three wide without cover throughout.

**KITTY POWER** (M Taylor) – Crowded shortly after the start losing ground.

**PHELAN THE POWER** (C Johnson) – Jumped in the air at the start and was slow away as a result.

**BOYSLIGHTUP** (T Jonker) – Restrained to obtain cover after jumping from the outside barrier.

**ALL OR NOTHING** (L Callaway) – Over raced in the early stages.

**BLINDSPOTT** (R Mudhoo) – Awkwardly placed on heels passing the 900 metres having to be restrained.

**Race 6** | **NZB INSURANCE PEARL SERIES RACE 1600m**

**MISS OAKS** (K Williams) – Slow away.

**ITS SO EASY** (M Taylor) – Slow away and lost contact with the body of the field through the middle stages despite the efforts of the rider.

**SURE IS** (T Comignaghi) – Slow away.

**PAPAGENA** (S Toolooa) – Made the first turn awkwardly. Crowded making contact with the rail and becoming briefly unbalanced passing the 900 metres when placed in restricted room by MISS HARLEY QUINN which lay inwards at this point.

**RINGADINGDING** (S Khetoo) – Made contact with the running rail before becoming briefly unbalanced passing the 900 metres. When spoken to regarding the apparent improved performance, co-trainer K Tyler was at a loss to explain the mare’s poor performance at her last start after having gone a good race at this venue two starts ago, and added that the stable apprentice rider’s 4 kg claim had assisted today.

**CRISPIN** (J Lowry) – Rider reported that the mare had held its breath during the running.

**S Khetoo** (RINGADINGDING) admitted a breach of excessive whip use prior to the 100 metres, with the Adjudicative Committee imposing a fine of \$400.

**CASE STUDY** (J Lowry) – Slow away.

**HARLEEN QUINZEL** (G Jogoo) – Slow away.

**CASTLE BLACK** (K Asano) – Slow away. Raced wide without cover throughout.

**VALYRIAN** (R Mudhoo) – Slow away. Raced three wide without cover throughout.

**COAX** (S Toolooa) – Raced keenly in the early stages having to be steadied away from heels passing the 1400 metres.

**MEGALOMANIAC** (K Williams) – Steadied off heels racing into the bend near the 900 metres. When questioned regarding the performance of this favoured runner, rider advised that in her opinion the mare had not handled the step up in distance on today’s testing track. Received post-race veterinary treatment for an irregular heart rhythm. Stewards will follow up with the stable in coming days.

**EAVESDROP** (C Campbell) – Lay in early in the run home having to be straightened on at least two occasions. Rider reported that the mare had held its breath during the running.

**WESTERN DREAM** (S Khetoo) – When questioned regarding the disappointing performance, the rider was of the opinion the gelding was not comfortable in today’s track conditions.

**SUMMER NIGHT** (K Williams) was a late scratching at 3.39 pm on veterinary advice after rearing up and becoming cast in the barriers, which delayed the start approximately two minutes. Trainer D Crozier was advised that the mare is now required to barrier trial to the satisfaction of a Stipendiary Steward prior to racing next.

**FORT WILLIAM** (K Asano) – Jumped away awkwardly losing ground.

**ICEBREAKER** (T Moseley) – Slow to begin. Under pressure passing the 800 metres and was not persevered with over the concluding stages. A warning was placed on the mare’s racing manners.

**KENKI** (B Murray) – When asked to comment on the disappointing performance, the rider was of the opinion the gelding had failed to handle today’s testing track conditions.
