### RACE COMMENTS:

Race 1	SUPER STAR SEA KING HURDLE (2900 Metres)
	<b>DR HANK</b> (S Phelan) – Over-raced in the early stages and skied its head for some distance when being restrained. Shifted out and bumped FANTASY FLIGHT when jumping the second fence.
	<b>KIPKEINO</b> (E Farr) – Retired from the race near the 1300 metres after E Farr considered there was something amiss with the gelding. A subsequent veterinary examination initially revealed KIPKEINO to have suffered tachycardia. A further check a short time later revealed an underlying atrial fibrillation. Connections were advised that a veterinary clearance is required prior to KIPKEINO racing or trialing next.

**FANTASY FLIGHT** (D Parker) – Bumped second fence. Hampered second last fence.

**RITESAIDZED** (H McNeill) – Jumped the fourth last fence awkwardly.

**BAKELA** (S Fannin) - Hit the fence near the 400 metres and blundered.

**ELUSIVE ACE** (M Cropp) – ELUSIVE ACE ran out at the second last fence, briefly hampering FANTASY FLIGHT. Connections of the third place FANTASY FLIGHT viewed footage of the final stages but elected not to proceed with an objection against the second placed ELUSIVE ACE.

**M Gibbs-Manssen** (MY TOMMY) – Spoken to regarding his whip use in the home straight.

**Race 2** | **SUPER STAR ZED EM 'CHASE' (4000 Metres)**

**WHOLETTHEFOXOUT** (S Fanin) – Jumped the last fence poorly. WHOLETTHEFOXOUT returned to the enclosure with blood present in both nostrils. A subsequent veterinary inspection, which included an endoscopic examination, revealed the gelding to have suffered a head trauma and was not considered a bleeder.

**NOTABADROOSTER** (M Cropp) - Hit the last fence.

**COCONUT** (J Seivwright) - When questioned J Seivwright advised the gelding, which got back in the early stages, was outpaced on the better going in the centre and struggled to maintain contact with the field throughout.

**Race 3** | **THANKS FOR THE MEMORIES MELODY BELLE 1400 (1400 Metres)**

**MADURO** (T Taiaroa) - Began awkwardly. Raced in restricted room in the early part of the home straight and when being angled out dictated HAPPY STAR over a little extra ground.

**L Allpress** (HAPPY STAR) – Spoken to regarding the use of her whip prior to the 100 metres.

**Race 4** | **WOODRIDGE HOMES 2200 (2200 Metres)**

**SPEED CALL** (A Scott) – Began awkwardly and settled back. Commenced to over-race in the back straight so was allowed to stride forward to lead near the 1400 metres.

**SENASSY** (L Kennedy) - Steadied off heels near the 1600 metres.

**NEDWIN** (B Yuill) - Shifted out under pressure over the final stages.

**ROCKING GOOD TIME** (C Isdale) – When questioned, C Isdale advised the gelding had got its tongue over the bit near the 2000 metres placing him at a disadvantage for the remainder of the race.

**Race 5** | **JENNIAN HOMES 2100 (2100 Metres)**

**BRINGITONPET** (L Allpress) – Underwent a pre-race veterinary examination and was cleared to start after coming into contact with a fence in the enclosure. Dismounted on returning to the enclosure as L Allpress considered there was something amiss. A subsequent veterinary examination was clear.

**COLLINSTREET** (C Jones) - Shifted out under pressure in the home straight.

**STORMY HABIT** (D Hirini) - Unsited to the slow early pace so was taken forward to lead in the back straight.

**Race 6** | **CARFINANCE.CO.NZ 1000 (1000 Metres)**

**VATICAN NEWS** (L Allpress) - Slow away.

**CHIKIRA LASS** (T Taiaroa) - Slow away.

**CASAQUINMAN** (S O'Malley) – Began awkwardly and was slow away. Ran wide in the straight in search of better footing. Shifted in when struck with the whip near the 200 metres.

**MAGIC INCANTO** (M Hudson) - Ran wide in the straight in search of better footing.

**S O'Malley** (CASAQUINMAN) - Was spoken to regarding his whip use prior to the 100 metres.

<b>Race 7</b>	<b>WYNDSPELLE AT GRANGEWILLIAM STUD 1600 (1600 Metres)</b>

**WAY ABOVE** (C Butler) – Slow away.

**KAHU ROCK** (D Hirini) – Saddle slipped forward in the back straight, placing rider D Hirini at a disadvantage for the remainder.

**CHASE** (C O'Beirne) - Inclined to shift in in the straight and had to be straightened.

**KEEP QUIET** (L Allpress) - When questioned into the run of KEEP QUIET, L Allpress was of the opinion the gelding may be better suited to a longer distance.

**C Butler** (WAY ABOVE) – Issued with a warning for her use of the whip prior to the 100 metres.

<b>Race 8</b>	<b>NZB INSURANCE PEARL SERIES RACE (1400 Metres)</b>

**WORT HOG** (S Macnab) - Tightened at the start.

**FAR SITE** (C Jones) – Slow away. Bumped final stages.

**SURPRIZE ME** (L Hemi) – Jumped out and made heavy contact with MISS DIXIE and COOGA MOON at the start.

**COOGA MOON** (C Butler) – Bumped start.

**MISS DIXIE** (L Allpress) – Bumped start. When questioned into the run of MISS DIXIE, L Allpress advised the filly had raced keenly in the early and middle stages and had little left at the finish.

**D Hirini** (ESTEFANIA) – D Hirini was shown footage of her ride and issued with a warning under Rule 638(1)(d) for allowing her mount ESTEFANIA to shift out some distance in the home straight, bumping with FAR SITE inside the 100 metres. D Hirini was advised she is expected to straighten her mount sooner than she did on this occasion.
