**Race 7 - AGC TRAINING STAKES WFA 1600**

**L Allpress** (CROWNING STAR) – L Allpress was issued with a warning under [Rule 638(3)(b)(ii)] in that she used her whip excessively prior to the 100 metres.

**Race 2 - MONSTAVISION SUPPORTING LIFE EDUCATION TRUST HWT**

**C Chipperfield** (I AM A CRAFTSMAN) - Fined \$250 by the Judicial Committee for using his whip excessively prior to the 100 metres.

**N Downs** (BLANCO BAY) - Fined \$350 by the Judicial Committee for using his whip excessively prior to the 100 metres.

**RACE COMMENTS:**

**Race 1** | **WANGANUI FUNCTION CENTRE HWT 2060**

**JACKAROO** (S O'Malley) - Began awkwardly losing ground.

**MASTER FIN** (C Chipperfield) - Began awkwardly losing ground. Raced in restricted room for a distance passing the 1200 metres.

**FRANKLIN** (B Donoghue) – Began awkwardly losing ground.

**THE COSSACK** (H McNeill) – Began awkwardly. Hampered when forced wider 400 metres.

**RED RUFUS** (T Johnson) - Lay out shortly after the start despite the efforts of its rider crowding HE'S RIC approaching the 1900 metres. Continued to race ungenerously when hanging out through the early and middle stages. Became awkwardly placed near heels passing the 400 metres when laying out, shifting out forcing HE'S RIC on to THE COSSACK which was forced wider. Footage of this incident proved inconclusive with Rider T Johnson advising that the gelding's racing manners had caused the incident. When questioned regarding the performance Rider T Johnson advised that the gelding had not been entirely comfortable in today's track conditions.

**HE'S RIC** (N Downs) - Crowded 1900 metres when steadied. Briefly hampered 400 metres.

**VERRY FLASH** (K Macnab) - Raced wide without cover for the majority of the race.

**E Farr** (NITRO TED) - Was reminded of her obligations regarding her whip use.

**H McNeill** (THE COSSACK) – Was reminded of his obligations regarding his whip use.

**Race 2** | **WANGANUI MASTER PAINTERS MAIDEN 2060**

**FATHER DOM** (S Macnab) - Slow to begin.

**GO MICKEY** (D Bradley) – Slow to begin.

**SPLODGE** (J Riddell) - Over-raced in the early stages.

**IAN'S LEGACY** (D Hirini) – Crowded 1700 metres then raced keenly for a distance.

**SWIFT** (C O'Beirne) - Commenced to over-race when being restrained in the early stages becoming awkwardly placed near the heels of **GREYSTONE** (C Jones) passing the 1700 metres which shifted in. As a result **IAN'S LEGACY** who was racing to the inside of **SWIFT** was also crowded for a short distance. Apprentice Rider C Jones was reprimanded and advised that he must be fully clear when shifting ground.

**Race 3** | **JOHNNY MAC MEMORIAL MAIDEN HWT 1600**

**FIRE DANCER** (M Roustoby) - Began awkwardly losing ground.

**JENEVER** (S Fannin) – Began awkwardly losing ground. Rider S Fannin reported the mare failed to handle the existing track conditions. A veterinary examination could find no obvious abnormality.

**DR ZEUS** (B Donoghue) – Began awkwardly losing ground. Awkwardly placed 900 metres.

**HAPPY CHAPPY** (K Macnab) - Raced keenly in the early stages.

**Race 4** | **B CONNORS FAMILY CLAN 1600**

**CANDY CROSS** (C Dell) - Crowded leaving the barrier.

**WINE N'DINE** (M Hudson) – Began awkwardly.

**SIR BEETS** (J Riddell) - Steadied from a wide barrier.

**MIRACULOUS** (B Rogerson) - Restrained 1400 metres when in restricted room then raced keenly for a distance.

**GOBUYIT** (C Butler) – Restrained to avoid heels 1400 metres then raced keenly in the early stages.

**MAUNA LOA** (C Jones) - Steadied when crowded 1400 metres.

**SMOOTH COGNAC** (D Hirini) - Shifted out 300 metres when becoming awkwardly placed.

**LUCKY VIKING** (K Hercock) – Crowded and checked 300 metres.

**FLYING ZACK** (L Hemi) - Raced in restricted room 300 metres.

**WONDERFUL BARBIE** (L Kauri) – Inconvenienced 125 metres and steadied to avoid heels.

**ST NANCY** (S Macnab) - Raced in restricted room near the 300 metres.

**D Hirini** (SMOOTH COGNAC) - Issued with a warning after permitting SMOOTH COGNAC to shift in near the 1400 metres crowding MUANA LOA and GOBUYIT which were both steadied.

**C Jones** (MUANA LOA) – Issued with a warning after allowing MUANA LOA to shift out near the 125 metres inconveniencing WONDERFUL BARBIE which was steadied to avoid heels.

**D Hirini** (SMOOTH COGNAC) - Admitted a breach of careless riding in that she permitted SMOOTH COGNAC to shift out near the 300 metres when insufficiently clear of LUCKY VIKING which was crowded and checked. After considering submissions the Judicial Committee suspended her licence to ride in races from the conclusion of racing on Friday 25 June up to and including racing on Friday 2 July, 4 national riding days and in addition fined \$200.

<b>Race 5</b>	<b>GUDELL CLAN 1200</b>
<p><b>RINGTHEBELLEDARCI</b> (M Singh) - Began awkwardly unbalancing its rider then crowded.</p> <p><b>KOPUA</b> (S O'Malley) – Crowded shortly after the start.</p> <p><b>ALEXAVIA</b> (D Montes de Oca) – Began awkwardly shifting out and when being corrected by its rider shifted in crowding KOPUA and RINGTHEBELLEDARCI.</p> <p><b>GLAMOUR</b> (H Schofer) - Raced ungenerously when being steadied in the middle stages.</p> <p><b>CHEEKY AZZ</b> (C O'Beirne) – Briefly steadied approaching the 300 metres to avoid the heels of RINGTHEBELLEDARCI. M Singh was advised to exercise greater care in similar circumstances.</p> <p><b>HARRY HARRISON</b> (A Mudhoo) - Briefly steadied 100 metres to avoid the heels of CHEEKY AZZ which shifted in.</p> <p><b>K Hercock</b> (CHEERS) - Reminded of her obligations in that she must ride her mounts out fully to the end of the race when circumstances permit her to do so.</p> <p><b>D Bradley</b> (TANGO LOVE) - Was reminded of his obligations in that he must ride his mounts out fully to the end of the race when circumstances permit him to do so.</p>	
<b>Race 6</b>	<b>THE WHANGAEHU O'LEARYS 1360</b>
<p><b>RACED EVENS</b> (J Kamaruddin) - Raced keenly when leading.</p> <p><b>NOW IS NOW</b> (L Allpress) - When questioned regarding the performance Rider L Allpress advised her mount was unsuited to the existing track conditions.</p>	
<b>Race 7</b>	<b>MAD BUTCHER MAIDEN 1360</b>
<p><b>BLUE ARROW</b> (H Schofer) - Crowded start losing ground. Raced ungenerously for a distance passing the 1000 metres.</p> <p><b>ALBUFEIRA</b> (D Hirini) - Began awkwardly.</p> <p><b>KINGFISHER LAD</b> (S O'Malley) - Began awkwardly. Raced in restricted room passing the 300 metres between ICONIC LASS which lay out when making the bend between and SHEZ MALEFICENT which shifted in when the rider was changing whip hands.</p> <p><b>KAITLIN ROSE</b> (C Jones) - Saddle shifted forward in the early stages placing the rider at a disadvantage for the remainder of the race.</p> <p><b>ICONIC LASS</b> (A Mudhoo) - Lay out when making the bend and continued to lay out in the final straight.</p> <p><b>LORD SPENCER</b> (L Allpress) – Began awkwardly.</p> <p><b>MIRACLES TAKE TIME</b> (D Montes de Oca) – Raced keenly when being restrained in the early stages then further restrained to avoid heels 1200 metres.</p> <p><b>R Elliot</b> (GAELIC SPIRIT) – Issued with a warning after he allowed GAELIC SPIRIT to shift out near the 1200 metres dictating KAITLIN ROSE into the line of MIRACLES TAKE TIME which had to steady. Stewards took into account that the saddle on KAITLIN ROSE had commenced to shift forward at the time placing the rider in difficulty and also the racing manners of MIRACLES TAKE TIME which had been racing ungenerously leading up to the incident.</p>	

<b>Race 8</b>	<b>ST JOHN'S CLUB MAIDEN 1360</b>
<p><b>RONI</b> (J Riddell) - Underwent a veterinary examination on arrival at the barrier after being kicked and was declared a late scratching at 4.06pm.</p> <p><b>CHOLULA</b> (H Schofer) – Slow to begin. Awkwardly placed 300 metres.</p> <p><b>DERECHO</b> (D Hirini) – Raced in restricted room soon after the start and steadied. Improved into restricted room 600 metres then restrained. Had some difficulty obtaining clear running early in the final straight.</p> <p><b>BUSYBEINGFABULOUS</b> (L Allpress) - Dipped when making the crossing near the 1100 metres.</p> <p><b>DAWN COUNTY</b> (S Macnab) – Commenced to over-race in the early stages becoming awkwardly placed near heels for a distance and shifting out near the 1100 metres crowding ZOEY SATIN onto SACRED LADY. DAWN COUNTY then continued to over-race for a distance.</p> <p><b>ZOEY SATIN</b> (A Mudhoo) – Crowded 1100 metres.</p> <p><b>SACRED LADY</b> (C O'Beirne) – Crowded 1100 metres. Dipped when improving near heels 700 metres.</p>
