Race 5 GREEN RACING MILE (1600 metres)

CRAFTY JESS (T Newman) – Co-trainer Mr A Forsman advised Stewards, the stable was satisfied with the post-race condition of the mare, however, CRAFTY JESS, will be given a brief freshen up.

YAMUNA (M McNab) – Trainer Mr D Miller advised Stewards, he was satisfied with the post-race condition of YAMUNA, and it is his intention to continue with the mare's current preparation.

RACE COMMENTS:

Race 1	ATLAS QUARRIES (1400 metres)
<p>HIT THE ROAD JACK (E Nicholas) – Slow to begin. Commenced to race keenly in the middle stages shifting out to avoid heels near the 800 metres forcing FRIENDLY FIRE wider on the track. Lay in under pressure in the final straight.</p> <p>FRIENDLY FIRE (J Riddell) – Forced wide from near the 800 metres.</p> <p>SHIRAZELLE (D Danis) – Slow to begin. Raced wide without cover for the majority of the race. Crowded 300 metres by HIT THE ROAD JACK which lay in under pressure. E Nicholas was advised that she must take greater care in a similar circumstance.</p> <p>VISTOCK (S Spratt) – Began awkwardly. Held up early in the final straight. When questioned regarding performance Rider S Spratt advised that after beginning awkwardly the mare had got back further than anticipated but could offer no further excuse. Underwent a post-race veterinary examination which failed to find any obvious abnormality.</p> <p>SELVA VERDE (T Newman) – Steadied to avoid heels passing the 1200 metres then over-raced for a distance.</p> <p>BOOMER HILL (C Grylls) – Held up early in the final straight.</p> <p>E McCall (OCEANS OF STANIMA) – Issued with a warning after permitting OCEANS OF STANIMA to shift in near the 1200 metres when insufficiently clear of SELVA VERDE which had to be steadied to avoid heels.</p> <p>N Bishara (SELVA VERDE) – Fined \$500 by the Judicial Committee after admitting a breach in that he misconducted himself by raising his voice and giving instructions to his jockey that were inappropriate after it had been fractious in its preliminary.</p>	
Race 2	O'CASEY STAKES (1400 metres)
<p>ACQUITTAL (B Rogerson) – Began awkwardly.</p> <p>BONO (L Satherley) – Began awkwardly.</p> <p>APATCHEE POWER (E Nicholas) – Crowded at the start.</p>	

RELIABELLE DEB (D Danis) – Began awkwardly.

ISTINA (E McCall) – Restrained from its wide barrier. Raced keenly passing the 900 metres when being restrained.

THATCHER (A Calder) – Raced wide without cover.

CAUSE CELEBRE (T Thornton) – Raced keenly when being restrained to obtain cover for a distance passing the 1000 metres.

WAR COMMAND (S Weatherley) – Forced wide passing the 700 metres by **ACQUITTAL** which shifted out when improving forward.

KHANT REID (T Moseley) – Underwent a post-race veterinary examination which failed to reveal any obvious abnormalities.

B Rogerson (**ACQUITTAL**) – Issued with a warning after permitting **ACQUITTAL** to shift out passing the 700 metres hampering **WAR COMMAND** which was forced wider on the track.

T Moseley (**KHANT REID**) – Spoken to for his use of the whip on a runner that is out of contention.

J Fawcett (**I'M ALICE**) – Spoken to for her use of the whip on a runner that is out of contention.

L Satherley (**BONO**) – Spoken to for her use of the whip on a runner that is out of contention.

E McCall (**ISTINA**) – Spoken to for her use of the whip on a runner that is out of contention.

Race 3	TRIGG CONSTRUCTION (1200 metres)

A false start was declared after the barrier stalls malfunctioned when the start was effected. **DARCI'S FLIGHT** (S Collett) dislodged its rider shortly after the start with the remaining runners galloping various distances before being pulled up. S Collett was attended to by St John Ambulance personnel and found to be uninjured. **DARCI'S FLIGHT** who had dislodged its rider and galloped a distance and **ROOFTOP** who had also galloped a distance were declared late scratchings with **ALL ABOUT YOU** (S Spratt), **LADY MAK** (J Kamaruddin) and **NIGHT 'N' VEGAS** (E Nicholas) also declared late scratchings acting on advice of the veterinarian. It was established an electrical fault had caused the starting gates to malfunction. When the remaining runners were at the barrier it was further established the backup manual starting mechanism was not in working order. A ruling was requested by Stewards with the Judicial Committee abandoning Race 3. The manual start mechanism was then able to be repaired after consultation, with the barrier stalls undergoing considerable testing prior to the meeting resuming with Race 4 running late as a result.

Race 4	MARSDEN COVE DENTAL (1600 metres)

WITSABOUTHIM (M McNab) – Slow to begin. Inclined to lay in under pressure in the final straight.

WHETU (S Weatherley) – Slow to begin. Had difficulty obtaining clear running throughout the final straight.

BE SOMEBODY (T Newman) – Raced keenly in the early and middle stages.

GREGORY (S Spratt) – Raced wide without cover throughout.

BARRACUDA (J Kamaruddin) – Made the crossing awkwardly shifting out hampering **LAPEL** approaching the 1400 metres.

LAPEL (L Satherley) – Hampered 1400 metres. Had difficulty obtaining clear running in the final straight until shifting out passing the 100 metres to obtain clear running.

STRAIGHTSHOOTERDEB (S Collett) – Proved difficult to load into the barriers with Trainer T Powell advised that the filly will be required to barrier trial to the satisfaction of Stewards prior to racing again. Contacted 30 metres by NONAAME which had lay out when improving to the inside with STRAIGHTSHOOTERDEB becoming briefly unbalanced.

Race 5	LOGIC FENCE (1600 metres)

FLYING FANTASIA (J Kamaruddin) – Began awkwardly losing ground. Raced keenly for a distance passing the 1200 metres when being restrained.

RIVER RUN (M McNab) – Restrained behind runners shortly after the start.

TRIGON LAD (T Thornton) – Restrained behind runners shortly after the start.

RONCHI (M Hashizume) – Raced ungenerously in the early and middle stages.

MAKE TIME (S Spratt) – Hampered 1300 metres. When questioned regarding performance rider S Spratt was unable to offer any excuse. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

OHCEEDEE (J Riddell) – Raced keenly for a distance passing the 1200 metres when being restrained.

HUGH GLASS (E McCall) – Raced three wide without cover throughout.

CALL ME EVIE (J Fawcett) – Contacted 250 metres by MAKE TIME which shifted out under pressure with CALL ME EVIE becoming briefly unbalanced.

QUEEN CONSTANTINE (C Grylls) – Had difficulty obtaining clear running in the straight before improving into restricted room passing the 150 metres.

SUPER GEE (A Goindasamy) – Held up early in the final straight having to shift out to obtain clear running approaching the 200 metres.

M Hashizume (RONCHI) – Issued with a warning after permitting RONCHI to shift in near the 1300 metres when insufficiently clear of CALL ME EVIE which became awkwardly placed on that runner's heels laying in and hampering MAKE TIME.

Race 6	TELFER YOUNG (1200 metres)

FUNTONIC (J Riddell) – Slow to begin.

MINI MYSTIC (E Nicholas) – Slow to begin.

LAURANT (C Grylls) – Slow to begin. Had to be steadied when awkwardly placed on heels passing the 1150 metres. Improved onto heels and steadied approaching the 200 metres. Underwent a post-race veterinary examination which failed to reveal any obvious abnormalities.

MANCHU (A Goindasamy) – Slow to begin.

FINN McCOOL (M Hashizume) – Raced wide without cover throughout.

JOEY'S GIFT (S Spratt) – Hampered when crowded 1000 metres then over-raced for a distance.

BOLT FROM THE BLUE (E Leighton) – Raced wide in the early to middle stages.

HASSTOBEYOU (V Colgan) – Contacted 150 metres becoming briefly unbalanced by BOLT FROM THE BLUE.

J Kamaruddin (VIKING) – Issued with a warning after permitting VIKING to shift in near the 1000 metres when insufficiently clear of JOEY'S GIFT which was hampered.

Race 7	MWIS LAWYERS BREAM BAY CUP (2100 metres)

RISING RENOWN (A Calder) – Began awkwardly with its head making contact with the gate with the left Side Winker becoming partially detached and then falling off during the running.

SONOFABUTCHER (D Danis) – Slow to begin. Had blood present in both nostrils following the race and after undergoing a veterinary examination, was deemed to have bled. SONOFABUTCHER is now subject to a 2 month stand down from training and a 3 month stand down from racing or trialling with a clear veterinary certificate of fitness being required prior to racing or trialling next.

BIG MIKE (E Nicholas) – Began awkwardly.

MASETTO (E McCall) – Slow to begin. Restrained 1700 metres when awkwardly placed near runner's heels.

CASSIO (M Hashizume) – Slow to begin. Raced wide without cover throughout. Commenced to give ground from near the 700 metres hampering ORAKEI OVERLORD which was steadied to avoid that runner's heels near the 600 metres, losing ground. Rider reported that the saddle slipped near the 1700 metres placing him at a disadvantage for the remainder of the race. Underwent a post-race veterinary examination which failed to reveal any obvious abnormalities.

DOUBLE HAPPY (A Goindasamy) – Raced wide throughout.

FINAL SUGGESTION (L Satherley) – Restrained behind runners shortly after the start.

MAJOR TOM (T Newman) – Restrained behind runners shortly after the start. Had to be restrained off the heels of the weakening INCY WINDY SPIDER near the 600 metres, losing ground.

E Nicholas (BIG MIKE) – Issued with a warning for her whip use prior to the 100 metres.

C Grylls – Fined \$100 under the minor infringement schedule for failing to make the contracted weight for DOUBLE HAPPY and was replaced by A Goindasamy.

PIMMS 'N' PEARLS (A Goindasamy) – Became fractious in its barrier stall and was then removed to undergo a veterinary examination and cleared fit to race. Underwent a post-race veterinary examination which could detect no significant abnormalities other than minor lacerations to the inside of both nostrils.

LOVE SQUIRRELS (V Colgan) – Slow to begin.

MONACO (M Hashizume) – Hampered leaving the barriers, losing ground.

MANRICO (E McCall) – Hampered leaving the barriers, losing ground.

GIGOLO GEORGE (T Moseley) – Raced keenly in the early to middle stages.

ACUTUS (J Kamaruddin) – Restrained off heels 850 metres.

BREEZON (S Spratt) – Commenced to race keenly for a distance from near the 900 metres and continued to do so through the middle stages.

NEW YORK JAZZ (T Newman) – Improved onto the heels of PIMMS ‘N’ PEARLS which commenced to give ground appreciably approaching the 250 metres and was checked.

CHEVAL PROMETTEUR (J Riddell) – Improved into a diminishing run approaching the 100 metres to the outside of BURGUNDY ROSE which shifted out under pressure with CHEVAL PROMETTEUR being held up. N Parmar was reprimanded by Stewards and advised that he must make a greater attempt to straighten his mounts when they are shifting ground, with Stewards considering some slight outward movement from EVA JAMES which had contributed to the incident.

Race 9	COOKSON PLUMBING (1600 metres)

PARISIAN (B Rogerson) – Crowded leaving the barrier losing ground.

MAKZABEEL (A Goindasamy) – Began awkwardly then steadied.

RED RUSHIN (M Hashizume) – Steadied from a wide barrier.

QUALITY PREVAILS (J Fawcett) – Began awkwardly. Improved into restricted room passing the 150 metres.

BENTAYGA (M McNab) – Restrained in the early stages in an attempt to obtain cover.

CATE BLANCO (T Thornton) – Contacted approaching the 400 metres, becoming unbalanced on two occasions.

SYMPATHIQUE (T Newman) – Held up passing the 400 metres and then for a distance approaching the 200 metres.

M McNab (BENTAYGA) – Issued with a warning after permitting BENTAYGA to shift out approaching the 400 metres when insufficiently clear of CATE BLANCO contacting that runner which became unbalanced. Stewards considered the racing manners of CATE BLANCO which lay back in when initially contacted.

J Kamaruddin (EXCITONIC) – Issued with a warning for his whip use prior to the 100 metres.
