RACE COMMENTS:

Race 1 PASLODE NEW ZEALAND MAIDEN HURDLES (2800 Metres)

SOIREE (G Walsh) – Crowded shortly after the start, losing some ground. Put in a poor jump at the 900 metres, losing ground from this point. Retired prior to jumping the second to last fence.

LA JUNGLES (J Seivwright) – Retired prior to jumping the second to last fence when out of contention.

PHELAN FOXY (B Donoghue) - Put in a faulty leap at the last fence, losing momentum.

Race 2 MANAWATU ITM AWAPUNI HURDLES (2900 Metres)

Trainer S Houston was issued with a warning under Rule 537(a) for the late declaration of rider H McNeill for MOKELE MBEMBE.

CHIEF SEQUOYAH (S O'Malley) - Put in an awkward leap at the second fence.

MAGIC CANNON (E Farr) – Raced keenly through the early stages. Ran down the last fence.

MOKELE MBEMBE (H McNeill) - Raced wide without cover through the early to middle stages.

MR FLYNN (R Cole) - Gave ground from the 1000 metres. Retired from the event prior to jumping the second to last fence.

SENASSY (D Parker) - Made a poor leap at the last fence.

BAKELA (S Fannin) - When asked to comment on the performance of BAKELA rider S Fannin could offer no tangible excuse. Trainer K Myers reported the gelding appeared to be suffering from dehydration post-race.

Race 3 CODY SINGER MEMORIAL STEEPLECHASE (3200 Metres)

THE FOT (D Parker) Put in a poor leap at the fence near the 1600 metres.

WICKLOW (S O'Malley) – Mixed its jumping and lost contact with the field passing the 2000 metres. Landed awkwardly after jumping the second to last fence, briefly losing its footing, unbalancing the rider with the horse being retired from the event as a result. When questioned, S O'Malley advised the gelding, which was having its first steeplechase start, jumped the brush fences too high and would improve with experience.

MRS TWINKLETOES (B Donoghue) - Made contact with a track marker near the 800 metres. Ran down the second to last fence.

PERIAN SPRING (E Farr) – Put in a poor leap at the last fence, landing awkwardly and briefly unbalancing the rider.

H McNEILL (ITISWHATITIS) – Spoken to advisedly regarding his celebratory gesture.

Race 4 LJ HOOKER MANAWATU STEEPLECHASE (4200 Metres)

TITTLETATTLE (G Walsh) – Very slow to begin. Landed awkwardly at the last fence.

AIGNE (S Fannin) – Put in a poor leap at the third fence, dislodging the rider. Both horse and rider were uninjured.

COUNTRY BUMPKIN (J Seivwright) – Ran down the fence at the 2400 metres hampering COCONUT as a result. COUNTRY BUMPKIN continued to run down its fences. Put in an awkward leap at the fence passing the 900 metres.

COCONUT (B Donoghue) - Hampered at the fence near the 2400 metres. Made contact with a marker near the 800 metres.

The connections of 2nd placed COUNTRY BUMPKIN (J Seivwright) viewed stewards' video footage of the race and in particular the area near the 800 metres where the 1st placed COCONUT made contact with a track marker, and in particular whether COCONUT had run the correct course. After viewing video footage connections elected not to proceed with an objection. Stewards questioned both riders but due to inconclusive video footage took the matter no further.

Race 5 IPL MARKETING LTD/NELSON PINE INDUSTRIES LTD 1600 (1600 Metres)

HARTLEY (A Mudhoo) - Over-raced in the early stages.

DEZ (S O'Malley) - When questioned into the run of DEZ, S O'Malley advised the gelding never travelled at any stage but had no excuse.

L Allpress (HAPPY STAR) – Spoken to regarding her the use of her whip prior to the 100 metres.

Race 6 WINSTONE WALLBOARDS 1100 (1100 Metres)

CASAQUINMAN (L Allpress) – Underwent a pre-race veterinary inspection and was cleared to start, after being kicked behind the barriers.

JUSTASKME (H Schofer) – Slow to begin; outpaced through the early stages despite the efforts of the rider. When questioned, H Schofer reported the gelding was reasonably comfortable in the going but would benefit with the addition of blinkers.

Race 7 MARSHALL INNOVATIONS 1200 (1200 Metres)

KOXINGA (S O'Malley) – Slow to begin.

EKSTREMEMISS (D Bradley) – Crowded shortly after the start losing ground.

EVA AMELIA (D Hirini) - Was under pressure passing the 600 metres and failed to maintain contact with the field, dropping out to finish in a distant last placing.

DIOGENES (C Jones) – Began awkwardly, contacted by an outside runner, being dictated inwards. Lay inwards passing the 50 metres becoming awkwardly placed on heels, having to be straightened by its rider.

Race 8 REDSTAG TIMBER LTD 1400 (1400 Metres)

VENATO (H Schofer) – Underwent a pre-race veterinary examination and was cleared to start after becoming fractious in the barriers. Crowded and contacted start losing ground.

MANOLO (L Hemi) – Shifted out at the start crowding and contacting VENATO with both these runners losing ground.

MY ZED (F Lazet) – Crowded shortly after the start losing ground.

PRINCE LEO (D Bradley) – When questioned, rider D Bradley advised the gelding was uncomfortable in today's conditions and is better suited to more ground.
