Race 1	BONNY GLEN LANDFILL-MIDWEST DISPOSALS 1200
TOWN BELT	<b>r</b> (T Taiaroa) – Made the bend awkwardly approaching the 850 metres.
	(L Hemi) – Went off stride 800 metres becoming unbalanced. Improved into restricted room near the 75 briefly steadied.
HALLELUJA	<b>H BROTHER</b> (A Mudhoo) – Hung outwards, making the bend near the 850 metres awkwardly and raced

#### Race 2 KELLY WATT & ASSOCIATES/RAYNER BUILDING LTD 1200

**GORGEOUS GEISHA** (S Macnab) – Was removed from the barrier after becoming fractious to undergo a veterinary examination and was cleared fit to race.

**BUTLER** (H Schofer) – Stewards inquired into the reason BUTLER was removed from its barrier. Starter G Phillips advised that in his opinion with the enforced delay due to the manners of GORGEOUS GEISHA, BUTLER had become restless and given its history was removed from its barrier until GORGEOUS GEISHA had been vetted.

TONADILLAS (D Hirini) – Slow to begin (3L).

SUSSEX (C O'Beirne) – Began awkwardly.

VATICAN NEWS (L Allpress) – Slow to begin.

### Race 3 BJW MOTORS/ALLAN MCNEILL 1300

**BEE STING** (H Schofer) – Began awkwardly and then crowded and steadied. Raced fiercely in the early stages when being restrained.

**JUGADOR** (D Hirini) – Began awkwardly, making contact. Restrained when improving on to heels near the 1100 metres. When questioned regarding the improved performance, Trainer D Parry advised that gelding had been temperamental, and the addition of blinkers and a shadow roll had been of benefit today.

**SIR BRIG O'DOON** (D Bradley) - Blundered leaving the barrier.

MYSALLY (A Mudhoo) - Restrained after improving on to heels near the 1100 metres.

**M Singh** (HERMES) - Reminded of his obligation regarding use of his whip prior to the 100 metres.

### Race 4 J&J WALTER LTD 3YO (1550 Metres)

MOHEGAN STAR (D Bradley) – Slow to begin.

**UCALLEDIT** (H Schofer) – Over-raced in the early to middle stages.

**KINGFISHER LAD** (S Macnab) – Over-raced in the early to middle stages. Had its hindquarters contacted 350 metres, briefly unbalanced.

**GAELIC SPIRIT** (L Hemi) – Crowded and checked near the 350 metres.

**INVISIBLE SPIRIT** (C O'Beirne) – Lay out when making the final bend near the 350 metres.

**R Elliot** (BLACK FOREST) - Admitted a breach of careless riding in that he permitted BLACK FOREST to improve into a marginal run near the 350 metres and shifted out when insufficiently clear of GAELIC SPIRIT, which was checked. After considering submissions the Adjudicative Committee suspended R Elliot's licence to ride in races from the conclusion of racing on Saturday, 17 July up to an including racing on Sunday, 25 July 2021, 4 national riding days, and in addition imposed a fine of \$250.

S Macnab (KINGFISHER LAD) - Reminded of her obligations regarding her whip use prior to the 100 metres.

# Race 5 RICHARDS CONSTRUCTION LTD/EVANS HENDERSON WOODBRIDGE BARRISTERS & SOLICITORS 1400

**DIOGENES** (C Jones) - Underwent a veterinary examination at the barrier after the gelding had bitten its tongue and was cleared fit to race.

**DOLCETTO** (A Mudhoo) – Slow away then crowded, losing ground, when TORRE DEL GRECO, which was forced out by DIOGENES, which had shifted out when leaving the barrier.

**TORRE DEL GRECO** (S Macnab) – Raced keenly in the early stages.

### Race 6 JOHNNY MONCKTON MEMORIAL (1550 Metres)

FIANO (A Mudhoo) - Began awkwardly with the rider becoming unbalanced, losing ground as a result.

**FLORAL ART** (S Macnab) - Crowded and hampered 300 metres by OHCEEDEE, which shifted in abruptly when placed under pressure before being corrected by its rider.

**OHCEEDEE** (R Elliot) - Shifted in abruptly 250 metres.

**FACETIME** (H Schofer) - When questioned regarding the performance, Rider H Schofer had no tangible excuse.

**SEMPER MAGICO** (C Dell) – When questioned regarding the performance Rider C Dell advised the gelding raced handier than anticipated and would also prefer a looser track.

### Race 7 PROPERTY BROKERS 2100

JANE O' (L Allpress) - Began awkwardly losing ground. Over-raced in the early stages.

**CAST IN BRONZE** (C O'Beirne) - Began awkwardly losing ground.

**WHOLETTHEFOXOUT** (F Lazet) – Raced in restricted room passing the 1800 metres between BEAUDACEA (D Bradley), which shifted out slightly, and JACKAROO (J Parkes), which shifted in slightly, with WHOLETTHEFOXOUT then steadying, losing ground. Riders D Bradley and J Parkes were both advised to exercise care when in similar circumstances.

BINGWA (A Mudhoo) - Improved on to heels and was hampered approaching the 200 metres.

MIZZENA (S Macnab) – Shifted out to obtain clear running 250 metres.

**C Jones** (MASTER PATRICK) – Issued with a warning for his whip use on a runner out of contention.

### Race 8 BAYLEYS FEILDING 1400

**KIRKLAND** (L Hemi) - Inspected by the veterinarian upon arrival on course after the gelding had suffered a minor laceration to the nose in transit.

MEILA REI (S Macnab) - Began awkwardly losing ground.

INCA WARRIOR (H Schofer) – Began awkwardly losing ground.

SHEZ EKSTRA (K Hercock) - Raced in restricted room and steadied near the 500 metres.

**HAPPY TAV** (T Taiaroa) – Began awkwardly, losing ground, with the rider becoming unbalanced. Underwent a postrace veterinary examination, after finishing a distant last, which could find no obvious abnormality. Stewards will follow up with Trainer K Gray in subsequent days.

**RED INFERNO** (J Parkes) – When questioned regarding the performance Rider J Parkes advised the gelding had not handled the track conditions, which he described as puggy, and in his opinion would improve with the run.
