## RACE COMMENTS:

Race 1	JO MCGARTLAND MEMORIAL HURDLES 3000m
	<b>HEAD OFFICE</b> (R Cuneen) – Raced ungenerously on the approach to the second fence and jumped indifferently throughout.
	<b>CASHEL N Downs</b> ) – Hampered by riderless horse passing the 1400 metres, put in a poor jump at the third fence, retired from the race prior to the final fence when well beaten.
	<b>BULLITT</b> (R Cole) - Badly misjudged the fence near the 1500 metres dislodging rider R Cole who was attended to by St John Paramedics and found to be uninjured.
	<b>SOUNDS PROMISING</b> (T Moki) – Hampered by the fallen rider after jumping the fence near the 1500 metres.
	<b>FRANCIS DRAKE</b> (M Gibbs-Manssen) – Stewards questioned the rider in regard to his ride. Of concern to Stewards was his

lack of urgency in the early to middle stages when restraining his mount and becoming detached from the field. M Gibbs-Manssen advised he had been instructed to settle the horse back and not place it under pressure too soon. He added that the horse had hung throughout and proved a difficult ride. M Gibbs-Manssen was advised he is expected to show better judgement in his riding in future, and after being shown footage was instructed to make a greater attempt to avoid a fallen rider after his mount struck dislodged rider R Cole.

**Race 2** | **NIGHT 'N DAY PARK MAIDEN 1200m**

**AZAFRAN** (W Papier) – Slow away. Rider dropped his whip passing the 400 metres.

**BABY CHEESES** (K Williams) – Slow away.

**TOTAL** (D Bothamley) – Made the bend by the 900 metres awkwardly getting its head up on a number of occasions.

**BUSH MILLS BILLY** (M Taylor) – Raced five wide through the early stages.

**LENNON** (L Callaway) – Raced four wide for the majority of the race.

**BARRY'S CHOICE** (R Beeharry) – Went amiss when racing free of interference near the 600 metres and was immediately pulled up by its rider. After being attended to by the on-course veterinarian and equine ambulance, BARRY'S CHOICE was humanely euthanased after being found to have suffered a catastrophic injury to the near foreleg.

**CHILLY FILLY** (K Kwo) – Raced greenly throughout the run home.

**COMMITMENT** (S Wynne) – Was inclined to lay inwards in the run home.

**Race 3** | **EQUINE VETERINARY SERVICES SPRINT 1200m**

**DRAKE BAY** (M Taylor) – Jumped away awkwardly getting its head up and losing ground.

**MANHATTAN FLAME** (J Laking) – Made contact with CONFSSIONAL leaving the barriers, had some difficulty obtaining clear running early in the run home.

**CONFSSIONAL** (W Papier) – Made contact with MANHATTAN FLAME leaving the barriers, lay out under pressure in the straight with the rider dropping his whip passing the 150 metres.

**IFFIDA** (R Beeharry) – Raced wide through the early to middle stages.

**GAS MONKEY** (R Mudhoo) – Severely restrained to avoid heels passing the 1050 metres and continued to race keenly for a distance thereafter placing the rider in difficulty.

**W Papier** (CONFSSIONAL), assisted by co-trainer M Pitman, admitted a breach of careless riding after allowing his mount to shift in when insufficiently clear of GAS MONKEY who was crowded and heavily restrained passing the 1050 metres, with the Judicial Committee suspending his licence to ride at race meetings for 4 national days effective from the conclusion of racing on 27 June up to and including 7 July and imposing a fine of \$200.

**Race 4** | **LASER ELECTRICAL TIMARU DASH 1200m**

**MR FOX** (B Murray) – Raced without the right hind plate. Jumped away awkwardly after being fractious in the barriers, over raced when being restrained passing the 1000 metres.

**GLOBAL STAR** (K Williams) – Steadied when placed in restricted room to the inside of RAZOR passing the 1000 metres, with the rider reporting that the mare had hung throughout.

**M Taylor** (RAZOR) was issued with a warning after allowing her mount to shift in passing the 1000 metres when not fully clear of GLOBAL STAR.

**A LITTLE VAGUE** (G Jogoo) – Hampered racing into the first bend near the 900 metres.

**KAPALKA** (C Johnson) – Made the first bend awkwardly shifting out hampering outside runners.

**LADY LIRA** (T Comignaghi) – Steadied to avoid the heels of A LITTLE VAGUE which had become awkwardly placed on the

heels of KAPALKA which made the bend near the 900 metres awkwardly.

**PHELAN THE POWER** (J Laking) – Raced wide in the early stages.

**TAP 'N' GO** (S Toolooa) – Raced three wide without cover throughout, with the rider reporting this had taken a toll on the gelding today.

**STRAIGHT SETS** (S Wynne) – Raced wide without cover throughout.

**MAKABAR** (K Asano) – Rider dropped his whip passing the 50 metres.

**Race 5 THE SAIL MILE MAIDEN 1600m**

**SPINDLESHANKS** (C Johnson) – Crowded leaving the barriers having to be checked shortly after the start losing ground.

**DETIFOSS** (K Asano) – Commenced to over race shortly after the start and continued to do so for a distance, had to be severely restrained passing the 1000 metres shifting in slightly placing CARDBOARD GANGSTER in restricted room which was buffeted and lost some ground as a result, held up early in the run home and shifted in passing the 300 metres to find clear racing room, placed in restricted room in the final 50 metres when CHOICE MOMENT shifted in under pressure.

**BEALEY INN** (L Callaway) – Over raced in the early stages having to be steadied away from heels passing the 1400 metres.

**SPLASH PALACE** (K Mudhoo) – Commenced to over race near the 1400 metres then raced ungenerously when being restrained.

**CARDBOARD GANGSTER** (R Mudhoo) – Buffeted losing ground near the 1000 metres.

**SARAYU** (T Moseley) – Raced wide without cover throughout.

**Race 6 L. J. HOOKER REAL ESTATE 1600m**

**ZAMBEZI ZIPPER** (M Taylor) – Restrained in the early stages to shift to a position adjacent to the running rail after jumping from the outside barrier. Rider reported that the filly had made abnormal breathing noises over the concluding stages. A post-race veterinary inspection did not reveal any obvious abnormality.

**OUR TEDDY BOY** (C Campbell) – When asked to comment on the disappointing performance, rider could offer no tangible excuse but advised he would be recommending gear changes.

**Race 7 NZB INSURANCE PEARL SERIES RACE 1600m**

**TUILANA** (K Mudhoo) – Hampered leaving the barriers losing ground.

**UPHOLD** (V Rathoar) – Jumped away awkwardly losing ground, improved wide rounding the first bend to sit parked outside the leader passing the 1000 metres.

**LAPIS LAZULI** (S Wynne) – Slow away.

**SANTISSIMA** (S Toolooa) – Steadied away from heels shortly after the start and when attempting to recover raced in restricted room having to be further restrained and shifted outwards hampering RINGADINGDING passing the 1300 metres.

**MISTLETOE** (J Laking) – Over raced in the early stages when being restrained to take cover.

**RINGADINGDING** (M Taylor) – Hampered passing the 1300 metres.

**MISS OAKS** (K Asano) – Briefly held up when denied a marginal run rounding the bend near the 400 metres.

**Race 8 PHAR LAP STAYERS MAIDEN 2200m**

**DIAMOND RIVIERE** (S Wynne) – Raced wide without cover until improving forward to lead near the 1000 metres.

**FORT WILLIAM** (K Asano) – Raced three wide without cover through the early stages.

**MADAME CHERIE** (K Kwo) – Came under pressure passing the 1000 metres and was not persevered with in the straight

finishing a distant last. Rider was of the opinion the mare had held its breath. A post-race veterinary inspection did not reveal any obvious abnormality other than the mare was suffering slightly from dehydration.

**MAXWELL** (D Bothamley) – When questioned about performance rider advised that the gelding failed to handle today's testing track conditions.

**R Cuneen** (MAN OH MAN) was spoken to advisedly regarding his whip use prior to the 100 metres.

**B Murray** (KENKI) was spoken to advisedly regarding his whip use prior to the 100 metres.
