GENERAL:

Following Race 3 Rider L Innes was stood down by Paramedics after suffering from dehydration.

RACE COMMENTS:

Race 1TULLOCH CAFÉ MDN 1400WITSABOUTHIM (L Innes) – Began awkwardly losing ground, then ridden urgently to recover. Crowded for a distance
passing the 300 metres to the inside of PETONE which shifted in under pressure with WITSABOUTHIM making contact
with the hindquarters of CHRISTOPHE VERMEER which became unbalanced. Then had difficulty obtaining clear
running for a distance before improving onto the heels of JUDAH passing the 150 metres.

ZOUPERB (D Johnson) – Began awkwardly losing ground.

UPCLOSENOUGH (A Goindasamy) – Restrained from its wide barrier.

RISING REWARD (L Satherley) – Began awkwardly.

CHRISTOPHE VERMEER (M Hashizume) – Had difficulty obtaining clear running early in the final straight. Contacted 300 metres becoming unbalanced. Underwent a post-race veterinary examination, which included an endoscopic examination after returning to the enclosure with blood present in one nostril which was found to be due to a minor laceration.

SMOLDERING YACHT (A Calder) – Raced wide without cover.

CANNSEA CLEARLY (T Yanagida) – Crowded over the concluding stages and steadied to the inside of ZOUPERB which shifted in under pressure.

S Spratt (PETONE) – Issued with a warning after allowing PETONE to shift in when weakening approaching the 300 metres when insufficiently clear of WITSABOUTHIM which was crowded then steadied.

D Johnson (ZOUPERB) – Admitted a charge of careless riding for allowing her mount ZOUPERB to shift in over the concluding stages when insufficiently clear of CANNSEA CLEARLY which was checked, with the Judicial Committee suspending D Johnson's licence to ride in races from the conclusion of racing on Saturday 01 April up to and including racing on Thursday 06 May, 3 national riding days and in addition imposed a fine of \$500.

CONQUISTADOR (M McNab) – Rider M McNab replaced O Bosson who was 0.5 kilograms overweight. Slow to begin. Held up passing the 400 metres and early in the final straight.					
RISING STORM (A Calder) – Began awkwardly losing ground.					
DAADS EXPRESS (C Dell) – Began awkwardly.					
CIAMBELLA (D Johnson) – Raced three wide without cover.					
RED STAR (B Rogerson) – Restrained when awkwardly placed near the 850 metres.					
LA RAPIDE (S Spratt) – Held up passing the 400 metres then had some difficulty obtaining clear running for the remainder of the final straight.					
FRIENDLY FIRE (R Elliot) – Raced keenly in the early stages then lay out when making the final bend. Contacted 250 metres becoming unbalanced.					
LEAVE IT TO ME (L Innes) – Held up early in the final straight and when looking to obtain clear running, made contact with FRIENDLY FIRE when shifting out approaching the 250 metres.					
L Innes (LEAVE IT TO ME) – Issued with a warning after permitting his mount LEAVE IT TO ME to shift out approaching the 250 metres making contact with FRIENDLY FIRE which became unbalanced.					
Race 3 NZB INSURANCE PEARL SERIES / FASTTRACK INSURANCE 2YOF SW 1200					
IRISH RED (O Bosson) – Declared a late scratching at 12.04 pm at the request of Trainer J Richards after rider O Bosson could not make the handicapped weight.					
IFYOURAMPLE (S Weatherley) – Began awkwardly then restrained in the early stages.					
SHOW ME A DREAMER (S Collett) – Began awkwardly losing ground. Held up early in the final straight then crowded 200 metres then further held up until inside the final 150 metres.					
TREE OF LIFE (V Colgan) – Began awkwardly then crowded, losing ground. Restrained 900 metres when awkwardly placed near heels.					
FUNNY GIRL (L Innes) – Began awkwardly.					
SHOW ME CHAMPAGNE (T Yanagida) – Held up for clear running until inside the final 200 metres. Ducked out passing the 150 metres when struck with the whip, hampering TRIESTE.					
CHANEL (M McNab) – Held up early in the final straight and when looking to obtain clear running, shifted out passing the 200 metres hampering TRIESTE onto SHOW ME A DREAMER which was crowded.					
QUARTZ QUEEN (C Grylls) – Had difficulty obtaining clear running for a distance early in the final straight.					
TRIESTE (D Johnson) – Crowded and hampered losing ground 200 metres. Crowded 150 metres and hampered. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.					
M McNab (CHANEL) – Admitted a charge of careless riding for allowing his mount CHANEL to shift out near the 200					

M McNab (CHANEL) – Admitted a charge of careless riding for allowing his mount CHANEL to shift out near the 200 metres when insufficiently clear of TRIESTE which was crowded and hampered, with the Judicial Committee

suspending M McNab's licence to ride in races from the conclusion of racing on Saturday 01 May up to and including racing on Saturday 08 May, 4 national riding days and in addition imposed a fine of \$250.

O Bosson (IRISH RED) – Fined \$200 under the minor infringement schedule by the Judicial Committee for failing to make the handicapped weight on IRISH RED and MOET BELLE.

Race 4

WESTBROOK VINE & WINE CLUB MDN 1200

BUNKERS (A Goindasamy) – Slow to begin. Steadied when in restricted room 1100 metres. Raced in restricted room and steadied passing the 125 metres to the outside of SEEN IT COMING which was dictated out slightly by ALPHA CHARLIE. J Riddell was advised he must exercise greater care in a similar circumstance.

DE CHAMBEAU (T Yanagida) - Slow to begin. Briefly crowded 100 metres.

CHOPPER REED (S Spratt) – Raced wide without cover. Shifted out under pressure passing the 75 metres crowding LADY DE WINTER onto BANKERS CHOICE. S Spratt was reprimanded and advised she must straighten her mount when they are shifting ground.

LADY DE WINTER (T Thornton) – Crowded 75 metres by CHOPPER REED which shifted out under pressure.

BANKERS CHOICE (M McNab) – Crowded at the start losing ground to the inside of LADY DE WINTER which was forced in by CHOPPER REED which shifted in abruptly despite the efforts of its rider. Crowded 75 metres.

Race 5 NZB INSURANCE PEARL SERIES RACE (1200 metres)

DARK SATIN (M McNab) – Became fractious in the barrier and was subsequently late scratched on veterinary advice at 2.32 pm. Trainer T Pike was advised that DARK SATIN would be required to barrier trial to the satisfaction of Stewards prior to racing next.

HASSTOBEYOU (S Collett) – Underwent a veterinary examination after being in the adjacent stall to DARK SATIN who had become fractious and was removed from the barrier, and declared a late scratching at 2.34 pm.

VITANI (D Johnson) – Began awkwardly.

SAINT ALICE (A Goindasamy) – Raced three wide without cover throughout.

SPLASH OF RED (V Colgan) – Slow to begin. When questioned regarding performance rider could offer no excuse. Underwent a post-race veterinarian examination which could find no obvious abnormality.

AGEY BABE (M Hashizume) – Restrained at the start from its wide barrier.

TRAVELLING KATE (C Grylls) – Had difficulty obtaining clear running until inside the final 200 metres.

Race 6 AVONDALE SUNDAY MARKETS R74 1200

PLUTON (B Rogerson) – Made contact with the front of the gates and was removed to undergo a veterinary examination, being declared a late scratching at 3.08 pm.

MAGDALA (L Satherley) – Restrained at the start from a wide barrier.

RHAPSODY IN BLUE (J Kamaruddin) – Began awkwardly. Allowed to improve forward to sit outside the leader near the 800 metres after being trapped three wide in the early stages.

MAKE TIME (S Spratt) – Held up early in the final straight before improving into a marginal run to the inside of RHAPSODY IN BLUE which was briefly contacted passing the 300 metres.

S McKee (MAKE TIME) – Was issued with a warning after MAKE TIME was presented without notified gear (winkers).

Race 7 AUCKLAND ALARMS MDN 1600

TELLING TALES (J Riddell) – Became fractious in its barrier and was removed to undergo a veterinary examination before being declared a late scratching at 3.39 pm. The gelding received veterinarian attention for lacerations to both sisal hind limbs. Trainer B Foote was advised that TELLING TALES would be required to barrier trial to the satisfaction of Stewards prior to racing next as well as a veterinary clearance.

POP 'N' UP (L Satherley) – Slow to begin.

ROCTHEPARTY (A Calder) – Raced ungenerously in the early stages.

Race 8 MARSHALL STAND AJC CONFERENCE CENTRE R65 1400

N Bishara (RISING RANSOM) – Issued with a warning after presenting RISING RANSOM to race without notified gear (blinkers).

HEART OF THE OCEAN (M McNab) – Slow to begin.

OSTASIO (V Colgan) – Began awkwardly. Raced three wide without cover throughout. Briefly steadied 350 metres when awkwardly placed near heels

LAMPUS (D Johnson) – Restrained at the start from its wider barrier.

OUR WONDERLAND (B Rogerson) – Forced wider 450 metres by FRANCESCA which hung out when looking to obtain clear running.

FRANCESCA (S Weatherley) – Hung out making the final bend. Was inclined to shift out under pressure inside the final 100 metres.

AMAL ROSE (R Elliot) – When questioned regarding performance rider R Elliot could offer no tangible excuse.

NO LIMITS (O Bosson) – Briefly contacted 300 metres by HEART OF THE OCEAN which lay out under pressure. When questioned regarding performance rider O Bosson could offer no tangible excuse. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

Race 9 AJC.CO.NZ MDN 1600

CURRENTLY (R Elliot) – Slow to begin.

ROCCIA (V Colgan) – Began awkwardly.

CASH ME OUSSIDE (J Kamaruddin) – Slow to begin.

ANOTHER ENTREE (A Calder) – Raced three wide without cover throughout.

TAVILUV (K Asano) – Restrained off heels for a distance passing the 1200 metres. Had difficulty obtaining clear running until approaching the 200 metres.

SWORD OF MERCY (S Collett) – Raced ungenerously when being steadied in the early stages. Raced in restricted room passing the 1300 metres to the inside of LATE TO THE PARTY which shifted in, then continued to race ungenerously for a distance. Held up until approaching the 200 metres.

TAUMALOLO (J Riddell) – Attempted to improve to the inside of ANOTHER ENTREE passing the 300 metres simultaneously as SWORD OF MERCY tried to improve into the same run with TAUMALOLO then being held up. TAUMALOLO was again held up passing the 200 metres when attempting to improve into a marginal run.

FRONT PAGE (L Satherley) – Underwent a post-race veterinary examination after trainer advised the filly had become distressed following the race which could find no obvious abnormality. Stewards will follow up in coming days the condition of FRONT PAGE.

T Thornton (LATE TO THE PARTY) – Issued with a warning after permitting LATE TO THE PARTY to shift in passing the 1300 metres placing SWORD OF MERCY in restricted room which then raced ungenerously for a distance.
