#### RACE COMMENTS:

Race 1 TERRY KENNEDY 1600m

**LONDONDERRY AIR** (C Barnes) – Slow away.

**MILANO** (S Wynne) – Briefly steadied near the 1200 metres to avoid the heels of JINGO. Again had to steady near the 400 metres when again becoming awkwardly placed on the heels of JINGO.

**K Kwo** (JINGO) – Issued with a warning for allowing his mount to shift in near the 1200 metres when not fully clear of MILANO which had to be steadied at this point.

**K Mudhoo** (FILL YA BOOTS) – Issued with a warning for allowing his mount to shift out passing the 400 metres dictating JINGO out into the line of MILANO which had to be steadied.

**B Murray** (MAMMA SANS) – Issued with a warning for the use of his whip prior to the 100 metres.

## Race 2 BRIAN & SHANE ANDERTON 1400m

**BECKIDBOO** (A Balloo) – Began awkwardly losing ground. Stewards questioned the rider in regards to him improving into the mid-field after a slow beginning inconveniencing runners to his outside. Mr Balloo explained that he had felt like the horse's saddle had slipped forward over the wither and did not wish to restrain the mare as she was also hanging at this point. After viewing replays Mr Balloo concurred with Stewards that he needs to show better judgement when riding in similar circumstances.

**CARSON RIVER** (K Chowdhoory) – Restrained leaving the barrier to obtain cover.

**KING COUGAR** (R Mudhoo) – Jumped away awkwardly then raced ungenerously when being restrained in the early stages. Tactics queried. Rider explained that he had been instructed to take cover on the gelding due to the weight carried. He further added that the horse had resented being restrained in the early stages but wished to follow the instructions given. Rider's explanation was noted.

**VELADERO** (W Papier) – Jumped away awkwardly. Inconvenienced 1100 metres.

MEARA MARY (S Wynne) - Blundered leaving the barriers.

#### Race 3 BARBARA VERLINDEN 1200m

**MAKE BELIEVE** (T Moseley) – Lost its footing and blundered badly at the start. When asked to comment on the performance rider advised that after blundering at the start the mare had been disappointing. Stewards ordered a post-race veterinary examination which revealed no abnormalities. Trainer advised Stewards the mare would now be sent for a spell.

**SHE'S A LADY** (K Mudhoo) – Lost its footing and blundered leaving the barriers.

**CRISPIN** (C Barnes) – Slow away.

**LOUIE LOUIE** (C Campbell) – Got its head up when racing keenly in the early stages with the rider reporting that the bit had displaced through the horse's mouth placing him at a disadvantage for the remainder of the event.

**S Weatherley** (DESERT MAGIC) – Was reminded of his obligations with regard to riding his mount out to the finish where circumstances permit.

#### Race 4 JO HILLIS & JACKIE JONES MAIDEN 1200m

**MEGALOMANIAC** (BB Hong) – Underwent a pre-race veterinary inspection after being fractious on the float ride and was cleared to start.

**THE LYRICAL ROSE** (T Moseley) – Jumped away awkwardly losing ground.

**MOVIE STAR** (B Murray) – Jumped away awkwardly. Returned to the enclosure showing signs of lameness with a post-race veterinary inspection revealing no obvious abnormalities.

**SHUTTHEFRONTDOOR** (L Callaway) – Got its head up and raced ungenerously shortly after the start inconveniencing LAST BID. Then over-raced badly when being restrained in the middle stages. The connections were advised the gelding was on a racing manners warning.

**REGAL GIRL** (C Campbell) – Went off stride briefly passing the 900 metres.

#### Race 5 STEVEN PRINCE 2200m

**COUNTESS RUBY** (S Weatherley) – Restrained to shift to a position closer to the running rail after jumping from an outside barrier.

PABLEAU (K Kwo) – Crowded shortly after the start and was then restrained to take a position adjacent to the rail.

**FINDING NEMO** (B Murray) – Raced three wide without cover and came under pressure passing the 800 metres then not being persevered with after the 500 meters after giving ground. A post-race veterinary inspection revealed no abnormalities. The connections were advised the gelding would be required to trial to the satisfaction of the Stipendiary Stewards before racing. The connections indicated that the gelding would now be retired.

**THE KRAKEN** (C Barnes) – Raced at the rear throughout and was a beaten runner passing the 1000 metres not being persevered with by its rider and dropping out finishing a distant last. A post-race veterinary inspection revealed no abnormalities. The connections were advised the gelding would be required to trial to the satisfaction of the Stipendiary Stewards before racing. The connections indicated that the gelding would now be retired.

**COLOUR ME RED** (L Callaway) – Briefly held up early in the run home. Returned to the enclosure with a superficial wound to the near fore leg.

**JACK BE QUICK** (C Campbell) – Was inclined to lay in throughout the run home and had to be straightened passing the 100 metres.

**SECRETARIA** (R Beeharry) – Held up passing the 250 metres and when shifting ground near the 200 meters was again disappointed for a run when beaten to a gap.

### Race 6 JIM BURNS & MARION STEVENSON MAIDEN 1400m

JIMMY WHO (A Balloo) – Jumped away awkwardly losing ground.

**NEVETS** (T Moseley) – Jumped away awkwardly hampering MIDDLE ISLAND. Raced three wide without cover throughout.

MIDDLE ISLAND (K Chowdhoory) – Hampered at the start.

**ALTAR GIRL** (L Callaway) – Crowded and checked passing the 900 metres going back onto ON THE BACKFOOT who also had to be severely restrained.

**ON THE BACKFOOT** (K Kwo) – Had to be severely restrained near the 900 metres.

**J Lowry** (SWAMPMAN) – Admitted a breach of the careless riding rule in that he shifted inwards when not sufficiently clear of ALTAR GIRL who was checked passing the 900 metres. After viewing the films and hearing evidence from all parties the Judicial Committee imposed a suspension from  $9^{th} - 15^{th}$  May 2021 (5 days) and a fine of \$250.

**EMILY ROSE** (S Wynne) – Crowded when tiring passing the 375 metres.

**J Lowry** (SWAMPMAN) – Was issued with a warning for allowing his mount to shift out crowding EMILY ROSE passing the 375 metres.

## Race 7 JASON COUTTS & CRAIG GRAHAM MAIDEN 1600m

**BELLA EVE** (B Murray) – Slow away.

**BRUCIE** (C Barnes) – Slow away.

**RAISE YA CARDS** (T Moseley) – Slow away.

**EAVESDROP** (C Campbell) – Fractious in its barrier prior to the start. Over-raced in the middle stages and had to be restrained away from heels passing the 1200 metres.

**C Johnson** (CEEDOUBLEUJAY) — Issued with a warning for allowing his mount to shift inwards near the 1200 metres resulting in EAVESDROP having to be restrained to avoid his heels.

**DARCI VINO** (K Kwo) – Raced wide without cover. Dislodged the rider on return to scale with neither horse nor rider injured in this incident.

**TACTFULL** (K Mudhoo) – Over-raced when sitting outside the leader through the early stages getting its head up on a number of occasions.

**CEEDOUBLEUJAY** (C Johnson) – Dictated inwards passing the 100 metres contacting inside runner and then raced in restricted room inside the final 50 metres.

**POPPA** (J Lowry) – Contacted and briefly unbalanced by CEEDOUBLEUJAY who shifted in and away from NAMIBIA MISS passing the 100 metres.

**CODA BIANCA** (S Wynne) – Raced greenly through the run home and was inclined to shift ground having to be straightened passing the 100 metres.

**KLEAR THE DECK** (L Callaway) – Rider was of the opinion the filly had come to the end of its current campaign and may now benefit from a spell.

# Race 8 CLAIRE ANDERTON & GRAHAM MEE 1400m

**DECEPTIO VISUS** (K Kwo) – Lost its footing and blundered leaving the barrier losing ground. Rider advised after losing ground at the start he had been unable to make ground over the concluding stages. Stewards will follow up with the connections in the coming days.

**DRAKE BAY** (A Balloo) – Slow away. Held up early in the straight shifting outwards to obtain clear running near the 250 metres.

TAPPY'S ONE (C Johnson) – Raced three wide without cover.

BLUE EYED SUSIE (C Barnes) – Lay inwards in the run home with the rider swapping the whip to the left hand.

C Campbell (LLOVIZNA) – Spoken to advisedly regarding the use of his whip prior to the 100 metres.

#### Race 9 WINGATUI FUNCTION CENTRE 1400m

**SOMBRA DEAMOR** (G Jogoo) – Jumped away awkwardly and then further hampered and crowded losing ground.

I'M A TIGER (C Barnes) - Slow away.

**SHAKER** (J Lowry) – Blundered leaving the barriers.

**THE SELECTION** (K Mudhoo) – Raced wide without cover.

**HIGHLAND DANCER** (S Wynne) – Got its head up when being restrained through the early stages. Rider reported post-race that the gelding had been awkward in its action. A subsequent veterinary inspection revealed no obvious abnormalities.

**PLUTONIUM** (K Chowdhoory) – Steadied to avoid the heels of LINEDANCEKING which shifted inwards when not fully clear near the 1100 metres.

A Balloo (LINEDANCEKING) – Issued with a warning after permitting his mount to shift inwards near the 1100 metres when not fully clear of PLUTONIUM.

A Balloo (LINEDANCEKING) – Spoken to advisedly regarding the use of his whip prior to the 100 metres.

JOHNNIE REDMOND (T Moseley) – Rider advised the gelding had hung throughout the running and had been disappointing.
