**GENERAL**

**D Parker** did not attend the meeting after feeling the effects of a fall the previous day at Wanganui and is required to provide a medical clearance prior to riding next.

**SUPPLEMENTARY****Oamaru Jockey Club – Sunday 25 July 2021****RACE 10 – EASYMADE MARMALADE LTD 1400 METRES**

**Apprentice S Khetoo** assisted by apprentice jockey mentor D Walsh admitted a breach of Rule 638(3)(b)(ii) in that he used his whip excessively on his mount PINHEAD prior to the 100 metres. After hearing from all parties the Adjudicative Committee suspended S Khetoo's licence to ride at race meetings for 6 national riding days effective from the conclusion of racing on Saturday 14 August up to and including Friday 27 August.

**RACE COMMENTS****Race 1 | AVON CITY FORD SYDENHAM HURDLES (3100m)**

**JACKFROST** (B Lammas) – Weakened from the 500 metres. When questioned regarding performance rider could offer no excuse.

**BEAU GESTE** (M Gillies) – Made a poor jump at the final fence.

**RINGBOLT** (H McNeill) – Made a poor jump at the final fence.

**Race 2 | NZB RTR SALE 17-18 NOVEMBER RATING 74 (1400m)**

**PEARL DAVONE** (T Moseley) – Began awkwardly.

**ISLAND HOP** (K Asano) – Lay outwards shortly after the start.

**FACETIME** (H Schofer) – Raced wide throughout and was inclined to over race in the middle stages on a moderate tempo. When questioned regarding performance rider could offer no tangible excuse, stating that the mare had been disappointing.

**PINHEAD** (L Allpress) – Lay outwards throughout.

**ALJAY** (S Macnab) – Placed in restricted room near the 1100 metres when NESTA lay in.

**LOUIE LOUIE** (C Johnson) – Had to be steadied off heels when over racing passing the 900 metres shifting outwards then racing wide.

**Race 3 | STALLION TENDER NOW OPEN MAIDEN STEEPLECHASE (3200m)**

**PIERIAN SPRING** (J Seivwright) – Made a poor jump at the fence near the 2000 metres unbalancing the rider. Retired from the race prior to the final fence when well beaten.

**FRANCIS DRAKE** (G Walsh) – Lost ground after jumping the fence near the 1700 metres. Returned to the enclosure with blood present in the right nostril which upon veterinary inspection was found to be from an abrasion inside the nostril.

**TAKEITLIKEAMAN** (H McNeill) – Unbalanced after jumping the fence near the 1000 metres. Retired from the race prior to the final two fences when well beaten.

**BAK DA MASTER** (M Roustoby) – Put in a poor jump at the third last fence. Jumped the second last fence awkwardly.

**MAN OH MAN** (R Cuneen) – Hit the final two fences.

**OXYMORON** (M Cropp) – Misjudged the final fence.

**R Cuneen** (MAN OH MAN) – Reprimanded and reminded of his obligation to retire his mount from the race when out of contention.

**G Walsh** (FRANCIS DRAKE) – Reminded of his obligation to retire his mount from the race when out of contention.

<b>Race 4</b>	<b>RACECOURSE HOTEL &amp; MOTOR LODGE KORAL STEEPLECHASE (4250m)</b>

**WHOLETTHEFOXOUT** (S Fannin) – Badly misjudged the fence near the 800 metres on the first occasion. When leading was retired from the race after jumping the fence near the 1000 metres. The gelding was immediately attended to by the on-course veterinarian, with the horse ambulance deployed to transport WHOLETTHEFOXOUT to a local veterinary clinic for further evaluation which revealed a ruptured suspensory ligament in the right foreleg.

**COUNTRY BUMPKIN** (H McNeill) – Jumped outwards at the first of the double near the 1200 metres on the second occasion making contact with the hindquarters of NOTABADROOSTER which was unbalanced.

**NOTABADROOSTER** (M Cropp) – Contacted jumping the first of the double near the 1200 metres on the second occasion becoming unbalanced. Badly misjudged the third last fence and fell. Rider M Cropp was uninjured. NOTABADROOSTER was attended to by the on-course veterinarian and found to have suffered superficial abrasions. Connections were advised that a veterinary clearance would be required prior to racing again. Trainer N Quinn indicated that consideration will now be given to retiring the gelding.

**MR ENTHUSIASTIC** (M Gillies) – Retired from the race after jumping the third last fence when well beaten.

**TALLYHO TWINKLETOE** (S Phelan) – Ran down the final two fences.

<b>Race 5</b>	<b>ROAD METALS OPEN HANDICAP (1200m)</b>

The start was delayed after **IRISH EXCUSE** proved reluctant to load.

**GOODANYA** (K Chowdhury) – Slow to begin.

**CARSON RIVER** (T Comignaghi) – Made contact with **IMBLAZE** when improving into a run between **IMBLAZE** and **IRISH EXCUSE** when both those runners shifted ground near the 350 metres.

**IMBLAZE** (C Johnson) – Contacted near the 350 metres.

**R Elliot** (CHOSEN PEAK) – Admitted a charge of excessive whip use prior to the 100 metres, with the Adjudicative Committee imposing a fine of \$500.

**S Khetoo** (KING COUGAR) – Reprimanded for his whip use prior to the 100 metres.

**BOLT FROM THE BLUE** (T Taiaroa) – Slow away.

**JUSTABELLE** (T Jonker) – Slow away.

**KAPALKA** (M Gestain) – Crowded leaving the barriers.

**THE BUFFER** (T Moseley) – Crowded leaving the barriers. Held up early in the straight.

**CURVE** (K Chowdhoo) – Had to be steadied near the 800 metres to avoid the heels of TAP 'N' GO which shifted inwards when not fully clear.

**PAPAGENA** (S Toolooa) – Unbalanced after making contact with THE BUFFER early in the straight. Rider reported that the mare had failed to handle today's testing track conditions.

**LUNA PERFECTA** (L Allpress) – Inconvenienced near the 500 metres when TAP 'N' GO shifted inwards to avoid the heels of THE GOOD SHEPHERD.

**L Callaway** (TAP 'N' GO) – Issued with a warning after angling his mount inwards near the 800 metres when not fully clear of CURVE.

**ADANNAYA** (T Comignaghi) – Rider reported that the mare had failed to handle today's testing track conditions.

**Race 7**

**WINNING EDGE PRESENTATIONS 124<sup>TH</sup> WINTER CUP (1600m)**

**JUSTASKME** (H Schofer) – Slow away. Briefly held up near the 600 metres having to shift ground back to the inside before again being held up rounding the final turn until passing the 400 metres.

**TAPPY'S ONE** (C Johnson) – Over raced in the middle stages.

**CETUS** (M Sanson) – Raced wide without cover.

**BEAUTY STAR** (W Pinn) – Raced wide throughout. Underwent a post race veterinary inspection which did not reveal any obvious abnormality.

**HAPPY STAR** (L Allpress) – Contacted near the 700 metres. Held up rounding the final turn until near the 400 metres.

**FULL FURY** (K Mudhoo) – Had to be steadied after making contact with HAPPY STAR near the 700 metres.

**QUEEN SWEEP** (M Gestain) – Steadied away from the heels of JUSTASKME passing the 400 metres.

**HE'S GOT POWER** (R Mudhoo) – Blundered approaching the 400 metres. Required post race veterinary attention for a laceration to the left hind leg after having been galloped on during the running.

**CITY SLICKER** (K Williams) – Underwent a post race veterinary inspection which did not reveal any obvious abnormality.

**T Jonker** (BLUEY'S CHANCE) – Reprimanded for her whip use prior to the 100 metres.

**K Asano** (RITANI) and **T Moseley** (TAKE THE DEEL) – Are to be spoken to and reprimanded after making contact by way of a celebratory gesture when pulling up post race.

**K Mudhoo** (FULL FURY) – Issued with a warning after attempting to improve to the inside of HAPPY STAR near the 700 metres when there was insufficient room to do so.

**H Schofer** (JUSTASKME) – Admitted a charge of excessive whip use prior to the 100 metres, with the Adjudicative Committee imposing a fine of \$400.

<b>Race 8</b>	<b>PURE CHAMPION @ WILLOW GLEN STUD RATING 74 (1800m)</b>
<p><b>POINT SCORE</b> (C Johnson) – Slow to begin.</p> <p><b>AQUATTACK</b> (T Comignaghi) – Slow to begin.</p> <p><b>SEVEN AAJES</b> (K Asano) – Rider reported that the gelding had not handled today’s testing track conditions.</p> <p><b>TELL ME MORE</b> (F Lazet) – Checked when crowded for room passing the 1000 metres going back onto FIVE PRINCES which was hampered.</p> <p><b>FIVE PRINCES</b> (M Sanson) – Hampered passing the 1000 metres having to be checked to avoid the heels of TELL ME MORE.</p> <p><b>T Taiaroa</b> (WANNABE ‘N’ PARIS) – Admitted a charge of careless riding in that she permitted her mount to shift inwards passing the 1000 metres when not sufficiently clear dictating RODOLFO inwards onto SIR BEETS which was forced inwards onto TELL ME MORE which was checked. After hearing submissions the Adjudicative Committee suspended T Taiaroa’s licence to ride at race meetings for 3 national days effective from the conclusion of racing on Saturday 14 August up to and including Saturday 21 August and in addition imposed a fine of \$250.</p>	
<b>Race 9</b>	<b>SPEIGHT’S RATING 65 (1600m)</b>
<p><b>CAST IN BRONZE</b> (B Murray) – Dropped its head as the start was effected and was slow away as a result.</p> <p><b>SO CALL ME</b> (R Elliot) – Ducked outwards abruptly on jumping unbalancing and dislodging its rider who was uninjured in this incident.</p> <p><b>HARLEEN QUINZEL</b> (T Comignaghi) – Got its head up when being steadied shortly after the start, with the left stirrup iron becoming detached shortly after when the leather broke. T Comignaghi was then in difficulty controlling her mount through the middle stages hampering BELT ROAD near the 1100 metres.</p> <p><b>BELT ROAD</b> (L Allpress) – Hampered near the 1100 metres.</p> <p><b>TAPDOG</b> (C Johnson) – Raced wide throughout.</p> <p><b>IFFIDA</b> (W Pinn) – Raced wide throughout.</p> <p><b>RED MAGICIAN</b> (J Laking) – Had to be steadied near the 1300 metres when crowded for room to the inside of KAJINO which lay inwards away from MISTLETOE despite the efforts of its rider with RED MAGICIAN going back onto HEY SOUL SISTER.</p> <p><b>HEY SOUL SISTER</b> (K Kwo) – Clipped a heel of RED MAGICIAN and blundered badly passing the 1300 metres.</p> <p><b>J Lowry</b> (BARRETT) – Reprimanded for his whip use prior to the 100 metres.</p> <p><b>B Murray</b> (CAST IN BRONZE) – Admitted a charge of excessive whip use prior to the 100 metres, with the Adjudicative Committee imposing a fine of \$600.</p>
