#### **SUPPLEMENTARY**

Race 5 CAL ISUZU MILE (1600 metres)

**SOVEREIGNTY** (A Goindasamy) – Co-trainer Mr R Norvall advised Stewards the stable was satisfied with the post-race condition on the gelding and it is their intention to continue on with SOVEREIGNTY'S current preparation.

## Race 6 DUNSTAN HORSEFEEDS BALMERINO STAKES (2000 metres) (Group 3)

**PEP TORQUE** (K Hercock) – Trainer Mrs K Lawrence reported to Stewards upon return to the stable PEP TORQUE underwent a veterinary examination which included an endoscopic examination and blood tests, which revealed no abnormalities. K Lawrence further advised it is her intention to continue on with the gelding's current preparation.

#### **RACE COMMENTS**

## Race 1 PHELAN RACING 2200

**THE BLING** (J Riddell) – Crowded at the start losing ground. Had to steady and shift ground passing the 100 metres to find clear racing room.

ENCHANTED ELLE (C Barnes) - Began awkwardly making firm contact with BROTHER MAX.

**BROTHER MAX** (T Newman) – Contacted at the start.

**BROOKBOURNE** (B Rogerson) - Held up through the middle part of the run home until obtaining clear running passing the 100 metres.

#### Race 2 TE AROHA TRAINERS RACEDAY 2200

**W Hillis** (UNCLE TERRY and NOTHINSWEETABOUTME) - Issued with a warning under Rule 635(1) when presenting his two runners late into the birdcage. As a result this race ran approximately 2 minutes late.

**VULTURE STREET** (A Goindasamy) - Slow to begin (3L).

**IFFRAAJINATOR** (W Pinn)—Began awkwardly losing ground.

**CURIOUS GEORGE** (J Kamaruddin) – Slow to begin. Raced three wide through the early and middle stages before improving to sit outside the leader with 1000 to go.

**OSTASIO** (T Yanagida) - Raced three wide without cover through the early stages.

**UNCLE TERRY** (M Cameron) - Got its head up when racing keenly in the early stages.

**NOTHINSWEETABOUTME** (N Parmar) - Held up early in the straight having to shift ground inwards passing the 300 metres to find clear racing room.

**CIAMBELLA** (M McNab) - Bumped from the inside passing the 450 metres and shifted outwards.

**MAHOMES** (V Colgan) - Crowded and checked passing the 450 metres.

**RODMAR** (S Weatherley) - Crowded and had to steady passing the 300 metres when VULTURE STREET lay outwards.

**T Yanagida** (OSTASIO) - Admitted a charge in that he struck his mount OSTASIO six times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$250.

J Riddell (GRANADOS) - Admitted a breach of careless riding in that he allowed his mount to shift out forcing CIAMBELLA out into the line of MAHOMES who was checked near the 450 metres. After considering submissions the Adjudicative Committee suspended J Riddell's licence to ride in races from the conclusion of racing on Tuesday 9 November up to and including racing on Wednesday 17 November, 5 national riding days.

## Race 3 STEPHEN RALPH RACING STABLES 1600

**BONO** (A Goindasamy) - Began awkwardly losing ground.

**HALSTON** (M McNab) – Bounded at the start losing ground. When questioned regarding performance rider advised that the muddling pace of the race had not suited and in his opinion the gelding may benefit from a freshen up.

BARROW BOY (D Johnson) - Crowded and buffeted at the start.

**LITTLE JOE** (V Colgan) - Crowded and buffeted at the start.

**IDYLLWILD** (J Kamaruddin) – Crowded and buffeted at the start.

**SWEET TUI** (T Yanagida) – Began awkwardly shifting out crowding outside runners. Over-raced through the early stages.

**TREVINO** (J Riddell) – Crowded and buffeted at the start. Raced three wide without cover throughout.

**T Yanagida** (SWEET TUI) - Admitted a charge in that he struck his mount SWEET TUI seven times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$500.

## Race 4 NZB INSURANCE PEARL SERIES RACE (1600 metres)

MADI'S DREAM (N Parmar) - Began awkwardly losing ground.

**RUMBLING ECHO** (J Kamaruddin) – Began awkwardly losing ground.

KAIMAI QUEEN (S Weatherley) – Slow to begin.

QUOTA (V Colgan) - Taken back from a wide draw to obtain cover.

MADAME LE FAY (M Cameron) – Over-raced through the early stages.

**SILVERSTREAM** (T Yanagida) - Awkwardly placed on heels passing the 500 metres and had to be briefly steadied.

#### Race 5 PIKE RACING 1400

**APERITIF** (A Goindasamy) – Began very awkwardly briefly unbalancing its rider, losing ground as a result. Inconvenienced passing the 250 metres when KARMAN LINE shifted out to find clear racing room. C Grylls was advised to exercise greater care.

**THREE CROWNS** (J Fawcett) – Slow to begin.

**ASSERTIVE NATURE** (V Colgan) - Made the bend near the 900 metres awkwardly.

**POLARIS** (R Elliot) – Lay out rounding the final bend.

**KARMAN LINE** (C Grylls) - Held up early in the run home having to be steadied then angled across heels passing the 250 metres to find clear racing room.

**COURTHEZON** (D Johnson) - Returned to the enclosure with blood present in both nostrils. Following a veterinary inspection including an endoscopic examination, COURTHEZON was confirmed to have bled. COURTHEZON shall not be ridden in exercise for a period of two months or start in any Race or Trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

## Race 6 TE AROHA STALLION SERVICE SCHEME 1400

TOOGOODTOSAYNO (T Yanagida) - Slow to begin.

**BOLEH** (J Riddell) - Raced three wide without cover throughout.

BURCHA (B Rogerson) - Had to be steadied away from heels passing the 800 metres when over-racing.

**OH TO BE** (W Pinn) - Held up until forcing a run passing the 200 metres

APOSTROPHE (R Elliot) - Crowded and checked passing the 200 metres.

KAI (D Johnson) – Crowded and checked passing the 200 metres.

KANTRA (C Grylls) - Crowded and checked passing the 200 metres.

**W Pinn** (OH TO BE) - Admitted a charge of careless riding in that he angled his mount out crowding and checking KANTRA, APOSTROPHE and KAI with all three runners being unbalanced and losing momentum passing the 200 metres. After considering submissions the Adjudicative Committee suspended W Pinn's licence to ride in races from the conclusion of racing on Saturday 13 November up to and including racing on Thursday 25 November, 7 national riding days.

## Race 7 STEVEN RAMSEY & JULIA RITCHIE RACING 1400

**PACKING JOY** (M McNab) – Slow to begin. Raced keenly rounding the bend near the 900 metres shifting wider on the track. Held up early in the run home.

**TABATA** (J Kamaruddin) - Held up in the middle part of the run home and had to be steadied near the 250 metres when LORD VALENTINE was taken outwards by THUNDER which continued to shift up the track.

LORD VALENTINE (T Yanagida) - Raced three wide without cover throughout.

**SONOFABUTCHER** (A Goindasamy) – Held up early in the run home.

**PROJECT** (C Barnes) – Crowded and checked passing the 350 metres.

**W Pinn** (TAMMIE WYNETTE) – Reminded of his obligations in that he must ride his mounts out to the finish when circumstances permit.

**N Parmar** (THUNDER) - Admitted a charge of careless riding in that he angled his mount THUNDER outwards when not sufficiently clear of PROJECT which was checked near the 350 metres. After considering submissions the Adjudicative Committee suspended N Parmar's licence to ride in races from the conclusion of racing on Saturday 13 November up to and including racing on Friday 19 November, 4 national riding days.

## Race 8 STEPHEN MARSH RACING STABLES 1200

**BIT NOSY** (J Kamaruddin) - Dislodged its rider during the preliminary and galloped some distance before being late scratched by order of Stewards. As a result this race ran 5 ½ minutes late. J Kamaruddin was attended to by the on-

course Doctor and stood down from his one remaining ride. J Kamaruddin was advised that a medical clearance would be required prior to riding next.

**SLEEPY JEAN** (R Elliot) – Slow to begin.

**LA CAPITA** (C Grylls) - Raced three wide without cover throughout and lay out on the final bend proving a difficult ride. When questioned regarding performance rider advised that the filly had raced greenly throughout.

**W Pinn** (LA GRANDE RUE) - Stewards inquired into the manner in which W Pinn used his whip in the home straight and could not be conclusively satisfied that he had contravened the rules.

## Race 9 MONACURRAGH LODGE 1200

**CHARLOTTE AMALIE** (A Goindasamy) - Bounded at the start losing ground. Lay out and away from QUEEN SARABI passing the 450 metres shifting wider on the track, inconveniencing THINKSO.

**STUNGUN** (J Fawcett) - Slow to begin. Had to be steadied to avoid the heels of LE CHAMOSSAIRE passing the 1000 metres then continued to over-race for some distance. Crowded and had to steady then over-raced for a distance passing the 800 metres.

THINKSO (R Elliot) – Raced wide without cover throughout. Inconvenienced 450 metres.

SHIVERS (M McNab) – Raced wide without cover throughout and lay out rounding the final bend.

JENESSA (D Johnson) - Awkwardly placed close to heels passing the 175 metres having to be steadied momentarily.

**T Yanagida** (LEGIT) - Issued with a warning for allowing his mount to shift inwards dictating LA CHAMOSSAIRE inwards onto STUNGUN which had to be steadied near the 1000 metres.

## Race 10 THANKS TO OUR SPONSORING TRAINERS 1200

**WELL I NEVER** (C Grylls) – Became fractious prior to the start and was removed from its barrier to undergo a pre-race veterinary inspection before being declared fit to start. Crowded and raced in restricted room having to be steadied passing the 50 metres.

**DON'T LOOK ETHEL** (N Parmar) - Began very awkwardly losing some ground.

**ACAPULCO** (R Elliot) – Crowded at the start losing ground when runners either side shifted.

PIN ME UP (D Johnson) - Raced wide without cover in the early stages.

**DEVOTIONINMOTION** (A Goindasamy) - Raced in restricted room early in the run home when DARCI DIVA lay inwards.

**DARCI DIVA** (M McNab) - Placed in restricted room passing the 50 metres.

**SIZZLING GOLD** (M Cameron) - Was obliged to shifted ground outwards passing the 250 metres to find clear racing room.

**D Johnson** (PIN ME UP) - Issued with a warning for allowing her mount to shift in placing WELL I NEVER and DARCI DIVA in restricted room passing the 50 metres. When assessing this incident Stewards also took into account some outwards movement from DEVOTIONINMOTION.
