GENERAL

Stewards questioned riders after Race 1 regarding track conditions. Riders were unanimously of the opinion the track was more rain-affected after showers since the Penetrometer was taken earlier that morning showing a Dead 6. The decision was subsequently made by the RIB to downgrade to a Slow 7.

SUPPLEMENTARY

RACE COMMENTS

Race 1 FEILDING HOTEL MAIDEN 1300

The start was delayed approximately 3 minutes due to VAMPISH failing to load.

VAMPISH (A Mudhoo) - Late scratching at the barrier at 11.42am after failing to load. Connections were advised that VAMPISH must barrier trial to the satisfaction of Stewards prior to racing next.

MONKEY KING (C Jones) - Slow away. Held up for a short distance when attempting a marginal run near the 200 metres.

PERFECT POSY (D Hirini) - Gave ground rapidly rounding the home turn and finished some distance last. When questioned D Hirini was of the opinion the mare was unsuited to the Slow track.

C Dell (TEQUILA SPIRIT) – Spoken to regarding his whip action (above shoulder).

Race 2 POWER FARMING MANAWATU 1300

POWER 'N' PASSION (M Singh) - Began awkwardly and got back. Held up for some distance near the 100 metres.

ARJAYBEE (S Weatherley) - Held up for a short distance on the final bend.

SUNLIT LANE (K Hercock) - Finished last. When questioned rider advised the mare was unsuited to the Slow track conditions.

GLIDE QUEEN (C Jones) - Returned to the enclosure with blood present in a nostril. A subsequent veterinary examination revealed a slight cut to the nostril.

Race 3 MARTIN BEVERIDGE LTD MAIDEN 1600

KHALFANI (W Pinn) - Began awkwardly shifting out tightening TARGET.

TARGET (D Bradley) - Tightened start.

AMATHUSIA (L Allpress) - Began awkwardly and got back from its wide draw. Three wide throughout.

GRAND PROSPECT (J Riddell) - Tended to over-race until gaining cover near the 1200 metres.

SAILOR JACK (M Singh) - Shifted outwards under pressure for the majority of the home straight.

S Weatherley (RONIN POROTENE) - Issued with a warning after using the whip in 2 consecutive strides on RONIN POROTENE inside the final 100 metre mark with Stewards taking into account his clear recent record.

Race 4 RATANUI DEVELOPMENT COMPANY 1600

CISJURANE (C Jones) - Shifted sideways abruptly at the start and lost ground. Over-raced when racing wide without cover until near the 800 metres.

SEQUOIA DAWN (M Hudson) - Slow away. Steadied near the 1200 metres when the pace eased.

CHOLULA (F Lazet) - Slow away after beginning awkwardly. Steadied near the 1200 metres when the pace eased.

LORD ESPERANZA (S Macnab) - Over-raced early and had to be restrained off heels near the 1200 metres.

DEN BOSCH (R Hannam) - Raced wide throughout.

RUE CLER (L Allpress) - Finished well back. When questioned rider said the filly failed to quicken today and was one-paced. Connections advised RUE CLER would be spelled.

Race 5 PGG WRIGHTSON LTD 1600

FACETIME (K Asano) - Tightened at the start when HINEPARA jumped outwards abruptly simultaneously as AOTEA LAD shifted in. Briefly held up passing the 200 metres when in restricted room.

AOTEA LAD (C Jones) - Raced wide throughout.

NOD OF THE HEAD (J Riddell) - Lost the two front plates during the running. Finished well back after racing fiercely on the pace throughout. When questioned J Riddell advised he was unable to obtain cover and NOD OF THE HEAD was unsuited to racing in front and over-raced throughout. A post-race veterinary examination did not reveal any obvious abnormality.

C Jones (AOTEA LAD) - Shown footage of his ride in the presence of the Riding Master and issued with a warning after allowing his mount to shift inwards near the 250 metres hampering ZOLA EXPRESS, which was improving to its inside.

Race 6 COURTESY FORD RED CRAZE BOWL 1400

EXCELLERATION (S Macnab) - Slow away. Hampered near the 200 metres.

TAVI MAC (C Jones) - Over-raced early to middle stages. When questioned C Jones advised his riding instructions were not to dig the gelding up early as it had tended to over-race in the past, so elected to take some cover behind. This resulted in TAVI MAC over-racing and taking some distance to settle. C Jones added the gelding felt full of running turning for home but when asked to quicken in the home straight, failed to respond as expected and was disappointing. A post-race veterinary examination did not reveal any obvious abnormality. Trainer A Sharrock undertook to monitor TAVI MAC over coming days and report any anomalies to the Stewards.

ROCK ISLAND LINE (K Asano) - Over-raced passing the 1000 metres. Angled out passing the 200 metres to improve and in doing so briefly hampered EXCELLERATION. K Asano was issued with a warning.

TAVI COURT (F Lazet) - Shied at some sections of the running rail which were placed on the ground inside the course proper when making the lead near the 800 metres, briefly losing its footing.

Stewards questioned riders who had ridden throughout the day with there being no obvious issues with the track surface and after an inspection, which included the RIB, riders, trainer and course staff, the meeting was able to continue.

Race 7 RUAPEHU FARM SUPPLIES 1100

OSELETA (S Weatherley) – Began awkwardly losing ground. Held up rounding the turn and early part of the home straight, gaining clear running passing the 200 metres.

MI CAROL (C Jones) - Raced wide without cover throughout.

CAN I GET AN AMEN (S Macnab) - Checked near the 200 metres when attempting a run to the inside of CHIKIRA LASS (J Riddell) which shifted in simultaneously as DURHAM LAD (D Hirini) shifted out. After questioning riders J Riddell was advised to exercise care when shifting ground.

Race 8 RICOH FEILDING GOLD CUP 2100 (Listed Race)

HOUSE OF CARTIER (S Macnab) - Over-raced in the early stages.

MARIETTA LANE (W Pinn) - Shifted outwards abruptly on jumping away dictating PRINCE LEO outwards into the line of PENELOPE CRUISE, which got back. Raced wide in the early and middle stages. Shifted out under pressure early in the home straight forcing SIR NATE over extra ground.

SIR NATE (K Asano) - Forced over extra ground early in the home straight.

ARICINA (C Jones) - Raced wide for the majority of the race.

Race 9 IAN HUMPHREY MOTORS & HUMPHREY FAMILY 2200

PRINCE TURBO (D Bradley) - Raced three wide without cover for the majority.

SPEED CALL (K Hercock) - Got its head in the air when being steadied for several strides leaving the home straight on the first occasion.

MONKEY TOWN (R Hannam) - Steadied near the crossing passing the 1600 metres.

BEAR GRYLLS (C Jones) and MISTEREX (M Singh) came together and bumped on the point of the turn.

DEEP BLUE (S Macnab) - Held up from near the 100 metres until the finish.
