#### Race 4 - HOWL AT THE MOON MAIDEN 1200m

**HYSPEC** (K Williams) – Co-trainer Ms A Tyler advised Stewards that HYSPEC underwent a wind operation on Monday, 1 November. A Tyler further advised that the filly has now been sent for a freshen up.

#### Race 7 - AON INSURANCE MAIDEN 1335m

**EBONY MAGIC** (C Johnson) - Trainer Ms S McKay advised Stewards that EBONY MAGIC underwent a veterinary examination on Friday, 5 November which revealed the mare to have a respiratory infection. S McKay further advised that EBONY MAGIC has now been treated for the infection and will continue on with the mare's current preparation.

# Race 1 - THANK YOU KEVIN HICKMAN MAIDEN 1600m

MR TOOL (L Callaway) - Trainer Ms F Robertson advised Stewards that MR TOOL has now been retired from racing.

#### **RACE COMMENTS**

# Race 1 NZB READY TO RUN SALE TRAINERS SERIES MAIDEN 1200m

**SNITZEL VANCRUMB** (D Bothamley) - Slow to begin.

JAMIESON'S TIPPLE (K Mudhoo) - Began awkwardly.

**PONY EXPRESS** (K Asano) - Raced three wide without cover throughout.

**NEON MOON** (M McNab) - Held up in the early and middle stages of the run home and was unable to obtain clear running until near the 150 metres.

**SHARPIE** (C Grylls) - Held up for the majority of the straight with the rider advising that the gelding had raced greenly. Co-trainer M Pitman was granted permission to add side winkers with the gelding being accepted for racing on Wednesday at Riccarton Park.

**AUTHORITY** (J Laking) - Had to be steadied to avoid the heels of LEROY near the 450 metres, then being hampered passing the 400 metres when HORACE (V Colgan) was looking to obtain clear running, with WHIPPERSNAPPER also being hampered as a result. V Colgan was advised to exercise greater care.

**WHIPPERSNAPPER** (T Moseley) - Hampered passing the 400 metres. Rider advised that the gelding hung inwards throughout the run home.

The track was upgraded to Good 3 retrospective to this race.

# Race 2 THE NED FASHION IN THE FIELD NOVEMBER 13 PREMIER 1100m

**TELLYAWHAT** (M Taylor) - Fractious in the barrier prior to the start.

**GOLDEN HARVEST** (C Grylls) - Began awkwardly. Inclined to over race in the early stages. Held up for a distance passing the 300 metres.

OHIO SHOWGIRL (S Wynne) - Jumped away awkwardly. Had difficulty obtaining a clear run throughout the straight.

**ROCKLAND** (L Allpress) - The saddle shifted backwards early in the race.

**J Laking** (STREET FIGHTIN MAN) - Admitted a charge of using the whip in two consecutive strides on his mount STREET FIGHTIN MAN near the 25 metres, with the Adjudicative Committee imposing a fine of \$200.

**T Newman** (OUR ECHO) - Admitted a charge in that she struck her mount OUR ECHO six times prior to the 100 metre mark, with the Adjudicative Committee imposing a fine of \$500.

#### Race 3 GARRARDS HORSE & HOUND PREMIER MAIDEN 1600m

IFITHAPPENSAGAIN (V Colgan) - Slow to begin.

**NOBLE KNIGHT** (J Lowry) - Lay outwards shortly after the start crowding runners to the outside.

**ROYAL KHAN** (T Moseley) - Crowded shortly after the start. Hampered near the 1100 metres. Lay in passing the 200 metres having to be straightened by its rider.

**EIGHT BALL** (D Johnson) - Crowded shortly after the start. Raced very ungenerously in the early and middle stages being inclined to get its head up.

**SERAPHIC** (S Macnab) - Crowded shortly after the start.

**LA COFRADIA** (M Cameron) - Raced keenly in the early stages. Raced very ungenerously in the middle stages getting its head up and having to be firmly restrained to avoid runners ahead hampering ROYAL KHAN near the 1100 metres. Again got its head up when improving onto heels passing the 1000 metres.

**COSY NOOK** (S Wynne) - Raced wide without cover throughout.

**DEMAND RESPECT** (O Bosson) - Held up over the concluding stages having to be steadied when improving onto the heels of ASTRAKHAN.

**ANCHOR ME** (T Comignaghi) - Held up for a distance near the 400 metres.

**DA VINCI GIRL** (C Grylls) - Held up for a distance passing the 300 metres.

#### Race 4 DAKINS GROUP PREMIER 1600m

**LADY MODENA** (R Mudhoo) - Over raced in the middle stages. Steadied when improving onto heels near the 450 metres.

**FETTERCAIRN** (S Wynne) - Held up rounding the final turn and throughout the straight before shifting outwards near the 25 metres.

**NAMIBIA MISS** (K Williams) - Had some difficulty obtaining clear running in the straight when racing in restricted room.

**WESTERN GIRL** (C Johnson) - Eased down over the concluding stages. When questioned regarding performance rider advised that the mare had travelled well enough until placed under pressure when it had felt indifferent in its action.

Underwent a post race veterinary examination which revealed the mare to have suffered from cardiac arrhythmia. Trainer A Carston was advised that WESTERN GIRL will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.

**SHOCK PROSPECT** (M Cameron) - Crowded then having to be severely checked near the 25 metres.

**S Wynne** (FETTERCAIRN) - Admitted a charge of careless riding in that she permitted her mount FETTERCAIRN to shift outwards when not sufficiently clear of SHOCK PROSPECT which was crowded then checked near the 25 metres. After considering submissions the Adjudicative Committee suspended S Wynne's licence to ride in races from the conclusion of racing on Saturday 13 November until the conclusion of racing on Thursday 25 November, 7 national riding days.

# Race 5 ONE GOOD HORSE AT AVONHEAD TAVERN PREMIER 2000m

**ZEEFA ZED** (L Allpress) - Raced fiercely in the early stages before being allowed to improve forward to lead near the 1200 metres. When questioned regarding performance rider advised that the gelding had over raced in the early stages and failed to finish the race off. A post race veterinary inspection did not reveal any obvious abnormality.

SULU SEA (T Comignaghi) - Over raced in the middle stages.

QUEEN SWEEP (M Gestain) - Raced wide from the 700 metres.

YOLO (K Asano) - Had some difficulty obtaining clear running until near the 100 metres.

# Race 6 DONALDSON BROWN PEGASUS STAKES 1000m

**GRAND MAYSON** (D Johnson) - Slow to begin. When questioned regarding performance rider advised that the gelding had been out paced today over the 1000 metres and in her opinion is better suited over more ground.

**DEVIOUS** (T Moseley) - Held up in the early stages of the run home then becoming awkwardly placed on the heels of OUR GIRL GILLY which was weakening. When having to be heavily restrained to avoid the heels of OUR GIRL GILLY, DEVIOUS shifted outwards buffeting LOVE SQUIRRELS for a distance passing the 300 metres.

LOVE SQUIRRELS (C Johnson) - Hampered when buffeted passing the 300 metres.

KHIMAR WAR (R Cuneen) - Hindquarters contacted by LOVE SQUIRRELS passing the 300 metres.

# Race 7 MILLENNIUM HOTELS & RESORTS – SIMPE JOYS 1200m

**WHERE'S WALLY** (K Asano) - Jumped away awkwardly. When questioned regarding performance rider advised that the gelding was not suited by the firm track conditions. A post race veterinary examination did not reveal any obvious abnormality.

SHE'S RECOMMENDED (K Kwo) - Raced wide throughout.

**TAKE A RISK** (T Newman) - Held up in the straight before shifting outwards across heels to obtain clear running near the 200 metres.

VINO BELLA (T Moseley) - Held up passing the 350 metres.

KOPUA (T Comignaghi) - Inconvenienced near the 200 metres when TAKE A RISK shifted outwards.

**CEDDY SMITH** (S Wynne) - When questioned regarding performance rider advised that in her opinion the gelding is better suited over more ground. A post race veterinary examination did not reveal any obvious abnormality.

# Race 8 AL BASTI EQUIWORLD DUBAI NZ 2000 GUINEAS (G1) 1600m

**WAKARI** (D Johnson) - Began awkwardly. When questioned regarding performance rider could offer no excuse, being of the opinion the gelding may be feeling the effects of recent racing and travelling. A post race veterinary inspection did not reveal any obvious abnormality.

**NOVERRE** (O Bosson) - Slow to begin then being restrained after jumping from a wide barrier. Steadied when improving onto heels passing the 700 metres. Steadied across the heels of the weakening FIREGLOW to obtain clear running passing the 400 metres.

MACKENZIE LAD (S Wynne) - Raced wide in the early stages.

**FIREGLOW** (T Moseley) - Raced three wide without cover throughout.

**FIELD OF GOLD** (M McNab) - Raced keenly in the middle stages. Steadied when placed in restricted room near the 500 metres after CEASAR dictated FIREGLOW outwards along with some inward movement from MERITABLE, then being held up entering the straight.

**S Wynne** (MACKENZIE LAD) - Admitted a charge in that she struck her mount MACKENZIE LAD seven times prior to the 100 metres. After considering submissions the Adjudicative Committee imposed a suspension of S Wynne's licence to ride in races from the conclusion of racing on Thursday 25 November until the conclusion of racing on Thursday 2 December, 5 national riding days, and in addition imposed a fine of \$500.

## Race 9 GOLD CLUB PREMIER 1400m

**AUGUSTACE** (J Laking) - Late scratched at 4.09 pm after refusing to enter its barrier. The connections were advised that given the gelding's barrier history it is now required to trial on multiple occasions prior to racing again.

ITSONLYMONEY (S Weatherley) - Restrained to obtain cover after jumping from the outside barrier.

**UCALLEDIT** (T Comignaghi) - Over raced in the middle stages.

**SUPREME KHAN** (O Bosson) - When questioned regarding performance, rider was of the opinion the gelding was not suited by today's firm track conditions.

# Race 10 NAUTICAL BOAT INSURANCE METROPOLITAN TROPHY HCP 2500m

**SOUTHERN OCEAN** (L Allpress) - Hampered leaving the barriers when MISS TAVI jumped outwards. Steadied when placed in restricted room near the 500 metres and then had difficulty obtaining clear running early in the straight. When questioned regarding performance, rider advised that after suffering interference at the start the mare had got further back than intended then being held up rounding the turn, adding she was satisfied with the run.

MISS TAVI (K Williams) - Shifted outwards abruptly on jumping crowding outside runners.

**RIVIERA ROCK** (S Wynne) - Began awkwardly. Raced wide in the early stages being allowed to improve forward to lead near the 2000 metres.

**BEAUDZ WELL** (S Weatherley) - Crowded at the start.

**SWORDS DRAWN** (C Grylls) - Crowded at the start. Raced wide throughout. Unbalanced when hindquarters contacted near the 2300 metres. When questioned regarding performance rider advised that despite being caught wide he had expected the gelding to finish the race off better. A post race veterinary inspection revealed 1/5 lameness in the left foreleg, with co-trainer S Ritchie being advised that a veterinary certificate of fitness is required prior to racing next.

**POINT SCORE** (C Johnson) - Shifted outwards when being steadied near the 2300 metres making contact with the hindquarters of SWORDS DRAWN which was unbalanced. Got its head up when being steadied and raced ungenerously near the 2200 metres.

**LINCOLN KING** (D Johnson) - Held up near the 150 metres making contact with MADAM DE SOIR when shifting out to obtain clear running before racing in restricted room over the concluding stages.

**WANNABE 'N' PARIS** (T Moseley) - Inconvenienced when weakening near the 100 metres when RIVIERA ROCK (S Wynne) shifted outwards under pressure. S Wynne was advised to exercise greater care.

C Faulkner (NOTABADHARADA) - Fined \$50 under the Minor Infringement Schedule for late declaration of rider.

# Race 11 BLUE STAR TAXIS PREMIER 1600m

TOO FERLAXED (K Asano) - Slow to begin.

GOODONYAMATE (S Wynne) - Slow to begin.

**SAVEZAR** (J Lowry) - Jumped in the air at the start and was slow away as a result. Raced wide throughout. Held up in the early stages of the run home continuing to have difficulty obtaining clear running until near the 200 metres.

**MISTER RELIABLE** (C Grylls) - Crowded on jumping. Raced keenly in the middle stages. Held up passing the 300 metres until near the 100 metres.

MISS CURIOUS (D Bothamley) - Raced wide in the early stages and was inclined to over race.

**SAIGON HOT NIGHT** (L Callaway) - Raced keenly in the middle stages. Eased down over the concluding stages with the rider reporting that the gelding had felt indifferent in its action. A post race veterinary inspection found the gelding to have multiple superficial abrasions to the left hind pastern most likely as a result of striking itself during the running.

**S Wynne** (GOODONYAMATE) - Admitted a charge in that she struck her mount GOODONYAMATE six times prior to the 100 metres. After considering submissions the Adjudicative Committee imposed a suspension of S Wynne's licence to ride in races from the conclusion of racing on Thursday 2 December until the conclusion of racing on Wednesday 15 December, 7 national riding days.
