Racing Te Aroha - Thursday, 28 October 2021

Race 8 DONAGHYS TASMAN TIM MAIDEN 1200

ADJUDICATOR (R Elliot) – Trainer Mr A Burton advised Stewards upon return to the stable ADJUDICATOR underwent a veterinary examination which revealed no abnormalities. A Burton further advised it is his intention to continue on with the gelding's current preparation.

Racing Tauranga Date - Saturday, 30 October 2021

Race 1 BETH DAWSON POWERS REALTY MAIDEN (1200 metres)

MOOVIT ONOVA (M McNab) – Trainer Mr S Ritchie advised Stewards MOOVIT ONOVA underwent a veterinary examination on Monday 1 November which revealed no abnormalities. S Ritchie further advised it is his intention to continue on with the gelding's current preparation and may look to apply blinkers prior to MOOVIT ONOVA'S next race day start.

Race 5 QUICK COUNT MAIDEN (1600 metres)

BEFRANKLIN (O Bosson) – Trainer Mr J Richards reported to Stewards BEFRANKLIN is now no longer a racing prospect for Te Akau Racing Stable.

Race 7 PRH TRANSPORT TROPHY (1600 metres) (Listed Race)

TANNAHILL (E Leighton) – Co-trainer Mr C Phelan advised Stewards upon return to the stable TANNAHILL underwent a veterinary examination which revealed no abnormalities. C Phelan further advised TANNAHILL has now been sent for a spell.

Race 8 MILLS REEF HANDICAP (2100 metres)

MISS ONAKI (C Grylls) – Trainer Mr T Pike advised Stewards he was satisfied with the post-race condition of MISS ONAKI, however, the mare has now been sent for a spell.

RACE COMMENTS

Race 1 SVS STARTING GATES 2YO (1000 metres)

MONTEZUMA (R Elliot) – Slow to begin.

WESTWOOD (J Kamaruddin) - Began awkwardly shifting out making contact with SACRED SATONO.

KAHMA SUITSYA (L Satherley) - Bumped shortly after the start losing some ground. When questioned regarding performance the rider advised that the filly had raced greenly throughout and may benefit from the addition of blinkers.

Race 2 FAIRVIEW MOTORS MAIDEN 3YO (1600 metres)

ADHIRAA (T Yanagida) - Began awkwardly.

BERGHEIM (L Satherley) - Contacted at the start losing ground. Contacted near the 150 metres.

EYESONTHEPRIZE (S McKay) – Lay out rounding the final bend.

HOW MUCH FOR CASH (J Riddell) - Began awkwardly making firm contact with BERGHEIM with both runners losing some ground.

CAERUS (B Grylls) - Held up for clear running until angling across heels near the 150 metres to find clear racing room making contact with BERGHEIM.

Race 3 WAIKATO DRAUGHT 2100

PLUSHENKO (A Goindasamy) – Began awkwardly losing ground. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

CERYS (T Yanagida) – Slow to begin. Had difficulty obtaining clear running early in the final straight.

BARRACUDA (T Thornton) – Over-raced through the early stages.

BRINGITONPET (J Mudhoo) – Began awkwardly losing ground.

RODOLFO (B Rogerson) – Raced wide early before improving to sit outside the leader near the 1200 metres.

TEROTI (A Mudhoo) - Raced wide without cover throughout.

TRUEFALLS (B Grylls) - Improved onto heels near the 1600 metres and shifted outwards hampering WINDERMERE. Momentarily raced in restricted room passing the 300 metres. Collapsed on return to scale and was immediately attended to by the on-course veterinarian with the Horse Ambulance being deployed. Upon examination the mare was found to have suffered from a heart attack.

WINDERMERE (R Elliot) – Hampered and forced wider 1600 metres.

J Fawcett (FINEST WINE) - Admitted a charge in that she struck her mount FINEST WINE seven times prior to the 100 metre mark with the Adjudicative Committee imposing a suspension of her licence to ride in races from the conclusion of racing on Tuesday 16 November up to and including racing on Thursday 25 November, 5 national riding days and in addition imposed a fine of \$150.

Race 4 SKYCITY HAMILTON WAIKATO CUP PRELUDE (2100 metres)

SUMMER FESTIVAL (J Kamaruddin) – Shifted out at the start crowding outside runners. Raced wide through the early stages.

JUDY'S SONG (J Fawcett) - Crowded at the start losing ground.

MIGHTY CONNOR (S McKay) - Crowded at the start losing ground.

LILY D'OR (T Yanagida) - Began awkwardly after being fractious in its barrier stall. When questioned regarding performance rider could offer no excuse.

C Barnes (RIP EM UP) - Stewards enquired into the manner in which C Barnes used her whip in the home straight and could not be conclusively satisfied that she had contravened the rules.

J Fawcett (JUDY'S SONG) - Admitted a charge in that she struck her mount JUDY'S SONG seven times prior to the 100 metre mark with the Adjudicative Committee imposing a suspension of her licence to ride in races from the conclusion of racing on Thursday 25 November up to and including racing on Friday 3 December, 6 national riding days and in addition imposed a fine of \$200.

Race 5 LEGACY LODGE SPRINT (1200 metres) (Listed Race)

FAMILIA (S McKay) - Began awkwardly losing ground.

RUN TO PERFECTION (T Yanagida) - Began awkwardly. Had difficulty obtaining clear running early in the final straight before shifting outwards approaching the 100 metres.

VERNAZZA (B Grylls) – Slow to begin. Had to be steadied when placed in restricted room just prior to the winning post by RUN TO PERFECTION which continued to shift outwards. Contributing was slight inward movement from ROCH 'N' HORSE.

MASCARPONE (R Elliot) - Raced wide without cover for the majority of the race. Forced wider first bend and was then obliged to race three wide without cover for the remainder of the race.

SHOSHONE (K Hercock) - Made the first bend awkwardly when over-racing and shifted out forcing MASCARPONE wider. Underwent a post-race veterinary inspection which found the mare to have a laceration on the right hind pastern which required veterinary attention.

SHOWOROSES (L Satherley) - Crowded and checked passing the 100 metres.

SHORT FUSE (T Thornton) - Crowded and checked passing the 100 metres.

ROMANTIC LADY (J Kamaruddin) - Steadied over the concluding stages after improving onto the heels of MASCARPONE which shifted in slightly. R Elliot was advised to exercise care.

ROCH 'N' HORSE (A Goindasamy) - Began awkwardly.

T Yanagida (RUN TO PERFECTION) - Admitted a charge in that he permitted his mount to shift out near the 100 metres crowding and checking SHOWOROSES and SHORT FUSE. After considering submissions the Adjudicative Committee suspended his licence to ride in races from the conclusion of racing on Saturday 13 November up to and including racing on Thursday 25 November, 7 national riding days and in addition imposed a fine of \$200.

Race 6 SUPER SETH @ WAIKATO STUD MILE (1600 metres)

MAASIR (S McKay) – Began awkwardly making contact with VEDO ROSSO, losing ground.

VEDO ROSSO (A Goindasamy) – Jumped away awkwardly making contact with MAASIR, losing ground.

STARRYBEEL (C Barnes) – Jumped away awkwardly.

CRAFTY JESS (N Parmar) – Raced three wide without cover for a majority of the race.

FEELIN' FANCY (J Kamaruddin) – Raced keenly when being restrained approaching the 800 metres.

AURORA DOLCE (W Pinn) - Raced in restricted room for a distance early in the final straight.

SWEET ANNA (R Elliot) – Inconvenienced approaching the winning post by FEELIN' FANCY which shifted outwards. J Kamaruddin was advised to exercise care.

LILY'S LADY (B Grylls) - Improved onto heels over the concluding stages.

SHOCKALLIA (J Riddell) – Briefly held up passing the 300 metres.

J Kamaruddin (FEELIN' FANCY) – Issued with a warning and reminded of his obligations that he must ride his mounts out to the end of the race when circumstances permit him to do so.

J Riddell (SHOCKALLIA) – Issued with a warning for weighing in 0.5 kgs over the weight at which he weighed out at.

Race 7 DUNSTAN HORSEFEEDS 1300

TINA AGAIN (L Satherley) - Became fractious in its barrier stall. Shifted out abruptly at the start making firm contact with ROSE 'N' POWER with both runners becoming briefly unbalanced then raced in restricted room for a distance shortly after.

ROSE 'N' POWER (J Fawcett) – Contacted by TINA AGAIN at the start, becoming briefly unbalanced.

PERFECT SCENARIO (N Parmar) – Raced in restricted room shortly after the start.

TEVERE (A Goindasamy) - Raced in restricted room shortly after the start.

CAMPIONESSA (J Kamaruddin) - Raced in restricted room when making the bend near the 850 metres to the outside of MARIA FARINA which shifted outwards when racing keenly. Improved onto heels approaching the 400 metres having to be steadied.

MARIA FARINA (C Barnes) – Made the bend awkwardly when racing keenly near the 850 metres.

MR UNIVERSE (T Thornton) – Had difficulty obtaining clear running early in the final straight.

N Parmar (PERFECT SCENARIO) - Issued with a warning after using his whip in two consecutive strides on PERFECT SCENARIO near the 250 metres with Stewards taking into account his clear recent record.

T Yanagida (HASSTOBEMAGIC) - Was questioned regarding the riding tactics he had adopted on the mare and in particular the decision not to restrain his mount through the middle stages. T Yanagida advised that he had been instructed to lead and not fight the mare after it had won well on 2 September at Cambridge using similar tactics. Stewards noted his comments however advised T Yanagida that he would be expected to show better judgement in the future.

Race 8 HAPPY BIRTHDAY KARYN FENTON-ELLIS 1400

ZOUPERB (R Elliot) – Began awkwardly.

GONE WITH THE WIND (A Goindasamy) – Began awkwardly losing some ground.

DEAR OH DEAR (B Grylls) - Raced three wide without cover throughout.

PENNY JANE (C Barnes) - Clipped the heel of DEAR OH DEAR which had commenced to give ground quickly and blundered losing considerable momentum and ground near the 400 metres.

STELLA ECLIPSE (K Hercock) - Had to be steadied after becoming awkwardly placed on the heels of ROC CHA which shifted in when not fully clear passing the 1000 metres. Then continued to over-race for a distance.

BENTAYGA (J Riddell) - Held up until shifting outwards passing the 300 metres.

B Rogerson (ROC CHA) - Issued with a warning for permitting her mount to shift in passing the 1000 metres when not sufficiently clear of STELLA ECLIPSE which had to be steadied.
