<b>RACE COMMENTS</b>	
<b>Race 1</b>	<b>CARRFIELDS LIVESTOCK 1200</b>
<p><b>GEE STRING</b> (K Hercock) - Over-raced in the lead through the early and middle stages. Lay out under pressure in the straight.</p> <p><b>K Hercock</b> (GEE STRING) - Admitted a charge in that she struck her mount GEE STRING 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of her licence to ride in races from the conclusion of racing on Sunday, 14 November until the conclusion of racing on Wednesday, 24 November, 5 national riding days and in addition imposed a fine of \$150.</p>	
<b>Race 2</b>	<b>CR GRACE / BAYLEYS MAIDEN 3YO 1200</b>
<p><b>GOLDEN HOUR</b> (S Weatherley) - Jumped away awkwardly. Briefly hampered near the 100 metres when AVIATOR lay in.</p> <p><b>LADY PRISTINA</b> (J Kamaruddin) - Slow away after being fractious in its barrier stall. When questioned regarding performance rider advised the filly had not felt comfortable in today's track conditions.</p> <p><b>AVIATOR</b> (S Macnab) - Raced three wide without cover and raced keenly through the middle stages.</p>	
<b>Race 3</b>	<b>AWWASSI / CENTRAL LINES MAIDEN 1400</b>
<p><b>WEOWNA TIGER</b> (J Fawcett) - Raced very ungenerously shifting outwards abruptly crossing the junction on to the course proper approaching the 1300 metres hampering PIN POINTING, MOONLIGHT HUSTLER, FLAT TRACK BULLY and ANNELIESE. Had to be steadied near the 900 metres to avoid the heels of NO TIME TO JAZZ, which shifted in when not fully clear.</p> <p><b>PIN POINTING</b> (C Dell) - Hampered approaching the 1300 metres. Over-raced in the middle stages, improving onto the heels of WEOWNA TIGER near the 900 metres then going off stride and ducking away from the running rail, badly unbalancing its rider.</p> <p><b>MOONLIGHT HUSTLER</b> (K Hercock) - Badly hampered approaching the 1300 metres, having to be checked, losing ground.</p> <p><b>FLAT TRACK BULLY</b> (J Kamaruddin) - Hampered approaching the 1300 metres. Over-raced in the early to middle stages. J Kamaruddin said after the gelding had over-raced in the early stages the gelding had little left at the finish in the soft going.</p> <p><b>ANNELIESE</b> (C Grylls) - Hampered approaching the 1300 metres. Rider reported the filly had raced greenly in its race-day debut.</p> <p><b>NO TIME TO JAZZ</b> (F Lazet) - Lay out rounding the final turn and continued to lay out under pressure in the straight.</p> <p><b>C Dell</b> (PIN POINTING) - Was reminded of his obligation to ride his mounts out to the finish.</p> <p><b>F Lazet</b> (NO TIME TO JAZZ) - Issued with a warning after permitting her mount to shift inwards near the 900 metres when not fully clear of WEOWNA TIGER.</p> <p><b>K Hercock</b> (MOONLIGHT HUSTLER) - Admitted a charge in that she struck her mount MOONLIGHT HUSTLER 7 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of her licence to ride in races from the conclusion of racing on Wednesday, 24 November until the conclusion of racing on Thursday, 2 December, 6 national riding days and in addition imposed a fine of \$150.</p>	

<b>Race 4</b>	<b>AFFCO CHB CUP 1600</b>
<p><b>OVERSTAYER</b> (S Weatherley) - Raced wide without cover until near the 1000 metres.</p> <p><b>SLIM</b> (J Mudhoo) - Rider reported the gelding had not felt comfortable in today's slow track conditions.</p>	
<b>Race 5</b>	<b>GROUNDWORKS PLUS MAIDEN 1600</b>
<p><b>I'M CHUCK</b> (C Dell) - Slow away. Held up entering the straight, having to shift ground to obtain clear running near the 250 metres. Shifted outwards under pressure near the 75 metres having to be straightened by its rider.</p> <p><b>NONCHALANT</b> (S Weatherley) - Raced three wide without cover throughout.</p> <p><b>SAILOR JACK</b> (K Hercock) - Held up rounding the turn from the 700 metres.</p>	
<b>Race 6</b>	<b>AON INSURANCE BROKERS WAIPUKURAU CUP 1600</b>
<p><b>GALLARDO</b> (C Grylls) - Slow away.</p> <p><b>FIDDYAFORTNIGHT</b> (S Macnab) - Raced three wide without cover.</p>	
<b>Race 7</b>	<b>RURAL AIR WORK / MT HERBERT FARM 1400</b>
<p><b>TANGO LOVE</b> (S Macnab) - Passed suitable to race following a pre-race veterinary inspection after suffering a minor abrasion to the left hind hip when being transported to the course.</p> <p><b>ATENARTIN</b> (F Lazet) - Slow away. When questioned regarding performance rider advised that after a poor beginning, she had ridden her mount with urgency to recover, then chasing the tear-away leader before weakening from the 600 metres. A post-race veterinary examination did not reveal any abnormality.</p> <p><b>TUIGIRL</b> (K Hercock) - Had to be steadied when placed in restricted room to the inside of ORLOV (C Grylls) near the 900 metres with some outward movement from PARISIAN POPPY contributing to the incident.</p> <p><b>SHOW ME CHAMPAGNE</b> (J Kamaruddin) - Rider was of the opinion the filly failed to handle today's track conditions.</p> <p><b>C Grylls</b> (ORLOV) - Issued with a warning after permitting his mount to shift inwards when not fully clear, placing TUIGIRL in restricted room near the 900 metres.</p> <p><b>A Mudhoo</b> (MARIA DIOR) - Reprimanded for his use of the whip on a horse clearly winning.</p>
