<p>Otago Racing Club - Tuesday 2 November 2021</p> <p>Race 2 - OTAGO FARM MACHINERY MAIDEN 1400m</p> <p>POWERLITE (T Comignaghi) - Co-trainer Mrs K Parsons advised Stewards that POWERLITE underwent a veterinary examination on Wednesday 3 November which included blood tests, with results revealing the filly to have a virus and to be showing signs of tying up. K Parsons further advised that POWERLITE has now been sent for a spell.</p> <p>Race 3 - K B CONTRACTORS MAIDEN 1200m</p> <p>KAMENNA (C Barnes) – Trainer Mr T Kennedy reported to Stewards he was satisfied with the post-race condition of the mare and it is his intention to continue on with KAMENNA’S current preparation.</p>

Race 1	STEPHANIE MURRAY MORTGAGES PREMIER MAIDEN 2000m
<p>DA VINCI GIRL (C Grylls) - Began awkwardly making firm contact with TAKEITEASY with both runners losing ground as a result. When questioned regarding performance rider was unable to offer any excuse.</p> <p>ROYAL KHAN (B Murray) - Shifted outwards at the start crowding POITIN onto NO RIGMAROLE. Held up rounding the final turn and early in the straight having to shift ground inwards passing the 350 metres continuing to have difficulty obtaining clear running and being inclined to lay in making contact with ITS ALL OVER ROVER near the 100 metres.</p> <p>POITIN (R Elliot) - Crowded and buffeted at the start losing ground. Steadied when racing in restricted room inside the final 75 metres.</p> <p>NO RIGMAROLE (L Hemi) - Crowded and buffeted at the start losing ground.</p> <p>SPONSOR (J Laking) - Shifted outwards at the start making firm contact with THREE OVER TWO. Over raced in the early stages. Held up in the early stages of the run home.</p> <p>AINE BEAG (K Kwo) - Raced wide through the early stages.</p> <p>IFITHAPPENSAGAIN (L Allpress) - Over raced in the early stages. Raced wide without cover throughout.</p> <p>ITS ALL OVER ROVER (J Lowry) - Contacted near the 100 metres. Rider advised that after travelling well enough the gelding had failed to respond once placed under pressure and had been disappointing.</p> <p>MR GIBSON (K Asano) - Rider advised that in his opinion the gelding is better suited to rain affected footing.</p>	
Race 2	AVON CITY FORD PREMIER MAIDEN 1400m
<p>KUDOS DE SOTHYS (D Bothamley) - Slow to begin. Restrained when improving onto the heels of JUSTANACE near the 900 metres.</p> <p>JUSTANACE (C Grylls) - Jumped away awkwardly making contact with IFFRAAJABLE.</p>	

IFFRAAJABLE (K Williams) - Contacted leaving the barriers.

JAY BEE GEE (R Elliot) - Slow to begin.

DUSHKU (K Asano) - Blundered leaving the barriers. Hampered near the 200 metres.

VORALTO (L Callaway) - Began awkwardly then further hampered when crowded shortly after the start.

WILD ROVER (S Wynne) - Over raced in the middle stages. Lay in throughout the run home having to be straightened on a number of occasions hampering DUSHKU near the 200 metres.

Race 3 | **HOTEL MONTREAL PREMIER MAIDEN 1400m**

JAMIESON'S TIPPLE (C Johnson) - Began awkwardly losing ground. Got its head up when over racing in the early stages.

BODYGUARD (S Wynne) - Jumped away awkwardly. Over raced in the early stages and had to be steadied to avoid the heels of SHIBUYA KOSATEN which shifted inwards when not fully clear passing the 1000 metres. K Williams was advised to exercise care.

LA COFRADIA (K Asano) - Restrained to obtain cover after jumping from the outside barrier. Commenced to over race passing the 800 metres then having to be heavily restrained when improving onto the heels of MCDREAMY and shifted outwards making contact with TARRAS FALLS which became unbalanced near the 600 metres. Lay in under pressure in the straight.

BEAU STITCH (B Murray) - Raced three wide without cover.

SHIBUYA KOSATEN (K Williams) - Held up in the early and middle stages of the run home until obtaining clear racing room passing the 150 metres.

LENNON (K Chowdhury) - Over raced in the middle stages. Dictated inwards passing the 175 metres by LA COFRADIA then having to be steadied just short of the finish when placed in restricted room between TREYBON and LA COFRADIA which both shifted ground.

TARRAS FALLS (T Comignaghi) - Hampered and unbalanced when contacted near the 600 metres.

DRIFT ON BY (R Mudhoo) - Had to be steadied when crowded near the 150 metres.

Following the running of the race the co-trainer of the third placed horse LENNON, Mr Michael Pitman, lodged a protest with the Adjudicative Committee alleging interference over the concluding stages by the second placed horse LA COFRADIA. After considering submissions the Adjudicative Committee dismissed the protest.

K Williams (SHIBUYA KOSATEN) - Issued with a warning after angling her mount SHIBUYA KOSATEN inwards when not sufficiently clear of the weakening DRIFT ON BY which was crowded near the 150 metres.

K Asano (LA COFRADIA) - Issued with a warning and advised he must make a greater effort to straighten his mount after allowing LA COFRADIA to shift inwards inside the final 175 metres.

Race 4 | **BIDFOOD PROCESSING PREMIER 1400m**

PALMETTO (J Lowry) - Declared a late scratching at 1.21pm on veterinary advice.

There was a delay to the start of this race when MASTER MARKO required attention to its gear in the barriers.

MASTER MARKO (L Callaway) - Fractious in its barrier prior to the start. Crowded and buffeted shortly after the start. Had to be steadied away from the heels of FAH LUN near the 1100 metres after that runner was taken out by AVITUS. Hampered as a result were MEGAVISION, SHARPIE and BEAU ROUGE.

VAN DIESEL (T Moseley) - Jumped away awkwardly then having to be steadied shortly after the start when AVITUS shifted outwards when racing ungenerously. Had difficulty obtaining clear running over the final 200 metres.

ON TILT (R Elliot) - Slow to begin. Briefly held up approaching the 200 metres then briefly steadied when placed in restricted room near the 100 metres.

BELASARD (K Chowdhoo) - Slow to begin. Was inclined to lay inwards under pressure in the straight and after being struck with the whip shifted away from NOT A BRASS RAZOO abruptly near the 200 metres crowding BEAU ROUGE which was checked with some outward movement from ON TILT being a contributing factor. Also hampered in this incident was MEGAVISION which had to steady. K Chowdhoo was advised to exercise greater care.

NOT A BRASS RAZOO (S Macnab) - Blundered at the start and shifted outwards abruptly crowding outside runners. Lay inwards under pressure in the straight. Jostled with BELASARD when that runner was attempting to find clear running near the 500 metres.

FAH LUN (C Barnes) - Crowded and buffeted at the start.

AVITUS (J Laking) - Got its head up on a number of occasions when over racing in the early stages and continued to race ungenerously for some distance.

SHARPIE (C Grylls) - Raced wide throughout. Hampered near the 1100 metres. Raced greenly throughout with the rider advising that the gelding had failed to back up from its debut run the previous Saturday.

MEGAVISION (K Kwo) - Hampered near the 1100 metres. Hampered having to steady passing the 200 metres. Reported by its rider to have hung throughout the running. Post race MEGAVISION was attended to by the on-course veterinarian and transported by horse ambulance to Canterbury Equine Veterinary Clinic with a suspected fractured left fore cannon bone.

BEAU ROUGE (R Mudhoo) - Hampered near the 1100 metres. Crowded and checked near the 200 metres. When questioned regarding his ride apprentice Mudhoo advised that he had been instructed to attempt to obtain a midfield position with cover but after jumping from a wide barrier the gelding had got its head up and raced ungenerously when he was attempting to get it to settle and several other runners to his inside had also been over-racing going into the first turn where he had been further hampered and forced even wider on the track. Mr Mudhoo further advised that when BEAU ROUGE continued to refuse to settle that he had then elected to try and improve forward to obtain a position closer to the running rail but continued to be trapped wide for a distance initially when MEGAVISION was also urged forward to his inside and was never able to get to a position closer than three wide and had fought on well in the circumstances including being crowded and checked near the 200 metres.

SEA SHEPHERD (C Johnson) - Over raced in the middle stages.

B Murray (BORNHOLM) - Issued with a warning after weighing in in excess of 0.5 kgs greater than which he had weighed out.

Race 5 | **HALLS REFRIGERATED TRANSPORT PREMIER 2000m**

CAMINO ROCOSO (C Johnson) - Over raced when leading through the early to middle stages.

BULLY BOY (K Asano) - Lay in through the run home having to be straightened on a number of occasions.

Race 6 | **VALACHI DOWNS CANTERBURY BREEDERS STAKES (G3) 1400m**

LONDON BOUND (S Macnab) - Began awkwardly losing ground.

ALL ABOUT MAGIC (S Wynne) - Slow to begin.

PULLYOURSOCKSUP (C Barnes) - Began awkwardly shifting inwards crowding inside runners. Hampered near the 850 metres.

BENEFICIAL (L Allpress) - Crowded at the start losing some ground. Held up in the straight.

TAMAHINE (C Johnson) - Crowded at the start losing some ground. Commenced to over race near the 1100 metres when shifting outwards to avoid heels near the 850 metres hampering PULLYOURSOCKSUP. Held up until near the 200 metres.

MINT JULEP (T Comignaghi) - Raced three wide without cover.

SEVERINE (K Asano) - Over raced in the middle stages.

PROVIDENCEPROVIDES (M McNab) - Lay in in the run home making contact with the running rail passing the 100 metres going off stride and becoming unbalanced losing considerable momentum.

THE GIFT (K Mudhoo) - Rider reported that the mare had held its beath during the running. A post race veterinary inspection did not reveal any obvious abnormality.

Race 7 | **HAASE MARSHALL DRAINAGE PREMIER 2500m**

AQUATTACK (S Wynne) - Fractious in its barrier prior to jumping. Had to be steadied racing into the first bend when crowded for room.

MAXWELL (K Chowdhoory) - Bounded at the start losing ground.

YOLO (R Elliot) - Slow to begin.

BORN TO BE BAD (T Jonker) - Slow to begin.

REDGUM (C Johnson) - Raced wide through the early stages.

PLATINUM SPIRIT (C Dell) - Raced three wide without cover until near the 1700 metres.

ZAKUNDA (C Grylls) - Underwent a post race veterinary examination after finishing a distant last which revealed the gelding to have suffered from cardiac arrhythmia. Co-trainer M Pitman was advised that ZAKUNDA will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.

Following the running of the race the rider of the second placed horse PLATINUM SPIRIT, C Dell, viewed films and advised he wished to lodge a protest with the Adjudicative Committee alleging interference over the concluding

stages by the first placed horse JACK BE QUICK. After further consideration and discussion with the stable representative, C Dell elected to withdraw the protest.

Race 8 | **LINDAUER STEWARDS STAKES HANDICAP (G3) 1200m**

GOODANYA (C Barnes) - Slow to begin.

SHEZZACATCH (S Macnab) - Slow to begin.

OKAY PAL (S Wynne) - Over raced in the early stages. Crowded near the 100 metres.

MADAM HASS (S Weatherley) - Raced greenly crossing the junction onto the course proper passing the 800 metres. Shifted ground under pressure in the straight. Contacted by OKAY PAL near the 100 metres.

SATU LAGI (D Johnson) - Over raced in the middle stages.

ROCANTO (K Asano) - Had to be steadied to avoid the heels of SATU LAGI near the 650 metres.

OUR ECHO (T Newman) - Held up for a distance passing the 400 metres.

JOHNNY JONES (L Hemi) - Had to be steadied to avoid the heels of MADAM HASS near the 250 metres.

LIVE DRAMA (T Comignaghi) - Held up near the 300 metres having difficulty obtaining clear running until the 200 metres.

WEKAFORCE (L Allpress) - Gave ground over the concluding stages to finish in last placing. When questioned regarding performance rider was of the opinion that its 60 kg top weight had proved too large an impost. A post race veterinary inspection did not reveal any obvious abnormality.

S Weatherley (MADAM HASS) – Issued with a warning after permitting his mount MADAM HASS to shift outwards under pressure when not sufficiently clear of JOHNNY JONES which was steadied near the 250 metres.

O Bosson (SUMMER MONSOON) - Issued with a warning after allowing his mount SUMMER MONSOON to shift inwards under pressure when not sufficiently clear of OKAY PAL which was crowded near the 100 metres.

Race 9 | **AMICUS INSURANCE BROKERS PREMIER 1000m**

The start was delayed approximately eight minutes as a result of the incidents prior to the start.

O'JESSICA (S Toolooa) - Became fractious in the barriers, rearing and becoming cast in its stall eventually being removed and declared a late scratching acting upon veterinary advice. Trainer A Carston was advised that O'JESSICA is now required to barrier trial to the satisfaction of a Stipendiary Steward prior to racing again.

BLAIR FLIGHT (J Laking) - Was in an adjoining stall to O'JESSICA reacting when that runner became cast and burst through its barrier before being recaptured undergoing a veterinary inspection before being cleared to race. Held up early in the run home.

MADAM SEQUOIA (C Campbell) - Began awkwardly.

WALKTHISSWEY (C Barnes) - Slow to begin.

DORINGO (S Weatherley) - Slow to begin.

MELODY ROXX (K Williams) - Held up early in the run home and continued to be held up for the majority of the straight going to the line untested.

OUR ROSETTE (C Grylls) - Held up early in the run home.

TWIN SHOT (K Chowdhooory) - Rider dropped his whip near the 300 metres.

EMANON (T Moseley) - Lay out passing the 100 metres having to be straightened.

MAKE BELIEVE (J Lowry) - Briefly held up passing the 150 metres and raced in restricted room over the concluding stages.

C Campbell (MADAM SEQUOIA) - Admitted a charge in that he struck his mount MADAM SEQUOIA six times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of C Campbell's licence to ride in races from the conclusion of racing on Saturday 13 November until the conclusion of racing on Wednesday 24 November, 5 national riding days.

Race 10 | **17TH COUPLAND'S BAKERIES MILE (G2) 1600m**

WHALE SONG (S Wynne) - Very slow to begin. The connections were advised that WHALE SONG would be placed on a barrier manners warning.

MAXIMUS PRIME (T Comignaghi) - Shifted outwards at the start crowding outside runners. Raced wide without cover throughout. Gave ground over the concluding stages finishing a distant last. Returned to the enclosure with blood present in both nostrils. Following a veterinary inspection MAXIMUS PRIME was confirmed to have bled. MAXIMUS PRIME shall not be ridden in exercise for a period of two months or start in any Race or Trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

GERMANICUS (S Weatherley) - Crowded at the start losing ground. Rider reported that the gelding had felt indifferent in its action on pulling up. A post race veterinary inspection revealed mild lameness in the right foreleg. Stewards will follow up with connections in coming days.

ROCK SENSATION (K Chowdhooory) - Slow to begin.

HASABRO (J Lowry) - Began awkwardly. Got its head up when being steadied passing the 1200 metres.

ZOLTAN (T Moseley) - Held up entering the straight having to shift ground to obtain clear running passing the 200 metres.

K Asano (DAWN PARADE) - Admitted a charge in that he struck his mount DAWN PARADE seven times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of K Asano's licence to ride in races from the conclusion of racing on Saturday 13 November until the conclusion of racing on Friday 26 November, 7 national riding days.

Race 11 | **CHAMPION FLOUR PREMIER 1800m**

PANZER (K Chowdhooory) - Bounded at the start and was slow to begin as a result.

DECISIVE (G Jogoo) - Slow to begin.

TAVILIGHT (M McNab) - Raced wide without cover throughout.

KICK ON (T Comignaghi) - Was inclined to over race for a distance passing the 1400 metres. Contacted near the 250 metres when CANNOLI shifted outwards under pressure.

PATSY LASS (T Moseley) - Had to be steadied off heels passing the 1150 metres when over racing.

KING OF THE CASTLE (R Mudhoo) - Held up rounding the bend having to shift ground outwards passing the 350 metres to find clear racing room.

KHAFEEF (R Elliot) - Held up in the early and middle stages of the run home only gaining clear running near the 150 metres.
