RACE COMMENTS

Race 1 | **MANAWATU BMW/PETER BAKER GLASS 1400**

TUI ROCKS (W Pinn) - Began awkwardly.

LA BELLA BEALS (D Johnson) - Crowded shortly after the start, losing ground. Held up approaching the 500 metres, having to shift out early in the final straight to obtain clear running.

ANSU (T Yanagida) - Blundered shortly after the start.

BELARDO BOY (K Hercock) - Over-raced, getting its head up when being restrained in the early stages. Continued to over-race, having to be steadied off heels approaching the 1000 metres. Placed in restricted room having to be steadied when LA BELLA BEALS (D Johnson) shifted out when not clear on making the home turn. D Johnson was advised to exercise more care in a similar circumstance.

REIGN IT IN (L Allpress) - Raced greenly throughout and near the 100 metres hung outwards prior to obtaining a run inside the final 100 metres.

QUEEN OF SPADES (F Lazet) - Raced three wide without cover throughout. When questioned regarding performance, rider advised the filly may be better suited to more rain-affected footing. Connections advised QUEEN OF SPADES would now be spelled.

Race 2

MCINTOSH CRANES/WAKA PROPERTY BUILD & RENO MAIDEN 1200

DUBAI LADY (S Macnab) - Began awkwardly losing ground. Raced keenly in the early and middle stages. Raced three wide without cover throughout.

DENY (M Singh) - Began awkwardly shifting out.

STORMCAST (L Allpress) - Hampered at the start losing ground. Raced keenly in the early and middle stages making the bend near the 800 metres awkwardly.

ESPIONAGE (R Elliot) - Began awkwardly. Over-raced in the early stages when being restrained to obtain cover.

GEE CEE (D Johnson) - Raced keenly in the early and middle stages.

RACCOURCI (L Hemi) - Had to be steadied off heels when making the home bend awkwardly.

PRIORESS (W Pinn) - Held up approaching the 400 metres having to shift in to obtain clear running passing the 150 metres.

FINAL IMPACT (S McKay) - Commenced to give ground from near the end of the back straight and was not persevered with. When questioned, S McKay had no excuse and said the gelding failed to hit out at any stage. A subsequent veterinary examination did not reveal any obvious abnormality. Trainer P McKay was advised the gelding must trial prior to its next race-day start. P McKay advised FINAL IMPACT would be spelled.

Race 3

CASAQUINMAN (K Hercock) - Slow to begin. Held up early in the home straight and was angled out to gain clear running.

LADY KARTEL (L Hemi) - Knuckled shortly after the start.

CAVALLO VELOCE (S McKay) - Restrained behind runners shortly after the start.

MEHRTENS (A Mudhoo) - Raced three wide without cover throughout.

FIBONACCI (C Dell) - Held up early in the home straight and was angled out to gain clear running. Rider reported the saddle shifted forward shortly after the start placing the rider at a disadvantage throughout.

TOP BRASS (D Johnson) - Raced keenly in the early and middle stages.

STUMPY (L Allpress) - Checked 800 metres.

F Lazet (KAPINOS) - Admitted a charge of careless riding in that she permitted KAPINOS to shift inwards near the 800 metres when not sufficiently clear of STUMPY which was checked. After hearing submissions, the Adjudicator imposed a suspension of her licence to ride in races from the conclusion of racing on Sunday, 14 November until the conclusion of racing on Saturday, 20 November, 4 national riding days.

SWISH AZ (D Hirini) - Began awkwardly.

PURE IMAGINATION (D Johnson) - Tightened at the start. Lost the offside front plate during the running.

GRAND GESTURE (S McKay) - Tightened start. Finished well back. S McKay advised the gelding may be better suited to more rain-affected footing. A subsequent veterinary examination was clear.

ANJARDEN (F Lazet) - Raced greenly throughout, shifting in at the start tightening PURE IMAGINATION and GRAND GESTURE. Shifted out abruptly near the 800 metres dictating BRADMAN over extra ground, which resulted in BRADMAN then racing greenly. A short distance further ANJARDEN shifted out abruptly and dictated BRADMAN over more ground resulting in BRADMAN making the home turn very wide.

BRADMAN (L Allpress) - Raced greenly and dictated wide on the home turn.

CADEAU (T Yanagida) - Improved onto heels, shifting out, dictating FLYING ZACK wider on the track passing the 400 metres.

FLYING ZACK (W Pinn) - Dictated wider 400 metres.

SANIBEL (K Hercock) - Briefly held up approaching the 400 metres.

MOTIVATION (L Hemi) - Began awkwardly.

UAREASTAR (D Johnson) - Slow to begin. Lugged in under pressure throughout the final straight. When questioned D Johnson was of the opinion the mare is now better suited to a longer distance.

BAD 'N' BOUJ (D Bradley) - Hampered shortly after the start losing ground.

CHARLIE HORSE (A Mudhoo) - Checked shortly after the start. Over-raced in the early stages.

JEWEL OF PATCH (D Hirini) - Checked shortly after the start.

L Kauri (THE MITIGATOR) - Admitted a charge of careless riding in that he permitted THE MITIGATOR to shift inwards shortly after the start when not sufficiently clear of JEWEL OF PATCH and CHARLIE HORSE, both of which were checked. After hearing submissions, the Adjudicator imposed a suspension of his licence to ride in races from the conclusion of racing on Sunday, 14 November up to the conclusion of racing on Wednesday, 24 November, 5 days.

Race 6	MANAWATU ITM 2000
<p>BRIDAL VEIL (K HercocK) - Hampered shortly after the start losing ground. Shifted in under pressure near the 100 metres and had to be straightened.</p> <p>KAHU ROCK (M Singh) - Raced wide without cover throughout.</p> <p>MASTER FIN (T Yanagida)- Partially lost the left-fore plate during running. A post-race veterinary examination found the gelding to be 3/5 lame in the left foreleg due to the plate displacement.</p>	
Race 7	CARTERS/INTER BUILDING 1400
<p>OLD TOWN ROAD (L Allpress) - Contacted at the start losing ground. Made the bend awkwardly passing the 800 metres, dictating LIFFEY wider on the track. When questioned L Allpress advised the gelding is better suited to more rain-affected footing and advised OLD TOWN ROAD is to be spelled.</p> <p>LIFFEY (S Macnab) - Contacted at the start losing ground. Dictated wider 800 metres.</p> <p>TAKE THAT (S McKay) - Restrained behind runners shortly after the start.</p> <p>CARLINGFORD BAY (L Kauri) - Began awkwardly losing ground.</p> <p>POWER 'N' GLORY (M Singh) - Over-raced for a distance when being restrained to gain cover shortly after the start. Made the bend awkwardly passing the 800 metres.</p> <p>BOLD IRIS (T Yanagida) - Held up early in the final straight and was unable to obtain clear running until passing the 150 metres and was then placed in restricted room over the final stages.</p> <p>WINSTON (L Hemi) - Lay out round the final bend. Raced in restricted room over the final stages.</p> <p>EXTORTION (R Elliot) - Placed in restricted room, having to be steadied when awkwardly placed on the heels of WINSTON, which lay out around the final bend.</p> <p>S Marsh (ILLUMINATION) - S Marsh requested permission to scratch ILLUMINATION at 2.12pm based on track conditions. Given that official track conditions were as declared at official scratching time on race morning, Stewards were not satisfied there were circumstances warranting scratching of the horse. Mr Marsh elected to scratch ILLUMINATION without the required authorisation and was fined the sum of \$200.</p>	
Race 8	JAPAC HOMES/FEILDING FLOORING XTRA 1400
<p>IRON EAGLE (W Pinn) - Late scratching at 4.45pm on veterinary advice after biting its tongue and having blood present in the mouth.</p> <p>JESSIE'S ROCK (R Hannam) - Slow to begin.</p> <p>AQUAOIR (D Johnson) - Slow to begin. When questioned regarding performance, D Johnson advised the mare will benefit from a step up in distance and application of blinkers. A post-race veterinary examination did not reveal any obvious abnormality.</p> <p>PINKERTON (C Dell) - Began very awkwardly, losing considerable ground. Connections were advised a warning has been placed against the barrier manners of PINKERTON.</p> <p>LANGKAWI (S McKay) - Over-raced in the back straight. Improved on to heels having to be steadied approaching the 1000 metres. Lost the near hind plate during the running.</p>	

GLIDE QUEEN (F Lazet) - Began awkwardly. Rolled out on the home turn leaving room for SINDACATO to improve to its inside. GLIDE QUEEN then shifted in resulting in both runners buffeting for several strides prior to SINDACATO gaining clear running approaching the 100 metres.

DEDOJE (R Elliot) - Raced three wide without cover approaching the 600 metres.

SCUTAR (D Bradley) - Raced ungenerously in the early and middle stages.

HIGH OCTANE (L Allpress) - When questioned L Allpress had no excuses. A post-race veterinary examination did not reveal any obvious abnormality.
