##### Race 4 - DAKINS GROUP PREMIER 1600m

**WESTERN GIRL** (C Johnson) – Trainer Mr A Carston advised Stewards he was satisfied with the post-race condition of the mare and it is his intention to continue on with WESTERN GIRL'S current preparation.

##### Race 8 - AL BASTI EQUIWORLD DUBAI NZ 2000 GUINEAS (G1) 1600m

**WAKARI** (D Johnson) – Trainer Mr R Bergerson reported to Stewards he was satisfied with the post-race condition of the gelding, however it has now been sent for a spell.

##### Race 10 - NAUTICAL BOAT INSURANCE METROPOLITAN TROPHY HCP 2500m

**SWORDS DRAWN** (C Grylls) – Co-trainer Mr S Ritchie advised Stewards SWORDS DRAWN has now returned back to his Cambridge stable and will be sent for a brief spell.

#### RACE COMMENTS

##### Race 1 RACECOURSE HOTEL & MOTOR LODGE PREMIER 1400m

**RADEGAST** (O Bosson) - Blundered when losing its footing at the start and was slow to begin as a result. Was unable to obtain clear running throughout the home straight.

**SHANGHAI EXPRESS** (K Chowdhury) - Lost its footing and blundered leaving the barriers.

**THE GARRISON** (J Lowry) - Shifted inwards abruptly on jumping crowding runners to its inside. Held up near the 300 metres and again near the 200 metres.

**SHOW BAZZ** (S Weatherley) - Crowded at the start. Raced three wide without cover throughout.

**DIORADELLE** (C Campbell) - Crowded at the start.

**RUSSIAN FABLE** (S Toolooa) - Hampered at the start.

**O'JUDE** (K Asano) - Began awkwardly being slow away.

**CEDDY SMITH** (C Grylls) - Raced wide in the early stages. When well back steadied near the 150 metres when THE GARRISON shifted outwards.

**FETTERCAIRN** (S Wynne) - Lay inwards under pressure over the concluding stages.

##### Race 2 KN COOLTAINER PREMIER 2000m

**NAMIBIA MISS** (C Barnes) - Reared at the start and slow to begin as a result.

**BELINDABELLA** (S Wynne) - Slow to begin.

**JIMINY CRICKET** (J Laking) - Slow to begin.

**LORD ESPERANZA** (S Macnab) - Jumped away awkwardly crowding LADY MODENA. Had to be steadied shortly after the start to avoid the heels of JACK KNOWS BEST (R Cuneen) which shifted inwards when not fully clear. R Cuneen was advised to exercise greater care. Over raced in the middle stages. When questioned regarding performance rider advised that the gelding had not felt comfortable in today's track conditions.

**LADY MODENA** (C Grylls) - Crowded leaving the barriers. Held up when placed in restricted room early in the straight.

**CASE STUDY** (S Weatherley) - Raced three wide without cover throughout.

**STOP MAKING SENSE** (C Campbell) - Held up for a distance near the 400 metres.

**ALJAY** (T Comignaghi) - Lost the right front plate during the running.

**ASATHOUGHT** (M McNab) - Slow to begin.

**LETSBRINGITON** (G Jogoo) - Over raced in the middle stages.

**BULLY BOY** (K Asano) - When questioned regarding performance rider advised that the gelding had travelled a little too keenly but could otherwise offer no excuse other than possibly not being entirely comfortable in today's track conditions.

**HE'S READY** (K Asano) - Blundered at the start.

**OUR ROSETTE** (M Gestain) - Slow to begin.

**EPTIMUM** (V Colgan) - Held up entering the final straight.

**ROCA FUNDEEDA** (M McNab) - Lay in under pressure in the straight. When questioned regarding performance rider advised that the filly had failed to finish the race off in today's track conditions, adding that he had recommended the addition of blinkers to connections.

**TWIN SHOT** (K Chowdhoo) - When questioned regarding performance rider advised that the gelding had not been suited by today's track conditions.

**SPIDERMAN** (S Toolooa) - Began awkwardly.

**OHIO SHOWGIRL** (S Wynne) - Jumped away awkwardly.

**FINAL SAVINGS** (S Macnab) - Slow to begin. Had to shift outwards across heels to obtain clear running passing the 250 metres.

**OCEAN POINT** (R Mudhoo) - Had to be straightened on a number of occasions when racing greenly in the home straight.

**ROCKLAND** (L Allpress) - Rider advised that the gelding had failed to handle today's track conditions.

**Race 6** | **RICCARTON PARK FUNCTON CENTRE WELCOME STAKES 1000m**

The start was delayed when CHAMPAGNE DREAM had to be resaddled and proved difficult to load.

**TAP DANCER** (D Johnson) - Shifted outwards on jumping bumping with WAR TIME.

**WAR TIME** (C Grylls) - Bumped at the start.

**CHAMPAGNE DREAM** (S Wynne) - Began awkwardly shifting outwards losing ground.

**Race 7** | **NZB READY TO RUN SALE 17-18 NOVEMBER PREMIER 1400m**

**SWISSWATCH** (O Bosson) - Slow to begin.

**SILENT BATTLER** (J Laking) - Began awkwardly then further hampered when crowded shortly after the start.

**UCALLEDIT** (T Comignaghi) - Shifted outwards abruptly at the start crowding runners to its outside.

**MONZA CIRCUITO** (D Johnson) - Shifted inwards abruptly at the start crowding runners to the inside.

**GOODANYA** (C Barnes) - Crowded at the start.

**ALL ABOUT MAGIC** (S Wynne) - Over raced in the early stages.

**EL BEE DARCI** (R Mudhoo) - Over raced in the middle stages.

**R Mudhoo** (EL BEE DARCI) - Admitted a charge in that he struck his mount EL BEE DARCI six times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.

**Race 8** | **BARNESWOOD FARM 49<sup>TH</sup> NZ 1000 GUINEAS (G1) 1600m**

**SORRENTO** (S Weatherley) - Proved difficult to load delaying the start. The connections were advised that a warning would be placed on SORRENTO's barrier manners.

**EMANON** (S Toolooa) - Raced three wide without cover throughout. Required post-race veterinary treatment for a superficial wound to the left front pastern.

**THERE YOU GO** (K Asano) - Blundered badly on jumping almost dislodging its rider losing ground. When questioned regarding performance rider advised that the filly's chances had been affected when losing its footing at the start following which it had not felt comfortable in today's track conditions.

**GLOBAL BEAUTY** (T Comignaghi) - Shifted out abruptly on jumping crowding outside runners.

**BELLE EN ROUGE** (M McNab) - Crowded at the start. Steadied when placed in restricted room to the inside of MUSTANG VALLEY near the 1400 metres.

**AND WE DANCED** (L Allpress) - Crowded at the start.

**VENTURESOME** (K Mudhoo) - Checked when crowded near the 1400 metres.

**AND WE DANCED** (L Allpress) - Steadied to avoid heels near the 1400 metres.

**SHEPHERD'S DELIGHT** (S Wynne) - Inclined to over race in the middle stages.

**IRISH RED** (J Laking) - Held up near the 400 metres.

**O Bosson** (THE PEPECT PINK) – Admitted a charge of careless riding in that he permitted his mount THE PERFECT PINK to shift inwards when not sufficiently clear of VENTURESOME which was checked and forced into the line of AND WE DANCED which was steadied near the 1400 metres. After considering submissions the Adjudicative Committee imposed a suspension of O Bosson's licence to ride in races from the conclusion of racing on Saturday 20 November until the conclusion of racing on Thursday 2 December, 7 national riding days, and in addition imposed a fine of \$1500.

**O Bosson** (THE PERFECT PINK) - Admitted a charge in that he struck his mount THE PERFECT PINK eight times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$4,500.

**S Wynne** (SHEPHERD'S DELIGHT) - Admitted a charge in that she struck her mount SHEPHERD'S DELIGHT seven times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of S Wynne's licence to ride in races from the conclusion of racing on Wednesday 15 December until the conclusion of racing on Monday 27 December, 8 national riding days, and in addition imposed a fine of \$1,500.

Given S Wynne's poor recent record under this rule she has been directed by the Stewards to meet with an NZTR appointed Rider Skills Review Panel under the provisions of Rule 343.

**Race 9** | **VERNON & VAZEY TRUCK PARTS PREMIER 1400m**

**ISLAND HOP** (S Weatherley) - Slow to begin. Contacted rounding the turn near the 450 metres.

**GLORIOUS OCEAN** (C Grylls) - Raced wide without cover throughout.

**BENNY LINCOLN** (C Johnson) - Over raced in the middle stages.

**AVAQUINELLA** (R Cuneen) - Made contact with ISLAND HOP when attempting to obtain clear running rounding the turn near the 450 metres then having to be steadied passing the 400 metres when awkwardly placed near the heels of GLORIOUS OCEAN.

**Race 10** | **MARTIN COLLINS 158<sup>TH</sup> NEW ZEALAND CUP (G3) 3200m**

**BEAUDZ WELL** (S Weatherley) - Slow to begin. Raced wide in the early stages before being taken forward to lead near the 1800 metres.

**KHAFEEF** (G Jogoo) - Slow to begin. Over raced badly in the early and middle stages proving a difficult ride. Improved wide from the 1800 metres to reach the lead near the 1200 metres.

**MOIRAS TOWN** (T Moseley) - Over raced and raced wide in the early stages. A post-race veterinary inspection found the mare to have a poor rate of recovery.

**HIT THE ROAD JACK** (C Grylls) - Raced wide in the early stages. Improved forward quickly from the 2000 metres.

**WILD JACK** (A Bohorun) - Raced wide in the early stages.

**BLUEY'S CHANCE** (T Jonker) - Over raced in the early stages. Raced wide in the middle stages. Was not persevered with in the final straight when well beaten. Rider reported that the gelding had blundered rounding the turn and then felt indifferent in its action. A post-race veterinary inspection did not reveal any obvious abnormality.

**LEITRIM LAD** (S Wynne) - Over raced in the early to middle stages being allowed to improve forward from the 1900 metres.

**MADAM DE SOIR** (T Comignaghi) - Over raced badly having to be firmly restrained near the 1800 metres.

**OUR BOY RITCHIE** (B May) - Allowed to improve forward from the 1800 metres.

**Race 11**

**PENINSULAR BEACHFRONT RESORT-MOOLOOABA PREMIER 1600m**

**MY WORLD** (M McNab) – Late scratched at 5.11pm on veterinary advice after being fractious in the barriers becoming cast. Co-trainer M Pitman was advised that MY WORLD must now barrier trial to the satisfaction of a Stipendiary Steward prior to racing next.

**ZEEFA ZED** (S Macnab) - Slow to begin.

**EXCHANGE** (J Lowry) - Slow to begin. Had to be steadied away from the heels of CETUS near the 300 metres when CETUS was taken out by PETTY'S LEGACY.

**HE'S A DOOZY** (D Johnson) - Inclined to get its head up when being restrained in the early stages after jumping from a wide barrier.

**HEE'S OUR SECRET** (K Asano) - Commenced to over race near the 1400 metres continuing to do so through the middle stages.

**K Chowdhury** (PETTY'S LEGACY) - Issued with a warning after permitting his mount PETTY'S LEGACY to shift outwards passing the 300 metres dictating CETUS outwards resulting in EXCHANGE having to be steadied.

Trainer **S Marsh** (BRONTE BEACH) - Fined \$50 under the Minor Infringement Schedule after presenting BRONTE BEACH without an item of notified gear.

**Race 12**

**SPEIGHT'S PREMIER 2000m**

**SAIGON HOT NIGHT** (V Colgan) - Slow to begin. Over raced in the middle stages.

**HEY SOUL SISTER** (M McNab) - Raced wide in the early stages.

**DARCEE QUE** (T Comignaghi) - Raced three wide without cover throughout. Made contact with SAVEZAR near the 150 metres then racing in restricted room for a distance being struck over the head by the whip of S Wynne (ELIZABETH ROSE) late in the race.

**SAVEZAR** (J Lowry) – Unbalanced when contacted near the 150 metres.

**SUMMER NIGHT** (C Campbell) - Over raced in the middle stages.

**MASTER LINCOLN** (C Johnson) - When questioned regarding performance rider was unable to offer any excuse.
