Race 5 - FRANKLIN LONG ROOFING LTD 1100

CHAMPAGNE GOLD (D Prastiyou) - Stewards concluded an inquiry into the ride by Jockey D Prastiyou on **CHAMPAGNE GOLD** in particular his apparent lack of vigour at various stages in the final straight. D Prastiyou

explained the gelding had felt indifferent at times in the final straight and had been somewhat difficult. With Stewards taking into account the circumstances surrounding the meeting, Jockey D Prastiyou's explanation was noted and he was reminded that he must not ride his mounts in a manner that is left open to question.

RACING TAURANGA – Saturday, 13 November 2021

Race 5 - LASER PLUMBING WAIHI BEACH HANDICAP (2100 metres)

WHANGA WONDER (M Cameron) - Stewards concluded an inquiry into the ride of M Cameron on WHANGA WONDER in particular his apparent lack of vigour between the 225 metres and 100 metres. Stewards accepted M Cameron's explanation and reminded him to ride his mounts out when circumstances permit.

RACE COMMENTS

Race 1 | **WAITOMO FUELS 1215**

ROOFTOP (S McKay) - Slow to begin then hampered losing ground. Over-raced in the early and middle stages.

NOSSENKO (C Grylls) - Began awkwardly losing ground. Improved onto heels 200 metres and briefly held up before shifting out to obtain clear running.

LANEWAY FLIRTING (M McNab) – Began awkwardly. Raced keenly in the early and middle stages.

LINGJUN HERO (A Goindasamy) - Began awkwardly. Raced keenly in the early and middle stages and had to be restrained off heels passing the 600 metres with the trailing JIMMY KIRK also having to be restrained at this point.

SANCTIFY YOURSELF (M Cameron) – Hampered shortly after the start then raced three wide without cover for a majority of the race.

ORLEANS BELLE (J Fawcett) – Restrained behind runners shortly after the start. Underwent veterinary treatment for a small wound to the left forearm.

MADAME MOET (O Bosson) - Held up early in the run home.

BIT NOSY (B Grylls) - Raced in restricted room near the 800 metres when AOIDE lay in when negotiating the bend at this point. Underwent an endoscopic examination post-race at the request of the connections with no abnormality detected.

THE STONEY ONE (V Colgan) - Improved quickly onto heels passing the 700 metres having to shift outwards abruptly.

RAGAMUFFIN (J Kamaruddin) – Held up 200 metres and when attempting a marginal run made firm contact with JIMMY KIRK with both these runners being buffeted and unbalanced.

JIMMY KIRK (S Weatherley) - Restrained 600 metres. Buffeted and unbalanced 200 metres.

J Kamaruddin (RAGAMUFFIN) - Issued with a warning when allowing his mount to shift out when attempting a marginal run making firm contact with JIMMY KIRK with both runners being buffeted and unbalanced for a short distance near the 200 metres.

M McNab (LANEWAY FLIRTING) - Issued with a warning when weighing in 0.6 kgs over his weigh out weight.

Race 2 | **CAMPBELL INFRASTRUCTURE 1215**

AUBREE (C Grylls) - Began awkwardly losing ground.

PARISIAN (B Rogerson) - Began awkwardly. Over-raced in the early and middle stages. Improved onto heels having to shift out and was then obliged to race three wide without cover from the 1000 metres.

MORE THAN WORDS (L Allpress) - Raced keenly when being restrained to obtain cover in the early stages. Improved onto heels having to be steadied passing the 1000 metres and continued to race keenly for a distance afterwards.

JODELIN GAL (A Goindasamy) - Briefly held up rounding the final bend.

EXCITONIC (O Bosson) – Had some trouble obtaining clear running early in the run home.

Race 3	NOVARA PARK 1215

FELICIENNE (O Bosson) - Began awkwardly losing some ground. Steadied 600 metres. Had difficulty obtaining clear running until approaching the 100 metres.

LEICA STAR (J Kamaruddin) - Began awkwardly losing some ground. Hampered and buffeted 700 metres.

MANDALO (V Colgan) - Shifted out abruptly at the start crowding **PINK CHAMPAGNE** which lost some ground as a result. Raced erratically in the run down the back straight and near the 900 metres shifted out then when being straightened by its rider shifted in abruptly crowding **LASER'S FURY** which had to be checked and placing itself awkwardly on the heels of the runner in front having to be severely restrained with trailing runners being hampered. Continued to race greenly throughout causing the jockey some difficulty. Connections were advised that the gelding would be required to barrier trial prior to racing next.

PINK CHAMPAGNE (S Weatherley) – Crowded at the start losing ground.

MISS ELLA (D Johnson) - Hampered 950 metres having to be heavily restrained

LASER'S FURY (T Newman) - Crowded and checked having to be heavily restrained passing the 950 metres with the trailing **MISS ELLA** having to be also restrained and shift ground outwards. Underwent a post-race veterinary examination which found the gelding to be 1/5 lame in the right hind leg.

VALADAMS (M Cameron) - Had to be steadied away from the heels of **PISCO SOUR** passing the 850 metres and then hung outwards from this point proving difficult to control and failed to finish the race. Underwent a post-race veterinary examination which did not reveal any obvious abnormality. Trainer J Pender was advised that the mare would be required to barrier trial prior to racing next.

PISCO SOUR (C Grylls) - Made the bend near the 900 metres awkwardly shifting out hampering **VALADAMS**. Hampered and forced wider 700 metres.

PINATALE (J Fawcett) - Heavily restrained near the 700 metres when improving quickly onto the heels of the runners in front shifting out abruptly making firm contact with **LEICA STAR** who was forced outwards hampering **PISCO SOUR**.

GEMMA FLITZ (S McKay) – Lay out over the concluding stages having to be steadied by its rider crowding **MISS ELLA** onto **PISCO SOUR** which were both hampered.

Race 4	LANCE LAWSON 1560

DROVERS YARN (M Cameron) - Began awkwardly. Placed in restricted room having to be steadied losing ground shortly after the start.

SWORD OF MERCY (M McNab) - Slow to begin.

DO THE MATHS (B Grylls) - Slow to begin. Raced three wide without cover throughout.

BIGIFF (A Goindsamy) - Slow to begin.

KALUANUI (C Grylls) - Slow to begin.

ANDROMEDA (S Weatherley) - Crowded shortly after the start losing some ground.

ACQUITTAL (B Rogerson) - Over-raced when making the bend awkwardly near the 1200 metres getting its head up on a number of occasions and continued to over-race for some distance.

LEADING MAN (D Johnson) - Shifted in approaching the 250 metres to obtain clear running.

S Weatherley (ANDROMEDA) - Stewards inquired into the manner in which S Weatherley used his whip over the concluding stages and could not be conclusively satisfied that he had contravened the rules.

Race 5

RYDGES ROTORUA 1560

KOOL CHOUXZ (S McKay) - Crowded shortly after the start having to be steadied, losing ground.

CAPALDI (B Rogerson) - Slow to begin. Raced keenly in the early and middle stages.

CLIQUE (D Johnson) - Began awkwardly then was taken back to obtain cover. Lost the near fore plate during the running.

BRIAN LAMONT (B Grylls) - Over-raced in the early and middle stages.

ALEGRE (M Cameron) – Raced three wide without cover throughout.

SOCIALIGHTS (L Allpress) – Raced three wide without cover for the majority of the race.

SHE'S APPLES (M McNab) - Held up rounding the final bend and was unable to obtain full clear running and went to the line untested by its rider.

TICKLE ME ALMO (J Fawcett) - Shifted in under pressure passing the 50 metres making contact with QUICK PREVIEW.

Race 6

LASER ELECTRICAL 1400

OH NO NO NO (L Allpress) - Slow to begin. Had to be steadied off heels when becoming awkwardly placed losing ground as a result. Commenced to race ungenerously through the early and middle stages having to be steadied shifting out across heels and was then obliged to race three wide without cover near the 1000 metres.

MIDNIGHT (S McKay) - Slow to begin.

OUTFIT (J Kamaruddin) - Slow to begin. Held up passing the 150 metres and went to the line not fully tested by its rider.

TUSCAN HOLIDAY (C Grylls) – Taken back from a wide draw to obtain cover in the early stages.

EAGLE TARZAN (V Colgan) - Got its head up on a number of occasions when being steadied to take cover early in the run down the back straight and continued to over-race throughout the back straight.

POLIZZI (B Rogerson) - Over-raced through the middle stages and passing the 800 metres had to shift out to avoid the heels of the runner in front.

KORUBELA MISS (M Cameron) - Became awkwardly placed on the heels of KEANO REEVES passing the 700 metres.

Race 7 | **NZB INSURANCE PEARL SERIES RACE (1400 metres)**

J Bary (TOO SAVVY) - Issued with a warning after presenting TOO SAVVY to race with a noseband which was notified.

SOCIAL DISTANCE (S Weatherley) - Slow to begin. Had difficulty obtaining clear running until inside the final 100 metres before shifting out across heels passing the 100 metres.

IF ONLY I KNEW (B Rogerson) - Slow to begin.

DARCI'S QUEEN (M McNab) – Began awkwardly losing ground.

MIRIELLA (J Kamaruddin) - Slow to begin.

TOO SAVVY (C Grylls) - Raced keenly in the early and middle stages. Raced three wide without cover throughout.

SIDE HUSTLE (B Grylls) - Held up rounding the bend and early in the run home.

B Grylls (SIDE HUSTLE) - Admitted a charge in that she used her whip in two consecutive strides on her mount SIDE HUSTLE near the winning post. After considering submissions the Adjudicative Committee suspended B Grylls' licence to ride in races from the conclusion of racing on Wednesday 24 November up to and including racing on Thursday 2 December, 6 national riding days.

Race 8 | **ATKINSON & DONALDSON 1400**

PAPENHUYZEN (C Barnes) – Began awkwardly. Raced keenly in the early and middle stages.

REKINDLED EXPRESS (M McNab) – Over-raced in the early and middle stages.

SATIN BLANCO (B Grylls) – Raced three wide without cover throughout.

GEE VEE KAYE (J Kamaruddin) - Held up having to be steadied shifting out across heels approaching the 400 metres.

Race 9 | **MACMILLAN ACCOUNTANTS 1950**

JACK IN THE BOX (D Johnson) – Slow to begin.

REGAL LION (O Bosson) - Hampered shortly after the start losing ground.

GOODO JO (C Barnes) - Slow to begin.

BEAU ARCHERS ROSE (J Fawcett) - Began awkwardly losing ground.

LOGAN'S LOGIC (T Newman) - Over-raced for a distance when being restrained to obtain cover passing the 1800 metres.

AFITUSI (B Grylls) – Raced three wide without cover for the majority of the race.

O Bosson (REGAL LION) - Admitted a charge in that he used his whip in two consecutive strides on his mount REGAL LION inside the final 100 metres. After considering submissions the Adjudicative Committee suspended O Bosson's

licence to ride in races from the conclusion of racing on Thursday 2 December up to and including racing on Friday 10 December, 5 national riding days.
