RACE COMMENTS

Race 1 | **CROWDED HOUSE MAIDEN (1800 Metres)**

CURRENT SURGE (L Allpress) - Late scratching at 2.00 pm after becoming injured in the float.

MARGARET ELIZABETH (A Mudhoo) - Slow to begin then crowded losing ground. Rider reported the mare had raced greenly throughout.

MASTER ORTEGA (M McNab) - Slow to begin. When questioned M McNab advised the colt lacked concentration.

KHANT CATCH HER (S McNab) - Crowded just after the start losing ground.

HENRY JAMES (S O'Malley) - Restrained behind runners shortly after the start.

KUSHINDA (C Jones) - Raced three wide without cover throughout.

RISCHIO (L Hemi) - Clipped the heels of DOHA (S Weatherley) and went off stride near the winning post on the first round when DOHA shifted in when not the required distance clear. Also hampered was MADAM GUERIN which had to be steadied.

MADAM GUERIN (J Kamaruddin) - Hampered at winning post first round.

S Weatherley (DOHA) – Admitted a charge of careless riding in that he permitted DOHA to shift inwards when not sufficiently clear of RISCHIO which clipped that runner's heel and went off stride near the 1600 metres. After considering submissions the Adjudicator imposed a suspension of his licence to ride in races from the conclusion of racing on Saturday 27 November until the conclusion of racing on Friday 3 December, 4 national riding days.

Race 2	REVITAL FERTILISERS (1600 Metres)

JANE O' (J Mudhoo) - Began awkwardly losing ground. Improved onto heels when over racing having to be steadied passing the 800 metres.

GO BOBBY (A Goindasamy) - Slow to begin.

JUSTASTATE (M Sanson) - Underwent a veterinary examination on arrival at the barriers and was cleared fit to start. Slow to begin.

WICKED ROMANCE (L Douglas) - Restrained behind runner shortly after the start. Raced three wide without cover passing the 1000 metres.

ALL THAT JAZZ (A Mudhoo) - Steadied 150 metres

UP 'N' GONE (L Hemi) - Shifted out when not clear dictating ALL THAT JAZZ outwards having to be steadied near the 150 metres.

L Hemi (UP 'N' GONE) - Issued with a warning for allowing UP 'N' GONE to shift outwards when not sufficiently clear of ALL THAT JAZZ which was dictated out and steadied near the 150 metres.

Race 3	NZB INSURANCE PEARL SERIES MAIDEN RACE (1200 Metres)

VIOLETTA (A Goindasamy) - Slow to begin.

GINGER SNAPZ (L Douglas) - Began awkwardly losing ground

SONGSUNGLU (L Allpress) - Slow to begin. Raced keenly throughout.

WATUZZI (C Jones) - Began awkwardly losing ground.

STAR OF AUSTRALIS (J Kamaruddin) - Steadied when the pace eased in the back straight and went back on to VIOLETTA which also had to steady.

LINDT (S Macnab) - Over raced in the back straight.

ORGANISED CHAOS (T Thornton) - Steadied on the point of the home turn when FAR AND AWAY lay in. FAR AND AWAY continued to lay inwards for the remainder of the home straight.

FAR AND AWAY (D Johnson) - Lay inwards from home turn through the home straight.

Race 4 | **STELLA ARTOIS MAIDEN 3YO (12000 Metres)**

HI YO SASS BOMB (L Hemi) - Slow to begin. Over raced in the early and middle stages.

PLATINUM ASSAULT (S Macnab) - Reared at the start losing ground.

ZENA ROCKS (D Hirini) - Crowded shortly after the start losing ground when runners either side shifted ground.

KIANA BELLE (R Hannam) - Raced ungenerously in the early and middle stages

ASCERTAIN (D Johnson) - Finished well back. D Johnson was of the opinion the gelding may be better suited to the addition of blinkers, but was nevertheless disappointing.

FIVE ROAD JUNCTION (T Thornton) - Raced three wide without cover passing the 700 metres.

L Douglas (REVELRY) - Was shown footage of his ride in the presence of the Riding Master for allowing his mount to shift outwards throughout the final straight.

Race 5 | **PRIMO 1200**

ANJARDEN (M Sanson) - Slow away.

FLYING ZACK (L Hemi) - Shifted out at the start bumping with KID ROC.

TINY TERROR (C Dell) – Steadied into the first turn near the 800 metres and went back on to KID ROC which was over racing.

KID ROC (L Allpress) – Over raced in the early and middle stages.

ARABIAN SEA (S Macnab) – Held up for some distance in the home straight obtaining clear running when switched wide near the 150 metres.

Race 6 | **ENERGY CITY FORD 2000**

CISJURANE (C Dell) - Began very awkwardly shifting out abruptly briefly unbalancing its rider losing ground then commenced to over race. Hung out when under pressure throughout the final straight.

NITRO TED (H Schofer) - Taken forward near the 1100 metres due to a lack of pace ahead.

WEE DRAM (L Allpress) - Made contact with rail near 800 metres. Held up entering the final bend shifting outwards to obtain clear running.

ATA RANGI (J Kamaruddin) - Held up approaching the 400 metres and shifted outwards to obtain clear running early in the final straight.

Race 7 | **LA NUOVA APPARELMASTER 1100**

BARNEY RUBBLE (L Douglas) - Slow to begin.

ADDICTED TO YOU (L Allpress) - Began awkwardly losing ground. Bumped with MAISON ROXANNE near the 200 metres when both runners shifted ground under pressure.

SUMI (S Macnab) - Improved on to heels passing the 400 metres and had to be restrained. Angled wide near the 300 metres to improve.

MAISON ROXANNE (J Kamaruddin) - Bumped with ADDICTED TO YOU near the 200 metres. Tightened near the finish line

C Jones (CATSACHARMER) - Issued with a warning after allowing his mount to shift out under hard riding over the final stages resulting in MAISON ROXANNE being tightened near the line.

Race 8 | **CREDIFLEX MAIDEN (1100 Metres)**

CHAJABA (C Dell) - Slow to begin. Dictated over extra ground home turn.

SUPERCHARGED (L Hemi) - Began awkwardly. Dictated over extra ground home turn.

TAMBERI (A Goindasamy) - Crowded shortly after the start losing ground when runners to either side shifted ground.

SHE'S A SHOWOFF (D Johnson) - Began awkwardly then hampered having to be steadied losing ground. Dictated over extra ground home turn.

SHOW US MORE (S Macnab) - Over reacted shortly after the start and skied its head for some distance when being steadied inconveniencing CHARMANDER and SHE'S A SHOWOFF. When questioned into her ride, S Macnab advised her instructions were to trail and not lead, however agreed with the stewards view that she may have erred in her judgment by not letting the filly roll along in the early stages when able to do so.

CHARMANDER (S Weatherley) - Inconvenienced shortly after the start. Made the home turn awkwardly shifting out dictating SUPERCHARGED, SHE'S A SHOWOFF and CHAJABA over extra ground.

Race 9 | **CHRISTMAS AT THE RACES DECEMBER 2ND MAIDEN (1100 Metres)**

PASHAMALA (L Hemi) - Commenced to buck shortly after the start losing all chance and was not persevered with. Connections were advised the mare must trial prior to its next start.

SNORKEL (M Mcnab) - When questioned into the run of SNORKEL M McNab had no particular excuse.

M McNab (SNORKEL) - Was reminded of his obligations with regard to his use of the whip on a runner when not in contention.
